Opinion 2013-4

Re: Counties and County Officers—Sheriff—Qualifications for Office; Conviction of Possession or Consumption of Cereal Malt Beverage by a Person Under 21 Years of Age; Effect of Conviction; February 7, 2013.

Synopsis: K.S.A. 2012 Supp. 19-801b(a)(3) provides that a person who was convicted of any violation of federal or state laws or city ordinances relating to liquor is not eligible to serve as sheriff. A person who was convicted under K.S.A. 2012 Supp. 41-727(a) of possessing or consuming either an alcoholic liquor or cereal malt beverage when over 18 years of age but under 21 years of age is disqualified from serving as sheriff pursuant to K.S.A. 2012 Supp. 19-801b(a)(3). Article 4.—INSTANT GAMES AND DRAWINGS

111-4-3233. “Bonus Crossword” instant ticket lottery game number 526. (a) The Kansas lottery shall conduct an instant winner lottery game entitled “Bonus Crossword” commencing on or after January 1, 2013. The rules for this game are contained in K.A.R. 111-3-1 *et seq.* and 111-4-3233.

(b) The “play symbols” for this game are as follows: A - B - C - D - E - F - G - H - I - J - K - L - M - N - O - P - Q - R - S - T - U - V - W - X - Y - Z. There are no “play symbol captions” in this game.

(c) For this game, a play symbol shall appear in each of 18 play spots within the “YOUR LETTERS” play area, in each of two play spots within the “BONUS” play area, and a variable number of times within the crossword puzzle grid.

(d) The ticket numbers in each book of tickets in this game shall start with 000 and end with 149.

(e) The price of instant tickets sold by a retailer for this game shall be \$2.00 each.

(f) “Bonus Crossword” consists of three play areas. In the upper part of the ticket there is a crossword puzzle grid that contains 11 spaces (height) by 11 spaces (width) covered by transparent latex. In the “YOUR LETTERS” play area, located in the lower part of the ticket, there are 18 letters located under opaque latex. To the right of the “YOUR LETTERS” play area is the “BONUS” play area in which there are two letters covered by opaque latex. Imaged around each of the 18 “YOUR LETTERS” and two “BONUS” letters there will be a four-sided box composed of solid lines. A player will remove the latex from the “YOUR LETTERS” and “BONUS” play areas one letter at a time, and then for each matching letter in the crossword puzzle grid scratch off the transparent latex. Each letter revealed in the “YOUR LETTERS” and “BONUS” play areas may be used an unlimited number of times in the crossword puzzle grid. If a player reveals at least three complete words in the crossword puzzle grid, the player wins the corresponding prize in the prize legend. The prize legend on the front of the ticket indicates prizes won for number of words revealed.

(g) To qualify as a complete word to win a prize in this game, the words revealed must meet the following requirements:

- (1) must contain at least three letters;

25 DAYS OF KENO DRAWING

111-7-255. Name of drawing. The Kansas lottery shall conduct a drawing entitled “25 Days of Keno Drawing,” and will accept entries on and after January 7, 2013, beginning at 5 a.m., and ending on February 5, 2013, at 5:00 p.m. as specified in these rules. The drawing will be held at Kansas lottery headquarters office in Topeka, Kansas on Friday, February 8, 2013. Rules applicable to this drawing are contained in K.A.R. 111-7-255 through 111-7-260 and K.A.R. 111-3-1, *et seq.* (Authorized by and implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-2-25-13, Dec. 12, 2012.)

111-7-256. Definitions. (a) All applicable definitions contained in the Kansas lottery act (K.S.A. 74-8701 *et seq.*) and lottery regulations are hereby incorporated by reference and govern unless otherwise indicated.

(b) “25 Days of Keno Drawing” means the act of drawing prizes conducted by the Kansas lottery at the time and date described in these rules in which participants are selected to win various prizes as described in these rules.

(c) “Entry form” means any valid entry form generated at a Kansas lottery selling terminal as the result of a pur-

chase of \$10 or more on a single ticket of the Kansas lottery online Keno game during the term of this promotion.

(d) “Receptacle” or “drum” means a container in which completed entry forms are placed and from which the “25 Days of Keno Drawing” entries are drawn. Receptacles or drums may be sealable and shall be capable of being mixed or rotated for the purpose of ensuring random distribution.

(e) “Bare arm technique” means a type of drawing where the person drawing the winning ticket from the receptacle or drum wears a long-sleeved shirt with sleeve rolled up above the elbow, a short-sleeved shirt (sleeve not extending past the elbow) or a no-sleeve shirt which exposes the drawer’s bare arm and looks away from the drawing drum or receptacle while drawing. (Authorized by and implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-2-25-13, Dec. 12, 2012.)

111-7-257. Prize. (a) The first winner drawn in the “25 Days of Keno Drawing” shall receive \$365 worth of free Keno plays via coupons in denominations at the Kansas lottery’s discretion. Three secondary prize winners shall each receive a poker table and chip set.

(b) All prizes are subject to lottery validation, set-offs and deductions authorized by law.

(c) The Kansas lottery may, at its sole and absolute discretion, substitute a prize of approximate equal value, or change the time, date, and place of relevant entry or drawing times, if necessary. (Authorized by and implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-2-25-13, Dec. 12, 2012.)

111-7-258. Method of entry. (a) Entry into the “25 Days of Keno Drawing” to be conducted on February 8, 2013, shall be accomplished as follows:

(1) For every single purchase of \$10 or more of Kansas lottery online “Keno” tickets, an entry form will generate automatically on the online terminal where the ticket was sold. The selling clerk at the retailer location shall give the entry form to the person who purchased the ticket.

(2) The holder of the entry form must complete the information on the entry form in a legible manner. Only one name shall appear on an entry form entered.

(3) Players may deposit entry forms for the “25 Days of Keno Drawing” beginning on and after January 7, 2013, at any Kansas lottery event or location at which the lottery has specifically designated a receptacle for deposit of said entries until 5:00 p.m. on February 5, 2013.

(4) Entries other than those entered at Kansas lottery events or locations as identified in these rules shall be mailed with proper postage to “25 Days of Keno Drawing,” P. O. Box 3561, Topeka, Kansas 66601-3561. Mailed entries must be received by the morning mail pickup on Tuesday, February 5, 2013. More than one entry may be mailed in one envelope.

(5) The holder of the entry form is not required to personally attend the “25 Days of Keno Drawing” or be present at the time of the drawing to be determined a winner.

(b) There is no limit on the number of entries a person may make, but a person may only win one time in the drawing.

(continued)

(c) Only valid entry forms which are mailed to the "25 Days of Keno Drawing," at the above-stated address with proper postage and received by the morning mail pickup in Topeka, Kansas, on Tuesday, February 5, 2013, and valid entry forms entered into any other receptacle designated by the lottery as provided in the rules herein shall be eligible for the drawing. All entries so mailed or deposited shall be secured by the lottery until the drawing is conducted.

(d) Eligible entrants in the "25 Days of Keno Drawing" must be 18 years of age or older.

(e) Completing the information on the entry form and entering the entry form into the drawing constitutes authorization to publicly identify the person whose entry is drawn.

(f) The Kansas lottery shall not be responsible for any lost, destroyed, mutilated, unreadable, or altered entries into the "25 Days of Keno Drawing." Players enter this contest at their own risk. (Authorized by and implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-2-25-13, Dec. 12, 2012.)

111-7-259. Selection of winners. The following process shall be used for the selection of the winners in the "25 Days of Keno Drawing:"

(a) Kansas lottery personnel shall pick up all mail containing "25 Days of Keno Drawing" entries at the United States Post Office Box 3561, in Topeka, Kansas, with the final pick up at the Topeka post office in the morning mail pickup on Tuesday, February 5, 2013. Following the morning mail pickup on Tuesday, February 5, 2013, the envelopes containing mailed entries will be transported to lottery headquarters and opened by lottery personnel. All mailed entries shall then be placed in the drawing receptacle or drum designated by the lottery for the "25 Days of Keno Drawing" entries.

(b) Kansas lottery personnel shall pick up all "25 Days of Keno Drawing" entries deposited at any Kansas lottery event or location, at which the lottery specifically designated a receptacle for deposit of said entries, periodically throughout the drawing. The final pick up at any open receptacles shall be immediately after the close of the Kansas lottery claims centers in Topeka, Kansas, and Great Bend, Kansas, at 5:00 p.m. on February 5, 2013. All entries deposited at a designated receptacle for deposit of said entries shall be transported to lottery headquarters, if necessary, and opened by lottery personnel and placed in the drawing receptacle or drum designated for deposit of said entries by the lottery.

(c) The drawing shall be held at a location determined by the executive director of the Kansas lottery and shall be open to the public with lottery security personnel present. The drawing shall be audio and video taped.

(d) At the drawing on February 8, 2013, lottery security personnel will be present with the person designated by the executive director to perform the drawing. Prior to the drawing, if a drum is used, the drum shall be sealed and the contents mixed by rotating the drum at least 10 times. If a receptacle other than a drum is used, the contents shall be thoroughly mixed with a shovel or by other means.

(e) The designated individual shall then unseal the drum, if a drum is used, and using the bare-arm tech-

nique, while looking away, remove four entry forms from the receptacle or drum, which shall be marked as number one through four, in the order drawn. The person(s) whose name(s) appear on the entries drawn shall be the winner of the prizes identified in these rules, subject to validation by the lottery as set forth in these rules.

(f) After the prize entries have been drawn on February 8, 2013, and the entries have been verified as valid, four more valid entries will be drawn, one at a time, which entries drawn will serve as alternate entries. The alternate entries will be marked in order drawn, 1A, 2A, 3A, and 4A. The winners shall have until 5:00 p.m. on the fifth day following the date of the drawing to claim the prize. If a prize winner cannot be located or is declared ineligible, or fails to timely claim his prize, the prize will be awarded to the next alternate ticket selected in the order drawn. The alternate winner shall have until 5:00 p.m. on the fifth day following receipt of a claim form mailed by the Kansas lottery to claim the prize. The alternate winner process shall be repeated until the prize is properly claimed or until such time as no alternate winners remain, whichever occurs first.

(g) The Kansas lottery security official present shall review each entry drawn to determine the validity of the entry into the "25 Days of Keno Drawing" in accordance with these regulations. If it is a valid entry and the name is legible, the event manager and the security person present shall record the name of the winner and the prize won. The prize winner shall be contacted by phone by designated Kansas lottery personnel.

(h) If any entry drawn is determined to be ineligible, it shall be discarded by the security person present and another entry drawn. This procedure will be repeated until the required number of apparently eligible selections is obtained.

(i) Only qualified entry forms described in these rules are eligible for the drawing.

(j) All entries remaining in the drum or receptacle after the winners and alternates have been selected, and all entries not received in compliance with these rules shall be destroyed pursuant to K.A.R. 111-3-34. (Authorized by and implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-2-25-13, Dec. 12, 2012.)

111-7-260. Certification of drawing. (a) The "25 Days of Keno Drawing" shall be personally observed by a member of the Kansas lottery security department and a member of the Kansas lottery marketing or sales department or other person or persons designated by the executive director of the lottery.

(b) Upon completion of the drawing, the security official and the event manager shall issue a report to the executive director, certifying that the name of each prize winner is correct, and that to the best of their knowledge the procedures required by these rules were followed in selecting the prize winners. SENATE BILL No. 28

AN ACT authorizing the division of emergency management within the adjutant general's department to accept certain real property.

Be it enacted by the Legislature of the State of Kansas:

Section 1. (a) The division of emergency management within the adjutant general's department is hereby authorized to accept and hold, on behalf of the state of Kansas, the real property described in subsection (b) from any federal government department or agency of the United States.

(b) A tract of land being a part of the Southeast Quarter of Section 22 and the Southwest Quarter of Section 23, township 15 South, Range 4 West of the 6th P.M., Saline County, Kansas, more particularly described as follows:

Beginning at the Southeast corner of said Section 22 thence N 89°36'58" W along the South line of the Southeast Quarter of said Section 22, a distance of 50.00 feet; thence N 00°00'10" E Parallel to the East line of the Southeast Quarter of said Section 22, a distance of 2566.72 feet to a point 75.00 feet South of the North line of the SE Quarter of said section 22; thence S 89°33'46" E parallel to the North line of the Southeast Quarter of said Section 22, a distance of 50.00 feet to a point on the East line of the Southeast Quarter of said Section 22; thence S 89°24'08" E parallel to the North line of the Southwest Quarter of said Section 23, a distance

of 2299.88 feet; thence S 00°10'22" W parallel to the East line of the Southwest Quarter of said Section 23, a distance of 580.02 feet; thence S 89°24'08" E parallel to the North line of the Southwest Quarter of said Section 23, a distance of 340.01 feet to the East line of the Southwest Quarter of said Section 23, thence S 00°10'22" W along the East line of the Southwest Quarter of said Section 23, a distance of 1983.14 feet to the Southeast corner of the Southwest Quarter of said Section 23, thence N 89°28'38" W along the South line of the Southwest Quarter of said Section 23, a distance of 2632.25 feet to the Southeast corner of said Section 22 and the POINT OF BEGINNING.

AN ACT concerning hunting, relating to deer permits; amending K.S.A. 2012 Supp. 32-971 and repealing the existing section.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 2012 Supp. 32-971 is hereby amended to read as follows: 32-971. (a) ~~The commission~~ department may authorize youth hunt of a lifetime *and wounded warrior* deer permits to take deer. ~~Such Youth hunt of a lifetime~~ permits shall be made available only to nonprofit organizations based or operating in Kansas that actively promote hunting for youth under the age of 21 who are handicapped or experiencing life threatening illnesses. *Wounded warrior deer permits shall be made available only to disabled veterans who sustained injuries in combat and have a service-connected disability of not less than 30%.*

(b) The issuance of youth hunt of a lifetime *and wounded warrior* deer permits shall be subject to the following limitations:

(1) A total of not more than 10 youth hunt of a lifetime permits *and not more than 10 wounded warrior permits* shall be available in ~~one~~ each calendar year;

(2) youth hunt of a lifetime permits *and wounded warrior permits* shall not be included in nor reduce any limited quota permit allotments set by other rules and regulations of the secretary.

~~(c) Application requests by qualified organizations shall be submitted to any member of the commission and shall be provided to the commission as a whole.~~

~~(d)~~(c) The ~~commission~~ department shall conduct a random drawing from the pool of eligible qualified organizations to award youth hunt of a lifetime *or eligible individuals to award wounded warrior permits*, ~~subject to the approval of the secretary if demand exceeds the allocation of permits, as determined by the department.~~

~~(e)~~(d) Organizations awarded youth hunt of a lifetime *permits and individuals awarded wounded warrior permits* shall pay to the department the price established by rules and regulations for the highest value for the type of permit awarded.

~~(f)~~(e) Youth hunt of a lifetime *and wounded warrior* permits shall only be issued in the name of the final recipient. Once a youth hunt of a lifetime *or wounded warrior* permit is issued in the name of the final recipient, it shall not be transferred to any other individual.

~~(g)~~(f) Youth hunt of a lifetime *and wounded warrior* permits shall be subject to the restrictions of the season, sex, equipment type or hunt units as issued on the permit by the department.

~~(h)~~(g) Organizations awarded youth hunt of a lifetime permits shall provide the department with a final report on the use of the permit by the final recipient not later than 30 days following the close of the season for which the permit is valid.

~~(i)~~(h) The secretary may adopt, in accordance with K.S.A. 32-805, and amendments thereto, such rules and regulations as necessary to implement the provisions of this section.

Sec. 2. K.S.A. 2012 Supp. 32-971 is hereby repealed.

SENATE BILL No. 216

AN ACT concerning public building commissions; relating to municipal universities; amending K.S.A. 12-1758 and 12-1764 and repealing the existing sections.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 12-1758 is hereby amended to read as follows: 12-1758. (a) Any city or county, by appropriate ordinance or resolution, may create a public building commission for the purposes of acquiring a site or sites for and constructing, reconstructing, equipping and furnishing a building or buildings or other facilities of a revenue producing character, including parking facilities, or for purchasing or otherwise acquiring such building or buildings or facilities. Such building or buildings or facilities shall be maintained and operated for a county courthouse, the housing and accommodation of county offices or county business or for city offices or such other purposes as are commonly carried on in connection with such facilities or in county courthouses and general city buildings, including administrative offices for school districts and housing, accommodations and parking facilities for offices of state and federal agencies.

(b) A public building commission created by a city or county may acquire land and facilities adjacent to, near, or for the use of any educational institution under the supervision and control of the state board of regents or a municipal university or may acquire by lease, land and facilities constituting a part of the campus of any such institution. Any public building commission may construct, reconstruct, equip and furnish such facilities on such land and lease such land and facilities to the official governing body of such institution. Any such lease entered into shall pledge the net revenue from such land and facilities. Any city also may pledge such funds as may be necessary from those which are provided to be paid over to the board of trustees from the annual tax levy as provided by K.S.A. 76-3a07, and amendments thereto. Any county also may pledge such funds as may be necessary from those which are provided to be paid over to such institution from a special levy authorized for such purpose under K.S.A. 19-117, and amendments thereto. The governing body of such city or county is hereby authorized to designate any surplus from such tax levy as may be necessary to guarantee the rentals under any such lease, and such city or county is hereby exempted from the provisions of K.S.A. 10-1101 to 10-1122, inclusive, and 79-2925, and amendments thereto, to the extent necessary to enable such city or county to make a covenant to effect such guarantee.

Sec. 2. K.S.A. 12-1764 is hereby amended to read as follows: 12-1764. The public building commission established under this act shall have the power to acquire the fee simple title to real property, or a leasehold interest in real property located on the campus of any state university, including campus property as defined in subsection (c) of K.S.A. 76-3a01, and amendments thereto, or any municipal university, including easements and reversionary interests in the streets, alleys and other public places and personal property required for its purposes, by purchase, gift, devise or by the exercise of the power of eminent domain of the state and title thereto shall be taken in the corporate name of the commission.

Sec. 3. K.S.A. 12-1758 and 12-1764 are hereby repealed.

Sec. 4. This act shall take effect and be in force from and after its publication in the Kansas register.

HOUSE BILL No. 2041

AN ACT concerning criminal history record information; definition; relating to municipal court reporting; district court reporting; amending K.S.A. 2012 Supp. 12-4106, 22-4701 and 22-4704 and repealing the existing sections.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 2012 Supp. 12-4106 is hereby amended to read as follows: 12-4106. (a) The municipal judge shall have the power to administer the oaths and enforce all orders, rules and judgments made by such municipal judge, and may fine or imprison for contempt in the same manner and to the same extent as a judge of the district court.

(b) The municipal judge shall have the power to hear and determine all cases properly brought before such municipal judge to: Grant continuances; sentence those found guilty to a fine or confinement in jail,

or both; commit accused persons to jail in default of bond; determine applications for parole; release on probation; grant time in which a fine may be paid; correct a sentence; suspend imposition of a sentence; set aside a judgment; permit time for post trial motions; and discharge accused persons.

(c) The municipal judge shall maintain a docket in which every cause commenced before such municipal judge shall be entered. Such docket shall contain the names of the accused persons and complainant, the nature or character of the offense, the date of trial, the names of all witnesses sworn and examined, the finding of the court, the judgment and sentence, the date of payment, the date of issuing commitment, if any, and every other fact necessary to show the full proceedings in each case.

(d) The municipal judge shall promptly make such reports and furnish the information requested by any departmental justice or the judicial administrator, in the manner and form prescribed by the supreme court.

(e) The municipal judge shall ensure that information concerning dispositions of city ordinance violations that result in convictions comparable to convictions for ~~class A and B misdemeanors~~ offenses under Kansas criminal statutes is forwarded to the Kansas bureau of investigation central repository. This information shall be transmitted, on a form or in a format approved by the attorney general, within 30 days of final disposition.

(f) In all cases alleging a violation of a city ordinance prohibiting the acts prohibited by K.S.A. 8-2,144 ~~or~~, 8-1567 or 32-1131 or K.S.A. 2012 Supp. 8-1025, and amendments thereto, the municipal court judge shall ensure that the municipal court reports the filing and disposition of such case to the Kansas bureau of investigation central repository, and, on and after July 1, ~~2013~~ 2014, reports the filing and disposition of such case electronically to the Kansas bureau of investigation central repository.

(g) In all cases in which a fine is imposed for a violation of a city ordinance prohibiting the acts prohibited by K.S.A. 8-2,144 or 8-1567 or K.S.A. 2012 Supp. 8-1025, and amendments thereto, the municipal court judge shall ensure that the municipal court remits the appropriate amount of such fine to the state treasurer as provided in K.S.A. 2012 Supp. 12-4120, and amendments thereto.

Sec. 2. K.S.A. 2012 Supp. 22-4701 is hereby amended to read as follows: 22-4701. As used in this act, unless the context clearly requires otherwise:

(a) "Central repository" means the criminal justice information system central repository created by this act and the juvenile offender information system created pursuant to K.S.A. 2012 Supp. 38-2326, and amendments thereto.

(b) "Criminal history record information" means all data initiated or collected by a criminal justice agency on a person pertaining to a reportable event, and any supporting documentation. Criminal history record information does not include:

(1) Data contained in intelligence or investigatory files or police work-product records used solely for police investigation purposes;

(2) wanted posters, police blotter entries, court records of public judicial proceedings or published court opinions;

(3) data pertaining to violations of the traffic laws of the state or any other traffic law or ordinance, other than vehicular homicide; ~~or~~

(4) presentence investigation and other reports prepared for use by a court in the exercise of criminal jurisdiction or by the governor in the exercise of the power of pardon, reprieve or commutation; ~~or~~

(5) information regarding the release of defendants from confinement by the department of corrections or a jail.

(c) "Criminal justice agency" means any government agency or subdivision of any such agency which is authorized by law to exercise the power of arrest, detention, prosecution, adjudication, correctional supervision, rehabilitation or release of persons suspected, charged or convicted of a crime and which allocates a substantial portion of its annual budget to any of these functions. The term includes, but is not limited to, the following agencies, when exercising jurisdiction over criminal matters or criminal history record information:

(1) State, county, municipal and railroad police departments, sheriffs' offices and countywide law enforcement agencies, correctional facilities, jails and detention centers;

(2) the offices of the attorney general, county or district attorneys and any other office in which are located persons authorized by law to prosecute persons accused of criminal offenses;

(3) the district courts, the court of appeals, the supreme court, the municipal courts and the offices of the clerks of these courts;

(4) the Kansas sentencing commission;

(5) the prisoner review board; and

(6) the juvenile justice authority.

(d) "Criminal justice information system" means the equipment (including computer hardware and software), facilities, procedures, agree-

ments and personnel used in the collection, processing, preservation and dissemination of criminal history record information.

(e) "Director" means the director of the Kansas bureau of investigation.

(f) "Disseminate" means to transmit criminal history record information in any oral or written form. The term does not include:

(1) The transmittal of such information within a criminal justice agency;

(2) the reporting of such information as required by this act; or

(3) the transmittal of such information between criminal justice agencies in order to permit the initiation of subsequent criminal justice proceedings against a person relating to the same offense.

(g) "Reportable event" means an event specified or provided for in K.S.A. 22-4705, and amendments thereto.

Sec. 3. K.S.A. 2012 Supp. 22-4704 is hereby amended to read as follows: 22-4704. (a) In accordance with the provisions of K.S.A. 77-415 et seq., and amendments thereto, the director shall adopt appropriate rules and regulations for agencies in the executive branch of government and for criminal justice agencies other than those that are part of the judicial branch of government to implement the provisions of this act.

(b) The director shall develop procedures to permit and encourage the transfer of criminal history record information among and between courts and affected agencies in the executive branch, and especially between courts and the central repository.

(c) The rules and regulations adopted by the director shall include those: (1) Governing the collection, reporting, and dissemination of criminal history record information by criminal justice agencies;

(2) necessary to insure the security of all criminal history record information reported, collected and disseminated by and through the criminal justice information system;

(3) necessary for the coordination of all criminal justice data and information processing activities as they relate to criminal history record information;

(4) governing the dissemination of criminal history record information;

(5) governing the procedures for inspection and challenging of criminal history record information;

(6) governing the auditing of criminal justice agencies to insure that criminal history record information is accurate and complete and that it is collected, reported, and disseminated in accordance with this act;

(7) governing the development and content of agreements between the central repository and criminal justice and noncriminal justice agencies; and

(8) governing the exercise of the rights of inspection and challenge provided in this act.

(d) The rules and regulations adopted by the director shall not include any provision that allows the charging of a fee for information requests for the purpose of participating in a block parent program, including, but not limited to, the McGruff house program.

(e) Rules and regulations adopted by the director may not be inconsistent with the provisions of this act.

(f) (1) On or before July 1, ~~2012~~ 2013, the director shall adopt rules and regulations requiring district courts to report the filing and disposition of all cases alleging a violation of K.S.A. 8-1567 or K.S.A. 2012 Supp. 8-1025, and amendments thereto, to the central repository.

(2) On or before July 1, ~~2013~~ 2014, the director shall adopt rules and regulations requiring district courts to electronically report all case filings and dispositions for violations of K.S.A. 8-1567 or K.S.A. 2012 Supp. 8-1025, and amendments thereto, to the central repository.

Sec. 4. K.S.A. 2012 Supp. 12-4106, 22-4701 and 22-4704 are hereby repealed.

Sec. 5. This act shall take effect and be in force from and after its publication in the Kansas register.
