Summary: Pursuant to section 102(2)(c) of the National Environmental Policy Act of 1969; the Council on Environmental Quality Regulations (40 Code of Federal Regulations [CFR] Part 1500); and the Natural Resources Conservation Service Regulations (7 CFR Part 650); the Natural Resources Conservation Service (NRCS), U.S. Department of Agriculture, gives notice that an environmental impact statement is not being prepared for North Sector Upper Walnut Watershed, Butler County, Kansas.

The project's purpose is to meet current state and NRCS hazard class dam criteria so the structures will continue to provide flood damage reduction benefits. The planned works of improvement include the rehabilitation of North Sector Upper Walnut Watershed Floodwater Retarding Dam 6 & 21, located in Butler County, Kansas.

Notice to Private Activity Bond Applicants

Applications for allocation of 2018 Private Activity Bond (PAB) authority are now being accepted for qualified uses, as defined by the Internal Revenue Code of 1986, and amendments thereto.

The State of Kansas is projected to receive \$311,375,000 of federal authority for the issuance of PABs in calendar year 2018. Historically, the primary uses of this federal authority have included "qualified small issue bonds" used for construction and equipping of manufacturing facilities and beginning farmer programs; "exempt facility bonds" used by for-profit entities providing a public benefit, i.e., certain waste treatment facilities, qualified residential rental facilities, etc.; and "qualified mortgage bonds" issued to benefit first-time homebuyers. Allocations awarded by the secretary of Commerce are subject to the provisions of K.S.A. 74-5060 et seq. and the limitations of state volume cap.

In 2018, fees associated with PAB application are:

(1) **Application Fee**—A \$750 nonrefundable fee must accompany all applications before the request can be processed; and

(2) **Issuance Fee**—An issuance fee is assessed on the amount of allocation actually issued, excluding Qualified Mortgage Bonds, and shall be due and payable at bond closing. Issuance fees shall be determined as follows:

Allocation Used/Issued	Fee
Up to \$5,000,000	10 basis points (.10%)
\$5,000,001 and above	20 basis points (.20%)

"Qualified Mortgage Bond" programs will be assessed a fee equal to .5% of the PAB allocation used upon issuance of each mortgage loan assisted through the program.

Issuance fees shall be remitted within 30 days of bond closing. Checks for both the application and issuance fees for non-housing issues shall be payable to the "Kansas Department of Commerce Bond Fee Fund." Checks for the issuance fees for residential rental housing activities shall be payable to the "Kansas Housing Resources Corporation" or "KHRC."

Notice Concerning Proposed Kansas Air Quality Class I Operating Permit

Notice is hereby given that the Kansas Department of Health and Environment (KDHE) is soliciting comments regarding a proposed air quality operating permit. Kansas Paving has applied for a Class I operating permit in accordance with the provisions of K.A.R. 28-19-510 et al. The purpose of a Class I permit is to identify the sources and types of regulated air pollutants emitted from the facility; the emission limitations, standards, and requirements applicable to each source; and the monitoring, record keeping, and reporting requirements applicable to each source as of the effective date of permit issuance.

Kansas Paving, PO Box 4204, Wichita, KS 67219, owns and operates an air curtain incinerator located at 4800 N. Broadway, Wichita, Kansas.

Please direct written comments or questions regarding the proposed permit to Cathy Richardson, KDHE, BOA, 1000 SW Jackson, Suite 310, Topeka, KS 66612-1366. In order to be considered in formulating a final permit decision, written comments must be received no later than noon Monday, April 16, 2018.

A person may request a public hearing be held on the proposed permit. The request for a public hearing shall be in writing and set forth the basis for the request. The written request must be submitted to Cathy Richardson, KDHE, BOA, 1000 SW Jackson, Suite 310, Topeka, KS 66612-1366, no later than noon Monday, April 16, 2018 in order for the secretary of Health and Environment to consider the request.

The U.S. Environmental Protection Agency has a 45-day review period, which will start concurrently with the public comment period, within which to object to the proposed permit. If the EPA has not objected in writing to the issuance of the permit within the 45-day review period, any person may petition the administrator of the EPA to review the permit. The 60-day public petition period will directly follow the EPA's 45-day review period. Interested parties may contact KDHE to determine if the EPA's 45-day review period has been waived.

Any such petition shall be based only on objections to the permit that were raised with reasonable specificity during the public comment period provided for in this notice, unless the petitioner demonstrates that it was impracticable to raise such objections within such period, or unless the grounds for such objection arose after such period. Executive Order 18-10 Governor's Education Council

WHEREAS, Kansas is committed to continually improving and advancing educational opportunities for all its residents, as well as finding better and more improved ways of meeting the needs of individuals, families, and communities;

WHEREAS, providing quality education is one of the best ways to promote the success and well-being of individual citizens, as well as growing the economy and cultivating a highly trained and skilled workforce;

WHEREAS, students get the most out of their education when they gain the necessary skills and knowledge to quickly enter and thrive in various career fields;

WHEREAS, an integrated approach to career preparation, beginning with early learning and continuing through post-secondary education, would benefit individuals, companies, industries, and the state as a whole;

WHEREAS, bringing together educators, leaders of the business community, and state policymakers will help to promote education which can more effectively prepare students throughout their entire educational experience to successfully enter and remain in the workforce;

NOW, THEREFORE, pursuant to the authority vested in me as Governor of the State of Kansas, I hereby establish the Governor's Education Council ("Council"):

1. The Governor shall appoint one representative from each of the following agencies and organizations to serve as members of the Council:
 - a. Governor's Office
 - b. Kansas Children's Cabinet
 - c. Kansas Department for Children and Families
 - d. Kansas Department of Labor
 - e. Kansas Department of Commerce
 - f. Kansas Association of School Boards
 - g. United School Administrators of Kansas
 - h. Kansas Association of Community College Trustees
 - i. Kansas Independent Colleges Association
 - j. Kansas Association of Independent and Religious Schools
 - k. Kansas Association of Technical Colleges
 - l. Kansas Association of Workforce Boards
 - m. Kansas Parent Teacher Association
 - n. Kansas National Education Association
 - o. Kansas Association of American Educators
 - p. United Teachers of Wichita
2. The President & CEO of the Kansas Board of Regents (KBOR) and the Commissioner of Education of the Kansas State Department of Education (KSDE) shall serve as co-chairs and ex-officio members of the Council.
3. KBOR and KSDE shall each appoint two (2) additional representatives to the Council.
4. The Speaker of the House, President of the Senate, House Majority Leader, Senate Majority Leader, House Minority Leader, and Senate Minority Leader may each appoint one (1) member to serve on the Council.
5. The Governor shall appoint 3-5 members from the business community to serve on the Council.
6. Additional members with relevant experience or qualifications may be invited to join the Council by the Governor or Chairs of the Council.
7. Members shall receive no compensation and shall serve voluntarily. Officers or employees of state agencies who are appointed to the Council as part of their duties shall be authorized to participate on the Council and may claim subsistence, allowance, mileage or associated expenses from their respective agency budgets as permitted by law.
8. The Council shall be subject to the Kansas Open Records Act and the Kansas Open Meetings Act.
9. Plans, reports, or recommendations of any nature adopted by the Council shall be considered advice to the Governor and Legislature, and shall not be

construed as official policies, positions, or interpretations of laws, rules, or regulations by any department or agency of state government, nor shall any such department or agency be bound in any manner to consider such advice when conducting their advisory and regulatory affairs.

10. The Council shall:
 - a. Establish a vision statement and guiding principles that reflect the collaborative goals of the Council to build on successes and improve the education system in Kansas.
 - b. Explore methods for integrating college and workforce preparedness into K-12 learning programs that align with and compliment the work of the Kansans Can initiative of the KSDE.
 - c. Consider the application of public-private partnerships in developing industry specific learning goals.
 - d. Inventory and assess existing workforce development initiatives within the state.
 - e. Discuss a system for measuring effectiveness and accountability of educational opportunities beyond the common and known metrics.
 - f. Inform and advise the Governor on educational initiatives and policies to improve the overall success of education and workforce development in Kansas.
11. The Council shall be staffed by KSDE and KBOR along with the Executive Director of Business and Education Innovation from the Kansas Department of Commerce.
12. The Council shall meet quarterly or as often as is determined necessary by the co-chairs of the Council.
13. The Council shall submit regular reports to the Governor with an annual report submitted in December of each year during the term of the Executive Order.

This document shall be filed with the Secretary of State as Executive Order No. 18-10 and shall become effective immediately. The Council shall continue until such time as the Governor deems it no longer necessary and rescinds it by issuance of an executive order.

SENATE BILL No. 256

AN ACT designating a portion of United States highway 50 as the SGT Gregg Steimel and PFC Richard Conrardy memorial highway; amending K.S.A. 68-1027 and repealing the existing section.

Be it enacted by the Legislature of the State of Kansas:

New Section 1. The portion of United States highway 50 from the east city limits of Dodge City to 118 road in Ford county is hereby designated as the SGT Gregg Steimel and PFC Richard Conrardy memorial highway. Upon compliance with K.S.A. 2017 Supp. 68-10,114, and amendments thereto, the secretary of transportation shall place highway signs along the right-of-way at proper intervals to indicate that the highway is the SGT Gregg Steimel and PFC Richard Conrardy memorial highway.

Sec. 2. K.S.A. 68-1027 is hereby amended to read as follows: 68-1027. That portion of United States highway 50 from Emporia to Dodge City 118 road in Ford county is hereby designated as the "turkey wheat trail highway," and the secretary of transportation is hereby directed to erect suitable signs and markers along such highway showing such designation.

Sec. 3. K.S.A. 68-1027 is hereby repealed.

Sec. 4. This act shall take effect and be in force from and after its publication in the Kansas register.

Economic Impact:

The fiscal impact on the state universities and the impacted individuals who qualify for resident tuition rates will depend upon the number of new non-resident state university students who will be members of the ROTC and sign contracts obligating them to serve in the military. Any additionally paid tuition and fees would be a gain to the institutions from these students. The fiscal impact would also depend on the number of ROTC students already attending the state university who are currently paying the non-resident rate, but under this clarifying amendment would begin paying the lower resident rate, resulting in lower tuition revenues. The Board of Regents is unable to identify or predict the net tuition revenue change to the institutions. There will be no identifiable economic impact on the Board of Regents or other agencies as a result of this regulation.

(d) For this game, a play symbol shall appear in each of 20 play spots within the "YOUR LETTERS" play area, in each of five play spots within the "BONUS WORD" play area, and a variable number of times within the crossword puzzle grids.

(e) The ticket numbers in each book of tickets in this game shall start with 000 and end with 029.

(f) The price of instant tickets sold by a retailer for this game shall be \$10.00 each.

(g) Each ticket in this game may win up to three times.

(h) Approximately 600,030 tickets shall be ordered initially for this instant game. Additional ticket orders shall have the same prize structure, the same number of prizes per prize pool of 200,010 tickets, and the same odds as were contained in the initial ticket order.

Article 5. — MULTI-STATE ONLINE GAMES AND DRAWINGS

111-5-80. Definitions. The following definitions shall apply to the "2by2" game:

(a) "Cash prize" means all set prizes other than free ticket prizes.

(b) "Computer pick" or "quick pick" means the random selection of two-digit numbers by the computer system, which appear on a ticket and are played by a player in the game.

(c) "Drawing" means the formal process of selecting winning numbers which determine the number of winners for each prize level of the game.

(d) "Free ticket" means a free quick pick single-board "2by2" ticket for the next upcoming "2by2" drawing.

(e) "Game board" or "boards" means that area of the play slip which contains two sets of numbered squares to be marked by the player, each set containing 26 squares, number one through 26, with the first set of numbers designated as the "red" numbers, and the second set of numbers designated as the "white" numbers.

(f) "Game ticket" or "ticket" means a computer gener-

ated ticket issued by a terminal to a person as a receipt for the combination a person has selected.

(g) "MUSL" means the Multi-State Lottery Association, a government-benefit association wholly owned and operated by the party lotteries.

(h) "MUSL Board" means the governing body of the MUSL which is comprised of the chief executive officer of each party lottery.

(i) "Online lottery game" means a lottery game connected by telephone lines or other similar communication methodology, owned or controlled by the lottery, to a central computer in which each player selects numbers out of a larger predetermined set or sets of numbers.

(j) "MUSL Finance and Audit Committee" shall mean the committee of that name established by the MUSL Board.

(k) "Participating Lottery," "Party Lottery" or "Member Lottery" means a state lottery or lottery of a political subdivision or entity that has joined the MUSL and, in the context of "2by2" product group rules, has joined in selling the "2by2" game.

(l) "Product group" means the group of lotteries which has joined together to offer a product pursuant to the terms of the multi-state lottery agreement and the group's own rules.

(m) "Play" or "bet" means the four numbers, the first two from a field of 26 "red" numbers, and the second two from a second field of 26 "white" numbers that appear on a ticket as a single lettered selection and are to be played by a player in the game. Each play is played separately in determining matches to winning numbers and prize amounts.

(n) "Play slip" or "bet slip" means a card used in marking a player's game plays and containing one or more boards.

(o) "Retailer" or "agent" means a person or entity authorized by the Kansas lottery to sell lottery tickets.

(p) "Set prize" means all prizes except the grand prize that are advertised to be paid by a single cash payment, and except in rare instances outlined in these rules, will be equal to the prize amount established by the product group for the prize level.

(q) "Terminal" means a device authorized by a party lottery to function in an online, interactive mode with the lottery's computer gaming system for the purpose of issuing lottery tickets and entering, receiving, and processing lottery transactions, including purchases, validating tickets, and transmitting reports.

(r) "Validation" or "validate" means the process of determining whether a ticket presented for a prize is a winning ticket.

(s) "Winning numbers" means the four numbers, the first two from a field of 26 "red" numbers and the second two from a second field of 26 "white" numbers, randomly selected at each drawing which shall be used to determine winning plays contained on a game ticket. (Authorized by and implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-7-15-02, May 15, 2001; amended, T-111-2-27-18, Dec. 6, 2017.)

111-5-81. Game description; retail sale of tickets.

(a) The "2by2" game is a two out of 26 "red" numbers plus two out of 26 "white" numbers online lottery game drawn once a day, seven days a week as part of the 2by2

drawing event, which pays each grand prize and all other prizes on a single payment basis.

(b) 2by2 winning numbers applicable to determine 2by2 prizes will be determined daily as part of the 2by2 drawing event. During the drawing event, two (2) different numbers shall be drawn from the "red" set of twenty-six (26) numbers, and two (2) different numbers shall be drawn from the "white" set of twenty-six (26) numbers, which shall constitute the winning numbers. The red numbers selected may be the same as the white numbers selected.

(c) To play "2by2," a player shall select (or computer pick) two different "red" numbers between one through 26 inclusive, and two additional "white" numbers between one through 26 inclusive for input into a terminal. The numbers for the second (white) set of two numbers may be the same as the numbers for the first (red) set of two numbers selected by the player.

(d) A "2by2" game ticket shall sell for one dollar.

(e) Tickets shall not be sold to any person under the age of 18 years. Each retailer may require a person purchasing tickets to produce proof of age.

(f) Each ticket shall be purchased from a terminal operated by a retailer. The player may select four numbers by:

(1) communicating the four numbers to the retailer;

(2) marking four numbered squares on any one game board on a play slip and submitting the play slip to the retailer; or

(3) requesting a "quick pick" from the retailer.

The retailer shall then issue a ticket from the terminal containing the selected sets of numbers, each of which constitutes a game play.

(g) A validated ticket shall be the only proof of a game play or plays. The only method of claiming a prize or prizes shall be the submission of the winning ticket to and receipt of the ticket by the lottery or its authorized agent. A play slip shall have no pecuniary or prize value and shall not be used as evidence of a ticket purchase or of numbers selected.

(h) A ticket shall not be voided or cancelled by returning the ticket to the selling retailer, including tickets that are printed in error.

(i) Ticket sales will end at approximately 8:59 p.m. central time daily and will resume at approximately 9:05 p.m.

(j) Drawings will be conducted daily at approximately 9:30 p.m. central time (CT), after the game is closed at approximately 8:59 p.m. central time (CT) and the external auditor has verified that the game is closed, under conditions and procedures promulgated by the executive director of the lottery.

(k) A multi-draw ticket with one or more plays for only seven consecutive draws or only multiples of seven consecutive draws shall qualify for double prizes won on the included Tuesday draw, as limited by K.A.R. 111-5-83. Plays purchased for any number of draws other than in multiples of seven draws shall not qualify for double prizes won on any Tuesday. Proceeds from advance sales may be held by the Kansas Lottery until the draw date for which the play applies.

(l) Each player shall be responsible for verifying the accuracy of the game play or plays and other data printed on

(continued)

the ticket. The placing of plays is done at the player's own risk through the online retailer who is deemed to be acting on behalf of the player in entering the play or plays.

(m) These amendments shall take effect on or after March 1, 2018. (Authorized by K.S.A. 2017 Supp. 74-8710; implementing K.S.A. 2017 Supp. 74-8710 and 74-8718; effective, T-111-7-15-02, May 15, 2002; amended, T-111-9-18-2003, Sept. 10, 2003; amended, T-111-9-23-08, Feb. 13, 2008; amended, T-111-2-27-18, Dec. 6, 2017.)

111-5-82. Prize pool; reserve account. (a) Thirty-nine and one-half percent (39.5%) of each draw's sales shall be collected and placed in prize pool and prize reserve accounts for the payment of prizes. The contribution rate does not include a selling lottery's prize expense for "free plays." The product group shall set the contribution rates to one or more prize pool and prize reserve accounts established by this rule.

(b) The prize reserve account (PRA) is used to guarantee the payment of valid, but unanticipated, grand prize claims that may result from a system error or other reason; to fund deficiencies in prize payments (subject to the limitations of these rules); and for other purposes as established in these rules.

(c) The following prize pool accounts for the 2by2 game are hereby established:

(1) The grand prize pool (GPP), which is used to fund grand prizes; and

(2) The set prize pool (SPP), which is used to fund the set prizes. The SPP shall hold the temporary balances that may result from having fewer than expected winners in the set prize (low-tier prize) categories excluding "free play" prizes. The source of the SPP is the party lottery's weekly prize contributions less actual set prize liability.

(d) The above prize reserve and prize pool accounts may have maximum balance amounts or balance limiter triggers that are set by the product group.

The maximum balance amounts and balance limiter triggers are subject to review by the MUSL finance and audit committee. The MUSL finance and audit committee shall have two weeks to state objections, if any, to the approved maximum balance amounts or balance limiter triggers. Approved maximum balance amounts or balance limiter triggers shall become effective no sooner than two weeks after notice is given to the MUSL finance and audit committee and no objection is stated or sooner if the committee affirmatively approves the maximum balance amounts or balance limiter triggers. The product group may appeal the committee's objections to the full MUSL board. Product group approved changes in the maximum balance amounts or balance limiter triggers set by the product group shall be effective only after the next grand prize win.

(e) Contributions rates to prize pools and prize reserve account(s) are as follows:

(1) Twenty-two percent (22%) of a party lottery's sales shall be placed in the GPP;

(2) Seventeen and one-half percent (17.5%) of a party lottery's sales shall be placed in the SPP;

(3) An amount up to one and thirty-two thousand two hundred and thirteen one-hundred thousandths percent (1.32213%) of a party lottery's sales shall be placed in the PRA until it reaches its designated maximum balance.

(f) The product group may determine to expend all or a portion of these funds in these the 2by2 prize pools and the prize reserve accounts (except the GPP) for the purpose of indemnifying the party lotteries in the payment of prizes to be made by the selling lotteries; and for the payment of prizes or special prizes in the game, limited to prize pool and prize reserve contributions from lotteries participating in the special prize promotion, subject to the approval of the MUSL's finance and audit committee or that committee's failure to object after given two weeks' notice of the planned action, which actions may be appealed to the full MUSL board by the product group. The prize reserve shares of a party lottery may be adjusted with refunds to the party lottery from the prize reserve account as may be needed to maintain the approved maximum balance and sales percentage shares of the party lotteries. A party lottery may contribute to its sales percentage share of prize reserve accounts over time, but in the event of a draw down from a prize reserve account, a party lottery is responsible for its full sales percentage share of the prize reserve account, whether or not it has been paid in full. Any amount remaining in the 2by2 prize pools or prize reserve accounts when the product group declares at the end of this game shall be returned to the lotteries participating in the prize pool and reserve accounts after the end of all claim periods of all selling lotteries, carried forward to a replacement game or expended in a manner at the election of the individual members of the product group. (Authorized by K.S.A. 2017 Supp. 74-8710; implementing K.S.A. 2017 Supp. 74-8710 and K.S.A. 74-8731; effective, T-111-7-15-02, May 15, 2002; amended, T-111-8-20-02, Aug. 14, 2002; amended, T-111-4-12-12, March 14, 2012; amended, T-111-2-27-18, Dec. 6, 2017.)

111-5-83. Expected prize payout. (a) Each grand prize shall be a set amount of \$22,000, unless more than 10 game play areas contain four (4) winning grand prize numbers in any single game drawing, in which case the total prize money to be paid on greater than ten (10) eligible plays (taking into account eligible double prizes) shall be divided equally per prize type (standard prize and double Tuesday prize winners each receiving their proportionate share) on a pari-mutuel basis based on the number of winning game play areas.

The GPP shall be carried forward to subsequent draws if all or a portion of it is not needed to pay the set prizes awarded in the current draw. The SPP shall be carried forward to subsequent draws if all or a portion of it is not needed to pay the prizes awarded in the current draw. If the total of the set prizes awarded in a drawing exceeds the percentage of the set prize pool allocated to the prizes, then the amount needed to fund the set prizes awarded shall be drawn from the following sources in the following order:

(1) The amount available in the SPP, if any; and

(2) An amount from the prize reserve account, if available.

If, after these sources are depleted, there are not sufficient funds to pay the set prizes, then the highest set prize shall become a pari-mutuel prize. If the amount of the highest set prize, when paid on a pari-mutuel basis, drops to or below the next highest set prize and there are still not sufficient funds to pay the remaining set prizes

awarded, then the next highest set prize shall become a pari-mutuel prize. This procedure shall continue down through all set prize levels, if necessary, until all set prize levels become pari-mutuel prize levels. In that instance, the money available from the funding sources listed in this rule shall be divided among the winning plays in proportion to their respective prize percentages, with the exception that a "free play" prize shall always at a minimum be a "free play" prize. A "free play" prize shall constitute a free quick pick single play 2by2 play for the next upcoming draw.

(b) All prizes awarded shall be paid as single payment prizes or free play prizes. All prize payouts are made with the following expected prize payout percentages, although the prize payout percentages per draw may vary:

(b) All set prizes, (whether described as "cash" payment prizes or otherwise), shall be paid in a single payment or free plays through the party lottery which sold the winning play(s) and at the discretion of the selling lottery that sold the winning play(s), single payment

Entries into the first drawing will close at noon on February 28, 2018, and the winners will be announced by noon on March 9, 2018. Entries into the second drawing will close at noon on March 31, 2018, and the winners will be announced by noon on April 6, 2018. Entries into the third drawing will close at noon on May 1, 2018, and the winners will be announced at noon on May 9, 2018.

(b) The specific ticket eligible for entry into this drawing shall be winning or non-winning Kansas Lottery Lotto America tickets. The entry tickets may or may not include Lotto America tickets with the All Star Bonus play option.

(c) A player shall enter the drawing through the Kansas lottery PlayOn program available at www.kslottery.com. The player shall follow the hyperlink specifically designated for the purpose of accessing the “Kansas Lottery Lotto America Loves the Heart of America Draw-

ing.” The player may enter the required data from the entry ticket manually for entry into the drawing. If the player does not enter the ticket data manually, the player may scan, if available, the ticket to enter data to be used for entry into the drawing using a mobile device and a downloaded Kansas Lottery PlayOn app. After the ticket data is successfully entered either manually or scanned using an app, the player will receive one entry into the second-chance drawing.

Article 301.—SPECIFIC LOTTERY FACILITY GAMES AT LOTTERY GAMING FACILITIES

111-301-39. Name of the game; rules and regulations. The Kansas lottery shall conduct a lottery facility game at the Boot Hill Casino & Resort in Dodge City, Kansas, entitled “21 + 3” or “TriLux.”

The rules and regulations for the game of “21 + 3” and “TriLux” are contained in K.A.R. 111-301-39 through 111-301-44, and applicable generic rules are contained in K.A.R. 111-201-1 *et seq.* (Authorized by K.S.A. 2017 Supp. 74-8710 and 74-8748; implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-5-16-12, April 11, 2012; amended, T-111-2-27-18, Dec. 6, 2017.)

Article 302.—SPECIFIC LOTTERY FACILITY GAMES AT LOTTERY GAMING FACILITIES; CRAPS

111-302-4. Characteristics of the game. (a) Craps is played at a large rectangular shaped table with rounded corners.

(b) A cloth covering the table has areas for all possible bets that can be made.

(c) Two dice as described in K.A.R. 111-302-2 are required to play the game.

(d) The table layout is divided in half and both halves are imprinted the same.

(e) For each half of the table open for play there is a dealer (also known as a “base dealer”) and for the entire table one employee that is called the “stickperson” that is positioned at the center across from the base dealer or dealers.

(f) A box person floor supervisor or higher ranking casino official sits in between the location for the two base dealers.

(g) The players are able to play on either half of the table along the far side away from the stickperson and the base dealers. If only half of the table is open for play, the players are able to play on only the open half of the table along the far side away from the stickperson and the base dealer. (Authorized by K.S.A. 2017 Supp. 74-8710 and 74-8748; implementing K.S.A. 2017 Supp. 74-8710; effective; T-111-12-24-09, Dec. 3, 2009; amended, T-111-12-7-10, Oct. 6, 2010; amended, T-111-2-27-18, Dec. 6, 2017.)

111-302-5. Wagers. (a) The following shall constitute the permissible wagers at the games of craps:

(1) A “pass bet” is a wager placed on the pass line of the layout immediately prior to the come out roll. A pass bet shall win if, on the come out roll:

(AA) A total of 7 or 11 is thrown; or

(BB) A total of 4, 5, 6, 8, 9, or 10 is thrown and that total is again thrown before a 7 total appears.

A pass bet shall lose if, on the come out roll:

(CC) A total of 2, 3, or 12 is thrown; or

(DD) A total of 4, 5, 6, 8, 9, or 10 is thrown and a total of 7 subsequently appears before that total is again thrown.

(2) A “don’t pass bet” is a wager placed on the don’t pass line of the layout immediately prior to the come out roll. A don’t pass bet shall win if, on the come out roll:

(AA) A total of 2 or 3 is thrown; or

(BB) A total of 4, 5, 6, 8, 9, or 10 is thrown and a total of 7 subsequently appears before that total is again thrown.

A don’t pass bet shall lose if, on the come out roll:

(CC) A total of 7 or 11 is thrown; or

(DD) A total of 4, 5, 6, 8, 9, or 10 is thrown and that total is again thrown before a total of 7 appears.

A don’t pass bet shall be void if, on the come out roll, a total of 12 is thrown.

(3) A “come bet” is a wager placed on the come line of the layout at any time after the come out roll. A come bet shall win if, on the roll immediately following placement of such bet:

(AA) A total of 7 or 11 is thrown; or

(BB) A total of 4, 5, 6, 8, 9, or 10 is thrown and that total is again thrown before a total of 7 appears.

A come bet shall lose if, on the roll immediately following placement of such bet:

(continued)

(CC) A total of 2, 3, or 12 is thrown; or

(DD) A total of 4, 5, 6, 8, 9, or 10 is thrown and a total of 7 subsequently appears before that total is again thrown.

(4) A "don't come bet" is a wager placed on the don't come area of the layout at any time after the come out roll. A don't come bet shall win if, on the roll immediately following placement of such bet:

(AA) A total of 2 or 3 is thrown; or

(BB) A total of 4, 5, 6, 8, 9, or 10 is thrown and a total of 7 subsequently appears before that total is again thrown.

A don't come bet shall lose if, on the roll immediately following placement of such bet:

(CC) A total of 7 or 11 is thrown; or

(DD) A total of 4, 5, 6, 8, 9, or 10 is thrown and that total is again thrown before a total of 7 appears.

A don't come bet shall be void if, on the roll immediately following placement of such bet, a total of 12 is thrown.

(5) "Place bet to win" is a wager that may be made at any time on any of the numbers 4, 5, 6, 8, 9, or 10, which shall win if the number on which the wager was placed is thrown before a total of 7 and shall lose if a total of 7 is thrown before such number. All place to win bets, hardway bets and come odds bets shall be inactive on any come out roll unless called "on" by the player and confirmed by the dealer through placement of an "on" marker button on top of such player's wager.

(6) "Four the hardway" is a wager that may be made at any time, which shall win if a total of 4 is thrown the hardway (that is, with 2 spots appearing on each die) before a total of 4 is thrown in any other way and before a total of 7 is thrown.

(7) "Six the hardway" is a wager that may be made at any time, which shall win if a total of 6 is thrown the hardway (that is, with 3 spots appearing on each die) before a total of 6 is thrown in any other way and before a total of 7 is thrown.

(8) "Eight the hardway" is a wager that may be made at any time, which shall win if a total of 8 is thrown the hardway (that is, with 4 spots appearing on each die) before a total of 8 is thrown in any other way and before a total of 7 is thrown.

(9) "Ten the hardway" is a wager that may be made at any time, which shall win if a total of 10 is thrown the hardway (that is, with 5 spots appearing on each die) before a total of 10 is thrown in any other way and before a total of 7 is thrown.

(10) "Field bet" is a one roll wager that may be made at any time, which shall win if any one of the totals 2, 3, 4, 9, 10, 11, or 12 is thrown on the roll immediately following placement of such bet and shall lose if a total of 5, 6, 7, or 8 is thrown on such roll.

(11) "Any seven" is a one roll wager that may be made at any time, which shall win if a total of 7 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown.

(12) "Any craps" is a one roll wager that may be made at any time, which shall win if a total of 2, 3 or 12 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown.

(13) "Craps two" is a one roll wager that may be made at any time, which shall win if a total of 2 is thrown on

the roll immediately following placement of such bet and shall lose if any other total is thrown.

(14) "Craps three" is a one roll wager that may be made at any time, which shall win if a total of 3 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown.

(15) "Craps twelve" is a one roll wager that may be made at any time, which shall win if a total of 12 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown.

(16) "11 in one roll" is a one roll wager that may be made at any time, which shall win if a total of 11 is thrown on the next roll and shall lose if any other total is thrown.

(17) "Craps-eleven" or "C and E" is a one roll wager that may be made at any time, which shall win if either a craps (a total of 2, 3 or 12) is rolled or a total of 11 is rolled immediately following placement of such bet and shall lose if any other total is thrown.

(18) "Horn bet" is a one roll wager that may be made at any time, which shall win if any one of the totals 2, 3, 11 or 12 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown.

(19) "Horn high bet" is a wager that may be made at any time, which shall win if any one of the totals 2, 3, 11, or 12 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown. A horn high bet shall be placed in wager units of five with four units wagered as a horn bet and an additional unit wagered on one of the totals 2, 3, 11, or 12. If the craps table layout does not have a designated area for the acceptance of a horn high bet, a dealer shall break down the bet into two separate wagers on the horn and one of the totals 2, 3, 11, or 12.

(20) "Whirl bet" or "world bet" is a one roll wager that may be made at any time, which bet shall consist of a horn bet and an any seven wager. A whirl bet shall be placed in units of five, with four units wagered on 2, 3, 11 and 12 and the fifth unit wagered as an any seven wager. A dealer shall break down a whirl bet into two separate wagers on the horn bet and the any seven wager.

(21) "Four the hardway on the hop" is a one roll wager that may be made at any time, which shall win if a total of 4 is thrown the hardway (that is, with 2 spots appearing on each die) on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(22) "Six the hardway on the hop" is a one roll wager that may be made at any time, which shall win if a total of 6 is thrown the hardway (that is, with 3 spots appearing on each die) on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(23) "Eight the hardway on the hop" is a one roll wager that may be made at any time, which shall win if a total of 8 is thrown the hardway (that is, with 4 spots appearing on each die) on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(24) "Ten the hardway on the hop" is a one roll wager that may be made at any time, which shall win if a total of 10 is thrown the hardway (that is, with 5 spots appearing on each die) on the roll immediately following place-

ment of such bet and shall lose if any other combination is thrown.

(25) "One-three (ace-trey) on the hop" is a one roll wager that may be made at any time, which shall win if a total of 4 is thrown with a 1 spot appearing on one die and a 3 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(26) "One-four (ace-four) on the hop" is a one roll wager that may be made at any time, which shall win if a total of 5 is thrown with a 1 spot appearing on one die and a 4 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(27) "Two-three (deuce-trey) on the hop" is a one roll wager that may be made at any time, which shall win if a total of 5 is thrown with a 2 spot appearing on one die and a 3 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(28) "One-five (ace-five) on the hop" is a one roll wager that may be made at any time, which shall win if a total of 6 is thrown with a 1 spot appearing on one die and a 5 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(29) "Two-four (deuce-four) on the hop" is a one roll wager that may be made at any time, which shall win if a total of 6 is thrown with a 2 spot appearing on one die and a 4 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(30) "One-six (ace-six) on the hop" is a one roll wager that may be made at any time, which shall win if a total of 7 is thrown with a 1 spot appearing on one die and a 6 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(31) "Two-five (deuce-five) on the hop" is a one roll wager that may be made at any time, which shall win if a total of 7 is thrown with a 2 spot appearing on one die and a 5 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(32) "Three-four (trex-four) on the hop" is a one roll wager that may be made at any time, which shall win if a total of 7 is thrown with a 3 spot appearing on one die and a 4 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(33) "Two-six (deuce-six) on the hop" is a one roll wager that may be made at any time, which shall win if a total of 8 is thrown with a 2 spot appearing on one die and a 6 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(34) "Three-five (trex-five) on the hop" is a one roll wager that may be made at any time, which shall win if a total of 8 is thrown with a 3 spot appearing on one die and a 5 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(35) "Three-six (trex-six) on the hop" is a one roll wager that may be made at any time, which shall win if a total of 9 is thrown with a 3 spot appearing on one die and a 6 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(36) "Four-five on the hop" is a one roll wager that may be made at any time, which shall win if a total of 9 is thrown with a 4 spot appearing on one die and a 5 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(37) "Four-six on the hop" is a one roll wager that may be made at any time, which shall win if a total of 10 is thrown with a 4 spot appearing on one die and a 6 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(38) "Big 6," if offered, is a wager that may be made at any time on the big number 6 on the table layout, which shall win if a total of 6 is rolled before a total of 7 is rolled and shall lose if a total of 7 is thrown before a total of 6.

(39) "Big 8," if offered, is a wager that may be made at any time on the big number 8 on the table layout, which shall win if a total of 8 is rolled before a total of 7 is rolled and shall lose if a total of 7 is thrown before a total of 8.

(40) A "put bet" is a wager that may be made at any time on any of the numbers 4, 5, 6, 8, 9, and 10 which wins if the number on which the wager was placed is thrown before a 7 appears and loses if a 7 is thrown before such number.

(41) A "high low" bet is a one roll wager that wins if either a high (12) or low (2) is rolled and loses if any other total is thrown. This bet is broken down into separate wagers and placed on the appropriate areas of "12" and "2" on the table layout.

(42) "Three way craps" is a one roll wager that wins if either an ace deuce (3) or any craps (2, 3 or 12) is rolled and loses if any other total is thrown. This bet is broken down into separate wagers and placed on the appropriate areas of the "ace-deuce", "2", and "12" on the table layout.

(b) Wagers are made before the dice are thrown but they may also be made between the time the dice leave the shooter's hand and the time the dice come to rest, provided that the wager is confirmed orally by the dealer and a supervisor.

(c) All wagers at craps are made by placing gaming chips on the appropriate area of the table layout.

(d) A wager made on any bet may be removed or reduced at any time prior to a roll that decides the outcome of such wager except that a pass line bet and a come bet may not be removed or reduced after a come out point or come point is established with respect to such bet.

(e) A don't come bet and a don't pass bet may be removed or reduced at any time but may not be replaced or increased after such removal or reduction until a new come out roll.

(f) All place to win bets, hardway bets and come odds bets are inactive on any come out roll unless called "on" by the player and confirmed by the dealer through placement of an "on" marker button on the top of each player's wager. All other wagers are considered "on."

(continued)

(g) The minimum and maximum wagers allowed at a table shall be posted at the table.

(h) No call bets are allowed. A "call bet" is a bet made verbally without actually placing gaming chips on the table layout.

(k) A horn bet and horn high bet shall be paid as if they were four separate wagers on 2, 3, 11, and 12.

(l) A craps-eleven or C and E bet shall be paid as if one half of the wagered amount had been placed on "any

craps" and one half on "eleven," and shall be paid as if two separate wagers were made for the one roll.

(m) A lottery gaming facility manager ("manager") may offer true odds on place bets under the following circumstances:

(1) In addition to the payout odds set forth in above for place bets to win on 4, 5, 6, 8, 9, and 10, a manager may offer a player the option of receiving true odds on these bets in return for the player paying to manager, at the time of making the bet, a percentage of the amount wagered which in no event shall exceed five percent of such wager;

(2) If a true odds place bet to win is made by a player, winning wagers shall be paid as follows:

Buy Bet made	True odds paid
4 to Win	2 to 1
5 to Win	3 to 2
6 to Win	6 to 5
8 to Win	6 to 5
9 to Win	3 to 2
10 to Win	2 to 1

(3) In addition to the payout odds set forth in above, for lay bets on 4, 5, 6, 8, 9, and 10, a manager may offer a player the option of receiving true odds on these bets in return for the player paying to manager, at the time of making the bet, a percentage of the amount wagered to be won which in no event shall exceed five percent of such wager;

(4) Lay bets: If a true odds place bet to lose is made by a player, winning wagers shall be paid as follows:

4 to Lose	1 to 2
5 to Lose	2 to 3
6 to Lose	5 to 6
8 to Lose	5 to 6
9 to Lose	2 to 3
10 to Lose	1 to 2

(n) Supplemental wagers shall also be allowed as follows:

(1) Whenever a player makes a pass bet and a total of 4, 5, 6, 8, 9, or 10 is thrown on the come out roll, the player shall have the right to make a supplemental wager in support of the pass bet which may be limited to an amount that is equal to the amount of the original pass bet. If, in such circumstances, the pass bet wins, the original pass bet shall be paid at odds of 1 to 1 and the supplemental wager shall be paid at odds of 2 to 1 if the come out point was 4 or 10, at odds of 3 to 2 if the come out point was 5 or 9, and at odds of 6 to 5 if the come out point was 6 or 8. A player loses this supplemental wager if the pass bet loses.

(2) Whenever a player makes a don't pass bet and a total of 4, 5, 6, 8, 9, or 10 is thrown on the come out roll, the player shall have the right to make a supplemental wager in support of the don't pass bet which may be limited to an amount so calculated as to provide winnings not in excess of the amount originally wagered on the don't pass bet. If, in such circumstances, the don't pass bet wins, the original don't pass bet shall be paid at odds of 1 to 1 and the supplemental wager shall be paid at odds of 1 to 2 if the come out point was 4 or 10, at odds

of 2 to 3 if the come out point was 5 or 9, and at odds of 5 to 6 if the come out point was 6 or 8. A player loses this supplemental wager if the don't pass bet loses.

(3) Whenever a player makes a come bet and a total of 4, 5, 6, 8, 9, or 10 is thrown on the roll immediately following placement of such bet, the player shall have the right to make a supplemental wager in support of the come bet which may be limited to an amount that is equal to the amount of the original come bet. If, in such circumstances, the come bet wins, the original come bet shall be paid at odds of 1 to 1 and the supplemental wager shall be paid at odds of 2 to 1 if the come point was 4 or 10, at odds of 3 to 2 if the come point was 5 or 9, and at odds of 6 to 5 if the come point was 6 or 8. A player loses this supplemental wager if the come bet loses.

(4) Whenever a player makes a don't come bet and a total of 4, 5, 6, 8, 9, or 10 is thrown on the roll immediately following placement of such bet, the player shall have the right to make a supplemental wager in support of the don't come bet which may be limited to an amount so calculated as to provide winnings not in excess of the amount originally wagered on the don't come bet. If, in such circumstances, the don't come bet wins, the original don't come bet shall be paid at odds of 1 to 1 and the supplemental wager shall be paid at odds of 1 to 2 if the come point was a 4 or 10, at odds of 2 to 3 if the come point was 5 or 9, and at odds of 5 to 6 if the come point was 6 or 8. A player loses this supplemental wager if the don't come bet loses.

(5) Manager may allow a supplemental wager in support of a pass or come bet in an amount up to 10 (ten) times the amount of the original pass or come bet. Manager may allow a supplemental wager in support of a don't pass or don't come bet in an amount so calculated as to provide a winning player with winnings not in excess of up to 10 (ten) times the amount originally wagered on the don't pass or don't come bet. The original pass, don't pass, come or don't come bet and any supplemental wager allowed pursuant to this subsection shall be paid at the same odds as the original and supplemental wagers are paid under (1) through (4) above.

(6) Whenever a player makes a put bet, the player has the right to make an additional wager in support of the bet which may be limited to an amount equal to the table minimum or maximum odds. If, in such circumstances, the bet wins, the original amount of the bet is paid at odds of 1 to 1 and the supplemental amount is paid in multiples of 2 to 1 if the come point was 4 or 10, 3 to 2 if the come point was 5 or 9, and 6 to 5 if the come point was 6 or 8. A player loses this supplemental bet if the put bet loses.

(7) Manager may accept a supplemental wager that exceeds an amount that is otherwise authorized by this section or posted as the maximum wager permitted at the table, provided that the excess amount of the supplemental wager is necessary to facilitate the payouts permitted by this section.
