Filing fee	The filing fee for this form is \$20.					
Payment	Please enclose a check or money order payable to the Secretary of State. Forms received without the appropriate fee will not be accepted for filing. Please do not send cash. NOTICE: There is a \$25 service fee for all checks returned by your financial institution. Also, to expedite processing, please do not use staples on your documents or to attach checks.					
Resident agent	Any of the following may serve as resident agent: a. the corporation itself, b. an individual residing in Kansas, c. a Kansas corporation, limited partnership, limited liability company or business trust, or d. a foreign corporation, limited partnership, limited liability company or business trust authorized to do business in Kansas.					
Address change	This filing only changes the resident agent and/or registered office. If you wish to change the mailing address (where our office will send official mail), please submit form MA, available at www.sos.ks.gov.
