All information on the articles of organization **must be complete** and accompanied by the **correct filing fee** or the document will **not** be accepted for filing.

<input type="checkbox"/> Payment	<p>Please submit payment by check, money order, or credit card. Checks and money orders need to be made payable to the Secretary of State. Forms received without the appropriate fee will not be accepted for filing. Please do not send cash.</p> <p>NOTICE: There is a \$25 service fee for all checks returned by your financial institution.</p> <p>Visa, MasterCard, Discover, and American Express are accepted. <input type="checkbox"/> Company name	<p>A word of organization must be included in the name per K.S.A. 17-7673. Permitted words of organization are "Limited Company," "Limited Liability Company," or the abbreviation "L.C.," "L.L.C.," "LC" or "LLC." You may view statutes at www.ksrevisor.org.</p> <p>Kansas does not use "PLLC" designations.</p>
<input type="checkbox"/> Resident agent	The resident agent is a person or entity that is authorized to accept service of process (lawsuits) on behalf of the business entity. This does not necessarily mean that the agent himself/herself is being sued, but that he/she has the authority and responsibility to accept service of process on behalf of the business.
<input type="checkbox"/> Registered office	The registered office is the address where the resident agent is located.
<input type="checkbox"/> Original certificate from the regulatory board	The certificate must be issued by the state regulatory board for each member stating that they are licensed and that the business entity name is approved.
<input type="checkbox"/> Purpose	The articles must include a specific professional purpose (ex. Practice of Medicine).
