### STATE OBJECTIONS BOARD TO CONVENE

TOPEKA (June 14, 2012) – The Secretary of State will convene a meeting of the State Objections Board on Tuesday, June 19, 2012 at 10:00 a.m. in the Secretary of State's office, Memorial Hall, 120 SW 10th Avenue, Second Floor, Topeka, Kansas.

The board will meet to review the following objections:

- 1) Filed by William Scott Hesse to the eligibility of Dr. Shanti Gandhi for Kansas State Representative for the 52<sup>nd</sup> District of the House of Representatives;
- 2) Filed by Travis Couture-Lovelady to the eligibility of Lawrence J. Reichert for Kansas State Representative for the 110<sup>th</sup> District of the House of Representatives;
- 3) Filed by Thomas Witt to the eligibility of Janice L. Pauls for Kansas State Representative for the 102<sup>nd</sup> District of the House of Representatives;
- 4) Filed by Larry Joe Lambert to the determination of invalidity of withdrawal by Larry Joe Lambert for Kansas State Representative for the 109<sup>th</sup> District of the House of Representatives;
