The prime contractor selected to perform the work, shall be on KDOT's latest qualification list for class of work. No oral, facsimile, or telephonic bids or alterations will be considered.

The following required KDOT Certifications must be signed and submitted through QuestCDN at the time bids are submitted. The City of Overland Park will reject bids that fail to contain these certifications:

- Certification for e-Bid
- Certification – Non-collusion and history of debarment
- Declaration – Limitations on use of federal funds for lobbying
- Required Contract Provision – DBE contract goal
- Certification–Contractual services with a current legislator or a current legislator’s firm
- Tax clearance certificate

Each bidder shall submit with its bid a PDF copy of the original bid bond in an amount of not less than five percent (5%) of the total bid, or, the bidder may choose to provide a bid bond authorization code provided to them by Surety2000, which the bidder shall keep in effect until the city gives written notice that it may be released. If the bidder provides a PDF copy of a bid bond, the original must be provided to the city after the bid opening and by the end of business of the second business day after the bid opening. The bid security shall be retained by the City of Overland Park until a contract for the project has been executed. Bid bonds will be returned or written notice of release will be given to the unsuccessful bidders, with the exception of the second qualifying bidder, at such time as their bids are rejected. In the event the successful bidder is unable to execute the contract, for whatever reason, the city may exercise its legal prerogatives, including, but not limited to, enforcement of its rights as to the bid security.

The city reserves the right to accept or reject any and all bids and to waive any technicalities or irregularities therein. Bids may be modified or withdrawn through the QuestCDN site, prior to the time and date for bid opening; provided, however, that no bidder may withdraw its bid for a period of thirty (30) days from the date set for the opening thereof. All bidders agree that rejection shall create no liability on the part of the city because of such rejection. It is understood by all bidders that an unsuccessful bidder has no cause of action against the city for bid preparation costs. The filing of any bid in response to

this invitation shall constitute an agreement of the bidder to these conditions.

The website will allow the contractor to request approval from KDOT to bid as a prime contractor and be included on the “Bid Holders List,” or to be included on the “Non-Bid Holders List” as a subcontractor/supplier. KDOT’s approval is required to bid as a prime contractor. To bid as a prime contractor, KDOT needs to be notified of the intent to bid no later than the close of business on the Monday preceding the scheduled letting date. Failure to obtain prior approval to bid as a prime contractor on any projects listed below will be reason to reject your bid. #### Background and Purpose of Project

The Kansas Department of Transportation (KDOT) is seeking a consultant to provide construction inspection services for project 54-88 KA-2385-01. Project 54-88 KA-2385-01 is the reconstruction of US-54 in Seward County as a four-lane expressway. The project location is from Tucker Road northeast to County Road O.

#### Schedule/Deadlines

Request for Proposals (RFPs) are due on or before 12:00 p.m. (CST) September 3, 2021, to be delivered via email to [kdot.designcontracts@ks.gov](mailto:kdot.designcontracts@ks.gov). Evaluation and ranking of submissions will occur on or about September 22, 2021, after which time all firms that submitted will be notified of the ranking. Negotiations with the most highly ranked

firm to commence on or about October 13, 2021. An agreement should be in place on or about November 3, 2021. The project is scheduled for letting in August 2021. The project early start date is anticipated in March 2022 with an open to traffic date of August 31, 2023, and an overall calendar completion date of December 15, 2023.

#### Scope of Services to be Performed

The project manager/inspectors must be capable of inspecting the whole project, which includes grading, subgrade/base, concrete, HMA-Commercial grade, PCCP plant, PCCP roadway, traffic control, seeding, erosion control, CMS or AASHTOWare data entry, all project records, all project paperwork, and final paperwork, etc. Project records and paperwork including but not limited to: diary, pay quantities, certifications, sample identifications, change orders, pay estimates, monitoring subcontractor payments, and monitoring contractor's payrolls, etc. Records and paperwork must be submitted accurately and timely. Anticipated staffing needs: provide project management and all inspectors as needed to ensure inspection and material testing for this project are done correctly. The number of required inspectors will fluctuate throughout the project depending on the contractor's schedule and how they pursue the work. Submit the name and work history of the project manager. Provide all the equipment necessary to inspect and test materials.

#### Instructions for Proposal

No costs shall be contained in the proposal. The technical proposal must not exceed four (4) pages total (including any cover letter, index, etc.) and 2MB to address the pertinent topics. #### Notice of Pending Water Pollution Control Permit for Discharges from the Application of Pesticides

The Kansas Department of Health and Environment (KDHE) has prepared a Kansas Water Pollution Control and National Pollutant Discharge Elimination System general permit for discharges from the application of pesticides to, over, or near waters of the United States within the borders of Kansas, except for Native American lands.

This general permit covers discharges from the application of pesticides to, over or near waters of the U.S. within Kansas where the pesticide is applied directly to the water or where a portion of the pesticide will unavoidably be deposited to the water in targeting pests.

For the purpose of this permit, pesticides include both biological pesticides and chemical pesticides that leave a residue. This general permit authorizes coverage for four specific pesticide use patterns as well as providing automatic coverage for pesticide research and development activities. Discharges from the application of pesticides to waters of the U.S. for pesticide use patterns not listed in this permit, or approved by KDHE, will be in violation of the Clean Water Act (CWA) and are prohibited unless the

operator obtained coverage under another NPDES permit. It is KDHE's intent in drafting this general permit to mirror the scope and extent of the discharges from pesticide application activities addressed in EPA's 2011 Pesticide General Permit and fact sheet and the proposed general permit and fact sheet published in the January 26, 2016, Federal Register. The EPA's draft 2021 Pesticide General Permit (PGP) was published in the Federal Register on January 15, 2021. The 2021 EPA PGP does not propose any functional changes to the existing EPA PGP, only definitional changes for permit issued by EPA. Similarly, this proposed KDHE-issued PGP makes no substantive changes from the existing 2016 KDHE-issued PGP.

The general permit describes the conditions under which a formal application Notice of Intent (NOI) is required. Operators proposing to apply pesticides to a water of the United States for one of the designated pesticide use patterns, that triggers an annual treatment area threshold criteria, or that are proposing to discharge in, over, or near an Outstanding National Resource Water (ONRW), or are proposing to discharge within ¼-mile of a public water supply surface water intake are required to submit an NOI and \$60 permit fee. All other operators under this general permit continue to be automatically covered.

All operators covered by this general permit must comply with technology-based and water quality-based effluent limitations, standard conditions and monitoring, reporting, record keeping, and document retention requirements. Coverage under this general permit does not negate the requirements of any federal or Kansas law, statute, or regulation and specifically references FIFRA, the Kansas Agricultural Chemical Act, and the Kansas Pesticide law.
