Notice is hereby given that the Kansas Department of Health and Environment (KDHE) is soliciting comments regarding a proposed air quality operating permit. Vest-

com New Century, LLC has applied for a Class I operating permit renewal in accordance with the provisions of K.A.R. 28-19-510 et al. The purpose of a Class I permit is to identify the sources and types of regulated air pollutants emitted from the facility; the emission limitations, standards, and requirements applicable to each source; and the monitoring, record keeping, and reporting requirements applicable to each source as of the effective date of permit issuance.

In order to be considered in formulating a final permit decision, written comments must be received no later than 12:00 p.m. Monday, November 29, 2021.

A person may request a public hearing be held on the proposed permit. The request for a public hearing shall be in writing and set forth the basis for the request. The written request must be submitted to Cathy Richardson, KDHE BOA, 1000 SW Jackson, Suite 310, Topeka, KS 66612-1366, no later than 12:00 p.m. Monday, November 29, 2021, in order for the Secretary of Health and Environment to consider the request.

The U.S. Environmental Protection Agency (EPA) has a 45-day review period, which will start concurrently with the public comment period, within which to object to the proposed permit. If the EPA has not objected in writing to the issuance of the permit within the 45-day review period, any person may petition the administrator of the EPA to review the permit. The 60-day public petition period will directly follow the EPA’s 45-day review period. Interested parties may contact KDHE to determine if the EPA’s 45-day review period has been waived.

Any such petition shall be based only on objections to the permit that were raised with reasonable specificity during the public comment period provided for in this notice, unless the petitioner demonstrates that it was impracticable to raise such objections within such period, or unless the grounds for such objection arose after such period. The proposed action is to modify thirteen Class III Injection Well permits for the wells listed above. These wells are part of two gallery salt solution mining systems consisting of the existing H and I Galleries. Wells H-110, I-116, and I-120 shall only be used for the purpose of brine withdrawal. Well H-111 shall remain shut-in. Injection is to be made into the Hutchinson Salt member of the Wellington formation. Mining shall not extend into the upper 40 feet of the salt deposit. The maximum operational injection pressure is not to exceed 250 pounds per square inch at the wellhead. The shall be a maximum pressure differential of 20 psi between the caverns in H- and I-Galleries. The Wellington formation consists of inter-bedded salt and shale deposits with minor amounts of gypsum. The upper portion of the formation is primarily clayey shale with small amounts of gypsum present. The lower portion, which is known as the Hutchinson Salt member, is mainly salt with inter-bedded shale deposits. The salt deposits beneath Compass Minerals' salt mining operations described herein are first encountered about 688 feet below ground surface and extend to a depth of about 973 feet. #### Background and Scope of Project

##### 1. Background

The Kansas Department of Transportation (KDOT) is administering approximately \$2,000,000 available from the Volkswagen Mitigation Trust funds allocated for investment in EV charging infrastructure. KDOT has identified twelve preliminary locations for the installation of DC Fast Charging (DCFC) stations to help advance the state's effort to support publicly accessible charging stations every 50 miles along primary corridors. The twelve preliminary locations have been identified along the I-70, I-35, and I-135/US-81 corridors by the Clean Cities EV Working Group.

##### 2. Eligible Applicants

Eligible applicants may include one or more of the following organization types:

- Businesses/vendors
- Utility companies
- Federal, state, local, or tribal government agencies
- Nonprofit organizations
- Academic institutions/universities

Applicants are strongly encouraged to demonstrate collaboration with local governments including cities, towns, and county governments as well as other local partners such as other public and private stakeholders. Proposals that have strong support from local and regional stakeholders and/or demonstrate linkage or partnership with educational institutions will be evaluated more favorably.

Applicants are required to collaborate with the local electric utility and include appropriate documentation from the utility, such as a letter or service notice, indicating power supply availability for the proposed project. This link provides a map of electric utility service areas in Kansas: [https://kcc.ks.gov/images/PDFs/maps/ks\\_electric\\_certified\\_areas.pdf](https://kcc.ks.gov/images/PDFs/maps/ks_electric_certified_areas.pdf).

Applicants are strongly encouraged to identify one or more potential charging station location hosts; and must present a plan for five years of ownership, operation, and maintenance of the equipment and public access. Proposals that have identified a committed charging station host will be evaluated more favorably.

Applicants are required to provide a description of the business model which includes utility rates, operational costs, cost to charge at the stations, and anticipated revenue. The proposed pricing structures and rates to charge drivers should be fair and reasonable.

##### 3. Funding and Reporting Requirements

KDOT will administer approximately \$2,000,000 to awardees for the installation of DCFC charging stations.

KDOT will reimburse up to 80% of eligible costs for charging stations installation. Total average reimbursable cost per installation is expected to be approximately \$150,000. Acquisition of land, driveway access, or reduced energy charges to the customer are not reimbursable expenses.

In-kind match and non-cash match sources will not be eligible match sources. Only expenses incurred on eligible costs may be considered toward the match.

##### Eligible Costs

Only costs necessary for and directly connected to the acquisition, installation, operation, and maintenance of the EV charging equipment are eligible for reimbursement. The following items are eligible for reimbursement up to 80%:

- DC fast charging equipment costs
- Charger installation costs
- Equipment shipping costs
- Necessary electric service upgrades and connection of the charger to electric service; including utility upgrades such as transformers and line extensions
- Other hard costs of site preparation (concrete, conduit, cable/wiring)
- Signage and lighting directly associated with on-site charging infrastructure
- Networking costs (up to 5 years)
- Charging equipment extended warranties and service contracts (up to 5 years)
- Other equipment and non-labor project costs including design and engineering and project management
- Permit costs/fees

##### Ineligible Costs

Costs not directly connected to the acquisition, installation, operation, and maintenance of the EV charging equipment are not eligible for reimbursement. Ineligible costs include but are not limited to the following:

- Purchase or rental of real estate
- Other capital costs (construction of buildings or parking facilities)
- General maintenance (other than that of the EV charging equipment)
- Administrative costs
- Battery storage serving the charging equipment
- Solar photovoltaic panels providing power to the charging equipment
- Cost of electricity to power the EV charging equipment
- Restriping or repaving/resurfacing of parking lots outside of DCFC installation

##### Award Payment Schedule

Awardees will have the option of submitting invoices for a one-time lump sum reimbursement following the completion of the committed installation(s) or incremental billings will be accepted no more than once monthly and for no less than \$1,000. Invoices will be reviewed and approved by KDOT and must include in-progress

photographs of the charging station installation, receipts for equipment, contractor invoices including hours and rates, installation costs, and supplies. If applicant wishes to have any five-year operational and maintenance expenses included, prepaid invoices will need to be provided with invoice. Every effort should be made to complete project work within 12 months from the date the KDOT agreement is signed. If supply chain issues delay installation from proposed schedule, applicant will provide a monthly explanatory report to KDOT until installation is complete. Applicants that demonstrate their capability of completing charging station installations by October 1, 2022, will be evaluated more favorably.

**Reporting**

Pre-installation

Awardees are required to send a monthly progress report to KDOT to keep the agency informed of key milestones and schedules.

Post-installation

Awardees are required to have their charging stations registered on the following databases for a minimum of 5 years following the date of project completion:

Awardees are required to provide usage reports on a prescribed quarterly schedule that will be established in agreement with KDOT. Such information will help the program better understand the demand for charging and usage trends. Reports will be submitted for a minimum of 5 years after project completion. The following information shall be submitted for each charger installed:

- Connect and disconnect times
- Start and end charge times
- Maximum instantaneous peak power
- Average power
- Number of charging sessions completed
- Number of charging sessions with errors or incomple tion
- Total energy (kWh) per charging session
- Date/time stamp
- Unique ID for charging event
- Unique ID for identifying the EVSE
- Other non-dynamic EVSE information such as GPS ID
- Percentage of station downtime

**4. Site Locations**

**5. Equipment and Installation Requirements**

Equipment

- Stations with two DCFC ports must be capable of providing at least 100 kW charging for a single vehicle and at least 50 kW simultaneous charging for two vehicles
- Stations with four DCFC ports must be capable of providing at least 100 kW simultaneous charging for two vehicles and at least 50 kW simultaneous charging for four vehicles
- Regardless of whether applicant is submitting for 2 or 4 port charging, favorable evaluation will be awarded to charging stations with higher capacity than 100kW
- Stations must be backward compatible to CHAdeMO v0.9 and SAE J1772 Oct2012 or other similar standard to allow model year 2010 or newer DC charging equipped vehicles to charge at lower kW
- The DCFC and supporting equipment must comply with NEC (2020edition) Article 625 and related articles and tables
- DCFC and supporting electrical components, enclosures, and mounting systems must be built to UL 2202 and UL2594 standards or equivalent
- DCFC and supporting equipment shall be listed by a Nationally Recognized Testing Laboratory (NRTL)
- DCFC and supporting equipment shall comply with state and local codes and electrification requirements including, but not limited to, third party certification as appropriate (documentation to be included for each unit)
- Payment methods shall operate on equipment, software, and networks using publicly available open standard(s), such as Open Charge Point Protocol (OCPP) v1.6. The DCFC should have back-end capabilities to collect payment or provide reporting mechanisms such that another system, through secure re-programming of back-end server location and credentials, would be able to collect payment and provide access control

- DCFC shall be type evaluated through the National Type Evaluation Program (NTEP) and the installation and use shall comply with all requirements of the National Institute of Standards and Technology (NIST) Handbook 44 Section 3.40. Electric Vehicle Fueling Systems—Tentative Code and shall have received safety certification by a nationally recognized testing laboratory (NRTL). DCFC shall be indicated and recorded in kilowatt-hours (kWh) and decimal subdivisions thereof, with the value of the smallest unit of indicated delivery by a DCFC, and recorded delivery if the DCFC is equipped to record, shall be 0.001 kWh
- Physical Appearance, Function, and Design:
  1. DCFC and supporting equipment must utilize tamper-resistant screws and design but provide a locked or easy opening mechanism for service work
  2. DCFC enclosure must be constructed for use outdoors in accordance with UL50, Standard for Enclosures for Electrical Equipment, NEMA, Type 3R, or better to protect against blown dust or rain. Equivalent standards may be used if it is in accordance with or otherwise meeting the requirements of UL50
  3. Display screens must be protected from malfunctions due to condensation and normal local weather conditions
  4. Equipment and display screens should be sturdy enough to withstand most types of vandalism
  5. DCFC and supporting equipment must be capable of operating over beyond an ambient temperature range of minus 22 to 122 degrees Fahrenheit. Applicants should provide a derating curve for their equipment within this temperature range
  6. DCFC shall include barriers to prevent damage from equipment used for snow removal

#### Location

- Within 5 miles of the corridor, favorable evaluations will be given for closer installations

Board of Cosmetology

Permanent Administrative Regulations

Article 1.—LICENSING AND QUALIFICATIONS OF COSMETOLOGISTS

**69-1-4. Grades necessary to pass licensure examinations; development and administration of licensure examinations.** (a) Each applicant taking the state board of cosmetology examinations shall be granted a license authorizing the practice of cosmetology, nail technology, esthetics, or electrology if the applicant attains the following examination scores:

- (1) An average of at least 75 percent on the practical examination sections; and
  - (2) at least 75 percent on the written examination.
- (b) Each applicant for licensure as an instructor shall be required to attain a score of at least 75 percent on the written examination for instructors, in addition to meeting the applicable requirements specified in K.S.A. 65-1903, and amendments thereto.

(c) The licensure examinations shall be developed and administered by the board or by a board-approved examination provider. (Authorized by and implementing K.S.A. 65-1905; effective Jan. 1, 1966; amended May 1, 1981; amended Feb. 21, 1994; amended March 22, 1996; amended, T-69-12-29-04, Dec. 29, 2004; amended April 15, 2005; amended Nov. 12, 2021.)

Article 6.—BEAUTY SHOPS

**69-6-2. Sale or change of ownership.** Each establishment license shall be valid only for the premises named in the license. Each licensee shall notify the board, in writing, within 15 days of a sale or other change of ownership of the establishment. (Authorized by K.S.A. 74-2702a; implementing K.S.A. 65-1904a; effective Jan. 1, 1966; amended May 1, 1978; amended March 22, 1996; amended Nov. 12, 2021.)

Article 15.—TATTOOING, BODY PIERCING, AND PERMANENT COSMETICS

**69-15-31. Potentially disqualifying civil and criminal records; advisory opinion; fee.** (a) Conviction of any felony or class A misdemeanor listed in K.S.A. 65-1942, and amendments thereto, may disqualify an applicant from receiving a license.

(b) Civil records that may disqualify an applicant from receiving a license shall be any records of any court judgment or settlement in which the applicant admitted or was found to have engaged in conduct that would constitute a violation of any practice act under the jurisdiction of the board or any of the board's regulations. Those records shall not be used to disqualify an applicant for more than five years after the applicant satisfied any judgment or restitution ordered by the court or agreed to in the settlement.

(c) Any individual with a criminal or civil record described in this regulation may submit a petition to the board for an informal, advisory opinion concerning whether the individual's civil or criminal record may disqualify the individual from licensure. Each petition shall include the following:

- (1) The details of the individual's civil or criminal record, including a copy of court records or the settlement agreement;
- (2) an explanation of the circumstances that resulted in the civil or criminal record; and
- (3) a check or money order in the amount of \$50.00. (Authorized by K.S.A. 74-120 and 74-2702a; implementing K.S.A. 65-1942, 65-1947, and 74-120; effective Nov. 12, 2021.)

Permanent Administrative Regulations

Article 3.—STANDARDS FOR AMBULANCE ATTENDANTS, FIRST RESPONDERS, AND DRIVERS

**109-3-3. Emergency medical responder; authorized activities.** Each emergency medical responder shall be authorized to perform any intervention specified in K.S.A. 65-6144, and amendments thereto, and as further specified in this regulation:

## (a) Emergency vehicle operations:

(1) Operating each ambulance in a safe manner in nonemergency and emergency situations. "Emergency vehicle" shall mean ambulance, as defined in K.S.A. 65-6112 and amendments thereto; and

(2) stocking an ambulance with supplies in accordance with regulations adopted by the board and the ambulance service's approved equipment list to support local medical protocols;

## (b) initial scene management:

(1) Assessing the scene, determining the need for additional resources, and requesting these resources;

(2) identifying a multiple-casualty incident and implementing the local multiple-casualty incident management system;

(3) recognizing and preserving a crime scene;

(4) triaging patients, utilizing local triage protocols;

(5) providing safety for self, each patient, other emergency personnel, and bystanders;

(6) utilizing methods to reduce stress for each patient, other emergency personnel, and bystanders;

(7) communicating with public safety dispatchers and medical control facilities;

(8) providing a verbal report to receiving personnel;

(9) providing a written report to receiving personnel;

(10) completing a prehospital care report;

(11) setting up and providing patient and equipment decontamination;

(12) using personal protection equipment;

(13) practicing infection control precautions;

(14) moving patients without a carrying device; and

(15) moving patients with a carrying device;

## (c) patient assessment and stabilization:

(1) Obtaining consent for providing care;

(2) communicating with bystanders, other health care providers, and patient family members while providing patient care;

(3) communicating with each patient while providing care; and

(4) assessing the following: blood pressure manually by auscultation or palpation or automatically by noninvasive methods; heart rate; level of consciousness; temperature; pupil size and responsiveness to light; absence or presence of respirations; respiration rate; and skin color, temperature, and condition;

(d) cardiopulmonary resuscitation and airway management:

(1) Applying cardiac monitoring electrodes;

(2) performing any of the following:

(A) Manual cardiopulmonary resuscitation for an adult, child, or infant, using one or two attendants;

(B) cardiopulmonary resuscitation using a mechanical device;

(C) postresuscitative care to a cardiac arrest patient;

(D) cricoid pressure by utilizing the sellick maneuver;

(E) head-tilt maneuver or chin-lift maneuver, or both;

(F) jaw thrust maneuver;

(G) modified jaw thrust maneuver for injured patients;

(H) modified chin-lift maneuver;

(I) mouth-to-barrier ventilation;

(J) mouth-to-mask ventilation;

(K) mouth-to-mouth ventilation;

(L) mouth-to-nose ventilation;

(M) mouth-to-stoma ventilation;

(N) manual airway maneuvers; or

(O) manual upper-airway obstruction maneuvers, including patient positioning, finger sweeps, chest thrusts, and abdominal thrusts; and

(3) suctioning the oral and nasal cavities with a soft or rigid device;

(e) control of bleeding, by means of any of the following:

(1) Elevating the extremity;

(2) applying direct pressure;

(3) utilizing a pressure point;

(4) applying a tourniquet;

(5) utilizing the trendelenberg position; or

(6) applying a pressure bandage;

(f) extremity splinting, by means of any of the following:

(1) Soft splints;

(2) anatomical extremity splinting without return to position of function;

(3) manual support and stabilization; or

(4) vacuum splints;

(g) spinal immobilization, by means of any of the following:

(1) Cervical collar;

(2) full-body immobilization device;

(3) manual stabilization;

(4) assisting an EMT, an AEMT, or a paramedic with application of an upper-body spinal immobilization device;

(5) helmet removal; or

(6) rapid extrication;

(h) oxygen therapy by means of any of the following:

(1) Humidifier;

(2) nasal cannula;

(3) non-rebreather mask;

(4) partial rebreather mask;

(5) regulators;

(6) simple face mask;

(7) blow-by;

(8) using a bag-valve-mask with or without supplemental oxygen; or

(9) ventilating an inserted supraglottic or subglottic airway;

(i) administration of medications according to the board's "approved medication list," dated June 4, 2021, which is hereby adopted by reference;

(j) recognizing and complying with advanced directives by making decisions based upon a do-not-resuscitate order, living will, or durable power of attorney for health care decisions; and

(k) providing the following techniques for preliminary care:

(1) Cutting of the umbilical cord;

(2) irrigating the eyes of foreign or caustic materials;

(3) bandaging the eyes;

(4) positioning the patient based on situational need;

(5) securing the patient on transport devices;

(6) restraining a violent patient, if technician or patient safety is threatened;

(continued)

- (7) disinfecting the equipment and ambulance;
- (8) disposing of contaminated equipment, including sharps and personal protective equipment, and material;
- (9) decontaminating self, equipment, material, and ambulance;
- (10) following medical protocols for declared or potential organ retrieval;
- (11) participating in the quality improvement process;
- (12) providing EMS education to the public; and
- (13) providing education on injury prevention to the public. (Authorized by K.S.A. 2020 Supp. 65-6111; implementing K.S.A. 65-6144; effective March 9, 2012; amended May 5, 2017; amended Jan. 24, 2020; amended Nov. 12, 2021.)
