Electronic copies of the letting proposals and plans are available on the Kansas Department of Transportation (KDOT) website at https://kdotapp.ksdot.org/Proposal/ Proposal.aspx. The website will allow the contractor to request approval from KDOT to bid as a prime contractor and be included on the "Bid Holders List," or to be included on the "Non-Bid Holders List" as a subcontractor/supplier. KDOT's approval is required to bid as a prime contractor. To bid as a prime contractor, KDOT needs to be notified of the intent to bid no later than the close of business on the Monday preceding the scheduled letting date. Failure to obtain prior approval to bid as a prime contractor on any projects listed below will be reason to reject your bid. The Secretary reserves the right to reject bids that do not comply with all requirements for preparing a bidding proposal as specified in the 2015 edition of the Kansas Department of Transportation Standard Specifications for State Road and Bridge Construction.

KDOT will only accept electronic internet proposals using the Bid Express website at https://bidx.com/ks/main until 1:00 p.m. (Central Time) on letting day. The KDOT bid letting will be conducted remotely by audio broadcast only at 3:00 p.m. (Central Time) on letting day. For the conference call information see https://www.ksdot.org/bureaus/burconsmain/lettinginfo.asp. KDOT has tested the process, but in the event of an unforeseen issue, KDOT will provide updates.

Each bidder shall certify that such person, firm, association, or corporation has not, either directly or indirectly, entered into any agreement, participated in any collusion, or otherwise taken any action in restraint of free competitive bidding in connection with the submitted bid. This certification shall be in the form of a required contract provision provided by the state to each prospective bidder. Failure to complete the required contract provision and certify the completeness of the preceding statement when electronically signing the proposal will make the bid nonresponsive and not eligible for award consideration.

Beginning September 14, 2023, the Kansas Department of Transportation (KDOT) has officially made the switch to Bid Express for all request for proposal (RFP) solicitations for design and consulting services.

You can sign up now for a FREE "vendor" account on Bid Express at https://www.infotechexpress.com/registration/new?app_id=08b3d1713188df08d8970b79c2d30ea5628af16e53abe624a239557b2dcf3429&return_to=https%3A%2F%2Fwww.bidexpress.com%3A443.

- Every individual who might want to see KDOT RFPs needs to sign up for their own account (it is not a single account for each company).
- There is value to you and value to KDOT in associating all individuals from your company with the same company "instance" in Bid Express rather than creating new companies for each person.
- After signing up and logging into your personal account, vendors/consultants must enable free "follower notifications" from KDOT's Bid Express landing page to receive notifications each time a solicitation is advertised, addenda of any kind are issued (including Q&A), or if an advertisement is withdrawn from view.
- Note: KDOT is sponsoring the cost of this tool. Therefore, signing up and responding to KDOT RFQs or RFPs is free.

Currently, KDOT plans to continue soliciting on-call service requests via email through the end of 2023. This will switch to Bid Express for on-calls in January 2024.

Firms not prequalified must also provide documentation that demonstrates the firm is qualified for each specified category listed in this notice for the project. Consultants may create a team to meet the prequalification requirements. Anticipated Consultant Scope

KDOT anticipates the following to be included in the consultant's scope:

This inspection program will include bridges in multiple locations across the state. The full list of bridges which need to be inspected will be broken into annual lists, completed over the course of four years. The list of bridges to be inspected in a given calendar year will be provided at the beginning of each year. See the attachments (available at https://www.bidexpress.com/businesses/70801/home) for a full list of the bridges KDOT currently anticipates including in this program. Bridges affected and timings of inspections are subject to change.

The KMZ file provides a quick picture of the locations and timing KDOT anticipates for each inspection.

Legend for the KMZ file:

- Purple indicates a 2024 inspection with a 60-month frequency.
- Yellow indicates a 2024 inspection that, due to CFR interim guidance, is currently listed as a 24-month inspection frequency but is likely to change after collection of additional data.
- Orange indicates a 2025 inspection with a 24-month frequency.
- Cyan indicates a 2025 inspection with a 60-month frequency.

Article 20.—MISCELLANEOUS REGULATIONS

- **115-20-2.** Certain wildlife; legal equipment, taking methods, possession, and license requirement. (a) Subject to federal and state laws and regulations, wildlife listed in subsection (b) may be taken for personal use on a noncommercial basis.
- (b) For purposes of this regulation, wildlife shall include the following, excluding any species listed in K.A.R. 115-15-1 or K.A.R. 115-15-2:
 - (1) Amphibians, except bullfrogs;
 - (2) armadillo;
- (3) commensal rodents, excluding game and furbearing animals;
 - (4) exotic doves;
 - (5) feral pigeon;
 - (6) gopher;
 - (7) ground squirrel;
 - (8) invertebrates;
 - (9) kangaroo rat;
 - (10) mole;
 - (11) porcupine;
 - (12) prairie dog;
- (13) reptiles, except common snapping turtles and softshelled turtles;
 - (14) woodchuck; and
 - (15) wood rat.
- (c) Wildlife listed in subsection (b) shall be taken only with any of the following legal equipment or methods:
 - (1) Bow and arrow;
 - (2) crossbow;
 - (3) deadfall;
 - (4) dogs;
 - (5) falconry;
 - (6) firearms, except fully automatic firearms;
 - (7) glue board;
 - (8) hand;
 - (9) net or seine;
- (10) optical scopes or sights that project no visible light toward the target and do not electronically amplify visible or infrared light;

- (11) pellet and BB gun;
- (12) poison, poisonous gas, or smoke, if the toxicant is registered and labeled for that use and if all permit requirements for use of the poison, poisonous gas, or smoke have been met;
- (13) projectiles hand-thrown or propelled by a sling-shot;
 - (14) snare or noose; or
 - (15) trap.
- (d) The open season for the taking of wildlife listed in subsection (b) shall be year-round.
- (e) There shall be no maximum daily bag or possession limit for wildlife listed in subsection (b), except that no more than five total of any combination of amphibian may be possessed per person or domicile, whichever is reached first, and no more than five reptiles and no more than two individuals of any reptile species per person and/or domicile, whichever is reached first. No more than five live specimens of mussels may be possessed. Two opposing shells shall constitute one mussel.
- (f) For the purpose of this regulation, "domicile" shall mean the address you declare in legal documents to pay taxes, receive social security, vote, bank, permanent abode, and register vehicles and animals.
- (g) Each exotic dove possessed in excess of the aggregate daily bag limit or aggregate possession limit for migratory doves during the open season for migratory doves established in K.A.R. 115-25-19 shall retain a fully feathered wing. For the purpose of this regulation, "migratory dove" shall mean any mourning dove or white-winged dove, and "exotic dove" shall mean a Eurasian collared dove or ringed turtledove.
- (h) Legally taken wildlife listed in subsection (b) may be possessed without limit in time.
- (i) A hunting license shall not be required to take invertebrates. (Authorized by K.S.A. 32-807; implementing K.S.A. 32-807 and K.S.A. 32-919; as amended by L. 2023, ch. 43, sec. 4; effective Sept. 10, 1990; amended Nov. 30, 1998; amended July 13, 2001; amended Nov. 22, 2002; amended Feb. 18, 2005; amended July 28, 2017; amended Oct. 6, 2023.)
