In developing the 2024 Section 303(d) List of Impaired Waters in Kansas, the Kansas Department of Health and Environment (KDHE) is soliciting "all existing and readily available water quality-related data and information" in accordance with 40 CFR 130.7(b)(5). Section 303(d) of the Clean Water Act requires states to biennially prepare a list of waters failing to meet state water quality standards, based on data and information from local, state,

and federal agencies; members of the public; and academic institutions conducting research. Submitted data and information will be evaluated by KDHE for listing decisions for the 2024 Kansas 303(d) List of Impaired Waters, to be submitted to the U.S. Environmental Protection Agency by April 1, 2024.

This notice requests any data or information on the water quality condition of waters of the state over the period January 1, 2000 through September 30, 2023. Data associated with waters for which water quality problems have been reported are of particular interest. Submitted data may include chemical, physical, or biological measurements and should be accompanied by information to identify the waterbody with as much geographic specificity as possible. Data submitted to KDHE for consideration should have adequate quality control and quality assurance for accuracy, representation, and precision in describing the water quality of streams, lakes, and wetlands.

Public notice is hereby given that the Kansas Department of Transportation (KDOT), in cooperation with the Federal Highway Administration (FHWA), will prepare an Environmental Assessment (EA) for a proposal to modernize and expand the K-10 Corridor located in Johnson County, Kansas. The City of Olathe, the City of Lenexa, the City of De Soto, and Johnson County are serving as partners on the study.

The overall study limits on K-10 extend from west of the interchange at Evening Star Road to the I-435/I-35/K-10 interchange. The overall length is approximately 16.5 centerline miles along K-10. Major cross streets with service interchange access to K-10 included within the study area are Evening Star Road, Edgerton Road, Lexington Avenue, Kill Creek Road, Cedar Creek Parkway/Canyon Creek Boulevard, S. Woodland Road, S. Ridgeview Road, and Renner Boulevard. System interchanges within the study area include K-7 (from College Boulevard to Prairie Star Parkway) and I-435 (from 95th Street to Pflumm Road). Additionally, I-35 at the interchange with I-435/K-10 is included.

Within the EA, FHWA, and KDOT will evaluate a "No Action" alternative as well as expansion alternatives (tolled and non-tolled) for the K-10 study area as the proposed action. Roadway and interchange configurations

will be evaluated throughout the corridor. The toll alternative will evaluate the potential benefits of express toll lanes for eastbound and westbound traffic to improve safety and improve congestion in the corridor. Roadway and interchange configurations will be evaluated throughout the corridor.

The FHWA and KDOT plan to prepare an EA for the project. The EA will analyze the potential social, economic, and environmental impacts resulting from the proposed project. The following issues will be specifically analyzed as part of the EA: impacts to the aquatic ecosystem, impacts to cultural resources; impacts to threatened and endangered species; impacts to floodplains; impacts to transportation; impacts to parks/ recreation; environmental justice; and socioeconomics. This includes direct, indirect, and cumulative impacts. Other Federal approvals or permits that may be required; a Section 404 Permit from the U.S. Army Corps of Engineers (USACE), a floodplain development permit from the City of De Soto, the City of Lenexa, the City of Olathe, and Johnson County as well as water resource and floodplain permits from the Kansas Division of Water Resources.

A scoping and coordination process will be initiated that involves appropriate federal, state, and local agencies, as well as stakeholders and the public. This will continue throughout the study to engage the local and regional community, to obtain public input and to keep the public informed. Coordination meetings will be held as needed with affected/concerned local, state, tribal, and federal governmental entities. Public meetings will be held to gather input and share findings on the EA. The EA will be made available for public and agency review and comment prior to the final public meeting.

#### **Background and Scope of Project**

Periodically for a given project, KDOT personnel may be unable to perform Pile Drive Analysis (PDA) within the timeframe required so it may be necessary to engage a consultant firm on short notice. This process begins with KDOT issuing an on-call service request to firms that have executed an on-call PDA agreement specifically for this type of support. To expedite commencement of work, resulting work order(s) are executed under the terms and conditions of that agreement. KDOT anticipates entering into such an agreement with up to three to four qualified consulting firms. Below is a list needed to complete PDA testing:

• Pile Driving Analyzer (PDA), a dynamic load testing and pile monitoring device and CAPWAP, a signal matching software program that uses pile top force and velocity measurements obtained by PDA to determine deep foundation resistances. These should meet ASTM Standard D4945-17. Periodically, KDOT's own in-house equipment may be unable to perform the testing within the time frame required. In those instances, it may be necessary to engage a consultant (with appropriately accredited personnel and equipment) on short notice for testing under an on-call agreement. Therefore, KDOT is seeking to execute on-call agreements with three to four highly qualified firms, one of which may be selected on a project-by-project basis for specific assignment to be detailed in a task order/work order issued under a four-year term on-call agreement.

These are regulations supporting the Kansas Homestead Property Tax Refund program.

K.A.R. 92-22-17. Exercise of right to file claim on behalf of claimant. The Department proposes amending this regulation, simplifying it to match current statutory requirements and Department practice for accepting Homestead refund claims filed under a power of attorney.

K.A.R. 92-22-14. Rent constituting property taxes accrued; services. | 92-22-23. Computation of amount of claim; rental and ownership of a homestead during the same calendar year. | 92-22-32. Homestead; charges for services, furniture, personal property, etc. When these regulations were adopted, both homeowners and renters were eligible to receive Homestead refunds. These regulations address issues specific to renters. Because renters are no longer eligible for Homestead refunds, the Department proposes revoking these regulations.

- (D) "protocol for conducting measurements of radon and radon decay products in multifamily buildings," MAMF 2017 with 1/21 revisions, published by the Amer-

  - (1) Be at least 18 years of age;
- (2) complete and submit proof of completion to the department of a radon mitigation training course with at least 24 hours of classroom instruction that includes active participation in radon mitigation techniques approved by the department pursuant to K.S.A. 48-16a06, and amendments thereto;
- (3) attain a passing score of at least 70 percent on a closed-book examination on radon mitigation approved by the department pursuant to K.S.A. 48-16a06, and amendments thereto; and
- (4) provide any additional relevant information requested by the department.
- (b) Each radon mitigation technician shall meet the following requirements:
- (1) Conduct radon mitigation activities in accordance with the requirements of the following:
  - (A) K.S.A. 48-16a06, and amendments thereto;
- (B) "protocol for conducting measurements of radon and radon decay products in homes," which is adopted by reference in K.A.R. 28-35-603;
- (C) "performance specifications for instrumentation systems designed to measure radon gas in air," which is adopted by reference in K.A.R. 28-35-603;
- (D) "protocol for conducting measurements of radon and radon decay products in multifamily buildings," which is adopted by reference in K.A.R. 28-35-603;
- (E) "protocol for conducting measurements of radon and radon decay products in schools and large buildings," which is adopted by reference in K.A.R. 28-35-603;
- (F) "soil gas mitigation standards for existing homes," SGM-SF 2017 with 12/2020 revisions, published by the

American national standards institute and the American association of radon scientists and technologists, dated 2020, which is hereby adopted by reference, except for the introduction, table of contents, exhibits, appendices, and companion guidance;

- (G) "radon mitigation standards for multifamily buildings," ANSI/AARST RMS-MF 2018 with 12/2020 revisions, published by the American national standards institute and the American association of radon scientists and technologists, dated 2020, which is hereby adopted by reference, except for the introduction, table of contents, exhibits, appendices, and companion guidance;
- (H) "radon mitigation standards for schools and large buildings," ANSI/AARST RMS-LB 2018 with 12/2020 revisions, published by the American national standards institute and the American association of radon scientists and technologists, dated 2020, which is hereby adopted by reference, except for the introduction, table of contents, exhibits, appendices, and companion guidance; and
- (I) all applicable municipal, county, state, and federal laws and regulations;
- (2) upon request from the department, provide documentation of proficiency including continuing education requirements specified in K.A.R. 28-35-605; and
- (3) notify the department of any name or address changes within 30 days. (Authorized by K.S.A. 2022 Supp. 48-16a03; implementing K.S.A. 2022 Supp. 48-16a03 and 48-16a06; effective Feb. 3, 2012; amended Oct. 27, 2023.)
- **28-35-605. Continuing education.** (a) Before certification renewal, each radon measurement technician shall meet the following continuing education requirements:
- (1) Complete and submit proof of completion to the department of at least 16 hours of department-approved continuing education; and
- (2) maintain documentation, pursuant to K.A.R. 28-35-601(h), that the continuing education was successfully completed within the prior 24-month certification period.
- (b) Before certification renewal, each radon mitigation technician shall meet the following continuing education requirements:
- (1) Complete and submit proof of completion to the department of at least 16 hours of department-approved continuing education;
- (2) maintain documentation, pursuant to K.A.R. 28-35-601(h), that the continuing education was successfully completed within the prior 24-month certification period.
- (c) If a person is certified as both a radon measurement technician and a radon mitigation technician, continuing education credit shall be granted for both certifications if the person completes at least 24 hours of department-approved continuing education credits for radon services during the 24-month period that the certificates are valid.
- (d) Continuing education credit shall be accepted only for the completion of each different continuing education training course during a current certification period. Training courses for continuing education credit that are repeated shall be accepted only for the initial successful completion of the course during a current certification period. #### Article 34.—HOSPITALS

- **28-34-145. Definitions.** As used in K.A.R. 28-34-145 through 28-34-152, each of the following terms shall have the meaning specified in this regulation:
- (a) "Accrediting survey" means an inspection conducted by an accrediting organization approved by the centers for medicare and medicaid services.
- (b) "Administrator" means an individual who is appointed by the governing body to act on behalf of a rural emergency hospital in the overall management of a rural emergency hospital.
- (c) "Applicant" means a person who has applied for a license but who has not yet been granted a license to operate a rural emergency hospital.
- (d) "Change of ownership" means any transaction that results in a change of control over the capital assets of a rural emergency hospital.
- (e) "Critical access hospital" has the meaning specified for "critical access hospital" in K.S.A. 2022 Supp. 65-468, and amendments thereto.
- (f) "General hospital" has the meaning specified for "general hospital" in K.S.A. 65-425, and amendments thereto.
- (g) "Governing body" means the individual or individuals who comprise the legal administrative structure of a rural emergency hospital and direct how business shall be conducted.
- (h) "Licensee" means a person that has been granted a license to operate a rural emergency hospital.
- (i) "Licensing agency" means Kansas department of health and environment.
- (j) "Licensure survey" means an inspection conducted by surveyors of the licensing agency of any licensee to verify each rural emergency hospital's compliance with state statutes and the requirements specified in K.A.R. 28-34-146 through 28-34-152.
- (k) "Person" means any individual, firm, partnership, corporation, company, association, or joint-stock association, and the legal successor of the individual, firm, partnership, corporation, company, association, or joint-stock association.
- (l) "Rural emergency hospital" and "REH" have the meaning specified for "rural emergency hospital" in K.S.A. 2022 Supp. 65-483, and amendments thereto.
- (m) "Rural emergency hospital services" has the meaning specified for "rural emergency hospital services" in K.S.A. 2022 Supp. 65-483, and amendments thereto.

- (n) "Secretary" has the meaning specified for "secretary" in K.S.A. 65-483, and amendments thereto. (Authorized by and implementing K.S.A. 2022 Supp. 65-487; effective, T-28-9-29-23, Sept. 29, 2023.)
- **28-34-146.** Application process. (a) Any person wanting to operate a rural emergency hospital shall meet the eligibility requirements pursuant to K.S.A. 2022 Supp. 65-484, and amendments thereto, and shall file an application on a form provided by the licensing agency at least 90 days before the admission of patients.
- (b) Each applicant for a license to operate a rural emergency hospital shall submit all of the following information to the licensing agency:
- (1) An action plan for initiating rural emergency hospital services, including a transition plan that lists the specific services that the rural emergency hospital transitioning from a critical access hospital shall retain, modify, add, or discontinue;
- (2) a description of services the rural emergency hospital may provide on an outpatient basis;
- (3) a description of how the rural emergency hospital will use payments provided to the rural emergency hospital by the centers for medicare and medicaid services;
- (4) a written verification from county and municipal authorities showing that the rural emergency hospital complies with all local codes and ordinances, including all building, fire, and zoning requirements;
- (5) a written verification from the Kansas office of the state fire marshal showing that the rural emergency hospital building complies with all applicable fire codes and regulations;
- (6) a plan for the removal of biomedical waste and human tissue from the rural emergency hospital; and
- (7) a transfer agreement with a medicare certified level I or level II trauma center.
- (c) The granting of a license to any applicant may be denied by the secretary if the applicant is not in compliance with all applicable laws and regulations. (Authorized by and implementing K.S.A. 2022 Supp. 65-487; effective, T-28-9-29-23, Sept. 29, 2023.)
- **28-34-147.** Licensing procedure; renewals. (a)(1) No earlier than 90 days before but not later than 30 days before the renewal date, each licensee wishing to renew a license shall submit an application to renew the license to the licensing agency on a form provided by the licensing agency.
- (2) The licensing agency shall approve the application for renewal after the licensing agency has verified that the licensee is in compliance with the requirements specified in K.A.R. 28-34-146 through 28-34-152.
- (3) A license previously issued shall be renewed after the licensee has filed an annual report. The annual report shall be filed not later than 60 days after the beginning of each calendar year. The annual report shall include information regarding the following:
  - (A) Administration and ownership;
  - (B) classification;
  - (C) special care services;
  - (D) outpatient and emergency room services; and
  - (E) staff personnel.
  - (b) New construction, alterations, or renovations that

- provide space for patient services or patient room shall not be used until authorization has been received from the licensing agency. The licensing agency may give authorization orally or by telephone and shall provide the rural emergency hospital with written confirmation of the authorization.
- (c) If the rural emergency hospital is found to be non-compliant with the requirements specified in K.A.R. 28-34-146 through 28-34-152, the licensing agency shall notify the licensee, in writing, of each violation and require that a plan of correction be submitted before a license is issued or renewed. The plan of correction shall state specifically what corrective action shall be taken and the date on which the plan of correction shall be accomplished.
- (d) If during the term of the current license the rural emergency hospital is surveyed by an accrediting organization approved by the centers for medicare and medicaid services, the licensee shall submit the survey report to the licensing agency. As a result of the accrediting survey, any licensee may be subject to an additional licensing survey at the secretary's discretion.
- (e) The licensing agency shall verify compliance of the rural emergency hospital with the requirements specified in K.A.R. 28-34-146 through 28-34-152 in at least one of the following ways:
- (1) A statement of the administrator or an authorized staff member; or
  - (2) on-site observations by licensing agency surveyors.
- (f) If a licensed general hospital or critical access hospital applies for and receives licensure as a rural emergency hospital and elects to operate as a rural emergency hospital, the rural emergency hospital shall retain its original state license as a general hospital or critical access hospital. The original state license of the rural emergency hospital shall remain inactive and the reporting requirements of the general hospital or critical access hospital shall be waived while the rural emergency hospital license is in effect. (Authorized by and implementing K.S.A. 2022 Supp. 65-487; effective, T-28-9-29-23, Sept. 29, 2023.)
- **28-34-148.** Terms of a license; amendments. (a) Each rural emergency hospital license shall be effective for one year following the date of issuance.
- (b) Each license shall be valid for the licensee and the address specified on the license. When an initial, renewed, or amended license becomes effective, all previous rural emergency hospital licenses granted to licensee at the same address shall become invalid.
- (c) Only one physical location shall be described in each license.
- (d) Any applicant may withdraw the application for a license.
- (e) Any licensee may submit, at any time, a request to close the rural emergency hospital permanently and to surrender the license. Unless notified by the licensee in writing, if a licensee closes a rural emergency hospital and surrenders the license, any state general hospital license or state critical access hospital license that the licensee also holds shall be surrendered to the licensing agency.
- (f) If a rural emergency hospital is closed, any license granted for that rural emergency hospital shall become void.

- (g) Each licensee shall submit a request for an amended license to the licensing agency within 30 days after either of the following:
  - (1) A change of ownership by purchase or by lease; or
  - (2) a change in the name or address.
- (h) If a licensee that also holds a state-issued license as a general hospital or a critical access hospital submits a request for an amended license for a rural emergency hospital, the licensee shall ensure that the amendment to the license does not affect the status of the state-issued license for a general hospital or a critical access hospital. (Authorized by and implementing K.S.A. 2022 Supp. 65-487; effective, T-28-9-29-23, Sept. 29, 2023.)

- (c) Straight flush—a hand consisting of five cards of the same suit in consecutive ranking except for a royal flush as defined above.
- (d) Four-of-a-kind–a hand consisting of four cards of the same rank.
- (e) Full house–a hand consisting of three of a kind and a pair.
- (f) Flush–a hand consisting of five cards of the same suit, not in consecutive order.
- (g) Straight–a hand consisting of five unsuited cards of consecutive rank
- (h) Three-of-a-kind—a hand consisting of three cards of the same rank regardless of suit.
  - (i) Two pair-a hand consisting of two pairs.
- (j) One pair—a hand consisting of two cards of the same rank regardless of suit.

- (k) Dealing procedures for the golden talons shall be as follows:
- (1) Players must make the standard midi-baccarat wager and, if desired, the optional golden talons bet before the dealer reveals any of the cards.
- (2) The dealer will collect and pay standard wagers first, and then the optional golden talons bet of each player before moving to the next player position.
- (l) A commission shall not be charged on winning golden talons bets.
- (m) If offered at the midi-baccarat gaming table, players may also participate in the optional harmony progressive by placing a \$5 wager in the designated area. The harmony progressive wager is considered a side wager based on the player's and banker's hands. The player must place an original midi-baccarat wager to make a harmony progressive wager.

- (n) The harmony progressive will be comprised of a beginning base amount of \$10,000. Nineteen percent of each harmony progressive wager shall be added to the harmony progressive amount. Each time the harmony progressive is awarded it will be replenished to the base amount of \$10,000.
- (o) The current amount of the harmony progressive will be displayed in a manner visible to all players at the gaming table.
- (p) Winning harmony progressive wagers will be paid as follows:

Hand	Win
Four 8's	100% of progressive
Four-of-a-kind	\$5,000
Six 0's	\$1,000
Tie same color	\$100
Any tie	\$10

For a four 8's or four-of-a-kind hand to win a harmony progressive wager, there must be exactly four cards dealt in total. Tie same color means all cards are in the suits of diamonds and/or hearts or all cards are in the suits of clubs and/or spades. All other ties constitute an any tie. All set dollar amount payouts are based on a \$5 wager amount. When a winning harmony progressive hand is dealt, all players that made a harmony progressive wager during that round of play will win the posted prize, except that if the prize is the 100% progressive pool, the pool shall be split evenly among all eligible players. The 5 treasures baccarat bonus offers several optional side bets with separate pay tables. The pay tables shall be posted on the mini-baccarat table.

- (b) Rules for the 5 treasures baccarat bonus bet are as follows:
- (1) Players must make a standard mini-baccarat wager in order to make a 5 treasures baccarat bonus bet;
- (2) 5 treasures baccarat bonus bet limits will be posted at the table and must be made in \$5 increments; and
- (3) 5 treasures baccarat bonus bets must be placed within the designated betting area on the game table.
- (c) There are five optional wagers on the 5 treasures baccarat bonus, as follows:
- (1) Fortune 7 wins if the banker's outcome is a three-card total of seven and pays odds of 40 to 1.
- (2) Golden 8 wins if the player's outcome is a three-card total of eight and pays odds of 25 to 1.
- (3) Heavenly 9 wins if either the banker's outcome or the player's outcome is a three-card total of nine and pays odds of 10 to 1. Heavenly 9 wins if both the banker's outcome and the player's outcome are three-card totals of nine and pays odds of 75 to 1.
- (4) Blazing 7 wins if both the banker's outcome and the player's outcome are two-card totals of seven and pays odds of 50 to 1. Blazing 7 wins if both the banker's outcome and the player's outcome are three-card totals of seven and pays odds of 200 to 1.

- (5) The cover all bonus wins if any one or more of the separate bonus wagers in sections (c)(1), (c)(2), (c)(3) or (c)(4) win. The cover all bonus wager pays odds of 6 to 1. The cover all bonus may be played alone. Players are not required to place a separate bonus wager in order to win the cover all bonus wager.
- (d) Dealing procedures for the 5 treasures baccarat bonus shall be as follows:
- (1) Players must make the standard mini-baccarat wager and, if desired, the optional 5 treasures baccarat bonus bet before the dealer reveals any of the cards.
- (2) The dealer will collect and pay standard wagers first, and then the optional 5 treasures baccarat bonus bet of each player before moving to the next player position.
- (e) A commission shall not be charged on winning 5 treasures baccarat bonus bets.
- (f) The eternal baccarat bonus may be offered for play in the game of mini-baccarat. The eternal baccarat bonus offers several optional side bets with separate pay tables. The pay tables shall be posted on the mini-baccarat table.
- (g) Rules for the eternal baccarat bonus bet are as follows:
- (1) Players must make a standard mini-baccarat wager in order to make an eternal baccarat bonus bet;

- (3) Eternal baccarat bonus bets must be placed within the designated betting area on the game table.
- (h) There are five optional wagers on the eternal baccarat bonus, as follows:
- (1) Sun 7 wins if the banker's outcome is a three-card total of seven and pays odds of 40 to 1.
- (2) Moon 8 wins if the player's outcome is a three-card total of eight and pays odds of 25 to 1.
- (3) Supreme 7 wins if both the banker's outcome and the player's outcome is a three-card total of seven and pays odds of 200 to 1. Supreme 7 also wins if both the banker's outcome and the player's outcome are two-card totals of seven and pays odds of 50 to 1.
- (4) Divine 9 wins if both the banker's outcome and the player's outcome are three-card totals of seven and pays odds of 75 to 1. Divine 9 also wins if both the banker's outcome and the player's outcome are three-card totals of nine and pays odds of 10 to 1.
- (5) The eclipse bonus wins if any one or more of the separate bonus wagers in sections (h)(1), (h)(2), (h)(3) or (h)(4) win. The eclipse bonus wager pays odds of 6 to 1. The eclipse bonus may be played alone. Players are not required to place a separate bonus wager in order to win the eclipse bonus wager.
- (i) Dealing procedures for the eternal baccarat bonus shall be as follows:
- (1) Players must make the standard mini-baccarat wager and, if desired, the optional eternal baccarat bonus bet before the dealer reveals any of the cards.
- (2) The dealer will collect and pay standard wagers first, and then the optional eternal baccarat bonus bet of each player before moving to the next player position.

- **111-501-155.** Midi-baccarat 5 treasures and eternal baccarat bonus bet. (a) The 5 treasures baccarat bonus may be offered for play in the game of midi-baccarat. The 5 treasures baccarat bonus offers several optional side bets with separate pay tables. The pay tables shall be posted on the midi-baccarat table.
- (b) Rules for the 5 treasures baccarat bonus bet are as follows:
- (1) Players must make a standard midi-baccarat wager in order to make a 5 treasures baccarat bonus bet;
- (2) 5 treasures baccarat bonus bet limits will be posted at the table and must be made in \$5 increments; and
- (3) 5 treasures baccarat bonus bets must be placed within the designated betting area on the game table.
- (c) There are five optional wagers on the 5 treasures baccarat bonus, as follows:
- (1) Fortune 7 wins if the banker's outcome is a three-card total of seven and pays odds of 40 to 1.
- (2) Golden 8 wins if the player's outcome is a three-card total of eight and pays odds of 25 to 1.
- (3) Heavenly 9 wins if either the banker's outcome or the player's outcome is a three-card total of nine and pays odds of 10 to 1. Heavenly 9 wins if both the banker's outcome and the player's outcome are three-card totals of nine and pays odds of 75 to 1.
- (4) Blazing 7 wins if both the banker's outcome and the player's outcome are two-card totals of seven and pays odds of 50 to 1. Blazing 7 wins if both the banker's outcome and the player's outcome are three-card totals of seven and pays odds of 200 to 1.
- (5) The cover all bonus wins if any one or more of the separate bonus wagers in sections (c)(1), (c)(2), (c)(3) or (c)(4) win. The cover all bonus wager pays odds of 6 to 1. The cover all bonus may be played alone. Players are not required to place a separate bonus wager in order to win the cover all bonus wager.
- (d) Dealing procedures for the 5 treasures baccarat bonus shall be as follows:
- (1) Players must make the standard midi-baccarat wager and, if desired, the optional 5 treasures baccarat bonus bet before the dealer reveals any of the cards.
- (2) The dealer will collect and pay standard wagers first, and then the optional 5 treasures baccarat bonus bet of each player before moving to the next player position.

- (h) There are five optional wagers on the eternal baccarat bonus, as follows:
- (1) Sun 7 wins if the banker's outcome is a three-card total of seven and pays odds of 40 to 1.
- (2) Moon 8 wins if the player's outcome is a three-card total of eight and pays odds of 25 to 1.
- (3) Supreme 7 wins if both the banker's outcome and the player's outcome is a three-card total of seven and pays odds of 200 to 1. Supreme 7 also wins if both the banker's outcome and the player's outcome are two-card totals of seven and pays odds of 50 to 1.
- (4) Divine 9 wins if both the banker's outcome and the player's outcome are three-card totals of seven and pays odds of 75 to 1. Divine 9 also wins if both the banker's outcome and the player's outcome are three-card totals of nine and pays odds of 10 to 1.
- (5) The eclipse bonus wins if any one or more of the separate bonus wagers in sections (h)(1), (h)(2), (h)(3) or (h)(4) win. The eclipse bonus wager pays odds of 6 to 1. The eclipse bonus may be played alone. Players are not required to place a separate bonus wager in order to win the eclipse bonus wager.
- (i) Dealing procedures for the eternal baccarat bonus shall be as follows:
- (1) Players must make the standard midi-baccarat wager and, if desired, the optional eternal baccarat bonus bet before the dealer reveals any of the cards.
- (2) The dealer will collect and pay standard wagers first, and then the optional eternal baccarat bonus bet of each player before moving to the next player position.
- (j) A commission shall not be charged on winning eternal baccarat bonus bets. (Authorized by K.S.A. 2022 Supp. 74-8710 and K.S.A. 74-8748; implementing K.S.A. 2022 Supp. 74-8710; effective, T-111-6-1-22, May 11, 2022; amended, T-111-7-27-22, July 13, 2022; amended, T-111-9-25-23, Aug. 16, 2023.)
- **111-501-156.** Name of the game; rules and regulations. The Kansas lottery shall conduct a lottery facility game at the Kansas Star Casino in Mulvane, Kansas, entitled "DJ Wild Stud Poker" beginning on or after September 1, 2023.

The rules and regulations for the game of "DJ Wild Stud Poker" are contained in K.A.R. 111-501-156 through 111-501-162, and applicable generic rules are contained in K.A.R. 111-201-1 *et seq.* (Authorized by K.S.A. 2022 Supp. 74-8710 and K.S.A. 74-8748; implementing K.S.A. 2022 Supp. 74-8710; effective, T-111-9-25-23, Aug. 16, 2023.)

**111-501-157. Object of game.** DJ Wild Stud Poker is a poker-based game between the player and the dealer, in which one or more players have multiple wager options. Players are dealt five cards to make the highest ranking poker hand possible. DJ Wild Stud Poker is played with one standard deck of 52 cards plus one joker, the back of which cards shall all be identical in appearance. Each deck of playing cards shall consist of 13 value cards designated as ace, 2, 3, 4, 5, 6, 7, 8, 9, 10, jack, queen, and king in each of the four suits hearts, spades, diamonds, and clubs plus one joker. (Authorized by K.S.A. 2022 Supp. 74-8710 and K.S.A. 74-8748; implementing K.S.A. 2022 Supp. 74-8710; effective, T-111-9-25-23, Aug. 16, 2023.)

- **111-501-158. Definitions.** The following words and terms, when used in the game of DJ Wild Stud Poker shall have the following meanings unless the context clearly indicates otherwise:
- (a) "Ante" or "ante wager" means an initial wager, separate from but equal in amount to the player's blind wager, required to be made prior to any cards being dealt in order to participate in the round of play.
- (b) "Blind" or "blind wager" means an initial wager, separate from but equal in amount to the player's ante, required to be made prior to any cards being dealt in order to participate in the round of play.
- (c) "Fold" means the withdrawal of a player from a round of play by not making a play wager and discarding the player's five cards.
- (d) "Hand" or "poker hand" means the highest ranking five-card hand that can be formed from the five cards dealt to the dealer and the five cards dealt to a player. All players and the dealer may only form their hand from the five cards dealt to each of them.
- (e) "Natural hand" means a player or dealer hand that does not utilize any wild card to form the highest ranking hand.
- (f) "Play wager" means a wager made after five cards have been dealt to each player and the dealer but before the face values of the dealer's five cards are revealed, which wager must be two times the amount of the player's ante wager.
- (g) "Progressive pool" means the set percentage of all progressive wagers made in the game of DJ Wild Stud Poker and any other linked progressive game that accumulates until paid to one or more winners of a progressive wager.
- (h) "Progressive wager" means an optional wager that a player may make prior to any cards being dealt that the player's cards will constitute a three-of-a-kind, straight, flush, full house, four-of-a-kind, straight flush, or a royal flush, with a winning progressive wager being paid in accordance with a posted pay table regardless of the outcome of the player's hand otherwise.
- (i) "Push" means a tie or draw, and occurs if the player's five-card hand and the dealer's five-card hand are of equal rank.
- (j) "Rank" or "ranking" means the relative position of a card or group of cards as set forth in K.A.R. 111-501-159, "DJ Wild Stud Poker hand rankings."
- (k) "Round of play" or "round" means one complete cycle of play during which all players playing at the table have been dealt a hand, have folded or wagered upon it, and have had their wagers paid or collected.
- (l) "Suit" means one of the four categories of cards: club, diamond, heart, or spade, with no suit being higher in rank than another.
- (m) "Trips wager" means an optional wager that a player may make prior to any cards being dealt that the player's best five-card hand will be a three-of-a-kind or better ranking hand, with a winning trips wager being paid in accordance with a posted pay table regardless of the outcome of the player's hand against the dealer's hand.
- (n) "Two-way bad beat wager" means an optional wager that a player may make prior to any cards being dealt

that the player's and the dealer's best five-card hands will be a three-of-a-kind or better ranking hands but their hands do not tie, with a winning two-way bad beat wager being paid in accordance with a posted pay table based upon whichever of the player's or dealer's hands ranks lowest.

(o) "Wild card" means a 2 card or joker card, which card may be substituted for any other card to form a player's or the dealer's highest ranking hand.

(p) "Wild hand" means a player or dealer hand that utilizes one or more wild cards to form the highest ranking hand. (Authorized by K.S.A. 2022 Supp. 74-8710 and K.S.A. 74-8748; implementing K.S.A. 2022 Supp. 74-8710; effective, T-111-9-25-23, Aug. 16, 2023.)

# **111-501-159.** DJ Wild Stud Poker hand rankings. (a) The rank of the cards used in DJ Wild Stud Poker, for the determination of winning hands, in order of highest to lowest rank, shall be: ace, king, queen, jack, 10, 9, 8, 7, 6, 5, 4, 3, and 2. All suits shall be considered equal in rank. Notwithstanding the foregoing, an ace may be used to complete a "straight flush" or a "straight" formed with a 2, 3, 4, and 5. The joker card is wild and has no rank, but it may be substituted for any card value. A 2 card may be used as a 2 value card or as a wild card that substitutes for the rank of any value card.

- (b) The permissible poker hands at the game of DJ Wild Stud Poker, in order of highest to lowest rank, shall be:
- (1) "Five wilds" is a hand consisting of four 2 cards and one joker card;
- (2) "Royal flush" is a hand consisting of an ace, king, queen, jack, and 10 of the same suit;
- (3) "Five-of-a-kind" is a hand consisting of five cards of the same rank, regardless of suit, with five aces being the highest ranking five-of-a-kind and five 3s being the lowest ranking five-of-a-kind hand;
- (4) "Straight flush" is a hand consisting of five cards of the same suit in consecutive ranking, with king, queen, jack, 10 and 9 being the highest ranking five-card straight flush and ace, 2, 3, 4, and 5 being the lowest ranking fivecard straight flush;
- (5) "Four-of-a-kind" is a hand consisting of four cards of the same rank regardless of suit, with four aces being the highest ranking four-of-a-kind and four 2s being the lowest ranking four-of-a-kind;
- (6) "Full house" is a hand consisting of "three-of-a-kind" and a "pair," with three aces and two kings being the highest ranking full house and three 2s and two 3s being the lowest ranking full house;
- (7) "Flush" is a hand consisting of five cards of the same suit, not in consecutive order, with ace, king, queen, jack, and 9 being the highest ranking flush and 2, 3, 4, 5, and 7 being the lowest ranking flush;
- (8) "Straight" is a hand consisting of five unsuited cards of consecutive rank, with an ace, king, queen, jack, and 10 being the highest ranking straight and an ace, 2, 3, 4, and 5 being the lowest ranking straight;
- (9) "Three-of-a-kind" is a hand consisting of three cards of the same rank, with three aces being the highest ranking three-of-a-kind and three 2s being the lowest ranking three-of-a-kind;
- (10) "Two pairs" is a hand consisting of two cards of the same rank and two cards of a different same rank,

- with two aces and two kings being the highest ranking two pair and two 3s and two 2s being the lowest ranking two pair; and
- (11) "One pair" is a hand consisting of two cards of the same rank, with two aces being the highest ranking pair and two 2s being the lowest ranking pair.
- (c) When comparing two hands which are of identical poker rank as described herein as permissible poker hands, or which contain none of the hands authorized in this section, the hand that contains the highest ranking card as provided in (a) above which is not contained in the other hand shall be considered the higher ranking hand. If the hands are of identical rank after the application of this section, the hands shall be considered a push. (Authorized by K.S.A. 2022 Supp. 74-8710 and K.S.A. 74-8748; implementing K.S.A. 2022 Supp. 74-8710; effective, T-111-9-25-23, Aug 16, 2023.)
- **111-501-160.** Wagers. (a) All wagers at DJ Wild Stud Poker shall be made by placing gaming chips or, if applicable, a match play coupon on the appropriate betting area or areas of the table layout. A verbal wager accompanied by cash shall not be accepted.
- (b) All ante, blind, trips, two-way bad beat, and progressive wagers shall be placed prior to the dealer dealing the cards for that round of play. Except for a play wager as provided in K.A.R. 111-501-161, no wager shall be made, increased, or withdrawn after the dealer begins to deal the round of play.
- (c) Upon placing an ante wager and a blind wager, a player may also place a trips wager by placing a wager on the designated betting area of the layout. The outcome of the trips wager shall have no bearing on any other wager made by the player at the game of DJ Wild Stud Poker.
- (d) Upon placing an ante wager and a blind wager, a player may also place a two-way bad beat wager by placing a wager on the designated betting area of the layout. The outcome of the two-way bad beat wager shall have no bearing on any other wager made by the player at the game of DJ Wild Stud Poker.
- (e) Any player who places an ante and a blind wager may also make a progressive wager by placing gaming chips on the progressive wager sensor in front of their betting position prior to the dealer dealing the first card.
- (f) Play wagers shall be made in accordance with the provisions set forth in these rules.
- (g) Only players who are seated at the DJ Wild Stud Poker table may place a wager at the game.
- (h) A player shall not be permitted to wager on more than one player position at a DJ Wild Stud Poker table. (Authorized by K.S.A. 2022 Supp. 74-8710 and K.S.A. 74-8748; implementing K.S.A. 2022 Supp. 74-8710; effective, T-111-9-25-23, Aug. 16, 2023.)
- **111-501-161.** Play. (a) For the start of play, starting with the player farthest to the dealer's left and continuing around the table in a clockwise manner, the dealer shall deal the cards as follows:
- (1) Five card packets are dealt to each player who has placed one or more wagers and to the dealer. All cards dealt to players and the dealer shall be dealt face down.

- (2) After all cards have been dealt to the players and dealer, one additional card shall be dealt face down and placed in the area on the table gaming layout marked "Progressive Joker Replacement." This card shall only be used to determine the result of a progressive wager if a player making a progressive wager has the joker card in the player's hand, in which case the additional card shall replace the joker card.
- (b) After all cards have been dealt, starting with the player farthest to the dealer's left and proceeding in a clockwise manner around the table, the dealer shall ask each player if the player wishes to place a play wager. The player may either fold or place a play wager in an amount equal to two times the amount of the player's ante wager.

(c) If a player places a play wager, the wager shall be placed in the designated play betting area.

- (d) If a player folds, the ante and blind wagers of the player shall be collected, and if the player did not make a trips wager the player's cards will also be collected and the player will not participate in the rest of that round of play. If the player made a trips wager, the dealer shall place the cards of the player face down underneath the player's trips wager pending its resolution at the conclusion later in the round of play.
- (e) Once all players have either placed a play wager or folded, the dealer shall turn all five of the dealer's cards face up, position the cards to form the best possible five-card hand and announce the dealer's hand to the players.
- (f) Starting with the player farthest to the right of the dealer and working counter-clockwise, the dealer shall turn each player's cards face up and compare the dealer's hand to the player's hand. The dealer shall view the cards of each player who has placed a play wager face up and announce the best possible five-card poker hand that can be formed using the player's cards. The wagers of each player shall be resolved one player at a time regardless of outcome.
- (g) If the player's hand is ranked higher than the dealer's hand, the player shall win and the dealer shall pay any ante, blind and play wagers made by the player provided that the blind wager shall not be paid unless the player's winning hand has a rank of straight or higher.
- (h) If the player's hand and the dealer's hand are of equal rank, the player's hand shall be a push. In such case, the dealer shall not collect or pay the player's ante, blind, or play wagers.
- (i) After settling a player's ante, blind, and play wagers, the dealer shall settle any trips wager made by the player by determining whether the player's hand qualifies for a payout in accordance with K.A.R. 111-501-162. A winning trips wager shall be paid without regard to the outcome of any other wager made by the player.
- (j) If the player made a two-way bad beat wager and the player and dealer hands consist of a three-of-a-kind or higher ranking hand and do not tie, the two-way bad beat wager is paid as set forth in K.A.R. 111-501-162. The payout odds shall be based on the rank of the losing hand. If the player made a two-way bad beat wager but the player's hand does not consist of a three-of-a-kind or higher ranking hand, the two-way bad beat wager

- loses and will be collected by the dealer. Two-way bad beat wagers will also lose and be collected by the dealer if both the player and dealer do not have a hand ranking three-of-a-kind or higher. If the dealer's and player's hands are of the same rank of at least three-of-a-kind or higher, the wager shall be a push and the player shall retain the player's wager.
- (k) After settling a player's ante, blind, play, trips and two-way bad beat wagers, the dealer shall settle any progressive wager made by the player by determining whether the player's hand qualifies for a payout in accordance with K.A.R. 111-501-162.
- (l) A player making the progressive wager also qualifies to win an envy bonus. If any player at the table that has made a progressive wager is dealt a Straight Flush or Royal Flush, all other players who made a progressive wager during the same round of play win the envy bonus in accordance with K.A.R. 111-501-162. The player dealt the hand that wins the progressive bonus shall not be paid an envy bonus but shall only be paid the applicable progressive prize.
- (m) The dealer shall pay all envy bonuses at the end of the round of play. If more than one hand triggers an envy bonus, then multiple envy bonuses shall be paid.
- (n) The progressive system is an optional system and is not required to operate the game. If the progressive system is not functional for any reason, the game may still be operated without it. (Authorized by K.S.A. 2022 Supp. 74-8710 and K.S.A. 74-8748; implementing K.S.A. 2022 Supp. 74-8710; effective, T-111-9-25-23, Aug. 16, 2023.)
- **111-501-162.** Payout odds. (a) Each winning ante and play wager shall be paid at odds of 1 to 1.
- (b) Players shall be paid on each winning blind wager at the following payout odds:

Royal flush	50 to 1
Five-of-a-kind	10 to 1
Straight flush	9 to 1
Four-of-a-kind	4 to 1

The payouts listed above do not include the return of the player's original bet.

(e) Players shall be paid on each winning progressive wager in accordance with the following pay table based upon a \$5 progressive wager. For purposes of the progressive wager, no wild cards can be used in the player's hand. If a player has made a progressive wager and the player's hand contains a joker card, that card will be replaced with the additional card dealt during the dealing process:

The payouts listed above do not include the return of the player's original bet and only the three prizes denoted as percentages shall be paid out of the progressive pool.

(f) The progressive pool shall be funded as follows:

- (1) To establish the beginning amount for each of the three progressive prize pools, the casino manager shall initially contribute \$50,000 for the mega progressive pool, \$5,000 for the major progressive pool and \$1,250 for the minor progressive pool. A progressive pool will be replenished in those same amounts each time that progressive prize is awarded; and
- (2) From each progressive wager, 10% shall be added to the mega progressive pool, 8% shall be added to the major progressive pool and 3% shall be added to the minor progressive pool.
- (g) If during the same round of play one or more players are entitled to the same progressive prize pool, the total progressive amount will be split evenly between the one or more progressive winners.
- (h) The following rules regarding irregularities shall apply:
- (1) A card that is found face up in the shoe or the deck while the cards are being dealt shall not be used in the game and shall be placed in the discard rack. If more than one card is found face up in the shoe or the deck during the dealing of the cards, all hands shall be void and the cards shall be reshuffled. Notwithstanding the foregoing, if a card is found face up after each player and the dealer has received his or her five cards, any trips wager shall be settled in accordance with the payout odds set forth above; and
- (2) If an automated card shuffling device is being used and the device jams, stops shuffling during a shuffle, or fails to complete a shuffle cycle, the cards shall be reshuffled.
