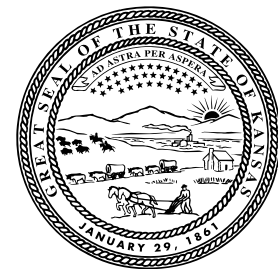

#### Notice of Proposed Phase II Acid Rain Permit

Notice is hereby given that the Kansas Department of Health and Environment (KDHE) is proposing to issue a five-year permit to the Evergy, Inc. – Lawrence Energy Center, PO Box 889, Topeka, KS 66601 pursuant to Title IV (Acid Deposition Control) of the Federal Clean Air Act and implementing regulations found at 40 CFR Parts 72 through 78. The effective date of the permit is from January 1, 2025 through December 31, 2029.

Two (2) utility boiler(s) affected by this permit action, identified as Unit Nos. 4 and 5 in the 40 CFR Part 73 Table 2 are located at 1250 N. 1800 Rd., Lawrence, Doug-

las County, KS 66049, operated by Evergy, Inc., PO Box 889, Topeka, KS 66601, would receive Sulfur Dioxide (SO<sub>2</sub>) allowances 948 and 3752 (respectively,) for each year from 2025 through 2029. Each allowance authorizes the utility boiler to emit up to one ton of sulfur dioxide during or after each of the years specified above. Evergy, Inc. – Lawrence Energy Center proposes to comply with the Acid Rain Program emission requirements by holding enough allowances to cover all sulfur dioxide emissions. Issuance of this permit would not affect the responsibility of Evergy, Inc. – Lawrence Energy Center to meet all other existing local, state, and federal sulfur dioxide emission requirements.

Acid Rain Program Nitrogen Oxides (NO<sub>x</sub>) emission requirement language: Lawrence Energy Center’s Unit Nos. 4 and 5 are Phase II tangentially fired boilers and will comply with the standard British thermal unit (Btu)-weighted annual average emission rate of 0.40 lb NO<sub>x</sub>/MMBtu heat input.

Notice is hereby given that the Kansas Department of Health and Environment (KDHE) is soliciting comments regarding the amendment of a previously issued air quality construction permit and a Class II Operating Permit Modification. QLX, LLC, PO Box 6, Bazine KS 67516, owns and operates the stationary source located at RR #1, Box 92, Bazine, Ness County, KS 67516. Certain requirements were found to no longer be appropriate in the construction permit dated August 10, 1999. These requirements are being modified. QLX, LLC has applied for a permit modification of the facility's Class II operating permit in accordance with the provisions of K.A.R. 28-19-544. Emissions of volatile organic compounds (VOC), particulate matter (PM), particulate matter with less than or equal to 10 microns in aerodynamic diameter (PM<sub>10</sub>), particulate matter with less than or equal to 2.5 microns in aerodynamic diameter (PM<sub>2.5</sub>), carbon monoxide (CO), oxides of nitrogen (NO<sub>x</sub>), oxides of sulfur (SO<sub>x</sub>), and hazardous air pollutants (HAPs) were evaluated during the permit review process. The purpose of a Class II permit is to limit the potential-to-emit for these pollutants to below major source thresholds.

In accordance with Kansas Administrative Regulations 28-16-57a through 63, 28-18-1 through 17, 28-18a-1 through 31 and 33, 28-16-150 through 154, 28-46-7, and the authority vested with the state by the administrator of the U.S. Environmental Protection Agency, various draft water pollution control documents (permits, notices to revoke and reissue, notices to terminate) have been prepared and/or permit applications have been received for discharges to waters of the United States and the state of Kansas for the class of discharges described below.

Synopsis: A person must register as a lobbyist in Kansas if they expend more than \$1,000.00 for lobbying on behalf of a client, regardless of whether the legislature is in session. The process for a nonprofit organization to register a lobbyist is no different than the process for any other person under K.S.A. 46-265. EdChoice does not fall within the narrow K.S.A. 46-237(h) exception for entities established to serve, inform, educate, and strengthen legislatures in all states.

In response to your May 7, 2024, email request, this opinion is provided by the Kansas Governmental Ethics Commission ("Commission"), concerning application of the state governmental ethics law, K.S.A. 46-214a *et seq.* The Commission's jurisdiction is limited to applicability of this law. This opinion, provided pursuant to K.S.A. 46-254, does not address whether some other statutory system, common law theory, agency rule, or regulation applies to your inquiry.

#### Factual Statement

EdChoice is a 501(c)(3) nonprofit organization that promotes state programs to expand school choice policies. EdChoice offers an "annual educational program" to which all Kansas legislators may be invited to. Legislators may participate in the program by offering their opinions on educational choice policies and how such policies have impacted Kansas. EdChoice would like to pay for the invited Kansas legislators to attend its annual program. This would include covering travel, lodging, food, and beverage for the legislators.

#### Questions

1. If EdChoice exceeds the \$1,000.00 registration threshold within K.S.A. 46-222(a)(3), is EdChoice required to register a lobbyist even if the legislature is no longer in session when the expenditures are made?
2. If EdChoice is required to register a lobbyist, do any additional steps need to be taken to register a nonprofit organization as opposed to registering any other person?

3. Would EdChoice be permitted to pay for Kansas legislators' travel, lodging, food, and beverage under the K.S.A. 46-237(h) exception?

#### Analysis and Opinion

1. If EdChoice exceeds the \$1,000.00 registration threshold within K.S.A. 46-222(a)(3), is EdChoice required to register a lobbyist even if the legislature is no longer in session when the expenditures are made?

K.S.A. 46-222(a) lists four actions that could render a person a "lobbyist" under Kansas law. Relevant here, K.S.A. 46-222(a)(3) states that a lobbyist includes "any person who makes expenditures in an aggregate amount of \$1,000 or more, exclusive of personal travel and subsistence expenses, in any calendar year for lobbying[.]" K.S.A. 46-223 defines "person" to mean "an individual, proprietorship, partnership, limited partnership, association, trust, estate, business trust, group, or corporation, whether or not operated for profit, or a governmental agency unit, or subdivision." Finally, K.S.A. 46-265 requires every lobbyist in Kansas to register with the Secretary of State.

EdChoice, as a nonprofit organization, is a "person" under K.S.A. 46-223. The first question posed is whether EdChoice expending over \$1,000.00 on lobbying outside of the duration of the regular session changes whether it must register a lobbyist.

The test of K.S.A. 46-222(a)(3) is indifferent to whether the Legislature is in session or not. The only deciding factor is whether the \$1,000.00 expense threshold for lobbying is exceeded. The question, as posed, indicates that \$1,000.00 would be expended for lobbying. Consequently, if EdChoice exceeds the \$1,000.00 registration threshold within K.S.A. 46-222(a)(3), then it must register as a lobbyist with the Kansas Secretary of State.

2. If EdChoice is required to register a lobbyist, do any additional steps need to be taken to register a nonprofit organization as opposed to registering any other person?

Additionally, a nonprofit organization does not register any differently than any other person under Kansas law. EdChoice must select an individual representative to register as a lobbyist in Kansas and that representative would list EdChoice as the "person compensating the lobbyist for lobbying" pursuant to K.S.A. 46-265(a).

3. Would EdChoice be permitted to pay for Kansas legislators' travel, lodging, food, and beverage under the K.S.A. 46-237(h) exception?

Based on the additional information submitted by EdChoice, it does not appear that EdChoice was established to serve, inform, educate, and strengthen legislatures in all states. Instead, EdChoice was established to advocate for certain education policies. "Serving, informing, educating and strengthening" is specific and narrow language and a national, nonprofit, nonpartisan organization seeking the K.S.A. 46-237(h) exception must have been established for all four reasons.

For the foregoing reasons, the Commission finds that EdChoice does not meet the K.S.A. 46-237(h) exception.

So, Kansas legislators may not be offered, nor may they accept the payment of their travel and lodging to the Ed-Choice annual program.

This notice exceeds the 60-day notice requirement of the pending public hearing and shall constitute the beginning of the public comment period for the purpose of receiving written public comments on the proposed rules and regulations. A summary of the proposed regulations and their economic impact is as follows: (Note: Statements indicating that a regulation is “not anticipated to have any economic impact” are intended to indicate that no economic impact on the State Corporation Commission, other state agencies, state employees, or the general public has been identified.)

**K.A.R. 82-4-1 – Definitions.**

The proposed amendments to this regulation, which defines the terms used in “Article 4 – Motor Carriers of Persons and Property,” includes updating the definition of “out-of-service” and “OOS” to include the latest version of the North American Standard Out-of-Service Criteria. The proposed amendments are not anticipated to have an economic impact.

**K.A.R. 82-4-3b – Procedures for transportation workplace drug and alcohol testing programs.**

This regulation adopts portions of the Federal Motor Carrier Safety Administration (“FMCSA”) regulations (49 C.F.R. Part 40) governing the procedures for workplace drug and alcohol testing programs relevant to motor carriers. The proposed amendments also include edits to reflect minor grammar and form corrections as

well as the most recent updates to FMCSA regulations. The proposed amendments are not anticipated to have an economic impact.

**K.A.R. 82-4-3c – Testing for controlled substances and alcohol use.**

This regulation adopts portions of the FMCSA regulations (49 C.F.R. Part 382) governing the procedures involved in testing for controlled substances and alcohol use. The amendments include edits to reflect minor grammar and form corrections and the most recent updates to FMCSA regulations. The proposed amendments are not anticipated to have an economic impact.

**K.A.R. 82-4-3i – Parts and accessories necessary for safe operation.**

This regulation adopts portions of the FMCSA regulations (49 C.F.R. Part 393) governing the parts and accessories necessary for the safe operation of commercial motor vehicles. The proposed amendments to this regulation include edits to reflect minor grammar and form corrections, deletions and additions required to reflect the most recent updates to FMCSA regulations. The proposed amendments are not anticipated to have an economic impact.

**K.A.R. 82-4-30a – Applications for interstate registration.**

This existing regulation adopts relevant portions of the FMCSA regulations (49 C.F.R. Part 367) and Unified Carrier Registration (UCR) Act (49 U.S.C. 14504a) which together establish the rules and registration fees owed by carriers based in Kansas that operate interstate. The proposed changes to this regulation allows the Kansas Corporation Commission and Kansas Highway Patrol to enforce the updated fee schedule approved for use in 2024. The proposed amendments are anticipated to have an economic impact in that fees have increased by \$9 for most carriers.

(1) The first drawing conducted shall be from among the entrants in the \$1 Holiday Surprise, game number 428, drawing. The cash prize awarded to the first entrant selected in the first drawing shall be \$1,000.

(2) The second drawing conducted shall be from among the entrants in the \$2 Happy Holly Days, game number 429, drawing. The cash prize awarded to the first entrant selected in the second drawing shall be \$5,000.

(3) The third drawing conducted shall be from among the entrants in the \$5 Full of \$500s, game number 430, drawing. The cash prize awarded to the first entrant selected in the third drawing shall be \$10,000.

(4) The fourth drawing conducted shall be from among the entrants in the \$10 Peppermint Payout Multiplier,



game number 431, drawing. The cash prize awarded to the first entrant selected in the fourth drawing shall be \$15,000.

(5) The fifth drawing conducted shall be from among the entrants in the \$20 Gifts of Gold, game number 432, drawing. The cash prize awarded to the first entrant selected in the fifth drawing shall be \$20,000.

(e) There is no limit on the number of tickets a player may enter. A player may win more than one drawing.

(f) The procedures set forth in K.A.R. 111-18-5 for contacting a winner and the claiming of the prize shall be followed. The Kansas Lottery is not responsible for electronic malfunction or player error.

(g) By entering the promotion, entrant agrees to Play-On terms and conditions.

(h) Winners are responsible for any state and federal taxes.

(i) Rules applicable to this promotion are contained in K.A.R. 111-19-184 and K.A.R. 111-18-1 *et seq.* (Authorized by K.S.A. 2023 Supp. 74-8710; implementing K.S.A. 2023 Supp. 74-8710 and K.S.A. 74-8720; effective, T-111-8-9-24, July 10, 2024.)

## Article 22.—GENERIC eINSTANTS RULES

**111-22-1. Definitions.** (a) “Account” means a player’s account in the Kansas lottery’s player loyalty program defined in K.A.R. 111-18-1 *et seq.* and any credentials, email, login information, or password associated with that account.

(b) “Click” means to manually interact with an interactive graphical element through the use of a mouse, touchscreen, or other input device.

(c) “eInstant game” means an online instant lottery game in which a ticket is purchased by a player from the Kansas lottery and the player can determine if they win a prize by clicking on each part of the play area or a “reveal all” icon and comparing the revealed play symbols with those specified as winners in the published game rules for that online instant lottery game.

(d) “Executive director” means the executive director of the Kansas lottery, or the person designated by the executive director.

(e) “Expiration date” means the last date an eInstant game ticket may be validated and eligible to win a prize.

(f) “Lottery security” means the Kansas lottery security officer or a certified enforcement officer designated by the executive director or the person designated by the executive director.

(g) “Multi-ticket” means an eInstant lottery game in which more than one ticket of the same denomination may be purchased per game.

(h) “Play area” is the portion of the eInstant game where the play or game symbols appear.

(i) “Play symbols” are the numbers, letters, symbols, or pictures displayed in the play area of each eInstant game and which determine if the ticket purchaser is entitled to a prize according to the published game rules for that eInstant game.

(j) “Pool” or “prize pool” means a certain number of eInstant game tickets, such number determined by the published rules for that eInstant game, used to seed prizes randomly across the game to determine winning and

non-winning tickets. The size of each pool shall be determined by the published rules for that eInstant game.

(k) “Serial number” means a unique number appearing on the front of each eInstant game which is used to identify and track the player’s purchase and which may be used to validate winning tickets.

(l) “Wallet” means an online service which tracks a player’s deposits, purchases, and prize payments. A player may make deposits, purchases, and withdrawals from the wallet according to the terms and conditions of the player loyalty program defined in K.A.R. 111-18-1 *et seq.* (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-8-9-24, July 10, 2024.)

**111-22-2. Manner of selection of winners.** Winners of an eInstant game are determined by the matching or specified alignment of the play symbols on a valid eInstant game ticket in accordance with the published rules for each eInstant game. (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-8-9-24, July 10, 2024.)

**111-22-3. Deadline for claiming prizes.** (a) A winning eInstant game ticket with a prize of \$599 or less shall automatically be paid to a player’s wallet. A winning eInstant game ticket with a prize in excess of \$599 shall not be paid until a player completes a claim form provided by the lottery as described in K.A.R. 111-22-8.

(b) All eInstant game tickets shall expire 180 days after purchase unless otherwise provided by the executive director. If a winner does not submit a claim form before a winning eInstant game ticket’s expiration date, the ticket shall be invalid and ineligible for any prize.

(c) For the purposes of this regulation, all tickets purchased concurrently within a multi-ticket eInstant game shall be considered a single eInstant game ticket. (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-8-9-24, July 10, 2024.)

**111-22-4. Disclosure of winners.** The city of residence of the winner of any claimed prize may be used in any lottery promotional campaign. (Authorized by K.S.A. 2023 Supp. 74-8710; implementing K.S.A. 2023 Supp. 74-8710 and K.S.A. 74-8720; effective, T-111-8-9-24, July 10, 2024.)

**111-22-5. Ticket sales.** (a) The sales price of any eInstant game ticket shall be \$1.00 unless a different price is established by game rules adopted by the Kansas lottery commission for a specific eInstant game.

(b) eInstant game tickets shall be sold only by the lottery.

(c) eInstant game tickets shall not be sold to any person under the age of 18. The seller of any eInstant game ticket may require the purchaser to prove their age. (Authorized by K.S.A. 74-8710; implementing K.S.A. 2023 Supp. 74-8710 and K.S.A. 74-8718; effective, T-111-8-9-24, July 10, 2024.)

**111-22-6. Determination of prize winners.** (a) Each eInstant game ticket shall be drawn from a pool at the time of purchase.

(b) If the play symbols meet the requirements of the rules of the game, the player wins the prize designated by the rules of the game.

(continued)

(c) Only play symbols and captions, if any, and serial numbers are used for determination of entitlement to prizes. Other numbers, symbols, icons, and the like, or any other portion of the game shall not be usable or playable to win prizes.

(d) In all events, the determination of eInstant prize winners shall be subject to the general ticket validation requirements set forth in K.A.R. 111-22-7 and the requirements set forth in the rules of each eInstant game.

(e) No particular prize may be paid more than once.

(f) All prizes must be claimed on or before an eInstant game ticket's expiration date. Any prize not claimed by the expiration date shall be forfeited.

(g) The right of any person to a prize shall not be assignable, except that payment of any prize may be paid to the estate of a deceased prize winner or to a person designated pursuant to an appropriate judicial order. (Authorized by K.S.A. 2023 Supp. 74-8710; implementing K.S.A. 2023 Supp. 74-8710 and K.S.A. 74-8720; effective, T-111-8-9-24, July 10, 2024.)

**111-22-7. Ticket validation requirements.** (a) Each eInstant game ticket shall be validated prior to payment of a prize.

(b) In addition to meeting all other requirements in these rules and the specific rules for each eInstant game, the following validation requirements shall apply to all eInstant game tickets:

(1) The ticket must have been issued by the Kansas lottery in an authorized manner and must not be counterfeit in whole or in part.

(2) The ticket must not be altered or tampered with in any manner.

(3) The ticket must be identified and accepted by the Kansas lottery's ticket validation system as a valid winning ticket.

(4) The serial number of an apparent winning ticket shall appear in the Kansas lottery's official computer database of ticket validation numbers of winning tickets and a ticket with that ticket validation number shall not have been paid previously.

(5) The ticket must pass all additional confidential validation tests of the Kansas lottery.

(c) Any ticket not passing all of the validation checks stated in this section is void and ineligible for any prize. In the event that a defective ticket is purchased, the only responsibility or liability of the Kansas lottery shall be for reimbursement of the cost of the defective ticket.

(d) Subject to certain conditions, prize payment may be made for an eInstant game ticket that is not claimed by applicable deadlines. The following conditions may constitute exceptions to the validation requirements previously identified in paragraphs (a), (b) and (c):

(1) Consideration will only be given to claimants following an attempt to claim a prize prior to the ticket's expiration.

(2) A record of the attempt must be contained within the Kansas lottery's website or mobile application identifying the date and time of the validation attempt, the serial number of the ticket, and the prize amount.

(3) The claimant must complete the claim process within 5 days of the expiration date, be authorized to purchase an eInstant lottery game ticket, be eligible to

claim the prize, and be the rightful recipient of the prize claimed as determined by the lottery.

(4) Lottery security will conduct an investigation to determine if the claim is or is not supported by the investigation and will submit a report with a recommendation to that effect to the executive director of the lottery.

(5) The final decision on whether a prize will be paid shall be made by the executive director. (Authorized by K.S.A. 2023 Supp. 74-8710; implementing K.S.A. 2023 Supp. 74-8710 and K.S.A. 74-8720; effective, T-111-8-9-24, July 10, 2024.)

**111-22-8. Payment of prizes.** The procedures for payment of monetary prizes to the winners of each eInstant game are as follows:

(a) The executive director or his designee shall award the designated prize to the person entitled to a prize pursuant to K.A.R. 111-22-6 as soon as it is determined that all laws, regulations, and rules have been adhered to.

(b) eInstant lottery game prizes of \$599.00 or less shall be automatically paid to the winner's wallet.

(c) eInstant lottery game prizes in excess of \$599.00 shall be paid to the winner's wallet after the winner has completed a claim form provided by the Kansas lottery. The winner shall be required to provide additional information including a complete social security number, bank account and routing numbers, or other information reasonably required to verify the winner's identity and pay the prize if that information was not provided during account registration in the lottery's player loyalty program defined in K.A.R. 111-18-1 *et seq.*

(d) All prizes are subject to deductions, withholding, and setoff provided by law. (Authorized by K.S.A. 2023 Supp. 74-8710; implementing K.S.A. 2023 Supp. 74-8710 and K.S.A. 74-8720; effective, T-111-8-9-24, July 10, 2024.)

**111-22-9. Responsibility for account security.** (a) The Kansas lottery is not responsible for lost or stolen accounts. The Kansas lottery is not responsible for any deposited funds or claimed or unclaimed prizes in any lost or stolen account.

(b) Players may be required to prove their identity to the satisfaction of the Kansas lottery prior to having their access to a lost or stolen account restored. (Authorized by K.S.A. 2023 Supp. 74-8710; implementing K.S.A. 2023 Supp. 74-8710 and K.S.A. 74-8720; effective, T-111-8-9-24, July 10, 2024.)

**111-22-10. Disputes.** In the event of a dispute between a ticket purchaser and the Kansas lottery concerning any eInstant game, the executive director shall determine the facts underlying the dispute and pay a prize to the purchaser of a valid winning ticket. If the investigation of the dispute is inconclusive, the executive director may, solely at his or her option, reimburse the ticket purchaser for the cost of the disputed ticket. If the investigation of the dispute determines facts in favor of the Kansas lottery, the executive director shall deny any claim relating to the dispute. (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-8-9-24, July 10, 2024.)

**111-22-11. Termination of the game.** At any time, the executive director may announce a termination date for an eInstant game, or announce a last date for sale of

tickets in a game. The executive director may make any such announcement for any reason permitted by the Kansas lottery act, including but not limited to: protecting the integrity of the game subject to the announcement; compliance with any other law, rule and regulation, or other legal obligation; and the orderly operation of the lottery. (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-8-9-24, July 10, 2024.)

**111-22-12. Payment of prizes to persons under 18 years of age.** (a) In the event a person entitled to a prize for any winning ticket by means of a gift or inheritance is under 18 years of age, the lottery may require:

(1) The claim form for all prizes of \$25 or more to be signed by the parent or legal guardian of the minor; and,

(2) Payment by delivery of a warrant, payable to the order of the minor, to a parent or legal guardian of the minor.

(b) Where the prize exceeds \$5,000, payment shall be made for the benefit of the minor to the court appointed guardian or conservator, or as may otherwise be ordered by the court, upon receipt of written verification of the appointment of the legal guardian or conservator satisfactory to the executive director. (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-8-9-24, July 10, 2024.)

**111-22-13. Invalidation of tickets.** No eInstant game ticket shall be valid after its expiration date. (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-8-9-24, July 10, 2024.)

**Article 23.—SPECIFIC eINSTANTS RULES**

**111-23-1. “Silver Fox Hunt” eInstant ticket lottery game.** (a) The Kansas lottery may conduct an eInstant lottery game entitled “Silver Fox Hunt.” The rules for this game are contained in K.A.R. 111-22-1 *et seq.* and 111-23-1.

(b) The “play symbols” for this game are as follows:

Symbol of Microfilm
Symbol of a Red Button
Symbol of a Sonar Scope
Symbol of a Recorder
Symbol of a Camera
Symbol of Binoculars
Symbol of a Watch
Symbol of a Bonus Envelope

Prize and bonus prize symbols shall be randomly assigned at the time of purchase and may appear in any combination that equals any prize described in paragraph (j).

(c) For this game, four play symbols and one prize symbol shall appear in each of the ticket play areas purchased by the player. There shall be six ticket areas. Each ticket area shall be dim or empty until the player purchases that ticket.

(d) Each pool shall consist of 10,000,000 tickets.  
 (e) The price of tickets for this game shall be \$1.00, \$2.00, and \$5.00.

(f) “Silver Fox Hunt” is a multi-ticket symbol match game with a bonus play feature. The player may select between one and six tickets to play at the time of purchase. Each ticket shall be the same denomination. The player may purchase the selected number of tickets by pressing the “Play” icon. Each purchased ticket is presented in the form of a single line. The player may reveal the play and prize symbols by manually clicking on each play and prize symbol, or by clicking on the “Reveal All” icon. If the player matches three symbols on any ticket, the player wins the prize amount for that ticket. If the player matches four symbols on any ticket, the player wins the prize for each ticket they purchased in that game. If a player matches four “Bonus Envelope” symbols, the player will play a bonus game. In the bonus game, the player has three Agent Silver Fox characters. The player will click on each character, which will progress across the bonus play area. Each character may land on a prize amount or be impeded by a shadow and not land on a prize. The player will win the total cumulative amount attained by all of the characters in the bonus game. Each bonus game will have at least one character land on a prize.

(g) The total number of prizes and bonus prizes in any winning game may be variable but shall equal any prize described in paragraph (j).

(h) Approximately 30,000,000 tickets shall be ordered initially for this eInstant game. Additional ticket orders shall have the same prize structure, the same number of prizes per prize pool of 10,000,000 tickets, and the same odds as were contained in the initial ticket order.

(i) Each prize shall be calculated by multiplying the prize multiplier by the ticket cost:
