This notice is to advertise the Letting of the Garden City Western Railway (GCWR) track rehabilitation project as shown in Kansas Grant Agreement No. 246-24

051242811RA-0523-01. This work is to be done on the GCWR West Branch Line near Garden City, Kansas.

Bidders will need to carefully examine the drawings and specifications of the bid package and make themselves familiar with the work. All work performed must comply with FRA Class 2 track standards and regulations.

The bidder shall deliver the required bonds and certificates of insurance (COI) to the GCWR with the executed contracts. A sample copy of the Contractor Agreement will be included in the bid package.

All requisite permits, applicable taxes, and other ancillary costs are to be calculated and included in the contractor’s bid pricing.

Notice is hereby given that the Kansas Department of Health and Environment (KDHE) is soliciting comments regarding a proposed air quality construction permit. Emerald Transformer PPM, LLC has applied for an air quality construction permit in accordance with the provisions of K.A.R. 28-19-300. Emissions of volatile organic compounds (VOC), particulate matter (PM), particulate matter with less than or equal to 10 microns in aerodynamic diameter (PM10), particulate matter with less than or equal to 2.5 microns in aerodynamic diameter (PM2.5), carbon monoxide (CO), oxides of nitrogen (NOx), oxides of sulfur (SOx), and hazardous air pollutants (HAPs) were evaluated during the permit review process.

Emerald Transformer PPM, LLC, 2474 N. US-169 Hwy., Coffeyville, KS 67337, owns and operates a Polychlorinated Biphenyl (PCB) commercial storage and disposal facility located at 2474 N. US-169 Hwy., Coffeyville, Montgomery County, KS 67337, at which a boiler will be added, and reclassification of the facility's status will change after removing the federal limits on HAPs and VOCs.

The wells shall be cased and cemented such that 1) injected or withdrawn fluid does not cause deterioration of the water quality of fresh and/or usable water zones, 2) the loss of fresh and/or usable water due to downward migration is prevented, and 3) the release of injected or withdrawn fluids into an unauthorized zone is prevented.
