Notice of Requested Architectural Services

Notice is hereby given of the commencement of the selection process for architectural services for the phased Heckert Wells Hall and Yates Hall renovations and addition at Pittsburg State University (PSU). Heckert Wells Hall and Yates Hall share a connecting atrium and, together, serve as PSU's core for STEM education. To reinforce connection and access to programs throughout the complex, the project includes adding space to expand the existing, shared single-story atrium to serve all primary levels of the existing complex.

Yates Hall is a 40,698 GSF facility built in 1963. It remains in average condition thanks to replacement of windows, doors, HVAC systems, switchgear, and lighting, but its mathematics and physics labs, classrooms, hallways, and several restrooms remain in near original condition. Heckert Wells Hall is a 65,393 GSF facility built in 1984 after its predecessor was suddenly condemned. It now has a range of deferred maintenance items of its own. Replacement of HVAC systems and switchgear occurred a decade ago, but the chemistry and biology labs, hallways, and restrooms remain in near original condition.

PSU has a program to redesign and upgrade these crucial facilities as a STEM eco-system to expand STEM education, make the facility more functional and attractive to today's students, and serve current needs for teaching and learning within this academic core. The School of Science and Mathematics provides basic support for the ecosystem that also includes the health sciences and engineering technology degree in addition to PSU's National Institute for Materials Advancement (NIMA) and National Center for Semiconductor Research and Testing (NCSRT).

PSU wishes to engage a professional design consultant for the entire project for delivery in one or more construction phases utilizing design-bid-build. Each phase will be bid independently based upon availability of funding. The initial \$6,000,000 phase of construction is anticipated to focus on the general chemistry lab for completion between June and December 2026. The estimated total project cost of the entire program is \$53,000,000.

Notice is hereby given that the Kansas Department of Health and Environment (KDHE) is soliciting comments regarding a proposed air quality construction permit. Walmart Supercenter #382 has applied for an air quality construction permit in accordance with the provisions of K.A.R. 28-19-300. Emissions of volatile organic compounds (VOC), particulate matter (PM), PM with less than or equal to 10 microns in aerodynamic diameter (PM $_{10}$), PM with less than or equal to 2.5 microns in aerodynamic diameter (PM $_{2.5}$), carbon monoxide (CO), oxides of nitrogen (NO $_{\rm X}$), oxides of sulfur (SO $_{\rm X}$), and hazardous air pollutants (HAPs) were evaluated during the permit review process.

Evergy, Inc. – McNew Energy Center (Evergy) has applied for an air quality construction permit in accordance with the provisions of K.A.R. 28-19-300 to construct a new electric power generation facility to be located near S. McNew Rd. and E. Morgan Ave., Hutchinson, Reno County, KS 67501. Emissions of oxides of nitrogen (NO_x), carbon monoxide (CO), volatile organic compounds (VOC), particulate matter (PM), PM with less than or equal to 10 microns in aerodynamic diameter (PM₁₀), PM with less than or equal to 2.5 microns in aerodynamic diameter (PM_{2.5}), oxides of sulfur (SO_x), sulfuric acid mist (H₂SO₄), lead (Pb), hazardous air pollutants (HAPs), and greenhouse gases (GHGs) as carbon dioxide equivalent (CO₂e) were evaluated during the permit review process.

The permit is to be issued in accordance with the provisions of K.A.R. 28-19-350, Prevention of Significant Deterioration (PSD) which adopt the federal standards, procedures and requirements of 40 CFR 52.21 by reference. These air quality regulations apply to major stationary emission sources located in areas designated as "attainment" or "unclassifiable" under the federal Clean Air Act (CAA). Attainment/unclassifiable areas are areas where the air quality meets or is better than the national ambient air quality standards (NAAQS).

The PSD regulations require evaluation of emission reduction techniques to identify the Best Available Control Technology (BACT) for each regulated pollutant, including GHGs, for which the emission rate exceeds the PSD significant level. The purpose of BACT is to affect the maximum degree of reduction achievable, taking into account energy, environmental and economic impacts for each pollutant under review. Evaluation of the estimated emissions for the proposed electric power generation facility indicates that the emission rates of NO_x, CO, PM, PM₁₀, PM_{2.5}, VOC, H₂SO₄, and GHGs all exceed the PSD significance levels. Evergy conducted the required BACT analyses. KDHE has reviewed Evergy's BACT analyses and concurs with its findings.

An ambient air quality impact analysis was performed on the air emissions of NO_x , CO, PM_{10} , and $PM_{2.5}$ from the proposed project. Likewise, a Modeled Emission Rates for Precursors (MERPS) analysis was performed for both ozone (O_3) and secondary $PM_{2.5}$ for this project. The analyses demonstrated no significant impact on ambient air quality for NO_x , CO, PM_{10} , $PM_{2.5}$, and O_3 .

On January 17, 2025, this project established the minor source baseline dates for NO_2 , $PM_{2.5}$, and PM_{10} . This project is the first PSD increment consuming source in Reno County. Maximum increment consumption from the PSD increment modeling results were included in the permit summary document.

No assessment of visibility impacts at a Class I area was performed by Evergy because there are no Federal Class I areas located within 300 kilometers (km) of the proposed project. Evergy did a visibility impact analysis for two local Class II areas, i.e., Carey Park (located 2.99 km away) and Fairgrounds Park (located 8.35 km away). KDHE also added a visibility analysis for the Hutchinson Regional Airport (located 8.79 km away). Results of the analyses showed that the proposed project will have no adverse impact on visibility of Federal Class I areas.

A public comment period has been established to allow citizens the opportunity to express any concerns they may have about this proposed permitting action. Notice of Hearing on Proposed Administrative Regulation

A public hearing will be conducted at 10:00 a.m. Tuesday, February 3, 2026, in Room 560 of the Landon State Office Building, 900 SW Jackson, Topeka, Kansas, to consider the adoption of a proposed administrative regulation of the Board of Emergency Medical Services on a permanent basis. The hearing will also be held via GoToMeeting conferencing. Remote access information will be provided upon request to any person wishing to observe, participate in, or listen to the hearing. Request for access must be submitted prior to 4:30 p.m. Thursday, January 29, 2026, via email to joseph.house@ks.gov.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed amendments to the regulation. All interested parties may submit written comments prior to the hearing to the Board of Emergency Medical Services, Landon State Office Building, 900 SW Jackson, Room 1031, Topeka, KS 66612 or by email to joseph.house@ks.gov. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed amendments to the regulation during the public hearing. In order to provide all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentations to five minutes.

K.A.R. 109-11-8 is being amended to eliminate a seven-day requirement for notification of successful course completion prior to challenging the state's cognitive knowledge examination.
