Pursuant to K.S.A. 82a-1041(b) and K.A.R. 5-19-3, notice is hereby provided that the Chief Engineer of the Kansas Department of Agriculture, Division of Water Resources (Chief Engineer) will hold an in-person hearing at 9:00 a.m. (Central Time) January 13, 2026, at the Wichita County Fairgrounds, 506 E. M St., Leoti, Kansas, to consider the proposed Wichita County Local Enhanced Management Area (LEMA) Plan submitted to the Chief Engineer by Western Kansas Groundwater Management District Number 1.

The hearing will be consolidated as provided for in K.A.R. 5-19-3 and will consider whether one or more of the circumstances specified in subsection (a) through (d) of K.S.A. 82a-1036 exist within the proposed boundaries of the proposed LEMA, whether the public interest of K.S.A. 82a-1020 requires that one or more corrective control provisions be adopted, and whether the geographic boundaries of the proposed LEMA are reasonable, and will also consider the LEMA's proposed corrective controls, the likelihood that the LEMA plan will achieve the stated goals, and any other matters the Chief Engineer deems necessary.

Anyone may submit written or oral statements to be included in the record of the hearing. Oral statements will be accepted only at the public hearing. Written statements may be submitted at the hearing, in advance of the hearing, or following the hearing. The deadline for the submission of written statements following the hearing will be January 27, 2026. #### **Notice of Available Grant Funding**

Grant funds are available from the Federal Sexual Assault Services Grant Program (SASP) for calendar year 2026. - Proficiency in the analysis, design, construction, and maintenance of load bearing structures that reinforce
  or counteract loads in dams, bridges, buildings, and other structures.
- Proficiency specifying, examining, and inspecting materials to be used for the construction of complex structures including, dams, bridges, pre-manufactured restrooms, shelters, shower buildings, cabins, and other load bearing structures.

#### **Notice of Water Quality Certification**

The Kansas Department of Health and Environment (KDHE) has drafted a water quality certification per Section 401 of the Clean Water Act (CWA) requested by the United States Army Corps of Engineers (USACE) CWA Section 404 on June 18, 2025, to meet CFR 121. et., seq. On June 18, 2025, the USACE also published in the Federal Register its proposal to reissue 56 existing nationwide permits (NWPs) as documented in the public notice found at <a href="https://www.nwk.usace.army.mil/Media/Public-Notices">https://www.nwk.usace.army.mil/Media/Public-Notices</a>. Many are not applicable to Kansas except for activities including yet not limited to construction of bridges, road ways, stream bank stabilization meeting the USACE threshold, utility lines, oil and gas pipelines, small developments not exceeding the USACE threshold, wetlands meeting the USACE threshold, certain agricultural practices not under the General Permit 40, pond and lake cleaning activities not included in the General Permit 41, renewable energy projects, stormwater outfalls, wildlife habitat restoration, etc. (a full list can be found at the aforementioned public notice link). There are no changes from the previous 401 WQC issued in 2022. All of the current 2021 NWPs expire March 14, 2026. The reissued/modified 2026 NWPs and associated 401 WQC would expire in 2031.

Summaries of the proposed regulations and their economic impact follow.

The Kansas Secretary of State is entirely fee-funded, with no State General Fund appropriations supporting its operations. Every filing and service provided by the Secretary of State has an associated fee authorized by statute. Following the successful replacement of a 40-year-old IT infrastructure, the agency is implementing the first major overhaul of its fee structure in 15 years.

As a result, the proposed changes repeal dozens of outdated fees and reduce many other fees. Fees for forming new LLCs and LLPs, for PEO filings, and for biennial reports have been significantly lowered. Fees for paper filings — when e-filing is available — have been marginally increased to reflect increased labor processing costs and to encourage the use of e-filing.

These new, amended and revoked regulations impose no economic burdens on governmental agencies or units, persons subject to the proposed rules and regulations, and the general public as fees are already required and are generally being decreased.

#### **Amended Regulations**

- 7-16-1: Information and Services fee: Hundreds of fees are addressed in this amended regulation. Most are reduced; paper-filing fees are slightly higher; fees for outdated filings and services are eliminated; and a new fee is imposed on agencies that file regulations.
- 7-16-2: Technology Communication fee: Dozens of fees are addressed in this amended regulation. Most remain set at the statutory maximum of \$5 per filing, and fees associated with outdated filings and services are eliminated.
- 7-17-4: Uniform Commercial Code: Fees for new bulk services have been added.

- 7-34-2: Corporations: Fees for unnecessary services and those provided automatically through the new IT system have been eliminated.

**92-52-12. Standards for vision examinations.** (a) Definitions. For the purposes of this regulation, the following definitions shall apply:

- (1) "Director" means director of vehicles, division of vehicles of the department of revenue.
- (2) "New driver" means a person who has never held a driver's license or permit in any jurisdiction, and who has never unlawfully operated a motor vehicle in any jurisdiction.
- (b)(1) Each driver's license applicant shall be deemed to have a "good driving record" pursuant to K.S.A. 8-295, and amendments thereto, if the applicant:
- (A) Is a new driver; or
- (B) during the previous three years, has not been:
- (i) Involved in a motor vehicle accident as the driver of a motor vehicle;
- (ii) convicted of any moving violation as defined in K.A.R. 92-52-9;
- (iii) placed on diversion on a charge of a moving violation; or
- (iv) subject to adverse administrative action resulting in suspension, revocation, restriction, denial, cancellation or non-renewal of a driver's license or permit.
- (2) In determining whether each applicant has a good driving record, consideration shall not be given to the applicant's previous failure to meet the 20/60 acuity standard of K.S.A. 8-295, and amendments thereto.
- (c) Criteria to determine whether each applicant "can safely operate a vehicle," as that term is used in K.S.A. 8-295, and amendments thereto, shall include:
- (1) A form prescribed by the director and completed by the applicant's ophthalmologist or optometrist reporting the applicant's static visual acuity, visual fields, diagnosis of visual condition and prognosis, and recommendations to the need of an annual vision exam; and
- (2) an actual test of the applicant's driving ability by an examiner employed by the director at a time and place arranged by the director. Each test shall be performed by an examiner who has training and experience in testing a visually impaired driver. No applicant shall be permitted to take a driving test if the examiner has cause to believe that allowing the applicant to drive creates an unreasonable risk to any person's safety. Before a driving test will be administered, each applicant:
- (A) Shall comply with the requirement specified in paragraph (c)(1); and

(B) may be required to secure a determination by the Kansas medical advisory board that there is no reason to believe the applicant's eyesight would preclude the applicant from safely operating a vehicle. The requirement to secure this determination shall be imposed at the director's discretion. The applicant may be required to submit to additional tests that the director or the Kansas medical advisory board deem necessary to make a determination. #### **Article 35.—RADIATION**

**28-35-189a.** Advance notification of transport of nuclear waste. (a) Before the transport of any nuclear waste outside the confines of the licensee's facility or any other place of use or storage, or before the delivery of any nuclear waste to a carrier for transport, each licensee shall provide advance notification of the transport to the governor or the governor's designee of each state through which the waste will be transported. For the purpose of this regulation, "nuclear waste" shall mean any large quantity of source material, by-product material, or special nuclear material required to be in a type B package while transported to, through, or across state boundaries to a disposal site, or to a collection point for transport to a disposal site.

- (b) Each advance notification required by this regulation shall contain the following information:
- (1) The name, address, and telephone number of the shipper, carrier, and receiver of the shipment;
- (2) a description of the nuclear waste contained in the shipment as required by regulation of the U.S. department of transportation 49 C.F.R. 172.202 and 172.203(d), as in effect on January 26, 2023, which are hereby adopted by reference;
- (3) the point of origin of the shipment and the seven-day period during which departure of the shipment is estimated to occur;
- (4) the seven-day period during which arrival of the shipment at state boundaries is estimated to occur;
- (5) the destination of the shipment and the seven-day period during which arrival of the shipment is estimated to occur; and
- (6) a point of contact specified by the licensee with a telephone number for current shipment information.
- (c) The notification required by this regulation shall be made in writing to the office of each appropriate governor or the governor's designee and to the Kansas department of health and environment. A notification delivered by mail shall be postmarked at least seven days before the beginning of the seven-day period during which departure of the shipment is estimated to occur. A notification delivered by messenger shall reach the office of each governor or the governor's designee at least four days before the beginning of the seven-day period during which departure of the shipment is estimated to occur. A copy of the notification shall be retained by the licensee for one year.
- (d) The licensee shall notify each appropriate governor or the governor's designee and the Kansas department of health and environment of any changes to the schedule information provided pursuant to this regulation. The notification shall be by telephone to a responsible individual in the office of each appropriate governor or to the governor's designee. The licensee shall maintain for one year a record of the name of the individual contacted.
- (e) Each licensee who cancels a nuclear waste shipment for which advance notification has been sent shall send a cancellation notice to the governor or the governor's designee of each appropriate state and to the Kansas department of health and environment. A copy of the notice shall be retained by the licensee for one year.

(f) When making advanced notifications, each licensee shall use the current name and mailing address of each governor or governor's designee and each Indian tribal official or tribal official's designee that is available on a list provided by request from the director, division of materials safety, security, state, and tribal programs as specified in 10 C.F.R. 73.37(b)(2), as in effect on December 14, 2022, the title and address of which are hereby adopted by reference. (Authorized by and implementing K.S.A. 48-1607; effective, T-86-37, Dec. 11, 1985; effective May 1, 1986; amended Dec. 26, 2025.)

**28-35-221b.** Appendix A; determination of  $A_1$ ,  $A_2$ , and B quantities. The provisions of 10 C.F.R. part 71, appendix A, as in effect on January 1, 2021, are hereby adopted by reference, with the changes specified in this regulation.

Personnel monitoring.** (a) The licensee or registrant shall not permit any individual to act as a radiographer or a radiographer's assistant unless, at all times during radiographic operations, each individual wears on the trunk of the body a personnel-monitoring device (PMD) as specified in K.A.R. 28-35-217a, a direct reading dosimeter, and an alarming ratemeter. At permanent radiographic installations where other appropriate alarming or warning devices are in routine use and during radiographic operations using radiation machines, the use of an alarming ratemeter shall not be required.
- (1) Each pocket ion-chamber dosimeter shall have a range from zero to 200 mrem and shall be recharged at the start of each work shift. Electronic personal dosimeters may be used in place of only pocket ion-chamber dosimeters.
- (2) Each PMD shall be assigned to and worn by only one individual.
- (3) Each PMD that requires replacement shall be replaced at least monthly.
- (4) After replacement, each PMD shall be returned to the supplier for processing within 14 calendar days after the end of the monitoring period, or as soon as practicable. In circumstances that make it impossible to return each PMD within 14 calendar days, these circumstances shall be documented in writing and available for review by the department.
- (b) Direct reading dosimeters, including pocket ion-chamber dosimeters and electronic personal dosimeters, shall be read and the exposures shall be recorded at the beginning and end of each work shift and records shall be maintained for three years.
- (c) All pocket ion-chamber dosimeters and electronic personal dosimeters shall be checked at least each 12 months for the proper response to and the accurate measurement of radiation and records shall be maintained for three years. An acceptable reading on each dosimeter shall be within plus or minus 30 percent of the true radiation exposure.
- (d) If an individual's pocket ion-chamber dosimeter is found to be off-scale or if an electronic personal

dosimeter reads greater than 200 mrem, and the possibility of radiation exposure cannot be ruled out as the cause, the individual's PMD that requires processing shall be sent for processing and evaluation within 24 hours. For personnel dosimeters that do not require processing, evaluation of the dosimeter shall be started within 24 hours. In addition, the individual shall not resume any work associated with the use of sources of radiation until a determination of the amount of that individual's radiation exposure is made. This determination shall be made by the radiation safety officer or the radiation safety officer's designee. The results of this determination shall be included in the records required in subsection (g).

- (e) If an individual's PMD is lost or damaged, the individual shall cease work immediately until a replacement PMD is provided and the exposure is calculated for the time period from issuance to loss or damage of the PMD. The results of the calculated exposure and the time period during which the PMD was lost or damaged shall be included in the records required in subsection (g).
- (f) Each licensee or registrant shall ensure that each alarming ratemeter meets the following requirements:
- (1) The alarming ratemeter is checked to ensure that the alarm functions properly before using at the start of each shift.
- (2) The alarming ratemeter is set to give an alarm signal at a preset dose rate of 500 mrem per hour, with an accuracy of plus or minus 20 percent of the true radiation dose rate.
- (3) The alarming ratemeter requires a special means to change the preset alarm function.
- (4) The alarming ratemeter is calibrated at least each 12 months for the accurate measurement of radiation.
- (g) Each licensee or registrant shall maintain the following exposure records:
- (1) Direct reading dosimeter readings and yearly operability checks for three years after the record is made;
- (2) alarm ratemeter calibrations for three years after the record is made;
- (3) PMD results until the department terminates the license; and
- (4) exposure estimates as a result of any direct reading dosimeter that reads off-scale or any lost or damaged personnel-monitoring equipment until the department terminates the license. Film badges shall be replaced at least monthly, and other personnel-monitoring devices that require replacement shall be replaced at least quarterly. All personnel dosimeters shall be evaluated at least quarterly or promptly after replacement, whichever is more frequent.
- (b) Each licensee shall provide bioassay services to individuals using licensed or registered material in subsurface tracer studies if required by the license.


