### Notice of Proposed Kansas Air Quality Class I Operating Permit Renewal

Notice is hereby given that the Kansas Department of Health and Environment (KDHE) is soliciting comments regarding a proposed air quality operating permit. Occidental Chemical Corporation has applied for a Class I operating permit renewal in accordance with the provisions of K.A.R. 28-19-510 et al. The purpose of a Class I permit is to identify the sources and types of regulated air pollutants emitted from the facility; the emission limitations, standards and requirements applicable to each source; and the monitoring, record keeping and reporting requirements applicable to each source as of the effective date of permit issuance.

Occidental Chemical Corporation, PO Box 12283, Wichita, KS 67277, owns and operates a chemical manufacturing facility in Wichita. The facility's major air emission sources are a bag hopper, a receiver filter, an absorber, three boilers, and a gas turbine. Other sources of regulated pollutants include storage tanks, process vents, refrigeration units, cell room seal pots, maintenance activities, maintenance and process wastewater, and equipment leaks located at 6200 S. Ridge Rd., Wichita, Sedgwick County, KS 67215. The facility requires a Class I Air Emission Source Operating Permit due to the following pollutants evaluated Carbon Monoxide (CO), Nitrogen Oxides (NO<sub>x</sub>), Particular matter less than or equal to 10 microns (PM<sub>10</sub>), and Hazardous Air Pollutants (HAPs) total emissions and individual HAPs emissions for Carbon Tetrachloride, Chloroform, Hydrochloric acid, Methyl Chloride, and Methylene Chloride.

A copy of the proposed permit, permit application, all supporting documentation, and all information relied upon during the permit application review process are available for public review during normal business hours of 8:00 a.m. to 5:00 p.m. at the KDHE, Bureau of Air (BOA), 1000 SW Jackson, Suite 310, Topeka, KS 66612-1366 and at the South Central District Office, 300 W. Douglas, Suite 700, Wichita, KS 67202. To obtain or review the proposed permit and supporting documentation, contact Donald Dyster Jr. at the central office of KDHE at 785-291-3271, or Joshua Webb at the South Central District Office at 316-337-6020. The standard departmental cost will be assessed for any copies requested. The proposed permit, accompanied with supporting information, is available, free of charge, at the KDHE BOA Public Notice website at <https://www.kdhe.ks.gov/413/Public-Notices>.

Please direct written comments or questions regarding the proposed permit to Donald Dyster Jr., KDHE, BOA, 1000 SW Jackson, Suite 310, Topeka, KS 66612-1366. In order to be considered in formulating a final permit decision, written comments must be received no later than 12:00 p.m. Monday, February 23, 2026.

A person may request a public hearing be held on the proposed permit. The request for a public hearing shall be in writing and set forth the basis for the request. The written request must be submitted to Donald Dyster Jr., KDHE BOA, 1000 SW Jackson, Suite 310, Topeka, KS 66612-1366, no later than 12:00 p.m. Monday, February 23, 2026, in order for the Secretary of Health and Environment to consider the request.

The United States Environmental Protection Agency (USEPA) has a 45-day review period, which will start concurrently with the public comment period, within which to object to the proposed permit. If the USEPA has not objected in writing to the issuance of the permit within the 45-day review period, any person may petition the administrator of the USEPA to review the permit. The 60-day public petition period will directly follow the USEPA 45-day review period.

Any such petition shall be based only on objections to the permit that were raised with reasonable specificity during the public comment period provided for in this notice, unless the petitioner demonstrates that it was impracticable to raise such objections within such period, or unless the grounds for such objection arose after such period. This notice supersedes the January 15, 2026 notice and includes the addition of updated language on the reserve capacity and updates to the point in time served. The comment period has been extended one week to accommodate these updates.

The Kansas Department for Aging and Disability Services (KDADS) is amending the following Kansas Medicaid 1915(c) Waiver: Brain Injury (BI).

The proposed amendment covers the following:

- I. Waiver Administration:
  - A. The state has separated the ADRC and the Assessing Entity into two separate contracts to mitigate conflict of interest.
  - B. The state is no longer contracting with local non-State entities.
- II. Reserve Capacity:
  - A. The state has updated the reserve capacity language, adjusted for two purposes, and added a third purpose:

### State of Disaster Emergency Proclamation

By virtue of the authority vested in me by the Kansas Emergency Management Act, Chapter 48, Article 9, of the Kansas Statutes Annotated, to meet the inherent dangers of disasters to which the State and its citizens have been exposed, and upon advice of the State Adjutant General as the Director of the Division of Emergency Management, I hereby proclaim a State of Disaster Emergency as follows:

#### **NATURE OF THE DISASTER**

Fire danger is high across the state due to low humidity, dry fuels, and gusty winds exceeding 60 mph. These conditions are causing visibility issues for drivers, resulting in multiple overturned semis, road closures, and isolated wildland fires. The State Emergency Operations Center has been partially activated to enhance coordination among emergency support partners and expedite resources to local jurisdictions.

#### **DATE THAT DISASTER AFFECTED THE AREA**

December 18-19, 2025

#### **AREA AFFECTED BY THE DISASTER**

Russell County

I hereby proclaim, direct and order the Adjutant General of the State of Kansas to activate the disaster response and recovery portions of the Kansas Response Plan and to utilize all available resources of the state to cope with the disaster as necessary. The Adjutant General shall coordinate local and inter-jurisdictional disaster plans applicable to the political subdivisions of areas affected by this Proclamation.

Any or all of the powers conferred upon the Governor by the Kansas Emergency Management Act may be delegated to the Adjutant General as deemed appropriate during this period of proclaimed State of Disaster Emergency. This may be delegated by written orders, or oral orders subsequently reduced to writing with reference to this Proclamation.

I hereby suspend the provisions of any regulatory statute prescribing the procedures for conduct of state business, or the order or rules and regulations of any state agency which implements such statute, if strict compliance with the provisions of such statutes, order or rule and regulation would prevent, hinder, or delay in any way necessary action in coping with the disaster as set forth in KSA 48-925(c)(1).

This Proclamation shall be filed promptly with the Division of Emergency Management, the Office of the Secretary of State and each city clerk or county clerk, as appropriate, in the area to which this Proclamation applies. Further dissemination of this Proclamation shall occur by means calculated to bring its contents to the attention of the general public.

(b) Any nongame species in need of conservation taken during established trapping seasons, authorized commercial wildlife operations, fishing by hook and line, baitfish seining, or other lawful activity shall not be unlawfully taken if immediately released.

(c) Any nongame species in need of conservation in possession before the effective date of this regulation and not prohibited by any previous regulation of the department or national listings may be retained in possession if either of the following conditions is met:

(1) An application of affidavit to that effect has been filed with and approved by the secretary within six months of the species listing as a nongame species in need of conservation in the state of Kansas that states the circumstances of how the species came into the applicant's possession; or

(2) Possession of the animal has been previously approved by the department. ## **Article 25.—WILDLIFE SEASONS; BAG, CREEL, POSSESSION, SIZE, AND LENGTH LIMITS**

**115-25-8. Elk; open season, bag limit, and permits.** (a) The unit designations in this regulation shall have the meanings specified in K.A.R. 115-4-6b, except that the area of Fort Riley, subunit 2a, shall not be included as part of Republican-Tuttle, unit 2.

(b) The open seasons for the taking of elk shall be as follows:

(1) The archery season dates and units shall be as follows:

(A) Statewide, except Fort Riley, subunit 2a, and unit 1: the Monday after the second Saturday in September through the last day of the same year.

(B) Fort Riley, subunit 2a: the first day of September through the last day of September.

(2) The firearm season dates and units shall be as follows:

(A) Statewide, except Fort Riley, subunit 2a, and unit 1: the first day of August through the last day of August; the Wednesday after Thanksgiving through the second following Sunday; and the first day of January through the 15th day of March.

(B) Fort Riley, subunit 2a:

(i) First segment: the first day of October through the last day of October.

(ii) Second segment: the first day of November through the last day of November.

(iii) Third segment: the first day of December through the last day of December.

(iv) Fourth segment: the first day of January through the last day of January.

(3) The muzzleloader season dates and units shall be as follows:

(A) Statewide, except Fort Riley, subunit 2a, and unit 1: the first day of September through the last day of September.

(B) Fort Riley, subunit 2a: the first day of September through the last day of September.

(c) A limited-quota either-sex elk permit shall be valid during any season using equipment authorized for that season. Fifteen either-sex elk permits shall be authorized.

(d) A limited-quota antlerless-only elk permit shall be valid during any season using equipment authorized for that season, except that a limited-quota antlerless-only elk permit shall be valid on Fort Riley, subunit 2a, only as follows:

(1) A first-segment antlerless-only elk permit shall be valid on Fort Riley, subunit 2a, only during the first segment. Eight first-segment antlerless-only elk permits shall be authorized.

(2) A second-segment antlerless-only elk permit shall be valid on Fort Riley, subunit 2a, only during the second segment. Eight second-segment antlerless-only elk permits shall be authorized.

(3) A third-segment antlerless-only elk permit shall be valid on Fort Riley, subunit 2a, only during the third segment. Eight third-segment antlerless-only elk permits shall be authorized.

(4) All antlerless-only elk permits shall be valid on Fort Riley, subunit 2a, during the September archery and muzzleloader seasons, and the January firearm season.

(e) The bag limit shall be one elk as specified on the permit issued to the permittee.

(f) An unlimited number of hunt-on-your-own-land antlerless-only elk permits and either-sex elk permits shall be authorized in units 2 and 3. A hunt-on-your-own-land permit shall be valid during any open season. The bag limit for each hunt-on-your-own-land elk permit shall be one elk as specified on the permit.

(g) An unlimited number of over-the-counter antlerless-only elk permits and either-sex elk permits shall be authorized in unit 3.

(h) Permits are not valid after March 15 following the date of issuance. ## Article 45.—WILDLIFE AND PARKS COMMISSION

**115-45-1. Wildlife and parks commission; draft rules and regulations.** (a) Any member of the Kansas wildlife and parks commission may make a motion to place on the agenda of a subsequent meeting a topic for discussion by the commission. Upon a majority vote in favor of the motion, the topic shall be placed on the agenda of the identified meeting. Upon a majority vote, the commission may direct the secretary to prepare a draft rule or regulation addressing the topic.

(b) If the commission votes to place on the agenda a topic for discussion, the commission shall provide the public the opportunity to comment on the draft rule or regulation at no less than two consecutive commission meetings.

(c) Following at least two consecutive commission meetings during which the public was permitted to comment on the draft rule or regulation, a majority of the commission may vote to direct the secretary to initiate the regulatory promulgation process pursuant to the Kansas rules and regulations filing act, K.S.A. 77-415, et seq. (Authorized by K.S.A. 2025 Supp. 32-807; implementing K.S.A. 2025 Supp. 32-805; effective Feb. 6, 2026.)
