The Department of Social and Rehabilitation Services will be implementing a parental fee program February 1 that will include parents of children participating in the Autism Home and Community Based Services Waiver, the Physical Disability (PD) Waiver and the Traumatic Brain (TBI) Waiver. These waivers serve individuals under the age of 18 and as part of the eligibility determination process allow financial eligibility to be determined without considering the parent's income.
The parental fee program was created for waivers to increase fairness and shared responsibility by charging families who have the means a portion of the cost of services provided to their minor children. SRS was authorized to utilized parental fee programs by the 2002 Legislature through a proviso to the omnibus appropriations bill. The fee assessed the family is based on the parents' income according to a sliding scale. Persons caring for a child with a disability who would not have to pay a fee include:

- Grandparents and other relatives
- Adoptive parents and foster parents
- Biological parents with incomes below 200 percent of the federal poverty level (FPL)
In certain circumstances (i.e., the loss of income or an increase in family size), SRS may waive or reduce a family's parent fee. Parents must make an official request for the fee to be waived.

## Notice to Private Activity Bond Applicants

Applications for allocation of 2010 Private Activity Bond (PAB) authority are now being accepted for qualified uses, as defined by the Internal Revenue Code of 1986, and amendments thereto.

The state of Kansas is projected to receive \$273,775,000 of federal authority for the issuance of PABs in calendar year 2010. Historically, the primary uses of this federal authority have included "qualified small issue bonds" used for construction and equipping of manufacturing facilities and beginning farmer programs; "exempt facility bonds" used by for-profit entities providing a public benefit, i.e., certain waste treatment facilities, qualified residential rental facilities, etc.; and "qualified mortgage bonds" issued to benefit first-time homebuyers. Allocations awarded by the Secretary of Commerce are subject to the provisions of K.S.A. 74-5060 et seq. and the limitations of the state volume cap.

Fees associated with PAB application and issuance are as follows:
(1) Application fee-A nonrefundable fee must accompany the application before the request can be processed. The application fee is determined as follows:

- $\$ 250$ for allocation requests up to $\$ 5,000,000$
- $\$ 500$ for allocation requests from $\$ 5,000,001$ to \$10,000,000
- \$1,000 for allocation requests from $\$ 10,000,001$ and above
(2) Issuance fee-An issuance fee for allocation amounts utilized, other than "Qualified Mortgage bonds" issued, shall be due and payable to the Kansas Department of Commerce at bond closing. Issuance fees shall be determined as follows:

Issuance fees shall be remitted within 30 days of bond closing. Checks for both the application and issuance fees for non-housing issues should be made payable to the Kansas Department of Commerce Bond Fee Fund. Checks for the issuance fees for housing activities should be made out to the State Housing Trust Fund.

Proposed changes listed below will be discussed at the public hearings:

1. Housing-If the value of the home is less than the cost of rehabilitation, do we want that to become a part of our walk away policy? This would then be true no matter the source of the additional funds. Example: The value of the home is $\$ 30,000$; the cost to bring the home to livability standard is $\$ 35,000$. We can spend $\$ 20,000$ in CDBG funds, $\$ 11,000$ in Weatherization, and $\$ 4,000$ in additional source of funds. Should we continue with the rehabilitation or walk away?
2. KAN STEP-Move the KAN STEP application round to November or December of the previous year instead of April.
3. Economic Development-Reduce the match requirement for projects utilizing more than $\$ 500,000$ of CDBG funds from $\$ 1$ of matching funds for every $\$ 1$ of CDBG funds to only $\$ 0.50$ of matching funds per $\$ 1$ of CDBG funds.

## 106 KA-1675-01 <br> Statewide

This project is to investigate and prepare reports for underwater bridge inspections in accordance with FHWA-DP-90-1 within calendar year 2010. The project has 21 locations, which includes four Missouri River crossings. The consultant will need to augment the underwater diving inspections with side-scan radar technology. The consultant also will be an "on-call" consultant for additional underwater inspections through 2014 as warranted by flood events.
It is KDOT's policy to use the following criteria as the basis for selection of the consulting engineering firm:

1. Size and professional qualifications;
2. experience of staff;
3. location of firm with respect to proposed project;
4. work load of firm; and
5. firm's performance record.

The proposed amendment will increase the fees paid by such institutions to the statutory maximums allowed by the authorizing statute, K.S.A. 2008 Supp. 74-32,181.

There is no anticipated economic impact on the board, as its duties will not expand with the promulgation of the amendment to this regulation. However, with the enhanced revenues that this regulatory change will bring about, KBOR will be better positioned to address and handle the increased workload. There is no anticipated economic impact upon other governmental agencies or entities, or private citizens. There will be an economic impact upon those private and out-of-state post-secondary educational institutions to which the Act applies.

Part I of the permit will allow Clean Harbors PPM, LLC to receive hazardous waste in both bulk and containers
from off-site generators to store a total of 107,800 gallons of hazardous waste in 196055 -gallon containers in the " A " Building. The materials stored at the facility will include corrosive, toxic and listed hazardous wastes. Container storage areas complies with 40 CFR Part 264 Subpart I, Subpart CC and Part 270 requirements for container storage areas. Emergency equipment is available at the facility and appropriate warning signs are posted on the perimeter fences. The EPA portion (Part II) of the joint permit will address the requirements of HSWA.

## Temporary Administrative Regulations

## Article 1.-REGISTRATION, RENEWAL, AND EXAMINATION

130-1-2. Registration renewal. Each person applying for annual renewal of registration shall provide the following to the board:
(a) The applicant's full legal name and date of birth;
(b) the applicant's residential, business, and mailing addresses;
(c) the applicant's residential and business telephone numbers;
(d) the applicant's electronic mail address;
(e) proof that the applicant has obtained at least 16 credit hours of approved continuing education;
(f) complete answers to all questions regarding conduct that might be grounds for denying an application for registration or imposing a disciplinary sanction against a registered home inspector;
(g) documentation from an insurer authorized to do business in Kansas stating that the applicant is insured by a policy of liability insurance in the amount required by K.S.A. $58-4509$, and amendments thereto;
(h) documentation from an insurer or financial institution establishing that the applicant is financially responsible as required by K.S.A. $58-4509$, and amendments thereto;
(i) the renewal fee specified in K.A.R. 130-2-1; and
(j) a declaration signed by the applicant under penalty of perjury under Kansas law stating that all information submitted is true and correct. (Authorized by K.S.A. 2008 Supp. 58-4504, as amended by L. 2009, Ch. 118, $\S 3$; implementing K.S.A. 2008 Supp. 58-4509, as amended by L. 2009, Ch. 118, §6; effective, T-130-1-4-10, Jan. 4, 2010.)

130-1-3. Examination. (a) To be approved by the board, each examination required for registration shall meet the following requirements:
(1) Test the applicant's knowledge of and proficiency in methods of inspection, residential building systems, report writing, and professional practices; and
(2) be psychometrically sound as evidenced by documented evaluation of the examination by an independent organization.
(b) Each examination shall be administered at a location that is under the control of either the examination owner or an entity that has agreed by contract to administer the examination. Each examination shall be proc-
tored according to written policies and procedures that ensure the security and integrity of the examination.
(c) Each applicant shall determine, before taking an examination, whether both the examination and the entity proctoring the examination have been approved by the board.
(d) Each applicant shall pay all examination fees directly to the examination owner or administrator.
(e) Successful completion of the examination by an applicant shall mean that the applicant meets one of the following requirements:
(1) Achieved a scaled score of at least 500 on a range of 200 to 800 on the national home inspection exam offered by the examination board of professional home inspectors;
(2) achieved a raw score of $70 \%$ on the examination offered by the national association of home inspectors, inc.; or
(3) on or before July 1, 2008, received official notice of passing the examination offered by the American society of home inspectors, inc. (Authorized by K.S.A. 2008 Supp. $58-4504$, as amended by L. 2009, Ch. 118, $\S 3$; implementing K.S.A. 2008 Supp. 58-4509, as amended by L. 2009, Ch. 118, §6; effective, T-130-1-4-10, Jan. 4, 2010.)

## Article 3.-EDUCATION PROGRAMS

130-3-1. Approval of education providers. (a) Each application packet submitted by an education provider shall include sufficient documentation to establish that all of the requirements of this regulation have been met.
(b) The course of study of each educational program shall include at least 80 hours of instruction in the following topics:
(1) Structural systems, including the following:
(A) Foundations, basements, and drainage;
(B) interior walls, windows, doors, stairways, ceilings, and floors;
(C) exterior walls, windows, doors, and stairways;
(D) exterior coatings, claddings, and glazing;
(E) roof structure, coverings, penetration, drainage, and attics;
(F) porches, decks, driveways, and walkways;
(G) railings and assistive devices; and
$(\mathrm{H})$ thermal insulation, air penetration, and moisture barriers;
(2) environmental heating, cooling, and ventilation devices, controls, and distribution systems, including the following:
(A) Solid, liquid, and gas fuel heating systems;
(B) electrical heating and cooling systems; and
(C) chimneys, ductwork, vents, fans, flues, and dryer vents;
(3) plumbing systems, controls, and drain, vent, water, and gas components;
(4) waste and sewage systems, but not including private waste systems;
(5) water supply systems and components, but not including private water supplies;
(6) electrical systems, controls, and components for heating, ventilation, and air conditioning;
(7) electrical systems, controls, and components for lighting and home appliance power;
(8) (A) Primary electrical service from the masthead to the main panel, which is also known as the electrical service entrance; and
(B) electrical panels, branch electrical circuits, connected devices, and fixtures;
(9) the Kansas home inspection laws and regulations;
(10) the Kansas code of ethics specified in K.A.R. 130-4-1 and the standards of practice specified in K.A.R. 130-4-2;
(11) home inspection documents, forms, and contracts; and
(12) report writing and the legal ramifications of report content.
(c) Instruction shall be on-site, except that an educational program may include as many as three field training experiences of no more than four hours each. Field training shall not include distance learning or any other type of instruction in a virtual classroom.
(d) Each instructor shall meet at least one of the following requirements:
(1) Have experience practicing as a home inspector for at least five of the seven years immediately before becoming an instructor;
(2) have experience teaching the subject matter now being taught for at least five of the seven years immediately before becoming an instructor in the program;
(3) have attained at least 12 credit hours in the subject being taught and have practiced in a field related to the subject being taught for at least 12 of the 24 months immediately before becoming an instructor;
(4) have successfully completed a postsecondary educational program in the subject being taught and have practiced in a field related to the subject matter being taught for at least 12 of the 24 months immediately before becoming an instructor; or
(5) have experience working in a field related to the subject being taught at least 1,000 hours each year for at least five of the seven years immediately before becoming an instructor.
(e) Each educational provider shall require 100 percent attendance during the course of study instruction.
(f) Each educational provider shall require successful completion of at least one comprehensive examination on the topics in the course of study.
(g) The provider of each educational program shall furnish a certificate or other official document verifying successful completion of the program to each student who has successfully completed the program. (Authorized by and implementing K.S.A. 2008 Supp. 58-4504, as amended by L. 2009, Ch. 118, §3; effective, T-130-1-4-10, Jan. 4, 2010.)

## Article 4.-CODE OF ETHICS AND STANDARDS OF PRACTICE

130-4-1. Code of ethics. Each registrant shall conduct each home inspection in accordance with the Kansas home inspectors registration board's "code of ethics," as approved on April 17, 2009 and hereby adopted by reference. (Authorized by and implementing K.S.A. 2008 Supp. 58-4504, as amended by L. 2009, Ch. 118, §3; effective, T-130-1-4-10, Jan. 4, 2010.)

130-4-2. Standards of practice. Each registrant shall conduct each home inspection in accordance with the Kansas home inspectors registration board's "home inspection standards of practice," as approved on September 17, 2009 and hereby adopted by reference. (Authorized by and implementing K.S.A. 2008 Supp. 58-4504, as amended by L. 2009, Ch. 118, §3; effective, T-130-1-4-10, Jan. 4, 2010.)
