# State of Kansas Governmental Ethics Commission 

Opinion No. 2011-01

Written March 23, 2011, to Eric Rucker, Assistant Secretary of State, Topeka.

This opinion is in response to your letter of March 4, 2011, in which you request an opinion concerning Kansas Secretary of State Kris Kobach's ability to receive an honorarium for the presentation of a lecture sponsored by the KU School of Business.

We note at the outset that the Commission's jurisdiction in this case is limited to K.S.A. 46-215 et seq. Thus, whether some other statutory system, common law theory or agency rule and regulation applies to your inquiry is not covered by this opinion.

## Factual Statement:

Your letter states that on October 20, 2010, the KU School of Business invited Kris Kobach to serve as a speaker for the Spring 2011, J.A. Vickers, Sr. and Robert F. Vickers, Sr. Memorial Lecture. The school was requesting Mr. Kobach's insights as the result of his service as a White House Fellow and as Counsel to the United States Attorney General. The letter to Mr. Kobach indicated that they would like Mr. Kobach to discuss economic development for Kansas and, in a subsequent telephone conversation, also requested Mr. Kobach address immigration policy making. At the time of the invitation, Mr. Kobach was a Professor of Law at the UMKC School of Law. The KU School of Business will provide a cash honorarium to Mr. Kobach should he present this lecture. You ask for this opinion as Assistant Secretary of State to Mr. Kobach.

## Question:

Based upon the facts presented to the Kansas Governmental Ethics Commission, the question you ask is whether Mr. Kobach, now serving as Kansas Secretary of State, can receive this honorarium for presentation of a lecture for the KU School of Business as well as the acceptance of future honoraria under similar circumstances?
Opinion:
K.S.A. 46-237(f) states, "No state officer or employee shall accept any payment of honoraria for any speaking engagement except that a member of the state legislature or a part-time officer or employee of the executive branch of government shall be allowed to receive reimbursement in the preparation for and the making of a presentation at a speaking engagement in an amount fixed by the Commission prior to the acceptance of the speaking engagement. Nothing in this section shall be construed to prohibit the reimbursement of state officers and employees for reasonable expenses incurred in attending seminars, conferences and other speaking engagements."

Secretary of State Kris Kobach is a state officer pursuant to K.S.A. 46-221. The letter from the University of Kansas School of Business inviting Mr. Kobach to speak indicates the University would pay Mr. Kobach an honorarium of $\$ 10,000$. Pursuant to K.S.A. 46-237(f), Secretary of State Kobach would be prohibited from accepting this honorarium.

## Notice of Available Grant Funding

Grant funds are available from the Federal Recovery Act Victims of Crime Act Victim Assistance (Recovery Act-VOCA) grant program. The purpose of this grant program is to hire and/or retain personnel that provide direct services to victims of crime. To receive grant funds to retain positions, there must be written documentation that demonstrates the positions would otherwise be eliminated due to budget cuts. Eligible applicants are units of state or local government; Native American Tribes; and nonprofit, community and faith-based organizations that provide services to crime victims.
Recovery Act-VOCA funds will be used for direct services to victims of sexual assault and/or victims of violent crime who were previously underserved. Underserved victims of either adult or juvenile offenders may include, but are not limited to, victims of federal crimes; survivors of homicide victims; or victims of assault, robbery, gang violence, hate and bias crimes, intoxicated drivers, bank robbery, economic exploitation, fraud and elder abuse.
The amount of grant funds available for grant awards is $\$ 242,424$. Each grant project funded under this grant program shall be for a period of 12 months, from June 1, 2011 to May 31, 2012.
For the purpose of these grant program guidelines, direct services are defined as those efforts that (1) respond to the emotional and physical needs of crime victims; (2) assist primary and secondary victims of crime to stabilize their lives after a victimization; (3) assist victims to understand and participate in the criminal justice system; and (4) provide victims of crime with a measure of safety such as boarding up broken windows and replacing or repairing locks. A crime victim is a person who has suffered physical, sexual, financial or emotional harm as a result of the commission of a crime.

(c) For this game, a play symbol shall appear in each of six play spots within the play area or areas.
(d) The ticket numbers in each book of tickets in this game shall start with 000 and end with 299.
(e) The three letters comprising the retailer validation codes used in this game shall appear in three of eight varying locations among the play symbols. The retailer validation codes for this game and their meanings are as follows:

(f) The price of instant tickets sold by a retailer for this game shall be $\$ 1.00$ each.
(g) "Top Dollar" is a match three of six prize amounts or a match two prize amounts plus a "MONEY BAG" symbol to win double the prize amount. The player will remove the latex covering the play area to reveal six prize amounts, or five prize amounts and a "MONEY BAG" symbol. If the player matches three like prize amounts, the player wins that amount. If the player matches two like prize amounts plus a "MONEY BAG" symbol, the player wins double the prize amount.
(h) Each ticket in this game may win up to one time.
(i) Approximately 600,000 tickets shall be ordered initially for this instant game. Additional ticket orders shall have the same prize structure, the same number of prizes per prize pool of 300,000 tickets, and the same odds as were contained in the initial ticket order.
(j) The expected number and value of instant prizes in this game shall be as follows:

## Article 15.-RAFFLE GAMES

111-15-3. Game description; retail sale of tickets. (a) "Holiday Millionaire Raffle" is a raffle drawing which offers a total of 150,000 online tickets available for sale. Each ticket shall bear a "TICKET NUMBER" on the face of the ticket. On a date specified in these rules, an electronic drawing machine, which has been approved by the executive director of the Kansas lottery, shall randomly select a total of 506 "WINNING NUMBERS." Each "WINNING NUMBER" consists of a six-digit number as it appears in exact order reading from left to right. A player wins by exactly matching his or her "TICKET NUMBER" to a "WINNING NUMBER" that was selected in the drawing. The first "WINNING NUMBER" selected during the drawing process shall be the grand prize winner. The second, third, fourth, fifth, and sixth "WINNING NUMBERS" selected during the drawing process shall be the second prize winners. The next 500 "WINNING NUMBERS" selected during the drawing process, which shall be drawn in the order of the seventh (7th) "WINNING NUMBER" through the five-hundred sixth (506th) "WINNING NUMBER," shall be the third prize winners. If 145,000 of the 150,000 tickets that are available for sale are sold, all prizes shall be paid as a cash lump sum payment. If less than 145,000 tickets available for sale are sold, all prizes shall be paid on a pari-mutuel basis as a cash lump sum payment of the total cash held for all tickets sold in this game. To play the "Holiday Millionaire Raffle," a player shall purchase a "Holiday Millionaire Raffle" ticket which bears a ticket number on the face of the ticket.
(b) A "Holiday Millionaire Raffle" ticket shall sell for \$20 (twenty) dollars.
(c) Tickets shall not be sold to any person under the age of 18 years. Each retailer may require a person purchasing tickets to produce proof of age.
(d) Each ticket shall be purchased from a terminal operated by a retailer.
(e) All tickets sold by a retailer shall be a "computer pick" or "quick pick" ticket.
(f) A validated ticket shall be the only proof of a game play. The only method of claiming a prize or prizes shall be the submission of the winning ticket to and receipt of the ticket by the lottery or its authorized agent.
(g) The only guaranteed methods of win checking a ticket to determine whether the ticket bears a winning number shall be through the Kansas lottery check-a-ticket machines, or submission of a ticket to the Kansas lottery or an authorized retail agent.
(h) A ticket shall not be voided or cancelled by returning the ticket to the selling retailer, including tickets that are printed in error.
(i) There shall be a total of 150,000 available tickets for sale.
(continued)
(j) Ticket sales will begin at the start of the business day central time on or about October 1, 2010.
(k) Ticket sales will end on or about the close of business day central time on December 29, 2010, or whenever all 150,000 tickets that are available for sale are sold, whichever comes first.
(l) The game will close on or about 4:30 a.m. on December 30, 2010.
(m) The drawing shall be conducted on or about December 30, 2010, before noon central time, at a secure location as determined by the executive director, after the game is closed and the external auditor has verified that the game is closed, under conditions and procedures promulgated by the executive director of the lottery.
(n) Each player shall have the sole responsibility for verifying the accuracy and condition of the data printed on the ticket. The purchase of a ticket is done at the player's own risk through the online retailer who is deemed to be acting on behalf of the player in entering the play or plays.
(o) If, for any reason, a player's bet is not accepted, the liability of the Kansas lottery or its agents shall be limited to a refund of the amount of the ticket purchase price.
(p) Winning ticket numbers shall be made available to the public on or about noon, December 30, 2010. (Authorized by K.S.A. 2009 Supp. 74-8710; implementing K.S.A. 2009 Supp. 74-8710 and 74-8718; effective, T-111-10-8-09, Sept. 9, 2009; amended, T-111-12-7-10, Sept. 8, 2010; amended, T-111-12-29-10, Dec. 9, 2010.)

## KANSAS EXPANDED LOTTERY RULES AND REGULATIONS

## Article 301.-SPECIFIC LOTTERY FACILITY GAMES AT LOTTERY GAMING FACILITIES

111-301-13. Name of the game; rules and regulations. The Kansas lottery shall conduct a lottery facility game at the Boot Hill Casino \& Resort in Dodge City, Kansas, entitled "Let It Ride" beginning on or after December 10, 2010.
The rules and regulations for the game of "Let It Ride" are contained in K.A.R. 111-301-13 through 111-301-20, and applicable generic rules are contained in K.A.R. 111-201-1 et seq. (Authorized by K.S.A. 2009 Supp. 74-8710 and 74-8748; implementing K.S.A. 2009 Supp. 74-8710; effective, T-111-12-29-10, Dec. 9, 2010.)

111-301-14. Object of game. "Let It Ride" is a fivecard stud poker game in which each player seeks a hand that qualifies for a posted payout, pair of 10's or better. (Authorized by K.S.A. 2009 Supp. 74-8710 and 74-8748; implementing K.S.A. 2009 Supp. 74-8710; effective, T-111-12-29-10, Dec. 9, 2010.)

111-301-15. Definitions. The following definitions, when used in the Southwest Kansas Lottery Gaming Zone, when pertaining to the game of "Let It Ride" shall have the following meanings unless the context clearly indicates otherwise:
(a) "Community card" means any of the three cards that are initially dealt face down in the designated area in front of the dealer and, once revealed, shall be used by
each player with his or her two cards to form a five card hand.
(b) "Hand" means the five (5) card hand formed for each player by combining the two (2) cards dealt to the player and the three (3) community cards.
(c) "Fold" means the withdrawal of a player from a round of play by discarding his or her two cards prior to placing a bet wager.
(d) "Let it ride" means that a player chooses not to take back a wager that may be withdrawn.
(e) "Push" means a player's hand resulting in neither payment on nor collection of the player's wagers.
(f) "Rank or ranking" shall mean the relative position of a card or group of cards.
(g) "Round of play" or "round" means one complete cycle of play during which all players then playing at the table have been dealt a hand, have folded or wagered upon it, and have had their wagers paid or collected.
(h) "Stub" means the remaining portion of the deck after all cards in the round of play have been dealt.
(i) "Suit" shall mean one of the four categories of cards, i.e., diamond, spade, club or heart. (Authorized by K.S.A. 2009 Supp. 74-8710 and 74-8748; implementing K.S.A. 2009 Supp. 74-8710; effective, T-111-12-29-10, Dec. 9, 2010.)

111-301-16. Let It Ride hand rankings. (a) The rank of the cards used in Let It Ride for the determination of winning hands, in order of highest to lowest rank, shall be: ace, king, queen, jack, 10, $9,8,7,6,5,4,3$, and 2. Notwithstanding the foregoing, an ace may be used to complete a "straight flush" or a "straight" formed with a $2,3,4$, and 5 . An ace may not be used, however, with any other sequence of cards to form a "straight" (for example, queen, king, ace, 2, and 3).
(b) The permissible poker hands at the game of Let It Ride, in order of highest to lowest rank, are as follows:
(1) Royal flush - a hand consisting of ace, king, queen, jack, and 10 of the same suit;
(2) Straight flush - a hand consisting of five cards of the same suit in consecutive ranking except for a Royal Flush as defined above;
(3) Four of a kind - a hand consisting of four cards of the same rank;
(4) Full house - a hand consisting of three of a kind and a pair;
(5) Flush - a hand consisting of five cards of the same suit, not in consecutive order;
(6) Straight - a hand consisting of five unsuited cards of consecutive rank;
(7) 2 pair - a hand consisting of two pairs;
(8) 1 pair - a hand consisting of two cards of the same rank regardless of suit. (Authorized by K.S.A. 2009 Supp. $74-8710$ and 74-8748; implementing K.S.A. 2009 Supp. 748710; effective, T-111-12-29-10, Dec. 9, 2010.)

111-301-1\%. Wagers. (a) All wagers at Let It Ride shall be made by placing gaming chips and, if applicable, a match play coupon on the appropriate betting areas of the table layout. A verbal wager accompanied by cash shall not be accepted.
(b) Only players who are seated at the Let It Ride table may touch the cards. Once a player has placed a wager
and received cards, that player must remain seated until the completion of the round of play.
(c) All ante wagers at Let It Ride shall be placed prior to the dealer dealing the first card. No wager at Let It Ride shall be made, increased or withdrawn after the dealer has dealt the first card.
(d) At the beginning of each round of play, each player shall be required to place three equal but separate wagers. The wagers shall be identified as bet number 1, bet number 2 and bet number 3 . Bet number 1 and bet number 2 may subsequently be removed by the player in accordance with K.A.R. 111-301-18, play rules.
(e) A Lottery Gaming Facility Manager may, in its discretion, permit a player to place wagers at two betting positions during a round of play provided that the two betting positions are adjacent to each other.
(f) After each round of play is complete, the dealer shall collect all losing wagers and pay off all winning wagers in accordance with the payout table. (Authorized by K.S.A. 2009 Supp. 74-8710 and 74-8748; implementing K.S.A. 2009 Supp. 74-8710; effective, T-111-12-29-10, Dec. 9, 2010.)

111-301-18. Play. (a) The starting position for the dealing of cards or the delivery of stacks of cards for the game of Let It Ride may be determined in the following manners:
(b) The dealer shall deliver the first stack of cards dealt by the shuffler to the player farthest to his/her left, face down in a clockwise manner, including the dealer who will receive three cards, also known as the community cards.
(c) After each player has examined his or her cards, the dealer shall, beginning with the player farthest to the dealer's left and moving clockwise around the table, ask each player if he or she wishes to withdraw bet number 1 or let it ride.
(1) If a player chooses to let bet number 1 ride, that bet shall remain on the appropriate betting area of the layout until the end of the round of play.
(2) If a player chooses to withdraw bet number 1 , the dealer shall move the gaming chips on the betting area designated for bet number 1 toward the player who shall then immediately remove the gaming chips from the betting area.
(d) After each player has made a decision regarding bet number 1, the dealer shall remove ("burn") the community card that is to his or her left, and place the burned card in the discard rack face down.
(e) The dealer shall then reveal the first community card.
(f) After the first community card is exposed, the dealer shall, beginning with the player farthest to the dealer's left and moving clockwise around the table, ask each player if he or she wishes to withdraw bet number 2 or let it ride. This decision shall be made by each player regardless of the decision made concerning bet number 1.
(1) If a player chooses to let bet number 2 ride, that bet shall remain on the appropriate betting area of the layout until the end of the round of play.
(2) If a player chooses to withdraw bet number 2, the dealer shall move the gaming chips on the betting area
designated for bet number 2 toward the player who shall then immediately remove the gaming chips from the betting area.
(g) After each player has made a decision regarding bet number two, each player's cards shall be placed face down on the appropriate area of the layout, the player shall not touch the cards again.
(h) The dealer shall then reveal the second community card.
(i) After the second community card is turned face up, the dealer shall, beginning with the player farthest to his or her right and continuing around the table in a counterclockwise direction, complete the following applicable procedures in succession for each player.
(1) The dealer shall turn the three cards of the player face up. The two community cards and the three cards dealt to the player shall form the five card poker hand of that player.
(2) The dealer shall examine the cards of the player to determine if the player's hand qualifies for a payout pursuant to the approved payout table. Any let it ride poker wager on a hand which has a rank that is lower than a pair of tens shall be a losing wager.
(3) The dealer shall then settle all wagers of that player. All losing wagers by the player shall be immediately collected by the dealer and placed in the table inventory container. After all losing wagers have been collected; all winning wagers shall be paid in accordance with the payout odds.
(4) All hands shall remain face up on the layout until all wagers have been settled by the dealer.
(j) After settling all wagers, the dealer shall immediately collect the cards of all players and the community cards and place them in the discard rack. All cards collected by the dealer shall be picked up in order and placed in the discard rack in such a way that they can be readily arranged to reconstruct each hand in the event of a question or dispute. (Authorized by K.S.A. 2009 Supp. 74-8710 and 74-8748; implementing K.S.A. 2009 Supp. 748710; effective, T-111-12-29-10, Dec. 9, 2010.)

111-301-19. Payout odds. (a) For a winning hand, bet number 1, bet number 2, and bet number 3 are paid the same payout odds ranging from 1 to 1 for a pair of 10's or better to 500 to 1 for a royal flush.
(b) All winning wagers will receive the following payout odds:

111-301-20. Irregularities. (a) A card that is found face up in the shoe or the deck while the cards are being dealt shall not be used in the game and shall be placed in the discard rack. If more than one card is found face up in the shoe or the deck during the dealing of the cards, all hands shall be void and the cards shall be reshuffled.
(b) A card drawn in error without its face being exposed shall be used as though it was the next card from the shoe or the deck.
(c) If any player or the area designated for the community cards is dealt an incorrect number of cards, all hands shall be void and the cards reshuffled.
(d) Any automated card shuffling device or automated dealing shoe shall be removed from a gaming table before any other method of shuffling or dealing may be utilized at that table.
(e) If an automated card shuffling device is being used and the device jams, stops shuffling during a shuffle, or fails to complete a shuffle cycle, the cards shall be reshuffled.
(f) If an automated dealing shoe is being used and the device jams, stops dealing cards, or fails to deal all cards during a round of play, the round of play shall be void, and the cards shall be removed from the device and reshuffled with any cards already dealt.
(g) If cards become soiled in the course of play and the dealer finds that a card is unsuitable for use, a table games floor supervisor will bring a substitute card from the card reserve in the pit stand and the unsuitable card is placed in a sealed envelope or container. The table games floor supervisor will maintain the envelope in a secure place within the pit until collection by Security. (Authorized by K.S.A. 2009 Supp. 74-8710 and 74-8748; implementing K.S.A. 2009 Supp. 74-8710; effective, T-111-12-29-10, Dec. 9, 2010.)

## Article 312.-SPECIFIC LOTTERY FACILITY GAMES AT LOTTERY GAMING FACILITIES; MISSISSIPPI STUD POKER

111-312-6. Play. (a) The starting position for the dealing of cards and the delivery of stacks of cards for the game of Mississippi Stud Poker may be determined in the following manner:
(1) The dealer shall deliver the first stack of three cards to the dealer, also known as the community cards, and will then deliver two cards dealt by the shuffler to the player farthest to his/her left, continuing to deal each player two cards face down in a clockwise manner.
(2) After all players have looked at their two cards, the players have a choice:
(A) Fold (and surrender their ante wager); or
(B) Make a $3^{\text {rd }}$ Street bet of $1 x, 2 x$, or $3 x$ their ante wager.
(3) The dealer shall then reveal the first community card.
(4) The players have a choice:
(A) Fold (and surrender their ante wager and 3rd Street bet); or
(B) Make a $4^{\text {th }}$ Street bet of $1 x, 2 x$, or $3 x$ their ante wager.
(5) The dealer shall then reveal the second community card.
(6) The players have a choice:
(A) Fold (and surrender their ante wager, 3rd Street bet, and 4th Street bet); or
(B) Make a $5^{\text {th }}$ Street bet of $1 x, 2 x$, or $3 x$ their ante wager.
(7) The dealer shall then reveal the third community card.
(b) Working from right to left, the dealer reveals each player's two-card hand and determines their hand combined with the three community cards.
(c) The dealer pays and takes according to the pay table. (Authorized by K.S.A. 2009 Supp. 74-8710 and 74-8748; implementing K.S.A. 2009 Supp. 74-8710; effective, T-111-12-7-10, Sept. 8, 2010; amended, T-111-12-29-10, Dec. 9, 2010.)

111-312-8. Irregularities. (a) A card that is found face up in the shoe or the deck while the cards are being dealt shall void all hands and require a reshuffle. If more than one card is found face up in the shoe or the deck during the dealing of the cards, all hands shall be void and the cards shall be reshuffled.
(b) A card drawn in error without its face being exposed shall be used as though it was the next card from the shoe or the deck.
(c) If any player is dealt an incorrect number of cards, all hands shall be void.
(d) If an automated card shuffling device is being used and the device jams, stops shuffling during a shuffle, or fails to complete a shuffle cycle, the cards shall be reshuffled in accordance with procedures approved by the commission.
(e) If an automated dealing shoe is being used and the device jams, stops dealing cards, or fails to deal all cards during a round of play, the round of play shall be void and the cards shall be removed from the device and reshuffled with any cards already dealt, in accordance with procedures approved by the commission.
(f) Any automated card shuffling device or automated dealing shoe shall be removed from a gaming table before any other method of shuffling or dealing may be utilized at that table.
(g) If an automated card shuffling device is being used and the device jams, stops shuffling during a shuffle, or fails to complete a shuffle cycle, the cards shall be reshuffled.
(h) If an automated dealing shoe is being used and the device jams, stops dealing cards, or fails to deal all cards during a round of play, the round of play shall be void, and the cards shall be removed from the device and reshuffled with any cards already dealt.
(i) If cards become soiled in the course of play and the dealer finds that a card is unsuitable for use, a table games floor supervisor will bring a substitute card from the card reserve in the pit stand and the unsuitable card is placed in a sealed envelope or container. The table games floor supervisor will maintain the envelope in a secure place within the pit until collection by security. (Authorized by K.S.A. 2009 Supp. 74-8710 and 74-8748; implementing K.S.A. 2009 Supp. 74-8710; effective, T-111-12-7-10, Sept. 8, 2010; amended, T-111-12-29-10, Dec. 9, 2010.)

Permanent Administrative Regulations

## Article 21.—WESTERN KANSAS GROUNDWATER MANAGEMENT DISTRICT NO. 1

5-21-4. Safe yield. (a) Except as specified in subsection (c), the district shall be closed to new appropriations of water in the portions of the unconsolidated aquifers commonly known as the Ogallala formation and the Niobrara formation that are located within the district.
(b) The approval of each application for a change in the point of diversion shall be subject to the following requirements, if the diversion works have not been completed under the original approved application:
(1) The proposed appropriation, when added to the vested rights, prior appropriation rights, and earlier priority applications, shall not exceed the allowable safe yield amount for the area included within a two-mileradius circle, which is approximately 8,042 acres, of the proposed well.
(2) For the purpose of analysis, all vested rights, certificates, permits, and prior unapproved applications shall be considered to be fully exercised, and all limitation clauses listed on permits to appropriate water and certificates shall be considered to be in force.
(3) In the case of an application for change in the point of diversion referred to in subsection (b), each application and water right with a priority earlier than the priority established by the filing of the application for change shall be included in the analysis.
(4) The allowable annual safe yield amount shall be calculated using the following formula:

$$
\mathrm{Q}=\frac{\mathrm{AR}}{12}
$$

$Q=$ the allowable annual safe yield amount in acrefeet per year
$\mathrm{A}=$ area of consideration, within a two-mile-radius circle, approximately 8,042 acres
$R=$ average annual recharge of 0.5 inches per year
(5) If part of the radial area is located outside the district boundary, that part shall be included in the depletion analysis only if the chief engineer determines that hydraulically connected groundwater exists in that portion of the area outside the district. A part of the area of consideration lying outside the state of Kansas shall not be included in the analysis.
(6) If wells authorized under a vested right, a certified water right, or a permit to appropriate water are divided by the circumference of the radial area, the authorized quantity of water shall be assigned to each well. If specific quantities are not authorized for each well, a proportional amount shall be assigned to each well.
(c) This regulation shall not apply to the following:
(1) Domestic use;
(2) temporary permits and term permits; and
(3) a new application filed to appropriate groundwater in any area of the district not within an intensive ground-
water use control area, meeting all of the following criteria:
(A) The sum of the annual quantity requested by the proposed appropriation and the total annual quantities authorized by prior permits allowed because of an exemption pursuant to this subsection does not exceed 15 acre-feet in a two-mile-radius circle surrounding the proposed point of diversion.
(B) Well spacing criteria in the area have been met.
(C) The approval of the application does not authorize an additional quantity of water out of an existing authorized well with a nondomestic permit or water right that would result in a total combined annual quantity of water authorized from that well in excess of 15 acre-feet.
(D) All other criteria for approving a new application to appropriate water at that location have been met.
(d) Exceptions to this regulation may be granted on an individual basis by recommendation by the board in conjunction with the approval of the chief engineer. The applicant may be required by the board to submit information necessary in order to make the determination. ## Permanent Administrative Regulations

## Article 1.—DISEASES

28-1-30. Definitions. For the purposes of this article, the following definitions shall apply:
(a) "College designee" and "university designee" mean a person determined by the administration at a postsecondary educational institution to be responsible for the oversight and implementation of that institution's TB prevention and control plan.
(b) "Department" means Kansas department of health and environment.
(c) "Health care provider" means any of the following licensed persons: medical doctor, doctor of osteopathy, doctor of podiatric medicine, advanced registered nurse practitioner as defined in K.S.A. 65-1113 and amendments thereto, and physician assistant.
(d) "High-risk student" means a student who meets any of the following conditions:
(1) Has signs and symptoms of active TB;
(2) has been in contact with a person who has been diagnosed with active TB; or
(3) has traveled, resided in for more than three months, or was born in any country where TB is endemic as determined by the secretary and consistent with guidance
provided by the centers for disease control and prevention.
(e) "Postsecondary educational institution" has the meaning specified in K.S.A. 65-129e, and amendments thereto.
(f) "Secretary" means secretary of health and environment or the secretary's designee.
(g) "Student" means an individual who has been admitted to a postsecondary educational institution where the course of studies will require physical attendance in a classroom setting with one or more persons.
(h) "TB" means tuberculosis.
(i) "TB prevention and control plan" means the policies and procedures adopted pursuant to K.S.A. 65-129f, and amendments thereto, used at a postsecondary educational institution to reduce the risk of tuberculosis transmission and derived from pages 32 through 42 of the guidelines in "controlling tuberculosis in the United States: recommendations from the American thoracic society, CDC, and the infectious diseases society of America," published in morbidity and mortality weekly report (MMWR) on November 4, 2005, vol. 54, no. RR-12. The pages specified in this subsection are hereby adopted by reference.
(j) "Tuberculosis" has the meaning specified in K.S.A. 65-116a, and amendments thereto. For the purposes of these regulations, the term "active TB" shall mean a person diagnosed with tuberculosis by a health care provider, and the term "latent TB infection" shall mean a person who is determined by a health care provider to have the bacterium that causes tuberculosis but has not been diagnosed with active TB. (Authorized by and implementing K.S.A. 2010 Supp. 65-129e and 65-129f; effective April 15, 2011.)
28-1-31. TB prevention and control plan. (a) Each college designee and university designee shall implement a TB prevention and control plan.
(1) The TB prevention and control plan shall include a TB evaluation component for each student determined to be a high-risk student, which shall include the following as necessary:
(A) Tuberculin skin testing;
(B) interferon gamma release assay;
(C) chest radiograph;
(D) sputum evaluation;
(E) physical exam; and
(F) review of signs of symptoms.
(2) The TB prevention and control plan shall provide notification to the department if a student has been found to have latent TB infection or active TB, in accordance with K.A.R. 28-1-2.
(b) Each postsecondary educational institution shall be in compliance with this regulation within 12 months after the beginning of the academic year following the effective date of this regulation. (Authorized by and implementing K.S.A. 2010 Supp. 65-129e and 65-129f; effective April 15, 2011.)

28-1-32. Health services at colleges and universities; submission of a TB prevention and control plan; monitoring of compliance. (a) Each college designee and university designee shall submit to the department a TB
prevention and control plan and any revisions that have been developed in consultation with the department, to ensure that the TB prevention and control plan includes evaluation criteria that are in compliance with the best practice standards as recommended by the division of tuberculosis elimination of the centers for disease control and prevention.
(b) Each postsecondary educational institution that provides health services and that performs infection or disease evaluations, or both, shall keep internal TB evaluation records for each high-risk student.
(c) Each postsecondary educational institution that does not have health services to perform infection or disease evaluations, or both, shall maintain the data on the form provided by the department for each individual considered to be a high-risk student.
(d) Each postsecondary educational institution shall be in compliance with this regulation within 12 months after the beginning of the academic year following the effective date of this regulation. (Authorized by and implementing K.S.A. 2010 Supp. 65-129e and 65-129f; effective April 15, 2011.)

## Article 21.-PRESCRIPTION MONITORING PROGRAM

68-2 1-2. Electronic reports. (a) Each dispenser shall file a report with the board for schedule II through IV drugs and any drugs of concern dispensed in this state or to an address in this state. On and after January 1, 2013, this report shall be submitted within 24 hours of the time that the substance is dispensed, unless the board grants an extension as specified in subsection (d). Before January 1, 2013, each dispenser shall submit the report within seven days of dispensing the substance. Each dispenser that does not dispense schedule II through IV drugs or any drugs of concern in this state or to an address in this state during the reporting periods specified in this subsection shall file a zero report with the board.
(b) In addition to the requirements of K.S.A. 65-1683 and amendments thereto, each dispenser shall submit the prescriber's name, the patient's telephone number, and the number of refills for the dispensed drug on the report to the board. As an alternative to reporting the dispenser identification number, any dispenser may report the pharmacy DEA number.
(c) Except as specified in K.A.R. 68-21-3, the report shall be submitted by secure file transfer protocol in the electronic format established by the American society for automation in pharmacy, dated no earlier than 2007, version 4 , release 1 .
(d) An extension may be granted by the board to a dispenser for the submission of a report if both of the following conditions are met:
(1)(A) The dispenser suffers a mechanical or electronic failure; or
(B) the dispenser cannot meet the deadline established by subsection (a) because of circumstances beyond the dispenser's control.
(2) The dispenser files a written application for extension on a form provided by the board within 24 hours of discovery of the circumstances necessitating the extension request or on the next day the board's administrative office is open for business.
(e) An extension for the filing of a report shall be granted to a dispenser if the board is unable to receive electronic reports submitted by the dispenser.
(f) Each dispenser that is registered or licensed to dispense schedule II through IV drugs or any drugs of concern in this state or to an address in this state but does not dispense any of these drugs shall notify the board in writing that the dispenser will not be reporting to the board. If the dispenser begins dispensing schedule II through IV drugs or any drugs of concern in this state or to an address in this state, the dispenser shall notify the board of this fact and shall begin submitting reports to the board pursuant to this regulation. ## Article 5.-LICENSING OF MARRIAGE AND FAMILY THERAPISTS

102-5-3. Education requirements. (a) Definitions. For purposes of this regulation, the following terms shall be defined as follows:
(1) "Core faculty member" means an individual who is part of the program's teaching staff and who meets the following conditions:
(A) Is an individual whose education, training, and experience are consistent with the individual's role within the program and are consistent with the published description of the goals, philosophy, and educational purpose of the program;
(B) is an individual whose primary professional employment is at the institution in which the program is housed; and
(C) is an individual who is identified with the program and is centrally involved in program development, decision making, and student training as demonstrated by consistent inclusion of the individual's name in public and departmental documents.
(2) "In residence," when used to describe a student, means that the student is present at the physical location of the institution for the purpose of completing coursework during which the student and one or more core faculty members are in face-to-face contact.
(3) "Primary professional employment" means a minimum of 20 hours per week of instruction, research, any other service to the institution in the course of employment, and the related administrative work.
(b) Each applicant for licensure shall meet both of the following education requirements:
(1) Each applicant shall have been awarded a master's or doctoral degree that meets the standards in subsection (c), (e), or (f).
(2) The applicant shall have completed no less than $50 \%$ of the coursework for the degree "in residence" at one institution, and the required practicum shall be completed at the same institution.
(c) To qualify for licensure with a master's or doctoral degree from a marriage and family therapy program, both of the following requirements shall be met:
(1) The college or university at which the applicant completed a master's or doctoral degree in marriage and family therapy shall be regionally accredited, with accreditation standards equivalent to those in Kansas.
(2) The marriage and family therapy program through which the applicant completed a master's or doctoral degree either shall be accredited by the commission on accreditation for marriage and family therapy education or shall meet the standards set out in subsection (d).
(d) Each marriage and family therapy program that is not accredited by the commission on accreditation for marriage and family therapy education shall meet all of these conditions:
(1) The program requires satisfactory completion by the applicant of a marriage and family therapy practicum, or its equivalent, that is provided by the program and that fulfills these conditions:
(A) Is a part-time clinical experience that integrates didactic learning with clinical experience and that is completed concurrently with didactic coursework at a typical rate of five to 10 hours of direct client contact per week;
(B) consists of at least 300 total hours of client contact; and
(C) includes at least 60 total hours of supervision that is provided by the program's core faculty and off-site supervisors. The practicum shall provide a minimum of 30 supervised hours in an individual format and no more than 30 supervised hours in a group format. Supervision shall occur at least once a week.
(2) The program requires that each marriage and family therapy student successfully complete a minimum of nine graduate semester credit hours, or the academic equivalent, in each of the following substantive content areas:
(A) Human development and family study courses in which the interplay between interpersonal and intrapersonal development is stressed and issues of gender, ethnicity, and ecosystems are addressed as they relate to human development. These courses may include studies in sexuality, sexual functioning, sexual identity, sexism, stereotyping, and racism;
(continued)
(B) theoretical foundations of marital and family functioning courses, including an overview of the historical development of systems theory and cybernetics, a study of the life cycle of the family, and a study of family processes and the modification of family structures over time. These courses may include studies in the birth of the first child, adolescent sexual development, death of a family member, and issues of context, including gender and ethnicity; and
(C) marital and family assessment and therapy courses that underscore the interdependence between diagnosis or assessment and treatment by insuring that students can use appropriate assessment instruments and methods within a systemic context. These courses shall provide a thorough understanding of the major theoretical models of systemic change, including structural, strategic, intergenerational, contextual, experiential, systemic, and behavioral theories. These courses also shall teach the principles and techniques evolving from each theory. In addition, the courses shall identify the indications and contraindications for use of each theory or technique, and shall address the rationale for intervention, the role of the therapist, and the importance of considering gender and ethnicity in selecting and using assessment and treatment methods.
(3) The program requires that each marriage and family therapy student successfully complete a minimum of three graduate semester credit hours, or the academic equivalent, in each of the following substantive content areas:
(A) A professional study course that contributes to the development of a professional attitude and identity by examining the role of professional socialization, professional organizations, licensure and certification, the code of ethics, the legal responsibilities and liabilities of clinical practice and research, and interprofessional cooperation, as these topics relate to the profession and practice of marriage and family therapy. A generic course in ethics shall not be considered appropriate for this area of study; and
(B) a research course in which students gain an understanding of research methodology, data analysis, computer research skills, and evaluation and critical examination of professional research reports. The emphasis of the course shall be placed on the quantitative and qualitative research that is relevant to marriage and family therapy.
(e) To qualify for licensure with a master's or doctoral degree in a related field, both of the following requirements shall be met:
(1) The college or university at which the applicant completed a master's or doctoral degree in a related field shall be regionally accredited, with accreditation standards equivalent to those in Kansas.
(2) To be considered equivalent to a marriage and family therapy program, the related-field degree program shall have provided and the applicant shall have completed the requirements of subsection (d).
(f) To qualify for licensure with a master's or doctoral degree in a related field with additional coursework in marriage and family therapy, both of the following requirements shall be met:
(1) The college or university at which the applicant completed a master's or doctoral degree in a related field shall be regionally accredited, with accreditation standards equivalent to those in Kansas.
(2) The marriage and family therapy program through which the applicant obtained additional coursework in marriage and family therapy either shall be accredited by the commission on accreditation for marriage and family therapy education or shall meet the standards approved by the board as set out in subsection (d).
(g) Each applicant for licensure as a clinical marriage and family therapist whose master's or doctoral degree is earned on or after July 1, 2003 shall meet the following education requirements:
(1) A graduate degree as required by the board for licensure as a licensed marriage and family therapist in accordance with subsection (c), (e), or (f); and
(2) in addition to or as a part of the academic requirements for the graduate degree, completion of 15 graduate semester credit hours, or the academic equivalent, supporting diagnosis and treatment of mental disorders using the "diagnostic and statistical manual of mental disorders" as specified in K.A.R. 102-5-14. Three of the 15 semester credit hours, or the academic equivalent, shall consist of a discrete academic course with the primary and explicit focus of psychopathology and the diagnosis and treatment of mental disorders as classified in the "diagnostic and statistical manual of mental disorders." The remaining 12 graduate semester credit hours, or their academic equivalent, shall consist of academic courses with the primary and explicit focus of diagnostic assessment, interdisciplinary referral and collaboration, treatment approaches, and professional ethics or other coursework that specifically contains identifiable, equivalent instruction. The 15 graduate semester credit hours shall be from an educational institution and graduate degree program meeting the requirements described in subsection (c), (e), or (f).
(h) The following activities shall not be substituted for or counted toward any of the education or supervised experience requirements set out in subsections (b) through (g):
(1) Academic courses that the applicant completed as a part of or in conjunction with undergraduate degree requirements;
(2) independent studies;
(3) thesis or independent research courses;
(4) academic coursework that has been audited rather than graded;
(5) academic coursework for which the applicant received an incomplete or a failing grade;
(6) graduate or postgraduate coursework or experiential training provided by colleges, universities, institutes, or training programs that do not qualify under subsection (c), (e), or (f); and
(7) continuing education, an in-service activity, or on-the-job training. ## HOUSE BILL No. 2003

An Act designating a part of K - 18 highway as the Medal of Honor
recipient Donald K. Ross memorial highway.
Be it enacted by the Legislature of the State of Kansas:
Section 1. From the junction of United States highway 81 and $\mathrm{K}-18$ highway then west on $\mathrm{K}-18$ highway to the western boundary of Lincoln county is hereby designated as the Medal of Honor recipient Donald K. Ross memorial highway. The secretary of transportation shall place signs along the highway right-of-way at proper intervals to indicate that the highway is the Medal of Honor recipient Donald K. Ross memorial highway, except that such signs shall not be placed until the secretary has received sufficient moneys from gifts and donations to reimburse the secretary for the cost of placing such signs and an additional $50 \%$ of the initial cost to defray future maintenance or replacement costs of such signs. The secretary of transportation may accept and administer gifts and donations to aid in obtaining and installing suitable signs.
Sec. 2. This act shall take effect and be in force from and after its publication in the Kansas register.
