The Kansas Department of Transportation is seeking a qualified consulting engineering firm prequalified in Category 231 - Traffic Control Analysis and Design, for the project as listed below. ## Traffic Engineering Assistance Program

The Bureau of Local Projects has a Traffic Engineering Assistance Program (TEAP). This program enables KDOT to utilize Federal 402 Safety funds in order to assist local political subdivisions in solving traffic engineering operational and safety improvements when they do not have the traffic engineering expertise available.

The consultants selected are to provide traffic engineering services during federal fiscal years 2013, 2014 and 2015 for one of two areas of the state. Area One comprises KDOT Districts One, Two and Three. Area Two comprises KDOT Districts Four, Five and Six. Each area will receive a maximum of $\$ 75,000$ per year. The development of detailed plans, designs, specifications or estimates will not be approved under this program.

The following is a list of possible areas where the consultant may be called upon to do work. Work will not be
limited to these categories and will depend upon the nature of a project and its impact on traffic safety.

The Consultant Shortlist Committee will select three to five of the most highly qualified firms expressing interest and schedule an individual interview. The consulting firms can more thoroughly discuss their experience related to the project at the interview and will be expected to discuss their approach to this project in detail and the personnel to be assigned to this project. Firms not selected to be shortlisted will be notified. Categories may be viewed at www.ksdot.org/divengdes/prequal.

The Consultant Selection Committee, appointed by the Secretary of Transportation, will conduct the discussions with the firms invited to the individual interview conferences. The committee will select one firm to perform the professional services required for completing the advertised project. After the selection, the firms not selected will be notified of the outcome.

It is KDOT's policy to use the following criteria as the basis for selection of the consulting engineering firms:

1. Size and professional qualifications.
2. Experience of staff.
3. Location of firm with respect to projects.
4. Work load of firm.
5. Firm's performance record.

The firm's accounting systems must have the following capabilities before the firm may be awarded a contract:

- Valid, reliable and current costs must be available within the system to support cost and pricing data.
- Capability to provide a means of measuring the reasonableness of incurred costs.
- Capability to identify and accumulate allowable costs by contract or project records that will reconcile with the general ledger.
- Ability to provide supporting documentation of actual expenditures for each billing, based on costs.

The purpose of a Class I permit is to identify the sources and types of regulated air pollutants emitted from the facility; the emission limitations, standards, and requirements applicable to each source; and the monitoring, record keeping, and reporting requirements applicable to each source as of the effective date of permit issuance.

The written request must be submitted to Sharon Burrell, Bureau of Air, not later than the close of business July 24 in order for the Secretary of Health and Environment to consider the request.

The U.S. Environmental Protection Agency has a 45day review period, which will start concurrently with the 30-day public comment period, within which to object to the proposed permit. If the EPA has not objected in writing to the issuance of the permit within the 45-day review period, any person may petition the administrator of the EPA to review the permit. The 60-day public petition period will directly follow the EPA's 45-day review period. Interested parties may contact KDHE to determine if the EPA's 45-day review period has been waived.

Any such petition shall be based only on objections to the permit that were raised with reasonable specificity during the public comment period provided for in this notice, unless the petitioner demonstrates that it was impracticable to raise such objections within such period, or unless the grounds for such objection arose after such period. US Energy Partners, LLC has applied for a construction permit in accordance with the provisions of K.A.R. 28-19-300, and a Class II operating permit in accordance with the provisions of K.A.R. 28-19-540. Emissions of sulfur dioxide $\left(\mathrm{SO}_{2}\right)$, nitrogen oxides $\left(\mathrm{NO}_{\mathrm{x}}\right)$, carbon monoxide (CO), particulate matter (PM), particulate matter with an aerodynamic diameter less than or equal to 10 mi crometers $\left(\mathrm{PM}_{10}\right)$, volatile organic compounds (VOCs), hazardous air pollutants (HAPs) and green house gases (GHGs) were evaluated during the permit review process. The purpose of a Class II permit is to limit the po-tential-to-emit to below major source thresholds.

US Energy Partners, LLC, 1030 E. 15th St., Russell, 67665 , owns and operates the stationary source located at the same address, at which the wheat gluten manufacturing facility is to be operated.

A public comment period has been established to allow citizens the opportunity to express any concerns they may have about this proposed permitting action. K.A.R. 115-14-14. This new permanent regulation establishes taking, banding, transporting and possessing raptors for falconry. The regulation includes provisions from both federal regulation and state regulations that are proposed for revocation. The provisions include hunting license requirements, capture devices, permission from the landowner, number of raptors that may be taken threatened or endangered species, reporting take of raptors, recapture of raptors, identification of raptors taken and release of raptors.

K.A.R. 115-14-15. This new permanent regulation establishes transfers, trading and sale of raptors for fal-
