The following ICFsMR cost center limits are being set forth for public comment. Comments should be sent to Pamela Keller, Program Administrator, KDADS/Community Services and Programs, 9th Floor East, Docking State Office Building, 915 S.W. Harrison, Topeka, 66612. The comment period will expire 30 days from the publication of this notice.
K.A.R. 30-10-214 provides for the annual review and adjustment of Class II ICFsMR cost center limits, approved by the secretary of KDADS or designee, based on current cost information supplied by the enrolled, licensed providers of ICF-MR services, and formula set forth in the Kansas State Medicaid Plan (Attachment 4.19D, Part II, Subpart O, page 1). The formula is as follows: Total allowable costs, including an inflation factor, are compared to the amount to be reimbursed under the current limits. The formula threshold requires that 60 percent of all ICFsMR are reimbursed 90 percent of their allowable costs. If less than 60 percent of the facilities are reimbursed 90 percent of their allowable costs, then the cost center limits are adjusted until the threshold is met. The inflation factor is based on the Global Insight Health-Care Cost Review (formerly Data Resources, Inc. [DRI] WEFA), National Skilled Nursing Facility Total Market Basket Index.

To determine where to make the adjustments, two major cost centers are analyzed according to the following prescription:

- Administrative costs are based on facility size.
- Habilitation costs are based on facility size and level of care (LOC).
The cost analysis for 2011 showed that 62 percent of the Class II ICFsMR were being reimbursed 90 percent or more of their allowable costs. Per the state plan, the analysis indicates that adjustments are not required.


## Recommendations

Based on cost report analysis and available funding, cost center limits for Class II ICFsMR are as follows:

Neither the city nor the consultant shall be responsible for the accuracy, completeness or sufficiency of any bid documents obtained from any source other than the source indicated above. Obtaining copies of plans, specifications, bid documents and other contract documents from any other source may result in obtaining incomplete and inaccurate information. Obtaining these documents from any source other than directly from the source listed herein also may result in failure to receive any addenda, corrections or other revisions to these documents that may be issued.
Contractors should read and be fully familiar with all contract documents before submitting a bid. In submitting a bid, the bidder warrants that it has read the contract documents and is fully familiar therewith and that it has visited the site of the work to fully inform itself as to all existing conditions and limitations and shall include in its bid a sum to cover the cost of all items of the work.
Should a bidder find "defects" as defined in paragraph GC-3 of the General Conditions, it shall follow the procedures outlined in paragraph GC-3 to bring same to the attention of the city. Changes necessitated thereby shall be in the form of addenda issued by the consultant.
All bidders shall verify that they have considered all written addenda. Neither the city nor the consultant shall be responsible for oral instructions.
Any written addenda issued during the time of bidding shall be covered and included in the bid. There will be no clarifications or exceptions allowed on the bid. Bids are for a total bid package, total contract price.
Bids shall be made upon the form provided, in ink or typewritten. Numbers shall be stated both in writing and
in figures, the signature shall be longhand and the complete form shall be without alteration or erasure. On alternate items for which a bid is not submitted, a written indication of "no bid" on the bid form is required.
No oral, telegraphic, facsimile or telephonic bids or alterations will be considered.
The following items must be included in the sealed envelope with the bid:
a. Bid
b. $5 \%$ Bid Security - bid bond, cashier's check or certified check (see below)
c. Signed Documents (KDOT Certifications)

Each bidder shall file with its bid a bid bond, a cashier's check or a certified check drawn on any acceptable bank, made payable to the city of Overland Park, Kansas, in an amount of not less than 5 percent of the total bid, which shall be retained by the city of Overland Park until a contract for the project has been executed. Bid bonds will be returned to the unsuccessful bidders, with the exception of the second qualifying bidder, at such time as their bids are rejected. The bid deposit of the successful bidder and the second qualifying bidder will be returned when satisfactory bonds in an amount equal to 100 percent of the contract amount, required insurance certificates and other required documents shall have been furnished and the contract documents have been executed.
In the event the successful bidder is unable to execute the contract, for whatever reason, the city may exercise its legal prerogatives, including, but not limited to, enforcement of its rights as to the bid security.
The city reserves the right to accept or reject any and all bids and to waive any technicalities or irregularities therein. The Kansas Department of Health and Environment is soliciting comments regarding a proposed air quality construction permit. Next Generation Processing, LLC (NGP), located at 15914 Stenbury Court, Cypress, TX 77429, has applied for an air quality construction permit in accordance with the provisions of K.A.R. 28-19-300 to construct the Haven Gas Plant, a 1.40-billion standard cu-
bic feet per day cryogenic natural gas processing facility, to be located in Section 6, Township 25 South, Range 4 West near Haven, Reno County, Kansas. The facility will consist of two natural gas-fired combined cycle turbines, each rated at $29,299 \mathrm{HP}$, with one compressor each, for natural gas compression and plant recompression; one natural gas-fired turbine generator set, rated at 40.27 MMBtu/hr; two natural gas-fired reciprocating engine generator sets, each rated at 1,980 HP; one amine unit, with a design capacity of 650 gallons per minute; one mol sieve dehydrator with a capacity of 1.40 billion standard cubic feet per day; one demethanizer unit in the cryogenic expander; and four electric compressors for plant compression and recompression of natural gas.

Emissions of particulate matter (PM), PM equal to or less than 10 microns in diameter $\left(\mathrm{PM}_{10}\right)$, PM equal to or less than 2.5 microns in diameter $\left(\mathrm{PM}_{2.5}\right)$, volatile organic compounds (VOCs), oxides of nitrogen $\left(\mathrm{NO}_{\mathrm{x}}\right)$, sulfur dioxide $\left(\mathrm{SO}_{2}\right)$, carbon monoxide (CO), hazardous air pollutants (HAPs) and greenhouse gases (GHGs) were evaluated during the permit review process. The proposed permit is to be issued in accordance with the provisions of K.A.R. 28-19-350, prevention of significant deterioration (PSD), which adopt the federal standards, procedures and requirements of 40 CFR 52.21 by reference. These air quality regulations apply to major stationary emission sources located in areas designated as "attainment" or "unclassifiable" under the federal Clean Air Act (CAA). Attainment areas are areas where the air quality meets or is better than the national ambient air quality standards (NAAQS). Unclassifiable areas are areas where the air quality cannot be classified on the basis of available information as meeting or not meeting the NAAQS.
The PSD regulations require evaluation of emission reduction techniques to identify the best available control technology (BACT) for each regulated pollutant, including greenhouse gases (GHGs), for which the emission rate exceeds the PSD significant level. The purpose of BACT is to affect the maximum degree of reduction achievable, taking into account energy, environmental and economic impacts for each regulated pollutant under review. Evaluation of the estimated emissions for the proposed NGP project indicates that the emission rate of $\mathrm{NO}_{x}, \mathrm{O}_{3}, \mathrm{CO}$, $\mathrm{PM}_{2.5}$ and GHGs all exceed the significance levels. NGP conducted the required BACT analyses. The department has reviewed NGP's BACT analyses and concurs with its findings.

- BACT for the two 29,299 HP combine cycle turbines is as follows: dry low $\mathrm{NO}_{x}$ technology, good combustion practices, energy efficient design, waste heat recovery and firing pipeline natural gas is BACT for $\mathrm{NO}_{x}$; good combustion practices, energy efficient design, waste heat recovery and firing pipeline natural gas is BACT for CO, $\mathrm{PM}_{2.5}$ and GHG emissions.
- BACT for the one $40.27 \mathrm{MMbtu} / \mathrm{hr}$ turbine generator set is as follows: dry low $\mathrm{NO}_{\mathrm{x}}$ technology, good combustion practices, energy efficient design and firing pipeline natural gas is BACT for $\mathrm{NO}_{x}$; good combustion practices, energy efficient design and firing pipeline natural gas is BACT for $\mathrm{CO}, \mathrm{PM}_{2.5}$ and GHG emissions.

- BACT for the two $1,980 \mathrm{HP}$ reciprocating engine generator sets is as follows: dual nonselective catalytic reduction (NSCR) three-way catalytic converters, good combustion practices and firing pipeline natural gas is BACT for NOx; dual nonselective catalytic reduction (NSCR) three-way catalytic converters, good combustion practices and firing pipeline natural gas is BACT for CO; good combustion practices, energy efficient design and firing pipeline natural gas is BACT for $\mathrm{PM}_{2.5}$ and GHG emissions.
- BACT for the one amine unit still vent is as follows: waste heat recovery from the turbines for amine regeneration is BACT for GHG emissions.
- BACT for plant fugitives and equipment leaks is as follows: an effective leak detection and repair (LDAR) program is BACT for GHG emissions.
An ambient impact analysis was performed on the potential air emissions of $\mathrm{NO}_{2}, \mathrm{PM}_{2.5}$ and CO from this project.
- A preliminary modeling analysis conducted for the annual $\mathrm{NO}_{2}$ averaging period demonstrated no significant impact to the annual $\mathrm{NO}_{2}$ ambient air quality standard and demonstrated that 1.3 percent of the annual Class II maximum allowable increment for $\mathrm{NO}_{2}$ is expected to be consumed. A preliminary modeling analysis for the one-hour $\mathrm{NO}_{2}$ ambient air quality standard demonstrated no significant impact to the one-hour $\mathrm{NO}_{2}$ ambient air quality standard. The EPA has not established a one-hour Class II maximum allowable increment for $\mathrm{NO}_{2}$. Accordingly, no calculation of the potential consumption of such increment is possible.
- A preliminary modeling analysis conducted for the annual $\mathrm{PM}_{2.5}$ averaging period demonstrated no significant impact to the annual $\mathrm{PM}_{2.5}$ ambient air quality standard and that 2.0 percent of the annual Class II maximum allowable increment for $\mathrm{PM}_{2.5}$ is expected to be consumed. A preliminary modeling analysis conducted for the 24 -hour $\mathrm{PM}_{2.5}$ ambient air quality standard demonstrated no significant impact to the 24-hour $\mathrm{PM}_{2.5}$ ambient air quality standard and that 6.4 percent of the 24 -hour Class II maximum allowable increment for $\mathrm{PM}_{2.5}$ is expected to be consumed.
- A preliminary modeling analysis conducted for the eight-hour CO averaging period demonstrated no significant impact to the eight-hour CO ambient air quality standard. A preliminary modeling analysis conducted for the one-hour CO averaging period demonstrated no significant impact to the one-hour CO ambient air quality standard. The EPA has not established any Class II maximum allowable increments for CO. Accordingly, no calculation of the potential consumption of such increment is possible.
An analysis of visibility was conducted for Hercules Glades Wilderness Area in southwestern Missouri and Haven High School. The VISCREEN model results indicate no exceedances of the screening criteria. No adverse impacts on soils and vegetation in the area are expected.

Any federal land manager who has reason to believe they may have a federal Class I area adversely impacted by the emissions from the proposed project has the opportunity to present KDHE with a demonstration of the adverse impact on the air quality-related values of the federal Class I area during the comment period.

A public comment period has been established until 5 p.m. November 5 to allow citizens the opportunity to express any concerns they may have regarding this proposed permitting action. All comments should be submitted in writing to Sharon Burrell, KDHE, Bureau of Air, 1000 S.W. Jackson, Suite 310, Topeka, 66612-1366.

Any member of the public may request the department hold a public hearing to receive comments on the proposed issuance of the draft air quality construction permit. A public hearing is tentatively scheduled by KDHE at 5 p.m. November 8 at the Haven Community Building, 215 S.W. Facility Description: This action consists of reissuance of an existing permit for operation of an existing wastewater treatment facility and discharge of noncontact cooling water. This is an underground storage facility located in an old quarry providing refrigerated storage for food products. About five gallons per minute of well water is used for evaporative condenser cooling and is discharged as noncontact cooling water to the Kansas River without any treatment (Outfall 001). Approximately two gallons per minute of domestic wastes are treated in a two-stage aeration sewage treatment plant (Outfall 002). This domestic waste is chlorinated and dechlorinated prior to discharging to the Kansas River. The proposed permit contains limits for biochemical oxygen demand, total suspended solids and pH , as well as monitoring of E. coli and effluent flow. # State of Kansas <br> Governmental Ethics Commission 

Opinion No. 2012-05
Written August 29, 2012, to Patricia Long, Topeka.
Synopsis: A state employee may not be substantially involved in the preparation of or participate in the making of a contract with any business in which the employee's sister and the sister's husband collectively have a substantial interest. Thus, a state employee is precluded from participating in the review of proposals, the selection of bids and/or the negotiation process for the contracts resulting from a request for proposals (RFP) for child welfare programs delivered by licensed child placing agencies if the company that employs the sister's husband submits a bid.
Cited herein: K.S.A. 46-229; K.S.A. 2011 Supp. 46-233.
Dear Ms. Long:
This opinion is in response to your letter dated July 30, 2012, wherein you request an opinion from the Kansas Governmental Ethics Commission, concerning application of the state conflict of interest laws, K.S.A. 46-215 et seq. We note at the outset that the Commission's jurisdiction is limited to the applicability of K.S.A. 46-215 et seq., and the Commission's opinion does not address whether some other statutory system, common law theory, or agency rule or regulation applies to your inquiry.

## Factual Statement

You request this opinion in your capacity as a program administrator for the Division of Prevention and Protection Services of the Department for Children and Family Services (DCF). You explain that your responsibilities include administration and oversight of the foster care and adoption programs. Services under these child welfare programs are delivered by licensed child placing agencies under contract with DCF. The contracts are the result of negotiated, competitive bids submitted in response to a request for proposals (RFP). The next RFP is being developed and you are participating in the RFP development process.

You indicate that your brother-in-law is employed by TFI Family Services Inc. (TFI). TFI was one of the successful bidders during the last procurement process. You state that whether TFI submits a proposal or not, you would like to participate in the review of proposals, the selection of bids and/or the negotiation process for the new contracts resulting from the RFP.

## Question

Do the conflict of interest laws prohibit or limit your participation in the review of proposals, the selection of bids and/or the negotiation process for the new contracts resulting from the RFP?

## Analysis and Opinion

K.S.A. 2011 Supp. 46-233(a) places restrictions on a state employee's participation in state contracts. That statute states in pertinent part as follows:
(1) No state officer or employee shall in the capacity as such officer or employee be substantially involved in the preparation of or participate in the making of a contract
with any person or business by which such officer or employee is employed or in whose business such officer or employee or any member of such officer's or employee's immediate family has a substantial interest.
"Substantially involved in the preparation or participate in the making of a contract" means "having approved or disapproved a contract or having provided significant factual or specific information or advice or recommendations in relation to the negotiated terms of the contract. ${ }^{\prime \prime 1}$ Based on your assertion that you would participate in the review of proposals, the selection of bids and/ or the negotiation process for the new contracts resulting from the RFP, you would be substantially involved in the preparation or participation in the making of a contract that resulted from the RFP.
The next issue to consider is whether your brother-inlaw is a member of your "immediate family," which is not defined in K.S.A. 2011 Supp. 46-233 or anywhere in the state level conflict of interest laws. "Family member" is defined in a regulation concerning nepotism under the state level conflict of interest laws, K.A.R. 19-40-4(b)(1). That definition includes "parent, child, or sibling related by marriage as denoted by the suffix of 'in-law'." It is significant that the nepotism law uses the more general term, "family member," while K.S.A. 2011 Supp. 46-233 uses the qualifier "immediate" before "family." We believe that "immediate family" is more limited than "family member." Black's Law Dictionary defines "immediate family" as a "[t]erm generally referring to one's parents, wife or husband, children, and brothers and sisters. ${ }^{\prime 2}$ It is our opinion that the term "immediate family" as used in K.S.A. 2011 Supp. 46-233 includes parents, children, brothers and sisters, and a spouse, but does not include persons related by marriage as denoted by the suffix of "in-law."

While your brother-in-law is thus not a member of your "immediate family," your sister, who is his wife, is a member of your immediate family.

A final issue to determine is whether a member of your immediate family has a "substantial interest" in TFI, Inc. The answer is found in K.S.A. 46-229(b):

If any individual or an individual's spouse, either individually or collectively, has received during the preceding calendar year compensation which is or will be required to be included as taxable income on federal income tax returns of the individual and spouse in an aggregate amount of $\$ 2,000$ from any business or combination of businesses, the individual has a substantial interest in that business or combination of businesses. ${ }^{3}$
Individually, your brother-in-law (not a member of your immediate family) would have a substantial interest in TFI from the time his taxable income from TFI equals or exceeds $\$ 2,000$.

However, his wife, i.e,. your sister (who is a member of your immediate family), and her husband, i.e., your brother-in-law, collectively would have a substantial interest in TFI from the time his taxable income from TFI equals or exceeds $\$ 2,000$.

Therefore, as a state employee, you may not be substantially involved in the preparation of or participate in the making of a contract with any business in which your
sister and her husband collectively have a substantial interest. This precludes you from participating in the review of proposals, the selection of bids and/or the negotiation process for the new contracts resulting from the RFP for child welfare programs delivered by licensed child placing agencies if TFI, Inc. submits a bid.

Governmental Ethics Opinion No. 2008-05 is withdrawn to the extent it conflicts with this opinion.

## Permanent Administrative Regulations

## Article 29.—QUALIFIED ADMISSION

88-29-11. Requirements for the qualified admission precollege curriculum. This regulation shall be applicable to each applicant graduating from high school in academic year 2013-2014 or earlier. In order to admit any applicant under the qualified admission precollege curriculum criteria, each state educational institution shall require the applicant to provide an official high school transcript documenting completion of the approved qualified admission precollege curriculum that meets the following requirements:
(a) For each student graduating from high school before 2010, the transcript shall indicate the following distribution of courses:
(1) Four units of approved qualified admission English courses, with the content described in K.A.R. 88-29-14;
(2) three units of approved qualified admission mathematics courses that have the content described in K.A.R. 88-29-15 and that meet the following requirements:
(A) Are at or above the level of qualified admission algebra I; and
(B) were taken during ninth through twelfth grades;
(3) three units of approved qualified admission natural science courses that have the content described in K.A.R. 88-29-16 and that meet the following requirements:
(A) The three units shall be selected from any of the following courses, with at least one unit in each selected course:
(i) Qualified admission biology;
(ii) qualified admission advanced biology;
(iii) qualified admission chemistry;
(iv) qualified admission physics;
(v) qualified admission earth-space science; or
(vi) qualified admission principles of technology; and
(B) at least one unit shall be selected from a qualified admission chemistry course or a qualified admission physics course; and
(4) three units of approved qualified admission social science courses that have the content described in K.A.R. 88-29-17 and that are distributed according to the following requirements:
(A) A minimum of $1 / 2$ unit shall be a qualified admission United States government course;
(B) a minimum of $1 / 2$ unit shall be selected from any of the following courses:
(i) Qualified admission world history;
(ii) qualified admission world geography; or
(iii) qualified admission international relations;
(C) a minimum of one unit shall be a qualified admission United States history course;
(D) up to one unit shall be selected from any of the following courses:
(i) A qualified admission anthropology course;
(ii) a qualified admission current social issues course;
(iii) a qualified admission economics course;
(iv) a qualified admission race and ethnic group relations course;
(v) a qualified admission sociology course;
(vi) a qualified admission psychology course;
(vii) a qualified admission United States history course; or
(viii) a qualified admission United States government course;
(E) a $1 / 2$-unit course shall not be used to fulfill more than one requirement of this regulation for more than one discipline in the qualified admissions precollege curriculum; and
(F) a one-unit course may be used to fulfill two $1 / 2$-unit requirements of this regulation.
(b) For each student graduating from high school in 2010 and thereafter but before academic year 2014-2015, the qualified admission precollege curriculum shall consist of courses that are among those listed in the document titled "Kansas board of regents precollege curriculum courses approved for university admissions," revised May 23, 2012, which is hereby adopted by reference. The qualified admission precollege curriculum shall consist of the following distribution of courses:
(1) Four units of approved qualified admission English courses that include reading, writing, and literature;
(2) three units of approved qualified admission mathematics courses that meet the following requirements:
(A) Each course shall be completed in the ninth through twelfth grades; and
(B) each course shall be selected from any of the following courses:
(i) Qualified admission algebra I;
(ii) qualified admission geometry;
(iii) qualified admission algebra II;
(iv) any mathematics course that has qualified admission algebra II as a prerequisite; or
(v) any other course approved by the chief executive officer of the board of regents or the chief executive officer's designee;
(3) three units of approved qualified admission natural science courses that meet the following requirements:
(A) The three units shall be selected from any of the following courses:
(i) Qualified admission biology;
(ii) qualified admission advanced biology;
(iii) qualified admission chemistry;
(iv) qualified admission physics;
(v) qualified admission earth-space science;
(vi) qualified admission principles of technology; or
(vii) any other courses approved by the chief executive officer of the board of regents or the chief executive officer's designee; and
(B) at least one unit shall be selected from a qualified admission chemistry course or a qualified admission physics course; and
(4) three units of approved qualified admission social science courses that are distributed according to the following requirements:
(A) A minimum of $1 / 2$ unit shall be a qualified admission United States government course;
(B) a minimum of $1 / 2$ unit shall be selected from any of the following courses:
(i) Qualified admission world history;
(ii) qualified admission world geography; or
(iii) qualified admission international relations;
(C) a minimum of one unit shall be a qualified admission United States history course;
(D) not more than one unit shall be selected from any of the following courses:
(i) Qualified admission anthropology;
(ii) qualified admission current social issues;
(iii) qualified admission economics;
(iv) qualified admission psychology;

## Article 20.-APPRAISAL MANAGEMENT COMPANY REGISTRATION

(a) "Applicant" means an appraisal management company seeking registration.
(b) "Good moral character" shall include the qualities of good judgment, honesty, fairness, responsibility, credibility, reliability, self-discipline, self-evaluation, initiative, trustworthiness, integrity, respect for and obedience to the laws of the state and nation, and respect for the rights of others and for the judicial process.
(c) "Good standing" has the meaning specified in K.A.R. 117-1-1.
(d) "Oversee an appraiser panel" means to supervise or manage an appraiser panel. (Authorized by L. 2012, ch. 93 , sec. 25 ; implementing L. 2012, ch. 93, secs. 4, 5, 9, $10,11,16$, and 22; effective, T-117-7-3-12, July 3, 2012; effective Oct. 19, 2012.)

117-20-2. Registration. (a) Each controlling person shall submit the application forms prescribed by the board with the fees specified in K.A.R. 117-20-4.
(b) Each application shall be supported by a separate form for the controlling person and for each owner of more than 10 percent of the applicant.
(1) Each owner of more than 10 percent of the applicant shall submit that individual's fingerprints and the fee specified in K.A.R. 117-20-4 in the manner prescribed by the board for a state and national criminal history record check. The individual shall not be fingerprinted more than 120 days before submitting the application for initial registration.
(2) The controlling person of the applicant shall submit that individual's fingerprints and the fee specified in K.A.R. 117-20-4 in the manner prescribed by the board for a state and national criminal history record check. The individual shall not be fingerprinted more than 120 days before submitting the application for initial registration. 117-20-4. Fees. The following fees shall be collected by the board: (a) For initial registration, \$1,500;
(b) for registration renewal, $\$ 1,500$;
(c) for late registration renewal, the amount specified in subsection (b) and an additional \$100;
(d) for processing fingerprints and a criminal history record check, \$50; and
(e) for initial registration and for registration renewal, the AMC federal registry fee in any amount assessed by the appraisal subcommittee of the federal financial institutions examination council for all AMCs holding a registration. (Authorized by and implementing L. 2012, ch.

93, secs. $8,9,10$, and 25 ; effective, T-117-7-3-12, July 3, 2012; effective Oct. 19, 2012.)

117-20-5. Certificate of registration. Each certificate of registration shall show on its face in clear and concise language the following information:
(a) The legal name of the AMC;
(b) the certificate of registration number;
(c) the date of issuance;
(d) the date of expiration; and
(e) the signature or facsimile signature of the chairperson of the board. (Authorized by and implementing L. 2012, ch. 93, sec. 25; effective, T-117-7-3-12, July 3, 2012; effective Oct. 19, 2012.)

117-20-6. Change of information. (a) Each holder of a registration, controlling person, and owner of more than 10 percent of an AMC shall submit written notice to the board of each change to any of the information required by L. 2012, ch. 93, sec. 4, and amendments thereto, within 10 days of the change.

(d) The only exceptions to prior authorization shall be the following:
(1) Emergencies. If certain surgeries and procedures that require prior authorization are performed in an emergency situation, the request for authorization shall be made within two working days after the service is provided.
(2) Situations in which services requiring prior authorization are provided and retroactive eligibility is later established. When an emergency occurs or when retroactive eligibility is established, prior authorization for that service shall be waived, and if medical necessity is documented, payment shall be made.
(e) Services requiring prior authorization shall be considered covered services within the scope of the program, unless the request for prior authorization is denied.
