# Notice of Available Grant Funding

The Kansas Criminal Justice Coordinating Council (KCJCC) establishes the guidelines for the Federal Edward Byrne Memorial Justice Assistance Grant (JAG). The JAG program is authorized by federal law 42 U.S.C. 3250. The KCJCC and the federal JAG program guidelines establish eligibility criteria that must be met by all organizations that receive JAG funds. Grant funds may be awarded to units of state and local government; Native American Tribes; and nonprofit, community and faithbased organizations. The primary use of JAG is to support the following purpose areas: (1) law enforcement programs, (2) prosecution and court programs, (3) prevention and education programs, (4) corrections and community corrections programs, (5) drug treatment and enforcement programs, (6) planning, evaluation and technology improvement programs, and (7) crime victim and witness programs. Grant funds must be requested within one or more of the seven purpose areas. Grant funds are available for the funding period of July 1, 2013 through June 30, 2014. Since this grant is competitive, there is a yearly application process with no guarantee of continued funding. In distributing grant funds, priority will be given to applicants who are not eligible to apply directly to the Federal Bureau of Justice Assistance for JAG funding.

The Kansas Department for Aging and Disability Services has a Special Project Grant opportunity for the Prevention of Elder Abuse, Neglect and Exploitation (PEANE). The grant period is from September 1, 2013 to August 31, 2014. Any Kansas public or private not-forprofit or for-profit corporation registered with the Office of the Secretary of State or local units of government may apply for these funds.

Applications are now being accepted for proposals to address the prevention of elder abuse, neglect and exploitation (including financial abuse). # Notice of Hearing on Proposed Administrative Regulation

A public hearing will be conducted at 10 a.m. Tuesday, July 2, in Suite 1102, Jayhawk Tower, 700 S.W. Jackson, Topeka, to consider the adoption of K.A.R. 117-20-4.

This 60-day notice of public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed regulation. All interested parties may submit written comments prior to the hearing to the Kansas Real Estate Appraisal Board, Suite 1102, Jayhawk Tower, 700 S.W. Jackson, Topeka, 66603. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulation during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant to limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulation and economic impact statement in an accessible format. The proposed regulation amendments are for adoption on a permanent basis. A summary of the proposed amendments to the regulation and the economic impact follows:

**117-20-4. Fees.** This regulation is being amended to decrease the registration renewal fees for appraisal management companies (AMC) from \$1,500 to \$1,000.

The economic impact to AMCs will be a savings of \$500 annually. The economic impact to the Real Estate Appraisal Board will be a decrease in revenues of approximately \$47,700 and to the state general fund of \$5,300. There is no economic impact to other state agencies or to the public.

**K.A.R.** 98-5-3 clarifies the procedures for a request to negotiate a water purchase contract.

The commission does not anticipate an economic impact resulting from the adoption of the proposed edits to this existing regulation.

K.A.R. 82-4-3c. This existing regulation adopts relevant portions of the FMCSA regulations (49 C.F.R. Part 382) governing the procedures for testing for controlled substances and alcohol use. The proposed amendments to this regulation include edits to reflect minor grammar and form corrections and the most recent updates to FMCSA regulations to include the final rule harmonizing Schedule I drug requirements.

The commission does not anticipate an economic impact resulting from the adoption of the proposed edits to this existing regulation.

**K.A.R. 82-4-3d.** This existing regulation adopts relevant portions of the FMCSA regulations (49 C.F.R. Part 385) governing motor carrier safety fitness procedures. The proposed amendments to this regulation include edits to reflect minor grammar and form corrections and the most recent updates to FMCSA regulations.

The commission does not anticipate an economic impact resulting from the adoption of the proposed edits to this existing regulation.

K.A.R. 82-4-3f. This existing regulation adopts relevant portions of the FMCSA regulations (49 C.F.R. 390), which establish the minimum safety requirements to be followed by motor carriers and their employees, the safety standards for commercial motor vehicles and intermodal equipment. The proposed amendments to this regulation include edits to reflect minor grammar and form corrections and the most recent updates to FMCSA regulations.

The commission does not anticipate an economic impact resulting from the adoption of the proposed edits to this existing regulation.

K.A.R. 82-4-3g. This existing regulation adopts relevant portions of the FMCSA regulations (49 C.F.R. 391), which establish the minimum duties of motor carriers with respect to the qualifications of their commercial motor vehicle drivers. This regulation also establishes the minimum qualifications for those drivers who own and operate commercial motor vehicles. The proposed amendments to this regulation include edits to reflect minor grammar and form corrections and the most recent updates to FMCSA regulations.

The commission does not anticipate an economic impact resulting from the adoption of the proposed edits to this existing regulation.

K.A.R. 82-4-3h. This existing regulation adopts relevant portions of the FMCSA regulations (49 C.F.R. 392), which establish the minimum duties and procedures for the driving of commercial motor vehicles. The proposed amendments to this regulation include edits to reflect minor grammar and form corrections and the most recent updates to FMCSA regulations, including the adoption of new texting and cell phone use prohibitions.

The commission does not anticipate an economic impact resulting from the adoption of the proposed edits to this existing regulation.

**K.A.R. 82-4-3i.** This existing regulation adopts relevant portions of the FMCSA regulations (49 C.F.R. Part 393) governing the parts and accessories necessary for the safe operation of commercial motor vehicles. The proposed amendments to this regulation include edits to reflect minor grammar and form corrections, and deletions and additions required to reflect the most recent updates to FMCSA regulations.

The commission does not anticipate an economic impact resulting from the adoption of the proposed edits to this existing regulation.

**K.A.R. 82-4-3j.** This existing regulation adopts relevant portions of the FMCSA regulations (49 C.F.R. Part 396) governing the inspection, repair and maintenance of commercial motor vehicles. The proposed amendments to this regulation include minor grammar and form corrections, and deletions and additions required to reflect the most recent updates to FMCSA regulations.

The commission does not anticipate an economic impact resulting from the adoption of the proposed edits to this existing regulation.

K.A.R. 82-4-3k. This existing regulation adopts relevant portions of the FMCSA regulations (49 C.F.R. Part 397) governing the transportation of hazardous materials with specific respect to driving and parking rules. The proposed amendments to this regulation reflect minor grammar and form corrections, and deletions and additions required to reflect the most recent updates to FMCSA regulations.

The commission does not anticipate an economic impact resulting from the adoption of the proposed edits to this existing regulation.

**K.A.R. 82-4-31.** This existing regulation adopts relevant portions of the FMCSA regulations (49 C.F.R. Part 398) governing the transportation of migrant workers. The proposed amendments to this regulation include edits to reflect minor grammar and form corrections, and deletions and additions required to reflect the most recent updates to FMCSA regulations.

The commission does not anticipate an economic impact resulting from the adoption of the proposed edits to this existing regulation.

**K.A.R. 82-4-3m.** This existing regulation adopts relevant portions of the FMCSA regulations (49 C.F.R. Part 399) establishing motor carrier employee safety and health standards. The proposed amendments to this regulation include edits to reflect minor grammar and form

corrections, and deletions and additions required to reflect the most recent updates to FMCSA regulations.

The commission does not anticipate an economic impact resulting from the adoption of the proposed edits to this existing regulation.

K.A.R. 82-4-3n. This existing regulation adopts relevant portions of the FMCSA regulations (49 C.F.R. Part 387) establishing requirements for the minimum levels of financial responsibility for motor carriers. The proposed amendments to this regulation include edits to reflect minor grammar and form corrections, and deletions and additions required to reflect the most recent updates to FMCSA regulations.

The commission does not anticipate an economic impact resulting from the adoption of the proposed edits to this existing regulation.

K.A.R. 82-4-30. This existing regulation adopts relevant portions of the FMCSA regulations (49 C.F.R. Part 386, Subpart F) establishing procedures relevant to imminent hazard with respect to motor carriers. The proposed amendments to this regulation include edits to reflect minor grammar and form corrections, and deletions and additions required to reflect the most recent updates to FMCSA regulations.

The commission does not anticipate an economic impact resulting from the adoption of the proposed edits to this existing regulation.

K.A.R. 82-4-6d. This existing regulation establishes the application procedures for motor carriers and their drivers regarding waivers of the federal physical fitness requirements. The waiver application process permits certain drivers an additional opportunity to prove fitness to operate a commercial motor vehicle. The commission does not anticipate an economic impact resulting from the adoption of the proposed edits to this existing regulation.

K.A.R. 82-4-8a. This existing regulation establishes the minimum requirement for safety equipment that must be maintained by motor carriers and drivers of commercial motor vehicles. The proposed edits to this regulation adopt the Environmental Protection Agency's (EPA) toxicity standards set out in 40 C.F.R. Part 82, Subpart G. The edits also include minor grammar and form changes.

The commission does not anticipate an economic impact resulting from the adoption of the proposed edits to this existing regulation.

K.A.R. 82-4-20. This existing regulation establishes the minimum requirements and standards to be observed in the transportation of hazardous materials by motor carriers and operators of commercial motor vehicles. The proposed edits to this regulation include the adoption of federal regulations concerning pretransportation functions and edits to achieve consistency with federal requirements.

The commission does not anticipate an economic impact resulting from the adoption of the proposed edits to this existing regulation.

**K.A.R. 82-4-27.** This existing regulation establishes the procedures for filing applications for certificates of convenience and necessity and certificates of public service. The proposed edits to this regulation delete the requirement to submit certain financial information.

The commission does not anticipate an economic impact resulting from the adoption of the proposed edits to this existing regulation.

**K.A.R. 82-4-29.** This existing regulation establishes the procedures for filing applications for private carrier permits. The proposed edits to this regulation delete the requirement to submit certain financial information.

The commission does not anticipate an economic impact resulting from the adoption of the proposed edits to this existing regulation.

**K.A.R. 82-4-39.** This existing regulation establishes the procedures for surrendering motor carrier identification and authority cards upon the abandonment or cancellation of the carrier's operating authority. The proposed edits to this regulation update and clarify the time and manner of surrendering identification and authority cards.

The commission does not anticipate an economic impact resulting from the adoption of the proposed edits to this existing regulation.

**K.A.R. 82-4-48a.** This existing regulation establishes the requirements and procedures for the issuance of bills of lading, way bills and freight bills. The proposed edits to this regulation remove all references to contract carriers.

The commission does not anticipate an economic impact resulting from the adoption of the proposed edits to this existing regulation.

# **Governmental Ethics Commission**

### **Opinion No. 2013-02**

Written April 17, 2013, to Mike Pirner.

**Synopsis:** The use of social media to solicit contributions by those described in K.S.A. 2012 Supp. 25-4153(a)(1) through (a)(6) violates the Campaign Finance Act if the solicitation would be received by any registered lobbyist, political committee or person, other than an individual (e.g. a business), after January 1 of each year and prior to adjournment sine die of the regular session of the legislature or at any other time in which the legislature is in session. A disclaimer, included in the solicitation, is not a defense to a violation of the Campaign Finance Act.

Dear Mr. Pirner:

This opinion is in response to your email sent March 8, 2013, requesting an opinion from the Kansas Governmental Ethics Commission, concerning application of the state Campaign Finance Act, K.S.A. 25-4119e, et seq. We note at the outset that the Commission's jurisdiction is limited to the applicability of the Campaign Finance Act, and the Commission's opinion does not address whether some other statutory system, common law theory, or agency rule or regulation applies to your inquiry.

# **Factual Statement**

We understand that you are asking for this opinion based upon your involvement with the campaign supporting the candidacy of Beverly Gossage for insurance commissioner, a state officer elected on a statewide basis. An announcement for a kickoff party scheduled during the regular session of the legislature soliciting donations is proposed for posting on the campaign's page on Facebook, a social networking website on the Internet. As proposed, the post would include: a link that would allow users to sign up to attend, a link which directs users to the campaign's Internet website to make donations, and a disclaimer. The disclaimer provides, "[d]onations from registered lobbyists, PACs, or businesses are prohibited during the legislative session. Accordingly, only an individual who is not a registered lobbyist in Kansas may donate to Beverly Gossage for Kansas."

Alternatively, the announcement is proposed to be posted on the campaign's website with a link to it posted on the campaign's Facebook page which directs users viewing the page to the campaign's website for the express purpose of making a donation. One example, of the language provided in your email, within which the link is to be embedded, is: "I need your support! Help our campaign by visiting my website and making a donation of \$50 today!"

A Facebook page is networked with others on a limited basis. In order for pages to be networked so that they may be viewed by other users, the pages must belong to users that are friends or be liked or shared by other users. To be "friends" on Facebook requires the action of users through the issuance and acceptance of a friend request. Once friends, users may visit each other's page or receive news feeds on their own page of new and edited content posted on their friends' pages. The accessibility of a user's content to "friends" may be limited or blocked by user options within Facebook.

Facebook describes the Like-feature (hereinafter Like) as a way for users to give positive feedback and connect with things they care about. When a user clicks on Like, the associated content appears in the news feeds of that user's friends. The distribution is not controlled by the user making the post. This is unlike the distribution of content between friends, since users control who their friends are. The use of Like, by a succession of users, causes distribution of posts through a large series of networked friends, friends of friends, and so on.

# Question

- 1. May a legislator, officer, candidate or committee described in K.S.A. 2012 Supp. 25-4153a(a)(1) through (a)(6) solicit contributions through social media after January 1 of each year and prior to adjournment sine die of the regular session of the legislature or at any time when the legislature is in session?
- 2. If not, will a disclaimer within such solicitation exculpate any legislator, officer, candidate or committee described in K.S.A. 2012 Supp. 25-4153(a)(1) through (a)(6)?

# Analysis and Opinion

The Campaign Finance Act, specifically K.S.A. 2012 Supp. 25-4153a(b), limits accepting and soliciting of contributions:

No legislator, officer, candidate or committee described in paragraphs (1) through (6) of subsection (a) shall accept or knowingly solicit any contribution as defined by K.S.A. 25-4143, and amendments thereto, from any registered lobbyist, political committee or person, other than an individual, during such period of time described in subsection (a).

Paragraphs (1) through (6) of subsection (a) describe "legislator, officer, candidate or committee" more specifically as:

- (1) Legislator;
- (2) candidate for membership in the legislature;
- (3) state officer elected on a statewide basis;
- (4) candidate for state officer elected on a statewide basis;
- (5) candidate committee of persons described in paragraphs (1) through (4); or
- (6) political committee of any political party and designated as a recognized political committee for the senate or house of representatives.

Subsection (a) describes the time period referenced in subsection (b) of K.S.A. 2012 Supp. 25-4153a as being:

...after January 1 of each year and prior to adjournment sine die of the regular session of the legislature or at any other time in which the legislature is in session.

And K.A.R. 19-20-2(c) implements 2012 Supp. K.S.A. 25-4153a by defining "session" as follows:

"Session" means both the regular and special sessions of the legislature. Regular session includes the time period commencing January 2 through final adjournment. Special session includes the time of commencement through final adjournment.

"Solicit" is defined as "to ask or seek earnestly or pleadingly; appeal to or for." Webster's New World College Dictionary, 1276 (3rd ed. 1996). Also, "to endeavor to obtain by asking or pleading; to seek eagerly or actively." Webster's Third New International Dictionary, 2169 (1993). "Solicitation" is defined as, "[t]he act or an instance of requesting or seeking to obtain something; a request or petition." Black's Law Dictionary, 1427 (8th ed. 2004). These definitions all indicate an overt action by a person in order to solicit.

Knowingly, or "knowing" is defined as "[h]aving an awareness or understanding; well-informed" and, "[d]eliberate; conscious." *Black's Law Dictionary*, 888 (8th ed. 2004). Also, "knowledge" is defined as "an awareness

or understanding of a fact or circumstance; a state of mind in which a person has no substantial doubt about the existence of a fact." (*ibid.*).

As a candidate for Kansas insurance commissioner, Beverly Gossage is a candidate for state officer elected on a statewide basis, as described in K.S.A. 2012 Supp. 25-4153a(a)(4). Pursuant to K.S.A. 2012 Supp. 25-4153(b), neither she, nor anyone on behalf of her campaign, may knowingly solicit contributions from "any registered lobbyist, political committee, or person, other than an individual" (hereinafter "prohibited persons").

Whether it is the kickoff party announcement, or a link embedded within the language "I need your support! Help our campaign by visiting my website and making a donation of \$50 today!," both are deliberate, conscious acts to seek contributions. We opine that both acts are within the statutory language of "knowingly solicit."

Unlike the event invite-feature or share-feature that allows a user (in this case the campaign) to select specific recipients to ensure that prohibited persons are not solicited, posts to the campaign's Facebook "page" are distributed to the news feeds of friends of the campaign's Facebook page. Further, use of Facebook's Like would distribute posts to the news feeds of friends of friends, and so on, without any ability to control or limit such distribution. It causes posts to be distributed by news feeds and viewable on other users' pages without any affirmative action by those users.

Given the present facts, Beverly Gossage's campaign may only intend to solicit individual persons, but has knowledge that, inevitably, the solicitation would, in turn, distribute to prohibited persons by use of Like. Receipt by a registered lobbyist, committee, or persons other than an individual occurs on their news feeds through no action on their part. Therefore, we opine that a general post to a Facebook page which solicits contributions—whether it is the kickoff party announcement or solicitation-language within which a link is embedded—is a violation of the Campaign Finance Act should it occur within the period specified by K.S.A. 2012 Supp. 25-4153a and K.A.R. 19-20-2(c).

Finally, a disclaimer, while reminding recipients who are prohibited persons of their obligation not to make contributions as proscribed by K.S.A. 2012 Supp. 25-4153a(a). Its inclusion would not relieve the candidate and the campaign of the subsection (b) requirement to not solicit contributions in the first place.

# Conclusion

When a legislator, officer, candidate or committee described in K.S.A. 2012 Supp. 25-4153a(a)(1) through (a)(6) solicits contributions though social media that are proscribed by K.S.A. 2012 Supp. 25-4153a(b), it is a violation of the Campaign Finance Act unless its distribution excludes any recipient that is a prohibited person described in statute. The essence of the violation is the solicitation. As such, a disclaimer is not exculpatory.

# **Request for Comments**

The Kansas Department of Health and Environment is soliciting comments regarding a proposed air quality construction permit. The Empire District Electric Company (Empire) located at 602 S. Joplin Ave., Joplin, MO 64802, has applied for an air quality construction permit in accordance with the provisions of K.A.R. 28-19-300 to convert the Unit 12 combustion turbine from simple-cycle to combined-cycle operation at the Riverton Power Station, 7240 S.E. Highway 66 in Cherokee County, Riverton, KS 66750.

Emissions of oxides of nitrogen (NOx), sulfur dioxide (SO<sub>2</sub>), carbon monoxide (CO), volatile organic compounds (VOC), particulate matter (PM), PM with a diameter less than 10 microns (PM<sub>10</sub>), PM with a diameter less than 2.5 microns (PM<sub>2.5</sub>), lead, sulfuric acid mist (SAM), hydrogen fluoride (HF) and carbon dioxide equivalent (CO<sub>2</sub>e) were evaluated during the permit review process.

The proposed permit is to be issued in accordance with the provisions of K.A.R. 28-19-350, prevention of significant deterioration (PSD), which adopt the federal standards, procedures and requirements of 40 CFR 52.21 by reference. These air quality regulations apply to major stationary emission sources located in areas designated as "attainment" under the federal Clean Air Act (CAA). Attainment areas are areas where the air quality meets or is better than the national ambient air quality standards (NAAQS).

The PSD regulations require evaluation of emission reduction techniques to identify the best available control technology (BACT) for each pollutant for which the emission rate exceeds the PSD significant level. The purpose of BACT is to affect the maximum degree of reduction achievable, taking into account energy, environmental and economic impacts for each pollutant under review. Evaluation of the estimated emissions for the proposed Riverton Power Station project indicates that the emission rates of PM, PM<sub>10</sub>, PM<sub>2.5</sub> and CO<sub>2</sub>e exceed the significance levels. Empire conducted the required BACT analysis for PM, PM<sub>10</sub>, PM<sub>2.5</sub> and CO<sub>2</sub>e. The department has reviewed Empire's BACT analysis and concurs with its findings for PM, PM<sub>10</sub>, PM<sub>2.5</sub> and CO<sub>2</sub>e.

An ambient impact analysis was performed on the potential air emissions of  $PM_{10}$  and  $PM_{2.5}$  from this project.

- A preliminary modeling analysis conducted for the 24-hour  $PM_{10}$  averaging period demonstrated no significant impact to the 24-hour  $PM_{10}$  ambient air quality standard and demonstrated that not more than 4.4 percent of the 24-hour Class II maximum allowable increment for  $PM_{10}$  is expected to be consumed.
- A preliminary modeling analysis conducted for the annual PM<sub>2.5</sub> averaging period demonstrated no significant impact to the annual PM<sub>2.5</sub> ambient air quality standard and that not more than 2.8 percent of the annual Class II maximum allowable increment for PM<sub>2.5</sub> is ex-

pected to be consumed. A preliminary modeling analysis conducted for the 24-hour  $PM_{2.5}$  ambient air quality standard demonstrated no significant impact to the 24-hour  $PM_{2.5}$  ambient air quality standard and that not more than 12.0 percent of the 24-hour Class II maximum allowable increment for  $PM_{2.5}$  is expected to be consumed.

An analysis of visibility was conducted for Crawford State Park and Joplin Regional Airport. No Class I areas are located within 100 km of the facility. The VISCREEN model results indicate that the proposed project is not expected to have an adverse impact on visibility in these areas. No adverse impacts on soils and vegetation in the area are expected. Any federal land manager who has reason to believe they may have a federal Class I area adversely impacted by the emissions from the proposed project has the opportunity to present KDHE with a demonstration of the adverse impact on the air quality-related values of the federal Class I area during the comment period.

A public comment period has been established until 5 p.m. June 3 to allow citizens the opportunity to express any concerns they may have about this proposed permitting action. All comments should be submitted in writing to Larry D. Lowry, P.E., KDHE, Bureau of Air, 1000 S.W. Jackson, Suite 310, Topeka, 66612-1366, or presented at the public hearing.

Any member of the public may request a public hearing be conducted to receive comments on the proposed issuance of the draft air quality construction permit. A written request to hold a public hearing should be sent to the attention of Larry D. Lowry, P.E., at the address listed above or by fax to 785-291-3953 and must be received by noon May 27. If no pertinent requests to hold the public hearing are received by this date and time, the public hearing will be cancelled. A notice of the cancellation will be posted at the KDHE website at http://www.kdheks.gov/bar/public\_notice.html.

If a pertinent request is received, a public hearing is tentatively scheduled by KDHE at 5 p.m. June 6 at the Riverton Community Center, 7029 S.E. 70th St., Riverton. The hearing will continue until audience members have an opportunity to submit comments.

If a hearing is conducted, all interested parties will be given a reasonable opportunity to present their views orally or by submission of written materials during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request that each participant limit oral presentations to a specific time limit.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed materials in an accessible format. Requests for accommodation must be made not later than May 27 by contacting Larry D. Lowry at 785-296-6281.

Copies of the proposed permit, permit application, all supporting documentation and all information relied upon during the permit application review process are available for public review for a period of 30 days from the date of publication during normal business hours, 8
