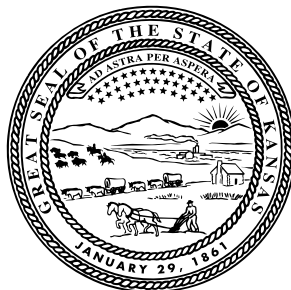

This project is to investigate and prepare reports for underwater bridge inspections in accordance with FHWA-DP-90-1 within calendar year 2015. The project has 21 locations, which include four Missouri River crossings. The consultant will need to augment the underwater diving inspections with side scan radar technology. The consultant will also be an “on-call” consultant for additional underwater inspections through calendar year 2018 as warranted by flood events and to fulfill the LPA annual underwater bridge inspection needs.

The Kansas Department of Health and Environment received Hazardous Waste Facility Part A and Part B permit renewal applications from Koch Nitrogen Company, LLC (operator/owner). The facility is located at 11559 U.S. Highway 50, Dodge City, Kansas, and has EPA identification number KSD044625010.

KDHE is providing notice of its intent to renew the RCRA hazardous waste management permit for the facility. The proposed permit will require Koch Nitrogen Company, LLC, to close the Chromium Destruct Unit, conduct post-closure care for this regulated unit, and implement site-wide corrective action including groundwater monitoring and remediation at the facility.

In October 1985, the state of Kansas received final authorization from the U.S. Environmental Protection Agency to implement a hazardous waste management program in lieu of the federal program, except for those portions covered by the 1984 Hazardous and Solid Waste Amendments (HSWA). In September 2013, authority for the corrective action portion of the RCRA program was delegated to the state of Kansas.

The draft permit sets forth in a concise document all of the applicable requirements that KDHE will require the permittee to comply with during the 10-year duration of the permit. The draft hazardous waste permit includes standard permit conditions, general facility conditions, closure and post-closure care requirements, groundwater monitoring and remediation, as well as corrective action for all solid waste management units and areas of concern.

The draft permit is being considered for issuance under authority of K.S.A. 65-3430 et seq. and K.A.R. 28-31-4 through 28-31-279a. Documents that support the permit conditions specified in the draft permit are part of the

administrative record. Applicable regulations are found in 40 CFR Parts 124, 260 through 264, 268 and 270, as specified in this permit. All citations found in the draft permit to federal regulations are for the sake of convenience. Some modifications to federal regulations by applicable state regulations are noted in this permit, but all modifications to federal regulations by state regulations are incorporated. To the extent that state regulations exclude any sections of applicable federal regulations, those sections are not in effect. In the instance of inconsistent language or discrepancies between conditions found in the permit, state regulations or federal regulations, the language of the more stringent provision will govern; otherwise, state law governs.

State hazardous waste laws require that the public be given at least 45 days to review the administrative record for the draft permit prior to KDHE taking a final action. The purpose of having a public comment period is to ensure that interested parties have the opportunity to evaluate the conditions specified in the draft permit and to provide their input into the permit decision-making process. A copy of the administrative record, which includes the draft permit, the fact sheet, the permit application and all information pertaining to this permit action, is available for public review from September 2 to October 17, Monday through Friday during normal business hours, at the following locations:

The bonds will be sold subject to the legal opinion of Triplett, Woolf & Garretson, LLC, Wichita, Kansas, bond counsel, whose fees will be paid by the city.

**Financial Matters**

The city's current assessed valuation for purposes of calculating statutory debt limitations is \$23,859,155. As of October 1, 2014, the city's total outstanding general obligation debt (including the bonds), is \$3,825,000, which excludes temporary notes outstanding in the amount of \$770,000 that will be retired with proceeds of the bonds described herein. The city's total indebtedness subject to debt limitation, as of October 1, 2014, is estimated to be \$269,111.05, which is 1.21 percent of the assessed valuation of the city.

**Article 9.—HOURS; LEAVES; EMPLOYEE-  
MANAGEMENT RELATIONS**

**1-9-22. Job injury leave.** (a) Each classified or unclassified employee who sustains a qualifying job injury, as determined by the employee’s appointing authority, shall be eligible for job injury leave in accordance with this regulation.

(b) “Qualifying job injury” shall mean an injury that meets the following conditions:

(1) Renders the employee unable to perform the employee’s regular job duties;

(2) arose out of and in the course of employment with the state; and

(3)(A) Was sustained as a result of a shooting, stabbing, or aggravated battery as defined in K.S.A. 21-5413 and amendments thereto, by another against the employee;

(B) was sustained as a result of a confrontation with a patient or client in a facility or ward for mental health, intellectual disability, or developmental disability in which the patient or client inflicts great bodily harm, causes disfigurement, or causes bodily harm with a deadly weapon or in any manner by which great bodily harm, disfigurement, dismemberment, or death can be inflicted; or

(C) was sustained in any other situation in which the appointing authority determines that job injury leave is in the best interest of the state.

(c) Job injury leave shall not exceed six total months away from work. While an employee is on approved job injury leave, the employing state agency shall continue to pay the employee’s regular compensation. If the employee is awarded worker’s compensation, the state

*(continued)*

agency shall pay the employee compensation in an amount that, together with worker's compensation pay, equals the regular pay of the employee. The employee shall not be required to use accrued sick leave or vacation leave. The employee shall continue to accrue sick and vacation leave as long as the employee remains in pay status. Nothing in this regulation shall be construed as providing voluntary or gratuitous compensation payments in addition to temporary total disability compensation payments pursuant to the worker's compensation laws.

(d) The appointing authority may require an employee on approved job injury leave to return to full or limited duty if the employee is physically able to perform the duty as determined by a physician selected by the appointing authority or selected by a representative of the state self-insurance fund. However, limited duty allowed shall not, in combination with time away from work on job injury leave, exceed the total six months allowed for job injury leave. If the employee remains unable to return to full duty, the appointing authority shall take any action deemed to be in the best interest of the state.

(e) While an employee is on approved job injury leave, the appointing authority may require the employee to be examined by a physician selected by the appointing authority to determine the capability of the employee to return to full or limited duty.

(f) Each employee on approved job injury leave shall be prohibited from being gainfully employed by any other employer.

(g) The requirements of this regulation may be waived or modified by the director upon written request of the appointing authority. Any waiver or modification may be granted only upon a finding by the director that both of the following conditions are met:

(1) Granting the requested waiver or modification would not be in conflict with any statutes pertaining to leave.

(2) Failure to grant the requested waiver or modification would create a manifest injustice or undue hardship on the employee requesting the job injury leave. (Authorized by K.S.A. 75-3706, K.S.A. 2013 Supp. 75-3747; implementing K.S.A. 75-3707 and 75-3746; effective, T-86-17, June 17, 1985; effective May 1, 1986; amended Nov. 21, 1994; amended Dec. 17, 1995; amended Sept. 12, 2014.)

#### Article 14.—LAYOFF PROCEDURES AND ALTERNATIVES TO LAYOFF

**1-14-11. Furlough.** (a) For purposes of this regulation, "furlough" shall mean mandatory leave without pay for a preset number of hours during each pay period covered by the furlough. There are two types of furloughs.

(1) An administrative furlough is a planned action by an agency that is designed to address budget reductions necessitated by reasons other than a lapse in appropriations. A furlough plan shall be required for each administrative furlough.

(2) An emergency furlough occurs if there is an immediate or imminent lack of funding to continue agency operations or any emergency that results in an unantic-

pated interruption of funding to the agency. In an emergency furlough, an affected agency could have to cease activities that are not excepted by law, typically with very little lead time. A furlough plan shall not be required for any emergency furlough.

(b) In accordance with this regulation, if an appointing authority deems it necessary, the appointing authority may implement an administrative furlough or an emergency furlough for all employees in the classified or unclassified service in designated classes, positions, organizational units, geographical areas, or any combination of those groups unless specific funding sources necessitate exceptions. An employee's social security and retirement contributions shall be affected under a furlough, but all other benefits, including the accrual of vacation and sick leave, shall continue, despite any other regulations to the contrary. A furlough shall not affect the employee's continuous service, length of service, pay increase anniversary date, or eligibility for authorized holiday leave or pay.

(c)(1) For each administrative furlough, at least 30 calendar days before the date the administrative furlough is to be implemented, the appointing authority shall prepare a furlough plan specifying the following information:

- (A) The cause of the funding shortage;
- (B) the effective date of the furlough and the date on which the furlough is to end;
- (C) the methods for notifying the affected employees;
- (D) the amount of advance notice that will be given to affected employees, which shall not be less than 10 calendar days;
- (E) the estimated cost savings;
- (F) each class, organizational unit, or geographical area to be affected;
- (G) the criteria used to select each class, position, organizational unit, or geographical area to be included in the furlough;
- (H) any exceptions to the furlough plan based on funding sources; and
- (I) the number of hours by which the workweek will be reduced, including separate categories detailing the proposed reduction in hours by standardized increments for exempt and nonexempt employees.

(2) A copy of each furlough plan prepared in accordance with this subsection shall be submitted to the director at least 30 days before the date the administrative furlough is to be implemented.

(d) For each emergency furlough, the affected employees and the director shall be notified by the appointing authority as soon as it is practical to do so.

(e) This regulation shall not be used as a disciplinary action against any employee. (Authorized by K.S.A. 75-3706, K.S.A. 2013 Supp. 75-3747, and K.S.A. 75-5514; implementing K.S.A. 75-3707, 75-3746, and 75-5505; effective, T-88-5, Feb. 11, 1987; effective, T-89-1, May 1, 1988; effective Oct. 1, 1988; amended May 31, 1996; amended June 5, 2005; amended Sept. 12, 2014.)

The retailer clerk shall give the \$1.00 2by2 quick pick free play to the customer who purchased the \$3.00 Powerball with Power Play ticket. The term of this promotion shall begin July 27, 2014, at 5:00 a.m. and will conclude on whatever date and time occurs when 30,000 2by2 quick pick free promotion tickets are generated. (Authorized by and implementing K.S.A. 2013 Supp. 74-8710; effective, T-111-8-7-14, July 16, 2014.)

**Article 7.—KANSAS-ONLY ONLINE GAMES**

**111-7-262. Keno doubler promotion.** (a) The Kansas lottery may conduct a Keno promotion entitled "Keno Doubler Promotion" offering Kansas lottery players the opportunity to win double the prize amount won on certain Keno tickets.

(b) The term of the "Keno Doubler Promotion" shall begin on August 10, 2014, at 5 a.m. and conclude at 2:00 a.m. on August 24, 2014. The term of the "Keno Doubler Promotion" shall mean the time during which qualifying Keno tickets may be purchased by lottery players.

(c) A qualifying Keno ticket purchased during the term of the promotion shall be utilized by the player to play a Keno game at a time which is subsequent to purchase of the ticket. Any Keno ticket with multiple draws purchased prior to the term of the promotion shall not be eligible to win a double prize in this promotion. Any Keno ticket with multiple draws purchased before the end of the promotion term with draws after the promotion ended will still be eligible to win a double prize in this promotion.

(d) Keno tickets eligible to win double a prize amount during "Keno Doubler Promotion" and according to the terms of the promotion shall be offered for sale at any Kansas lottery retail selling location which offers the Kansas lottery Keno product to its players.

(e) On every twentieth Keno ticket sold statewide during the promotion which is eligible to win a double prize amount, a qualifying message shall be printed on the ticket front. The qualifying message printed on the ticket front shall read, "Congratulations! Any prizes won on this ticket will be doubled! Good luck! Some exclusions apply."

#### Article 17.—SPECIFIC ONLINE DRAWING RULES

**111-17-15. Ultimate Chiefs experience second-chance drawing.** (a) The Kansas lottery shall conduct a second-chance online event drawing entitled "Ultimate Chiefs Experience Second-Chance Drawing." The Kansas lottery will accept online entries into the drawing beginning at midnight July 2, 2014, and ending at noon on February 3, 2015. The drawing will be announced with at least 24 hours advanced notice via the lottery's website, and other social media forums such as Facebook and Twitter. The drawing will be conducted sometime after entry into the drawing has closed, but before noon on February 6, 2015.

(b) The specific ticket eligible for entry into this second-chance online event drawing shall be the \$5 Kansas City Chiefs, game number 491.

(c) The Kansas lottery shall award five grand prize packages to players who entered the "Ultimate Chiefs Experience Second-Chance Drawing" using the \$5 Kansas lottery instant ticket named Kansas City Chiefs, game number 491. Each prize package shall consist of access to a 2015-2016 Kansas City Chiefs season suite for one winner and three guests for one game of the Lottery's choosing, and unlimited food and non-alcoholic beverages. Each suite guest will receive a gift bag with a \$25 stadium gift card, a Chiefs cheerleader calendar, a Chiefs hat, a Chiefs 2015 yearbook, and other lottery/Chiefs products possible. A drawing in the suite will be held for attending winners and their guests to win autographed merchandise. The game or games at which the events included in the grand prize package shall occur will be determined by the executive director of the Kansas lottery and representative(s) of the Kansas City Chiefs. Each grand prize is valued at approximately \$9,514.29.

(d) There will be one drawing held to select winners of the grand prizes. The drawing shall select 15 entrants. The first five entrants drawn in this drawing shall be awarded a grand prize identified in subsection (c). The next 10 entrants drawn in this drawing (identified as numbers 6 through 15) will be used as alternate winners, if necessary, in the order drawn.

(e) A winner of a grand prize shall be notified via email that he or she has won a prize. The winner shall be instructed how to verify his or her personal identification.

(f) A winner shall be sent a claim form via U. S. mail at the time the winner is notified he or she has won a prize.

(g) A player who is among the first five winners selected in this drawing to receive a grand prize must return his or her completed claim form and must be received by the Kansas lottery within 14 days following the date of the online event drawing. (k) In the event any football game in the grand prize package awarded for this drawing is postponed, changed, or canceled in whole or in part, no cash prize substitutions or other compensation shall be provided.

(l) Any player entering the Ultimate Chiefs Experience Second-Chance Drawing agrees to public disclosure.

(m) The Kansas lottery reserves the right to substitute prizes at its sole and total discretion of approximate equal value.

#### Article 301.—SPECIFIC LOTTERY FACILITY GAMES AT LOTTERY GAMING FACILITIES

**111-301-17. Wagers.** (a) All wagers at Let It Ride shall be made by placing gaming chips and, if applicable, a match play coupon on the appropriate betting areas of the table layout. A verbal wager accompanied by cash shall not be accepted.

(b) Only players who are seated at the Let It Ride table may touch the cards. Once a player has placed a wager and received cards, that player must remain seated until the completion of the round of play.

(c) All ante wagers at Let It Ride shall be placed prior to the dealer dealing the first card. No wager at Let It Ride shall be made, increased or withdrawn after the dealer has dealt the first card.

(d) At the beginning of each round of play, each player shall be required to place three equal but separate wagers. The wagers shall be identified as bet number 1, bet number 2 and bet number 3 (which betting position may also be designated by the symbol "\$"). Bet number 1 and bet number 2 may subsequently be removed by the player in accordance with K.A.R. 111-301-18, play rules.

(e) A Lottery Gaming Facility Manager may, in its discretion, permit a player to place wagers at two betting positions during a round of play provided that the two betting positions are adjacent to each other.

(f) After each round of play is complete, the dealer shall collect all losing wagers and pay off all winning wagers in accordance with the payout table. (Authorized by K.S.A. 2013 Supp. 74-8710 and 74-8748; implementing K.S.A. 2013 Supp. 74-8710; effective, T-111-12-29-10, Dec. 9, 2010; amended, T-111-8-7-14, July 16, 2014.)

**111-301-18. Play.** (a) The starting position for the dealing of cards or the delivery of stacks of cards for the game of Let It Ride may be determined in the following manners:

(b) The dealer shall deal three cards to each player starting with the player farthest to his/her left, face down in a clockwise manner. The dealer shall then burn one card, then deal two cards face down to the dealer, which cards are known as the community cards.

(c) After each player has examined his or her cards, the dealer shall, beginning with the player farthest to the dealer's left and moving clockwise around the table, ask

each player if he or she wishes to withdraw bet number 1 or let it ride.

(1) If a player chooses to let bet number 1 ride, that bet shall remain on the appropriate betting area of the layout until the end of the round of play.

(2) If a player chooses to withdraw bet number 1, the dealer shall move the gaming chips on the betting area designated for bet number 1 toward the player who shall then immediately remove the gaming chips from the betting area.

(d) After each player has made a decision regarding bet number 1, the dealer shall then reveal the first community card.

(e) After the first community card is exposed, the dealer shall, beginning with the player farthest to the dealer's left and moving clockwise around the table, ask each player if he or she wishes to withdraw bet number 2 or let it ride. This decision shall be made by each player regardless of the decision made concerning bet number 1.

(1) If a player chooses to let bet number 2 ride, that bet shall remain on the appropriate betting area of the layout until the end of the round of play.

(2) If a player chooses to withdraw bet number 2, the dealer shall move the gaming chips on the betting area designated for bet number 2 toward the player who shall then immediately remove the gaming chips from the betting area.

(f) After each player has made a decision regarding bet number two, each player's cards shall be placed face down on the appropriate area of the layout, the player shall not touch the cards again.

(g) The dealer shall then reveal the second community card.

(h) After the second community card is turned face up, the dealer shall, beginning with the player farthest to his or her right and continuing around the table in a counterclockwise direction, complete the following applicable procedures in succession for each player.

(1) The dealer shall turn the three cards of the player face up. The two community cards and the three cards dealt to the player shall form the five card poker hand of that player.

(2) The dealer shall examine the cards of the player to determine if the player's hand qualifies for a payout pursuant to the approved payout table. Any let it ride poker wager on a hand which has a rank that is lower than a pair of tens shall be a losing wager.

(3) The dealer shall then settle all wagers of that player. All losing wagers by the player shall be immediately collected by the dealer and placed in the table inventory container. After all losing wagers have been collected; all winning wagers shall be paid in accordance with the payout odds.

(4) All hands shall remain face up on the layout until all wagers have been settled by the dealer.

(i) After settling all wagers, the dealer shall immediately collect the cards of all players and the community cards and places them in the discard rack. All cards collected by the dealer shall be picked up in order and placed in the discard rack in such a way that they can be readily arranged to reconstruct each hand in the event of

a question or dispute. (Authorized by K.S.A. 2013 Supp. 74-8710 and 74-8748; implementing K.S.A. 2013 Supp. 74-8710; effective, T-111-12-29-10, Dec. 9, 2010; amended, T-111-8-7-14, July 16, 2014.)

**111-301-19. Payout odds.** (a) For a winning hand, bet number 1, bet number 2, and bet number 3 are paid the same payout odds ranging from 1 to 1 for a pair of 10's or better to 500 to 1 for a royal flush.

(b) All winning wagers will receive the following payout odds:

Hand Ranking	Odds
Royal Flush	500 to 1
Straight Flush	200 to 1
4 of a Kind	50 to 1
Full House	11 to 1
Flush	8 to 1
Straight	5 to 1
3 of a Kind	3 to 1
Two Pair	2 to 1
Pair of 10s or Better	1 to 1

(Authorized by K.S.A. 2013 Supp. 74-8710 and 74-8748; implementing K.S.A. 2013 Supp. 74-8710; effective, T-111-12-29-10, Dec. 9, 2010; amended, T-111-8-7-14, July 16, 2014.)

**111-301-45. Dead man's hand optional blackjack wager.** (a) On or after August 1, 2014, Boot Hill Casino & Resort may offer an optional "Dead Man's Hand" wager at any table offering the game of blackjack, as set forth in the rules herein. Except as otherwise set forth in the rules herein, all rules of the game of blackjack shall remain unaltered and any optional Dead Man's Hand wager made shall not affect any other blackjack wager.

(b) The Dead Man's Hand optional wager shall be played following the rules of the game of blackjack except as follows:

(1) A player may not place a Dead Man's Hand wager unless the player has also placed at least the minimum blackjack wager required at that blackjack table.

(2) Blackjack tables where the optional Dead Man's Hand wager is available shall have a spot designated on the table game layout where the wager can be placed.

(3) At the option of Boot Hill Casino & Resort, the game shall be played using one, two, five, six or eight standard 52-card decks of playing cards.

(4) At the same time a player makes his or her standard blackjack wager, the player has an opportunity to make the optional Dead Man's Hand wager in even dollar amounts. The minimum and maximum amounts of the Dead Man's Hand wager permitted shall be posted on the table signage and cannot be more than the maximum original blackjack wager.

(5) If the player is playing more than one hand, the same number of Dead Man's Hand wagers can be made.

(6) Players that have made the Dead Man's Hand wager and are not dealt at least one ace or one eight on his or her first two cards in each hand will lose his or her Dead Man's Hand wager.

(7) Players who make the optional Dead Man's Hand wager will win and be paid according to the pay table set forth hereinafter if:

(A) one of his or her first two cards dealt is an ace or an eight;

(B) his or her first two cards are an ace and an eight; or,

(C) his or her first two cards are two aces or two eights and the dealer has a blackjack.

(8) Players who have been dealt a pair of aces or a pair of eights can choose to split his or her hands. No additional Dead Man's Hand wager is required to split these hands. Splitting pairs will be handled as follows:

(A) Except as otherwise stated in these rules, the standard rules of the game of blackjack will apply to splitting pairs;

(B) Players may split pairs up to three times for a maximum of four hands;

(C) If a player splits a pair and then receives cards that bust the hand (results in a sum exceeding 21), the dealer will remove the cards that busted the hand and leave the initial aces or eights on the game table in a horizontal position. Once the player has completed taking cards, the dealer will calculate the winning pay out according to the pay table and pay the player accordingly;

(D) Players will be paid for the number of aces and/or eights they have been dealt when all splitting is done;

(E) If the player splits but does not receive any additional aces or eights, they will be paid for his or her initial pair of aces or eights according to the pay table;

(F) The objective of the game is to be dealt four sets of aces and/or eights after the player has split his or her initial pair of aces or eights;

(G) Players who split a pair of eights must clearly indicate on which hand they want to take an additional card or cards;

(H) Players who split eights up to three times under house rules allowing the splitting of aces only once will be paid for any two hands with an ace and an eight. Three or more hands with an ace and eight will not increase the payout; and,

(G) The game then continues to the next player.

(9) Players who make the Dead Man's Hand wager and are dealt a pair of aces or a pair of eights may choose not to split his or her pair and complete his or her hand according to his or her preference.

(10) In those instances when the dealer's card dealt face up is an ace, the procedure shall be as follows:

(A) Per standard rules of blackjack the dealer will offer all players the right to place an insurance wager;

(B) Per standard rules of blackjack the dealer will then check if he or she has a blackjack. If the dealer has a blackjack the dealer will collect all losing blackjack wagers from right to left;

(C) Per standard rules of blackjack the dealer will pay-out any winning insurance wagers; and,

(D) Starting from the dealer's right to left, the dealer shall then collect all losing Dead Man's Hand wagers and pay all winning Dead Man's Hand wagers according to the pay table, below.

(11) In those instances where the dealer's card dealt face up has a value of ten (10), the procedure shall be as follows:

(continued)

(A) The dealer shall check to see if he or she has a blackjack. If the dealer does have a blackjack, the dealer will collect all losing blackjack wagers and all losing Dead Man's Hand wagers;

(B) Starting from the dealer's right to left, the dealer will then pay all winning Dead Man's Hand wagers according to the pay table, below; and,

(C) If the dealer does not have a blackjack, the game resumes per the standard rules of the game of blackjack.

(12) The pay table of payout odds for the Dead Man's Hand optional wager is as follows (only the highest payout for which the hand is eligible shall be paid):

Two aces and two 8's - Pays 50 to 1

Two 8's - Pays 4 to 1

Two aces or two 8's with only an ace and 8 remaining after split - Pays 4 to 1

Two aces or two 8's with no split — Pays 4 to 1

Any ace or 8 dealt in the player's first two cards — Pays 2 to 1

Two aces or two 8's and the dealer has a blackjack — Pays 50 to 1

(13) Optional token wagers (dealer gratuities) may be placed on Dead Man's Hand wagers at the same time as the Dead Man's Hand wager is placed, and if placed shall also be paid or taken at the same time as the player's Dead Man's Hand wager is paid or taken and shall be paid at the same odds as the player's winning Dead Man's Hand wager. (Authorized by K.S.A. 2013 Supp. 74-8710 and 74-8748; implementing K.S.A. 2013 Supp. 74-8710; effective, T-111-8-7-14, July 16, 2014.)

**111-301-46. IN BETWEEN optional blackjack wager.** (a) On or after August 1, 2014, Boot Hill Casino & Resort may offer an optional "IN BETWEEN" wager at any table offering the game of blackjack, as set forth in the rules herein.

(b) Except as otherwise set forth in the rules herein, all rules of the game of blackjack shall remain unaltered and any optional IN BETWEEN wager made shall not affect any other blackjack wager.

(c) Blackjack tables where the optional IN BETWEEN wager is available shall have a spot designated on the table game layout where the wager can be placed.

(d) A player may not place an IN BETWEEN wager unless the player has also placed at least the minimum blackjack wager required at that blackjack table.

(e) All IN BETWEEN wagers shall be made at the same time as that player's blackjack wager and shall be no less than the minimum, and no more than the maximum, wager stated at the blackjack table for IN BETWEEN.

(f) IN BETWEEN wagers apply only to the first two cards dealt to a player and the card that is dealt face up to the dealer.

(g) An IN BETWEEN wager shall win if the dealer's card that is dealt face up is of a rank falling between the rank of the player's first two cards, and shall lose if it does not, when using the following order of rank: 2, 3, 4, 5, 6, 7, 8, 9, 10, jack, queen, king, and ace, except that an IN BETWEEN wager shall also win if the player's first two cards and the dealer's card that is dealt face up are all of the same identical rank.

(h) Winning combinations and payout odds for IN BETWEEN wagers are as follows:

(1) Winning wagers with a "one card spread" shall be paid at the rate of ten (10) to one (1). A "one card spread" occurs when the dealer's card dealt face up is one rank higher than one of the player's initial two cards and one rank lower than the other of the player's first two cards (by way of example only, the dealer's card dealt face up is an "8" and the player's initial two cards are a "7" and a "9");

(2) Winning wagers with a "two card spread" shall be paid at the rate of five (5) to one (1). A "two card spread" means when in order of rank there are two card ranks between the player's initial two cards, and the dealer's card dealt face up is equal to one of those two ranks (by way of example only, the dealer's card dealt face up is an "8" and the player's initial two cards are a "6" and a "9");

(3) Winning wagers with a "three card spread" shall be paid at the rate of three (3) to one (1). A "three card spread" means when in order of rank there are three card ranks between the player's initial two cards, and the dealer's card dealt face up is equal to one of those three ranks (by way of example only, the dealer's card dealt face up is an "8" and the player's initial two cards are a "5" and a "9");

(4) Winning wagers with a "three of a kind" shall be paid at the rate of thirty (30) to one (1). A "three of a kind" occurs when the dealer's card dealt face up and the player's first two cards are of the same identical rank; and,

(5) All other winning IN BETWEEN wagers are paid at the rate of one (1) to one (1).

(i) All IN BETWEEN wagers shall be paid or taken and removed from the betting area immediately after the second of each player's and the dealer's two cards have been dealt and before the blackjack hand is played. All IN BETWEEN wagers shall be paid or taken in order of the players at the table from the dealer's right to left.

(j) Optional token wagers (dealer gratuities) may be placed on IN BETWEEN wagers, which if placed shall also be paid or taken at the same time as the player's IN BETWEEN wager is paid or taken.

(k) All blackjack insurance wagers, if any, will be paid or taken after the IN BETWEEN wager is paid or taken. (Authorized by K.S.A. 2013 Supp. 74-8710 and 74-8748; implementing K.S.A. 2013 Supp. 74-8710; effective, T-111-8-7-14, July 16, 2014.)

#### Article 401.—NORTHEAST GAMING ZONE

**111-401-195. Name of the game; rules and regulations.** (a) The Kansas lottery shall conduct a lottery facility game at the Hollywood Casino at Kansas Speedway in Kansas City, Kansas, entitled "Running it Twice" beginning on or after August 1, 2014.

(b) Running it Twice is an optional game that may be played during any poker game specifically designated by Hollywood Casino at Kansas Speedway with the following conditions:

(1) the final card(s) to the player(s) or the community cards for that hand, as applicable to the poker game being played, have not yet been dealt;

(2) only two players remain in the game competing against each other;

(3) one of the two players has made an all-in bet (has bet all of his or her remaining chips) and the other player has matched the all-in bet; and,

(4) both players agree to play the Running it Twice optional game and timely communicate that agreement to the dealer.

(c) If all conditions for Running it Twice are met, dealing of the remaining cards shall proceed as follows:

(1) The dealer shall deal the remaining cards for that hand pursuant to the normal rules for that game; and,

(2) The dealer shall then slide those remaining cards for that hand upward on the table playing surface leaving them face up, and then in the space vacated by those cards shall deal a second set of remaining cards for that hand in the same way the remaining cards for that hand are dealt pursuant to the normal rules for that game, thereby creating a second set of final cards for the hand.

(d) If one player has the best hand regardless of which of the two sets of cards are used to complete his or her

hand, that player is awarded the entire pot. If one player has the best hand using one set of cards and the other player has the best hand using the other set of cards, the pot is split into two equal halves and one half is awarded to each player.

(e) The two players shall also have the option to split the pot into three equal portions. In that event all rules for Running it Twice set forth hereinabove apply except that instead of dealing two separate hands and creating two evenly divided pots, three separate hands shall be dealt and the pot shall be evenly divided into three parts.

(f) If this optional game is being played in any poker game where the house rakes the pot, the pot will be raked twice in the event two pots are created and three times in the event three pots are created. (Authorized by K.S.A. 2013 Supp. 74-8710 and 74-8748; implementing K.S.A. 2013 Supp. 74-8710; effective, T-111-8-7-14, July 16, 2014.)
