with and that it has visited the site of the work to fully inform itself as to all existing conditions and limitations, and shall include in its bid a sum to cover the cost of all items of the work as specified in the contract documents.

No oral telegraphic, telephonic proposals or alterations will be considered. Facsimile transmissions will not be accepted.

The following items must be included in the sealed envelope with the bid:

Each bidder shall file with its bid a bid bond, a cashier's check or a certified check drawn on an acceptable bank, made payable to the city of Lenexa, Kansas, in an amount equal to 5 percent of the total bid, which shall be retained by the city of Lenexa until a contract for the project has been executed. Bid bonds will be returned to the bidders, with the exception of the best and lowest and second best and second lowest responsible bidders, within 21 days after their bids are rejected. The bid deposit of the lowest and the second lowest responsible bidders will be returned when the performance bond, maintenance bond and statutory bond, each in an amount equal to 100 percent of the contract amount, the required insurance certificates and other required documents shall have been furnished and the contract documents have been executed by the successful bidder.

In the event the low bidder is unable to execute the contract, for whatever reason, within the time provided in the Notice of Award, the city may annul the Notice of Award and the bid deposit may be forfeited, and city shall exercise its legal prerogatives, including, but not limited to, enforcement of its rights as to the bid security or specific performance.

The city reserves the right to accept or reject any and all bids and to waive any technicalities or irregularities therein. Bids may be modified or withdrawn by written request of the bidder received in the office of city clerk prior to the time and date for bid opening.

Scope:

Approximately \$37 million total construction cost for renovations and additions to the four (4) principal attendance centers and improvements to the district stadium. Renovations and additions include, but are not limited to, secure entries, high wind shelters, building systems upgrades and re-

placements, interior finish upgrades and new high school auxiliary gymnasium.

This request for statements of qualifications is made pursuant to K.S.A. 72-6760e, alternative project delivery, and K.S.A. 72-6760f, construction management at-risk projects. The request for statements of qualifications is the first phase of a three-phase qualifications-based selection process. The board, after considering statements of qualifications submitted in response to this request, will qualify at least three, but not more than five, of the interested construction managers to be considered during Phase II of the selection process.

The board reserves the right to reject any or all statements of qualifications and may, at its discretion, disqualify any proposal submitted by a party that the board determines lacks the minimal qualifications to perform the proposed work.

The proposed projects involve substantial renovations, new construction and/or a combination of new construction and renovations.

Such statement of qualifications shall include, but should not be limited to, the following information:

- 1. The firm's legal name
- 2. Address of principal offices
- 3. Experience in successfully completing substantial and complex renovation projects
- Experience with providing construction management at-risk services*
- 5. Experience with providing construction management at-risk services for Kansas unified school districts and other Kansas public projects since the inception of CMaR for Kansas public projects in May 2008*
- References from design professionals and owners of completed projects using construction management at-risk services
- 7. Financial statement and evidence of bonding capacity
- 8. Statement of your plan to work with local subcontractors, vendors and businesses
- 9. Experience in renovating occupied schools
- 10. Any other information that may be relevant to evaluating such statement of qualifications

*The district is most interested in evaluating the firm's construction management at-risk experience. Projects delivered via other delivery methods (e.g., construction management-agency, design-build, general construction) will be considered less relevant by the district.

Kansas law requires a public work bond (K.S.A. 60-1111) in an amount not less than the contract amount, and the statement of qualifications should include evidence that the firm has the financial resources to provide the required bond in an amount at least equal to the construction budget of approximately \$37 million.

Opinion No. 2013-02 Amended

Written September 17, 2014, to Mike Pirner.

Synopsis: The use of social media to solicit contributions by those described in K.S.A. 2012 Supp. 25-4153(a)(1) through (a)(6) violates the Campaign Finance Act if the solicitation would be received by any registered lobbyist, political committee or person, other than an individual (e.g. a business), after January 1 of each year and prior to adjournment sine die of the regular session of the legislature or at any other time in which the legislature is in session. A disclaimer, included in the solicitation, is not a defense to a violation of the Campaign Finance Act.

Cited herein: K.S.A. 2012 Supp. 25-4153a, K.A.R. 19-20-2(c)

Dear Mr. Pirner:

This opinion is in response to your email sent March 8, 2013, requesting an opinion from the Kansas Governmental Ethics Commission, concerning application of the state Campaign Finance Act, K.S.A. 25-4119e, et seq. We note at the outset that the Commission's jurisdiction is limited to the applicability of the Campaign Finance Act, and the Commission's opinion does not address whether some other statutory system, common law theory, or agency rule or regulation applies to your inquiry.

Factual Statement

We understand that you are asking for this opinion based upon your involvement with the campaign supporting the candidacy of Beverly Gossage for insurance commissioner, a state officer elected on a statewide basis. An announcement for a kickoff party scheduled during the regular session of the legislature soliciting donations is proposed for posting on the campaign's page on Facebook, a social networking website on the Internet. As proposed, the post would include: a link that would allow users to sign up to attend, a link which directs users to the campaign's Internet website to make donations, and a disclaimer. The disclaimer provides, "[d]onations from registered lobbyists, PACs, or businesses are prohibited during the legislative session. Accordingly, only an individual who is not a registered lobbyist in Kansas may donate to Beverly Gossage for Kansas."

Alternatively, the announcement is proposed to be posted on the campaign's website with a link to it posted on the campaign's Facebook page which directs users viewing the page to the campaign's website for the express purpose of making a donation. One example, of the language provided in your email, within which the link is to be embedded, is: "I need your support! Help our campaign by visiting my website and making a donation of \$50 today!"

A Facebook page is networked with others on a limited basis. In order for pages to be networked so that they may be viewed by other users, the pages must belong to users that are friends or be liked or shared by other users. To be "friends" on Facebook requires the action of users through the issuance and acceptance of a friend request. Once friends, users may visit each other's page or receive

news feeds on their own page of new and edited content posted on their friends' pages. The accessibility of a user's content to "friends" may be limited or blocked by user options within Facebook.

Facebook describes the Like-feature (hereinafter Like) as a way for users to give positive feedback and connect with things they care about. When a user clicks on Like, the associated content appears in the news feeds of that user's friends. The distribution is not controlled by the user making the post. This is unlike the distribution of content between friends, since users control who their friends are. The use of Like, by a succession of users, causes distribution of posts through a large series of networked friends, friends of friends, and so on.

Question

May a legislator, officer, candidate or committee described in K.S.A. 2012 Supp. 25-4153a(a)(1) through (a)(6) solicit contributions through social media after January 1 of each year and prior to adjournment sine die of the regular session of the legislature or at any time when the legislature is in session?

If not, will a disclaimer within such solicitation exculpate any legislator, officer, candidate or committee described in K.S.A. 2012 Supp. 25-4153(a)(1) through (a)(6)?

Analysis and Opinion

The Campaign Finance Act, specifically K.S.A. 2012 Supp. 25-4153a(b), limits accepting and soliciting of contributions:

No legislator, officer, candidate or committee described in paragraphs (1) through (6) of subsection (a) shall accept or knowingly solicit any contribution as defined by K.S.A. 25-4143, and amendments thereto, from any registered lobbyist, political committee or person, other than an individual, during such period of time described in subsection (a).

Paragraphs (1) through (6) of subsection (a) describe "legislator, officer, candidate or committee" more specifically as:

- (1) Legislator;
- (2) candidate for membership in the legislature;
- (3) state officer elected on a statewide basis;
- (4) candidate for state officer elected on a statewide basis;
- (5) candidate committee of persons described in paragraphs (1) through (4); or
- (6) political committee of any political party and designated as a recognized political committee for the senate or house of representatives.

Subsection (a) describes the time period referenced in subsection (b) of K.S.A. 2012 Supp. 25-4153a as being:

...after January 1 of each year and prior to adjournment sine die of the regular session of the legislature or at any other time in which the legislature is in session.

And K.A.R. 19-20-2(c) implements 2012 Supp. K.S.A. 25-4153a by defining "session" as follows:

"Session" means both the regular and special sessions of the legislature. Regular session includes the time period commencing January 2 through final adjournment. Special session includes the time of commencement through final adjournment. "Solicit" is defined as "to ask or seek earnestly or pleadingly; appeal to or for." Webster's New World College Dictionary, 1276 (3rd ed. 1996). Also, "to endeavor to obtain by asking or pleading; to seek eagerly or actively." Webster's Third New International Dictionary, 2169 (1993). "Solicitation" is defined as, "[t]he act or an instance of requesting or seeking to obtain something; a request or petition." Black's Law Dictionary, 1427 (8th ed. 2004). These definitions all indicate an overt action by a person in order to solicit.

Knowingly, or "knowing" is defined as "[h]aving an awareness or understanding; well-informed" and, "[d]eliberate; conscious." *Black's Law Dictionary*, 888 (8th ed. 2004). Also, "knowledge" is defined as "an awareness or understanding of a fact or circumstance; a state of mind in which a person has no substantial doubt about the existence of a fact." (*ibid.*).

As a candidate for Kansas insurance commissioner, Beverly Gossage is a candidate for state officer elected on a statewide basis, as described in K.S.A. 2012 Supp. 25-4153a(a)(4). Pursuant to K.S.A. 2012 Supp. 25-4153(b), neither she, nor anyone on behalf of her campaign, may knowingly solicit contributions from "any registered lobbyist, political committee, or person, other than an individual" (hereinafter "prohibited persons").

Whether it is the kickoff party announcement, or a link embedded within the language "I need your support! Help our campaign by visiting my website and making a donation of \$50 today!," both are deliberate, conscious acts to seek contributions. We opine that both acts are within the statutory language of "knowingly solicit."

Unlike the event invite-feature or share-feature that allows a user (in this case the campaign) to select specific recipients to ensure that prohibited persons, are not solicited, posts to the campaign's Facebook "page" are distributed to the news feeds of friends of the campaign's Facebook page. Further, use of Facebook's Like would distribute posts to the news feeds of friends of friends, and so on, without any ability to control or limit such distribution. It causes posts to be distributed by news feeds and viewable on other users' pages without any affirmative action by those users.

Given the present facts, Beverly Gossage's campaign may only intend to solicit individual persons, but has knowledge that, inevitably, the solicitation would, in turn, distribute to prohibited persons by use of Like. Receipt by a registered lobbyist, committee, or persons other than an individual occurs on their news feeds through no action on their part. Therefore, we opine that a general post to a Facebook page which solicits contributions—whether it is the kickoff party announcement or solicitation-language within which a link is embedded—could be a violation of the Campaign Finance Act should it occur within the period specified by K.S.A. 2012 Supp. 25-4153a and K.A.R. 19-20-2(c).

Finally, a disclaimer, while reminding recipients who are prohibited persons of their obligation not to make contributions as proscribed by K.S.A. 2012 Supp. 25-4153a(a). Its inclusion would not relieve the candidate and the campaign of the subsection (b) requirement to not solicit contributions in the first place.

Conclusion

When a legislator, officer, candidate or committee described in K.S.A. 2012 Supp. 25-4153a(a)(1) through (a)(6) solicits contributions though social media that are proscribed by K.S.A. 2012 Supp. 25-4153a(b), it could be a violation of the Campaign Finance Act unless its distribution excludes any recipient that is a prohibited person described in statute. The essence of the violation is the solicitation. As such, a disclaimer is not exculpatory.

Notice of Available Grant Funding

Grant funds are available from the Federal S.T.O.P. (Services*Training*Officers*Prosecutors) Violence Against Women Grant Program for calendar year 2015 to award approximately \$1.65 million to support communities in their efforts to develop and strengthen effective law enforcement and prosecution strategies to combat violent crimes against women; develop and strengthen victim services in cases involving crime against women; and promote a coordinated community response to victims of domestic violence, dating violence, sexual assault/rape and stalking. The proposed permit contains limits for non-polar material, fluoranthene, phenanthrene and pH, as well as monitoring of flow.

102-3-3a. Education requirements. To qualify for licensure as a professional counselor or a clinical professional counselor, the applicant's education shall meet the applicable requirements provided in the following subsections.

- (a) (1) "Core faculty member" means an individual who is part of the program's teaching staff and who meets the following conditions:
- (A) Is an individual whose education, training, and experience are consistent with the individual's role within the program and are consistent with the published description of the goals, philosophy, and educational purpose of the program;
- (B) is an individual whose primary professional employment is at the institution in which the program is housed; and
- (C) is an individual who is identified with the program and is centrally involved in program development, decision making, and student training as demonstrated by consistent inclusion of the individual's name in public and departmental documents.
- (2) "In residence," when used to describe a student, means that the student is present at the physical location of the institution for the purpose of completing coursework during which the student and one or more core faculty members are in face-to-face contact.
- (3) "Primary professional employment" means at least 20 hours per week of instruction, research, any other service to the institution in the course of employment, and the related administrative work.
- (b) At the time of application, each applicant shall have fulfilled the following requirements:
- (1) Received either a master's or doctoral degree in counseling from a program that meets one of the following requirements:
- (A) Is not below the accreditation standards of the council for the accreditation of counseling and related educational programs; or

(continued)

- (B) meets the requirements in subsections (f) and (g); and
- (2) as a part of or in addition to the coursework completed for the counseling graduate degree, completed at least 60 graduate semester hours, or the academic equivalent, of which at least 45 graduate semester hours, or the academic equivalent, shall clearly satisfy the coursework requirements in subsection (c).
- (c) Each applicant shall have satisfactorily completed formal academic coursework that contributes to the development of a broad conceptual framework for counseling theory and practice as a basis for more advanced academic studies. This formal academic coursework shall consist of at least 45 graduate semester hours, or the academic equivalent, that are distributed across the substantive content areas provided in this subsection. None of these credit hours shall be earned through independent study courses. There shall be at least two discrete and unduplicated semester hours, or the academic equivalent, in each of the following substantive content areas:
- (1) Counseling theory and practice, which shall include studies in the basic theories, principles, and techniques of counseling and their applications to professional settings;
- (2) the helping relationship, which shall include studies in the philosophical bases of helping relationships and the application of the helping relationship to counseling practice, as well as an emphasis on the development of practitioner and client self-awareness;
- (3) group dynamics, processes, and counseling approaches and techniques, which shall include studies in theories and types of groups, as well as descriptions of group practices, methods, dynamics, and facilitative skills;
- (4) human growth and development, which shall include studies that provide a broad understanding of the nature and needs of individuals at all developmental levels and in multicultural contexts;
- (5) career development and lifestyle foundations, which shall include studies in vocational theory, the relationship between career choice and lifestyle, sources of occupational and educational information, approaches to career decision-making processes, and career development exploration techniques;
- (6) appraisal of individuals and studies and training in the development of a framework for understanding the individual, including methods of data gathering and interpretation, individual and group testing, and the study of individual differences;
- (7) social and cultural foundations, which shall include studies in change processes, ethnicity, subcultures, families, gender issues, the changing roles of women, sexism, racism, urban and rural societies, population patterns, cultural mores, use of leisure time, and differing life patterns. These studies may come from the behavioral sciences, economics, political science, and similar disciplines;
- (8) research and evaluation, which shall include studies in the areas of statistics, research design, development of research, development of program goals and objectives, and evaluation of program goals and objectives;
- (9) professional orientation, which shall include studies in the goals and objectives of professional organizations,

- codes of ethics, legal considerations, standards of preparation and practice, certification, licensing, and the role identities of counselors and others in the helping professions; and
- (10) supervised practical experience, which shall include studies in the application and practice of the theories and concepts presented in formal study. This experiential practice shall be performed under the close supervision of the instructor and on-site supervisor with the use of direct observation and the preparation and review of written case notes. Direct observation may include the use of one-way mirrors in a counseling laboratory, the use of videotaped or audiotaped sessions, or the use of real-time video conferencing or similar synchronous communication devices.
- (d) Each applicant for licensure as a clinical professional counselor whose master's or doctoral degree is earned before July 1, 2003 shall have earned the graduate degree in accordance with subsections (b) and (c).
- (e) Each applicant for licensure as a clinical professional counselor whose master's or doctoral degree is earned on or after July 1, 2003 shall meet the following education requirements:
- (1) Have earned a graduate degree in accordance with subsections (b) and (c);
- (2) in addition to or as a part of the academic requirements for the graduate degree, have completed 15 graduate semester credit hours, or the academic equivalent, supporting diagnosis and treatment of mental disorders using the "diagnostic and statistical manual of mental disorders" as specified in K.A.R. 102-3-15. The 15 graduate semester credit hours, or the academic equivalent, shall include both of the following:
- (A) The applicant shall have satisfactorily completed two graduate semester hours, or the academic equivalent, of discrete coursework in ethics and two graduate semester hours, or the academic equivalent, of discrete coursework in psychopathology and diagnostic assessment, including the study of the latest edition of the "diagnostic and statistical manual of mental disorders" and assessment instruments that support diagnosis.
- (B) The applicant shall have satisfactorily completed coursework addressing treatment approaches and interdisciplinary referral and collaboration; and
- (3) completion of a graduate-level, supervised clinical practicum pursuant to K.S.A. 65-5804a(c)(1)(C), and amendments thereto.
- (f) In order to be approved by the board, each educational program in professional counseling shall meet the following requirements:
- (1) Have established program admission requirements that are based, in part or in full, on objective measures or standardized achievement tests and measures;
- (2) require an established curriculum that encompasses at least two academic years of graduate study;
- (3) have clear administrative authority and primary responsibility within the program for the core and specialty areas of training in professional counseling;
- (4) have an established, organized, and comprehensive sequence of study that is planned by administrators who are responsible for providing an integrated educational experience in professional counseling;

- (5) engage in continuous systematic program evaluation indicating how the mission objectives and student learning outcomes are measured and met;
- (6) be chaired or directed by an identifiable person who holds a doctoral degree in counseling that was earned from a regionally accredited college or university upon that person's actual completion of a formal academic training program;
- (7) have an identifiable, full-time, professional faculty whose members hold earned graduate degrees in professional counseling or a related field;
- (8) have an established, identifiable body of students who are formally enrolled in the program with the goal of obtaining a degree;
- (9) require an appropriate practicum, internship, or field or laboratory training in professional counseling that integrates didactic learning with supervised clinical
- (10) conduct an ongoing, objective review and evaluation of each student's learning and progress, and report this evaluation in the official student transcripts;
- (11) require that at least 30 graduate semester credit hours, or the academic equivalent, of coursework be completed "in residence" at one institution and require that the practicum or internship be completed at the same institution; and
- (12) require that the number of graduate semester hours, or the academic equivalent, delivered by adjunct faculty does not exceed the number of graduate semester hours, or the academic equivalent, delivered by core faculty members.
- (g) In order for an applicant to qualify for licensure, the college or university at which the applicant completed the counseling degree requirements shall meet these require-
- (1) Be regionally accredited, with accreditation standards equivalent to those met by Kansas colleges and universities;
- (2) document in official publications, including course catalogs and announcements, the program description and standards and the admission requirements of the professional counseling education and training program;
- (3) identify and clearly describe in pertinent institutional catalogs the coursework, experiential, and other academic program requirements that must be satisfied before conferral of the graduate degree in counseling;

- (4) clearly identify and specify in pertinent institutional catalogs its intent to educate and train professional coun-
- (5) have clearly established the professional counselor education program as a coherent entity within the college or university that, when the applicant's graduate degree was conferred, met the program standards in subsection (f); and
- (6) have conferred the graduate degree in counseling upon the applicant's successful completion of an established and required formal program of studies.
- (h) The following types of study shall not be substituted for or counted toward the coursework requirements of subsections (b), (c), (d), and (e):
- (1) Academic coursework that the applicant completed as a part of or in conjunction with the undergraduate degree requirements;
- (2) academic coursework that has been audited rather than graded;
- (3) academic coursework for which the applicant received an incomplete or failing grade;
- (4) coursework that the board determines is not closely related to the field or practice of counseling;
- (5) graduate or postgraduate coursework or training provided by any college, university, institute, or training program that does not meet the requirements of subsections (f) and (g); and
- (6) any continuing education, in-service activity, or onthe-job training.
- (i) The following types of study may be counted toward the 60 graduate semester hours required under paragraph (b)(2):
- (1) No more than six graduate semester hours of independent study that is related to the field or practice of counseling, except that independent study shall not be used to meet any of the substantive content area requirements specified in subsection (c); and
