The Kansas Department of Health and Environment, Division of Health, Bureau of Family Health, will conduct a public hearing at 2 p.m. Wednesday, April 8, in Room 530 of the Curtis State Office Building, 1000 S.W. Jackson, Topeka, to consider adoption of new regulation K.A.R. 28-4-94, background check requests for residential centers, group boarding homes, and child placement agencies. A summary of the proposed regulation and the estimated economic impact follows:

## **Summary of Regulation:**

K.A.R. 28-4-94. Background check requests for residential centers, group boarding homes, and child placement agencies. The proposed regulation describes requirements for submitting requests for background

checks to the department to meet the requirements in K.S.A. 2014 Supp. 65-508 and K.S.A. 2014 Supp. 65-516. The significant change is the timing of requests. Residential centers and group boarding homes currently report the identifying information on individuals over 10, at the time of license application and reapplication and then within one week of a new individual residing, working, or regularly volunteering at the facility. Child placement agency regulations do not describe a process. The proposed regulation will require that facilities and child placement agencies submit a request before any individual at least 10 years old begins residing, working, or regularly volunteering at the facility or agency. Individuals admitted for care are excluded. Documentation of requests must be kept on file.

## **Economic Impact:**

Cost to the agency: There is no additional cost to the agency. Requests for background checks will be processed in the same way as they are currently processed.

Cost to licensees: There is no cost to the licensees.

Costs to other governmental agencies or units: There is no additional cost to other governmental agencies or units.

The time period between publication of this notice and the scheduled hearing serves as the required public comment period of at least 60 days for the purpose of receiving written public comments on the proposed regulation. At any time during the public comment period any interested parties may submit written comments to Dorothy Tenney, KDHE, Child Care Licensing Program, 1000 S.W. Jackson, Suite 200, Topeka, 66612-1274, by fax at 785-296-0803, or by email to dtenney@kdheks.gov. Written comments will be accepted until 5 p.m. on the day of the hearing. During the hearing all interested parties will be given a reasonable opportunity to present their views orally on the proposed regulation as well as an opportunity to submit their written comments. In order to give each individual an opportunity to present their views, it may be necessary for the hearing officer to request that each presenter limit any oral presentation to an appropriate time frame.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed adoption of K.A.R. 68-20-31. All parties may submit written comments prior to the hearing to Debra Billingsley, executive secretary, Kansas Board of Pharmacy, 800 S.W. Jackson, Suite 1414, Topeka, 66612, or to pharmacy@pharmacy.ks.gov. All interested parties will be given a reasonable opportunity to present their views orally on the regulation during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant to limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the regulation and economic impact statement in an accessible format. K.A.R. 68-20-31 is a new permanent regulation. The following is a summary of the new regulation:

K.A.R. 68-20-31. 2,5-dimethoxy-4-methyl-n-(2-methoxybenzyl)phenethylamine included in schedule I. 2,5-dimethoxy-4-methyl-n-(2-methoxybenzyl) phenethylamine, including its salts, isomers, and salts of isomers, shall be classified as a schedule I controlled substance.

The board does not anticipate any economic impact to the Kansas Board of Pharmacy. The board does not anticipate a financial impact on other governmental agencies, licensees and registrants, or private businesses or individuals other than the costs associated with prosecuting and defending criminal charges for illegally possessing this substance.

The drawing will be held after 6:00 p.m. on Saturday, June 6, 2015, at the Kansas lottery selling location at the Riverfest in Wichita, Kansas, or at a time and location designated by the executive director of the Kansas lottery. Rules applicable to this drawing are contained in K.A.R. 111-4-3374 through 111-4-3379 and K.A.R. 111-3-1, et seq. (Authorized by and implementing K.S.A. 2014 Supp. 74-8710; effective, T-111-1-15-15, Dec. 10, 2014.)
- **111-4-3375. Definitions.** (a) All definitions contained in the Kansas lottery act (K.S.A. 74-8701 *et seq.*) and lottery regulations are hereby incorporated by reference and govern unless otherwise indicated.
- (b) "Cabela's Drawing" means the act of drawing prizes conducted by the Kansas Lottery at the 2015 Riverfest in Wichita, Kansas, in which three participants will win prizes as described in these rules.
- (c) "Non-winning ticket" means any valid Kansas "Cabela's" instant game lottery ticket not eligible to win a prize under the rules of the "Cabela's" instant game.
- (d) "Receptacle" or "drum" means a container in which non-winning Kansas instant game lottery tickets are placed and from which the "Cabela's Drawing" entries are drawn. Receptacles or drums may be sealable and shall be capable of being mixed or rotated for the purpose of ensuring random distribution.
- (e) "Bare arm technique" means a type of drawing where the person drawing the winning ticket from the receptacle or drum wears a long-sleeved shirt with sleeve rolled up above the elbow, a short-sleeved shirt (sleeve not extending past the elbow) or a no-sleeve shirt which exposes the drawer's bare arm and looks away from the drawing drum or receptacle while drawing. (Authorized by and implementing K.S.A. 2014 Supp. 74-8710; effective, T-111-1-15-15, Dec. 10, 2014.)
- **111-4-3376. Prize.** (a) One grand prize package will be given away at the "Cabela's Drawing," which will be conducted on June 6, 2015. The grand prize winner will receive a prize package consisting of a \$20,000 Cabela's shopping spree and mandatory federal and state income withholding taxes and other applicable initial taxes and fees for this prize.
- (b) The Cabela's \$20,000 grand prize shopping spree is valid for in-store purchases only and is limited to the Cabela's store locations in either Kansas City, Kansas, or Wichita, Kansas.
- (c) The prizes are subject to lottery validation, set-offs and deductions authorized by law.
- (d) The Kansas lottery may, at its discretion, substitute a prize of approximate equal value.

- (e) The winner of the grand prize shall return to the lottery a completed claim form as provided by the lottery no later than 5:00 p.m. on the thirtieth day following the day the claim form is mailed to the person whose name was drawn or the person named on the ticket drawn will no longer be eligible for the prize. In such an event, the first eligible alternate entry drawn for that prize pursuant to these rules shall be declared the winner. (Authorized by and implementing K.S.A. 2014 Supp. 74-8710; effective, T-111-1-15-15, Dec. 10, 2014.)
- **111-4-3377. Method of entry.** (a) Entry into the "Cabela's Drawing" to be conducted on June 6, 2015, shall be accomplished as follows:
- (1) Obtain a valid "Cabela's" Kansas instant lottery ticket;
- (2) Determine if the ticket is a winning ticket in accordance with "Cabela's" game rules. If the ticket is a winning ticket, it is not eligible for the "Cabela's Drawing" and shall be redeemed in accordance with the instant game rules.
- (3) If the ticket is a valid non-winning ticket, the ticket is eligible for the drawing and the holder of the ticket may use it to enter the "Cabela's Drawing."
- (4) The holder of the non-winning ticket must complete the information form on the back of the ticket in a legible manner. Only one name shall appear on a non-winning ticket entered.
- (5) A receptacle or drum shall be available and entries may be made at the Kansas lottery selling location at the Riverfest until approximately 6:00 p.m. on June 6, 2015.
- (6) Players may also deposit entries for the "Cabela's Drawing" at any Kansas lottery event at which the lottery has specifically designated a receptacle for deposit of said entries until 5:00 p.m. on June 2, 2015.
- (7) Entries other than those entered at the Riverfest shall be mailed with proper postage to "Cabela's Drawing," P. O. Box 19226, Topeka, Kansas 66619-0226. Mailed entries must be received by morning mail pickup on Tuesday, June 2, 2015. More than one entry may be mailed in one envelope.
- (8) The holder of a ticket is not required to personally attend the "Cabela's Drawing" or be present at the time of the drawing to be determined a winner;
- (9) The drawing will be conducted soon after 6:00 p.m. on Saturday, June 6, 2015.
- (b) There is no limit on the number of entries a person may make, but a person may only win one time in the drawing.
- (c) Only valid non-winning "Cabela's" tickets which are mailed to the "Cabela's Drawing," at the above-stated address with proper postage and received by the morning mail pickup in Topeka, Kansas, on Tuesday, June 2, 2015, and non-winning "Cabela's" tickets entered into any other receptacle designated by the lottery or at the Riverfest as provided in the rules herein shall be eligible for the drawing. All tickets so mailed or deposited shall be secured by the lottery until the drawing is conducted.
- (d) Eligible entrants in the "Cabela's Drawing" must be 18 years of age or older.
- (e) Completing the information form on the non-winning ticket and entering the ticket into the drawing con-

stitutes authorization to publicly identify the person whose entry is drawn. (Authorized by and implementing K.S.A. 2014 Supp. 74-8710; effective, T-111-1-15-15, Dec. 10, 2014.)

- **111-4-3378. Selection of winners.** The following process shall be used for the selection of the winners in the "Cabela's Drawing:"
- (a) Kansas lottery personnel shall pick up all mail containing "Cabela's Drawing" tickets at the United States Post Office in Topeka, Kansas, with the final pick up at the Topeka post office in the morning mail pickup on Tuesday, June 2, 2015. Following the morning mail pickup on Tuesday, June 2, 2015, the envelopes containing mailed entries will be transported to lottery head-quarters and opened by lottery personnel. All mailed entries shall then be placed in a secure receptacle, transported to the Riverfest and placed in the drawing receptacle or drum with all entries deposited at the festival and into any other receptacle designated by the lottery.
- (b) The drawing shall be held at the Kansas lottery selling location at the Riverfest and shall be open to the public with lottery security personnel present. The drawing shall be audio and video taped.
- (c) At the drawing on Saturday, June 6, 2015, lottery security personnel will be present with the person designated by the executive director to perform the drawing. Prior to the drawing, if a drum is used, the drum shall be sealed and the contents mixed by rotating the drum at least 10 times. If a receptacle other than a drum is used, the contents shall be thoroughly mixed with a shovel or by other means.
- (d) The designated individual shall then unseal the drum, if a drum is used, and using the bare-arm technique, while looking away, remove one entry from the receptacle or drum. The person whose name appears on the entry drawn shall be the winner of the grand prize identified in these rules, subject to validation by the lottery as set forth in these rules.
- (e) After the grand prize winner has been drawn on June 6, 2015, and the entry has been verified as valid, five more valid entries will be drawn, one at a time, which entries drawn will serve as alternate entries for the grand prizes. The alternate entries will be marked in order drawn, 1A, 2A, 3A, 4A, and 5A. The winners shall have until 5:00 p.m. on the thirtieth day following mailing of a claim form to present the fully-executed claim form to lottery headquarters. If the grand prize winner cannot be located or is declared ineligible, or fails to timely present a fully-executed claim form to lottery headquarters, the grand prize will be awarded to the first alternate entry drawn. The alternates will be used, if necessary, in the order drawn. If an alternate winner for the grand prize cannot be located, is declared ineligible, or fails to present a fully-executed claim form to lottery headquarters as required herein, the alternate winner process shall be repeated until the prize is properly claimed or until such time as no alternate winners remain, whichever occurs
- (f) The Kansas lottery security official present shall review each ticket drawn to determine the validity of the

- entry into the "Cabela's Drawing" in accordance with these regulations. If it is a valid entry and the name is legible, the event manager and the security person present shall record the name of the winner and the prize won. The prize winner shall be given or sent a prize claim form to be completed and returned by 5:00 p.m. on the thirtieth day following mailing of a claim form.
- (g) If any entry drawn is determined to be ineligible, it shall be discarded by the security person present and another entry drawn. This procedure will be repeated until the required number of apparently eligible selections is obtained.
- (h) Only non-winning "Cabela's" instant tickets are eligible for the drawing.
- (i) All "Cabela's" tickets remaining in the drum or receptacle on June 6, 2015, after the winners and alternates have been selected, and all entries not received in compliance with these rules, shall be destroyed pursuant to K.A.R. 111-3-34. (Authorized by and implementing K.S.A. 2014 Supp. 74-8710; effective, T-111-1-15-15, Dec. 10, 2014.)
- **111-4-3379.** Certification of drawing. (a) The "Cabela's Drawing" shall be personally observed by a member of the Kansas lottery security department and a member of the Kansas lottery marketing department or other person or persons designated by the executive director of the lottery.
- (b) Upon completion of the drawing, the security official and the event manager shall issue a report to the executive director, certifying that the name of each prize winner is correct, and that to the best of their knowledge the procedures required by these rules were followed in selecting the prize winner(s). (Authorized by and implementing K.S.A. 2014 Supp. 74-8710; effective, T-111-1-15-15, Dec. 10, 2014.)

#### **Article 17.—SPECIFIC ONLINE DRAWING RULES**

- **111-17-17.** Kansas Speedway second-chance online event drawings. (a) The Kansas lottery shall conduct a series of two second-chance online event drawings entitled "Kansas Speedway Drawings." The Kansas lottery will accept online entries into the drawing(s) beginning at midnight, January 8, 2015, or any time on the date the "Super Red Hot Crossword" instant Kansas lottery ticket number 604 is first offered for sale to the general public, whichever occurs first. Entry into the first drawing will close at noon on March 24, 2015. Entry into the second drawing will close at noon on August 25, 2015. The drawings will be conducted sometime after entry into the drawings has closed, but before noon on March 27, 2015, for the first drawing and before noon on August 28, 2015, for the second drawing.
- (b) The specific ticket eligible for entry into the secondchance online event drawings shall be non-winning \$5 Kansas lottery instant ticket named Super Red Hot Crossword, game number 604. Winning tickets for game number 604 will be disqualified.
- (c) For the drawing to be conducted before noon on March 27, 2015, the Kansas lottery shall award 30 VIP race weekend prize packages for two to players who entered

the "Kansas Speedway Drawing" using the non-winning \$5 Kansas lottery instant ticket named Super Red Hot Crossword, game number 604. Each VIP racing weekend prize package shall consist of two tickets at Kansas Speedway for the NASCAR Camping World Truck Series races on May 8, 2015, and NASCAR Sprint Cup Series race on May 9, 2015; one double occupancy hotel room for the evenings of May 7, 8, and 9, 2015; transportation between the hotel and Kansas Speedway; food and other amenities at the Kansas lottery winner's suite at Kansas Speedway; \$400 cash; and state and federal mandatory income withholding taxes. Each VIP racing weekend prize package is valued at approximately \$4,800.

- (d) For the drawing to be conducted before noon on August 28, 2015, the Kansas lottery shall award 30 VIP race weekend prize packages for two to players who entered the "Kansas Speedway Drawing" using the nonwinning \$5 Kansas lottery instant ticket named Super Red Hot Crossword, game number 604. Each VIP racing weekend prize package shall consist of two tickets at Kansas Speedway for the NASCAR Xfinity Series race on October 17, 2015, and the NASCAR Chase for the Cup Series race on October 18, 2015; one double occupancy hotel room for the evenings of October 15, 16, and 17, 2015; transportation between the hotel and Kansas Speedway; food and other amenities at the Kansas lottery winner's suite at Kansas Speedway; \$400 cash; and state and federal mandatory income withholding taxes. Each VIP racing weekend prize package is valued at approximately \$4,800.
- (e) There will be two drawings held as described in subsection (a) to select winners of prizes. Each drawing shall select 100 entrants. The first 30 entrants drawn in the drawing which closes at noon on March 24, 2015, shall be awarded prizes identified in subsection (c). The next 70 entrants drawn in this drawing (identified as numbers 31 through 100) will be used as alternate winners, if necessary, in the order drawn. The first 30 entrants drawn in the second drawing which closes at noon on August 25, 2015, shall be awarded prizes identified in subsection (d). The next 70 entrants drawn in this drawing (identified as numbers 31 through 100) will be used as alternate winners, if necessary, in the order drawn.
- (f) A player may enter the drawing(s) an unlimited number of times, but may win only one prize package in each drawing. Entries into the first drawing will be eligible to win a prize in the second drawing provided the entry was not selected as the winner of a prize package in the first drawing.
- (g) A winner of a prize shall be notified via email that he or she has won a prize. The winner shall be instructed how to verify his or her personal identification.
- (h) A winner shall be sent a claim form via U. S. mail at the time the winner is notified he or she has won a prize.
- (i) A player who is among the first 30 winners selected in each drawing to receive a prize must return his or her completed claim form, and must be received by the Kansas lottery within 14 days following the date of the online event drawing. A player who is among the entrants selected as alternate winners in this drawing to receive a prize identified in subsection (e) must return his or her

- completed claim form within 14 days following the date the alternate winner was sent a claim form via U. S. mail.
- (j) Completed claim forms and non-winning ticket(s) can be mailed by the winner via U.S. Mail to: Kansas lottery, 128 North Kansas Avenue, Topeka, Kansas 66603, or the winner can deliver the completed claim form and non-winning ticket to the Kansas lottery claims center in Topeka, Kansas, during the hours the claim center is open for business.
- (k) If a player fails to answer any email, respond to any request for information, or fill out any forms required by the Kansas lottery within the time allotted in the winner's notification of winning a prize, said win shall be forfeited and the prize awarded to another alternate winner.
- (l) Each person who enters a Kansas Lottery non-winning Super Red Hot Crossword, game number 604, agrees to release Kansas Speedway Corporation, its parent and affiliated companies, the Kansas lottery and their respective officers, directors, employees, agents, and sponsors from liability of any kind or nature for any loss, claims, damages, or injuries of any kind associated with participation in the drawing or with acceptance and use of any prize.
- (m) In the event any race in the prize package awarded for this drawing is postponed, changed, or canceled in whole or in part, no cash prize substitutions or other compensation shall be provided.
- (n) Rules applicable to this online event drawing are contained in K.A.R. 111-17-17 and K.A.R. 111-16-1 *et seq.* (Authorized by K.S.A. 2014 Supp. 74-8710 and K.S.A. 74-8748; implementing K.S.A. 2014 Supp. 74-8710; effective, T-111-1-15-15, Dec. 10, 2014.)

## Article 401.—NORTHEAST GAMING ZONE

- **111-401-129.** Wagers and payout odds. (a) Minimum and maximum wagers will be posted on a sign at each table.
- (b) Maximum table payouts, if any, will be posted at each table and will not be less than the maximum bet times the maximum odds.
- (c) If a player has been permitted to wager less than the table minimum, the dealer will take or pay the amount actually wagered. If a player has been permitted to wager more than the table maximum, the excess will be returned to the player and the player will be paid the correct odds on the correct wager. The player will be informed of the table minimum and maximum for subsequent wagers.
- (d) A player may play two hands at double the table minimum or greater per hand not to exceed the table maximum. A player may play three hands at the table maximum per hand. Multiple hands must be on empty positions with no other players located between multiple hands. Exceptions will be made only at the discretion of the table games pit manager, the table games shift manager, or higher ranking casino official.
- (e) The following describes a list of the permissible wagers, payout odds, and what constitutes a win, loss, or tie:
  - (1) Initial Pai Gow wager:
- (A) All wagers must be placed prior to dealing of hands. The initial Pai Gow wager is a wager placed by a

player on either his own hand or the hand of another player.

- (i) Initial Pai Gow wagers may be placed on a position by more than one player, however, the total initial Pai Gow wagers per position cannot exceed the table maximum.
- (ii) Only the seated player for a position will handle the cards and set the hand. A seated player may refuse additional wagers.
- (iii) An additional initial Pai Gow wager may be made as a tip for the dealer.
  - (iv) No commission is charged on Pai Gow wagers.
  - (B) Payout odds on all winning wagers will be 1 to 1.
  - (C) Initial Pai Gow wagers will win if:
- (i) The player's low hand beats the dealer's low hand, and
  - (ii) The player's high hand beats the dealer's high hand.
  - (D) Initial Pai Gow wagers will lose if:
- (i) The player's low hand does not beat the dealer's low hand, and
- (ii) The player's high hand does not beat the dealer's high hand.
  - (iii) The player forfeited the hand.
- (iv) The low hand of the player is set to rank higher than the high hand of the player (fouled hand).
- (v) The low hand contains more or less than two cards, or the high hand contains more or less than five cards (fouled hand).
  - (E) Initial Pai Gow wagers will tie or push if:
- (i) The player's low hand beats the dealer's low hand and the player's high hand does not beat the dealer's high hand:
- (ii) The player's high hand beats the dealer's high hand and the player's low hand does not beat the dealer's low hand; or
- (iii) The player's hand contains a Tiger 9 (a hand set per house way with a 9 high in the low hand with any high hand).
- (2) Fortune Pai Gow bonus (also referred to as "fortune bonus") wagers:
- (A) The Fortune Pai Gow bonus wager is a player's optional side bet that the outcome of his or her high hand will be of a certain qualifying poker rank. Players who wager a minimum of \$5 on the Fortune Pai Gow bonus wager also qualify for the envy bonus. The Fortune Pai Gow bonus wager must be placed at the same time as the initial Pai Gow wager and may be larger than the initial Pai Gow wager.
- (i) Only the seated player for a position is allowed to place a Fortune Pai Gow bonus wager.
- (ii) An additional Fortune Pai Gow bonus wager may be made as a tip for the dealer.
- (B) Payout odds on winning Fortune Pai Gow bonus wagers will be independent of the outcome of the dealer's hand and the bonus will be paid at the following odds when the player's high hand or high hand and low hand combined consist of a:
  - (i) 3 pair push
  - (ii) straight 2 to 1
  - (iii) three-of-a-kind 3 to 1
  - (iv) flush 4 to 1
  - (v) full house 5 to 1

- (vi) four-of-a-kind 20 to 1
- (vii) straight flush 50 to 1
- (viii) royal flush 100 to 1
- (ix) five aces 250 to 1
- (x) seven card straight flush with joker 750 to 1
- (xi) royal flush plus a royal match (suited king and queen) 1,000 to 1
- (xii) seven card straight flush without a joker 5,000 to
  - (C) A Fortune Pai Gow bonus wager will win if:
  - (i) The player makes an initial Pai Gow wager
- (ii) The player makes a Fortune Pai Gow bonus wager of \$1 up to the table maximum in \$5 increments per hand once the bet reaches \$5; and,
- (iii) The hand on which the bets were placed consists of a combination of cards containing at least three pair.
  - (D) A Fortune Pai Gow bonus wager will lose if:
- (i) The hand on which the bet was placed does not consist of a combination of cards containing at least three pair, or
  - (ii) The seated player forfeited the hand.
  - (3) Envy bonus wager:
- (A) Players who wager a minimum of \$5 on the Fortune Pai Gow bonus wager qualify for the envy bonus, subject to the following:
- (i) Only the seated player for a position qualifies for the envy bonus.
- (ii) Before dealing the cards, the dealer will place an envy bonus lammer for each player who has a \$5 bonus wager.
- (iii) If two players have an envy bonus jackpot, the players will be paid on both hands.
- (iv) The dealer's hand never qualifies for the envy bonus.
- (v) The position which contains the qualifying envy bonus hand (at least a four-of-a-kind) cannot win the envy bonus
- (B) Payout odds on winning envy bonus wagers will be independent of the outcome of the dealer's hand and the following bonuses will be paid when a player wagers a minimum of \$5 on the Fortune Pai Gow bonus wager and another player's hand at the table contains a:
  - (i) four-of-a-kind \$5
  - (ii) straight flush \$10
  - (iii) royal flush \$25
  - (iv) five aces \$50
  - (v) Seven card straight flush with a joker \$100
  - (vi) royal flush plus royal match \$250
  - (vii) seven card straight flush without a joker \$1,000
  - (C) A Fortune Pai Gow envy bonus wager will win if:
  - (i) The player makes an initial Pai Gow wager
- (ii) The player makes a fortune bonus wager of a minimum of \$5, and
- (iii) Another player's hand consists of at least a four-of-a-kind
- (D) A Fortune Pai Gow envy bonus wager will lose if no players have a hand consisting of at least a four-of-akind.
  - (4) Progressive:
- (A) Players may participate in the optional progressive jackpot by placing a \$1 chip in the designated area. The

(continued)

progressive bet is considered a side wager and the dealer's hand has no bearing on the progressive bet's outcome. The player must have an original Pai Gow wager to make a progressive bet.

- (B) The progressive jackpot will be comprised of a beginning base amount of \$2,000.
- (C) The amount of the progressive jackpot will be displayed in a manner visible to players.
- (D) Winning progressive bets will be paid at the rate of:
  - (i) If the player's hand consists of a full house, 4 to 1.
- (ii) If the players hand consists of a four-of-a-kind, 75 to 1.
- (iii) If the player's hand consists of a straight flush, 100 to 1.
- (iv) If the player's hand consists of a royal flush, 500 to 1.
- (v) If the player's hand consists of five aces, 10 percent of the progressive jackpot.
- (vi) If the player's hand consists of a seven card straight flush (with or without the joker), 100% of the progressive jackpot.
- (E) A progressive bet will win if the player's hand consists of a seven card straight flush (with or without the joker), five aces, royal flush, straight flush, four-of-a-kind, or a full house.
- (5) Winning progressive bets will be paid in the following manner:
- (A) If the winning hand consists of a full house, fourof-a-kind, or straight flush, the table games supervisor will verify the winning hand and will verify the progressive bet was made, and direct the dealer to make the appropriate payout.
- (B) If the winning hand consists of a royal flush, five aces, or a seven card straight flush (with or without the joker), the table games supervisor or higher ranking casino official will verify the winning hand and will verify the progressive bet was made. The table games supervisor or higher ranking casino official will notify the table games pit manager or higher ranking casino official. Surveillance will also be notified to verify the winning hand.
- (i) The dealer will verify the deck of cards by counting down and sorting the remaining cards by suit.
- (ii) Once the jackpot has been deducted from the progressive jackpot for the five aces or seven card straight flush (with or without the joker), new cards will be placed on the table and play will resume.
- (iii) In the case of the seven card straight flush (with or without the joker), the meter will reset to an amount equal to the sum of \$2,000.
- (iv) In the event of multiple winning progressive hands consisting of five aces or seven card straight flush (with or without joker), the jackpot will be determined by whoever receives their hand first according to the time stated on surveillance video at the lottery gaming facility.
- (C) A progressive bet will lose if the player's hand consists of any combination of cards other than a seven card straight flush (with or without the joker), five aces, royal flush, straight flush, four-of-a-kind, or a full house.
  - (6) Tiger 9 bonus:
- (A) Only the seated player for a table position may place a tiger 9 bonus wager.

- (B) Any seated player who has made a Pai Gow wager may, at the same time, make a tiger 9 bonus wager by placing gaming chips in the area designed for that bonus wager at his or her betting position.
- (C) A tiger 9 bonus wager shall be no less than \$1.00 and may be larger than the original Pai Gow wager.
- (D) An additional tiger 9 bonus wager may be made as a toke (gratuity) for the dealer.
- (E) A tiger 9 bonus wager shall win if the dealer's hand contains a nine (9) high low hand and will lose if the dealer's hand does not contain a nine (9) high low hand.
- (F) All winning tiger 9 bonus wagers are paid at the rate of 30 to one. (Authorized by K.S.A. 2014 Supp. 74-8710 and 74-8748; implementing K.S.A. 2014 Supp. 74-8710; effective, T-111-2-9-12, Dec. 14, 2011; amended, T-111-9-4-14, Aug. 13, 2014; amended, T-111-1-15-15, Dec. 10, 2014.)
- **111-401-195.** Name of the game; rules and regulations. (a) The Kansas lottery shall conduct a lottery facility game at the Hollywood Casino at Kansas Speedway in Kansas City, Kansas, entitled "Running it Twice" beginning on or after August 1, 2014.
- (b) Running it Twice is an optional game that may be played during any poker game specifically designated by Hollywood Casino at Kansas Speedway with the following conditions:
- (1) the final card(s) to the player(s) or the community cards for that hand, as applicable to the poker game being played, have not yet been dealt;
- (2) one or more of the players has made an all-in bet (has bet all of his or her remaining chips) and the other player(s) has matched the all-in bet; and,
- (3) all players agree to play the Running it Twice optional game and timely communicate that agreement to the dealer.
- (c) If all conditions for Running it Twice are met, dealing of the remaining cards shall proceed as follows:
- (1) The dealer shall deal the remaining cards for that hand pursuant to the normal rules for that game; and,
- (2) The dealer shall then slide those remaining cards for that hand upward on the table playing surface leaving them face up, and then in the space vacated by those cards shall deal a second set of remaining cards for that hand in the same way the remaining cards for that hand are dealt pursuant to the normal rules for that game, thereby creating a second set of final cards for the hand.
- (d) If one player has the best hand regardless of which of the two sets of cards are used to complete his or her hand, that player is awarded the entire pot. If one player has the best hand using one set of cards and another player has the best hand using the other set of cards, the pot is split into two equal halves and one half is awarded to each player.
- (e) The players shall also have the option to split the pot into three equal portions. In that event all rules for Running it Twice set forth hereinabove apply except that instead of dealing two separate hands and creating two evenly divided pots, three separate hands shall be dealt and the pot shall be evenly divided into three parts.
- (f) If this optional game is being played in any poker game where the house rakes the pot, the pot will be raked

twice in the event two pots are created and three times in the event three pots are created. (Authorized by K.S.A. 2014 Supp. 74-8710 and 74-8748; implementing K.S.A. 2014 Supp. 74-8710; effective, T-111-8-7-14, July 16, 2014; amended, T-111-1-15-15, Dec. 10, 2014.)

**111-401-196.** Name of the game; rules and regulations. The Kansas Lottery shall conduct a lottery facility game at the Hollywood Casino at Kansas Speedway in Kansas City, Kansas, entitled "Free Bet Blackjack."

The rules and regulations for the game of "Free Bet Blackjack" are contained in K.A.R. 111-401-196 through 111-401-200, and applicable generic rules are contained in K.A.R. 111-201-1 *et seq.* (Authorized by K.S.A. 2014 Supp. 74-8710 and 74-8748; implementing K.S.A. 2014 Supp. 74-8710; effective, T-111-1-15-15, Dec. 10, 2014.)

- **111-401-197. Definitions.** The following definitions when pertaining to the game of "Free Bet Blackjack" shall have the following meanings unless the context clearly indicates otherwise:
- (a) "Blackjack" shall mean an ace and any card having a point value of 10 dealt as the initial two cards to a player or a dealer, except that this shall not include an ace and a ten-point value card dealt to a player who has split pairs.
- (b) "Burn" or "burning" a card shall mean to remove a card from play.
- (c) "Dealer" shall mean the person responsible for dealing the cards.
- (d) "Discard rack" shall mean the receptacle into which cards are placed after each round of decisions is rendered in a game.
- (e) "Free double down wager" shall mean an additional optional free wager that may be made by the player on the condition only one additional card will be dealt to the player. This free wager can be made on any hard total hand consisting of two (2) cards totaling 9, 10, or 11 points, including after splitting, with the exception of splitting aces. All free double down wagers shall be made without making an additional wager.
- (f) "Free split wager" shall mean an additional optional wager made when a player's initial two (2) cards are of the same face value. A player may make a free split wager up to three (3) times for a total of four (4) hands. A player may also double down after making a free split wager with the exception of after splitting aces. A player will only receive one additional card after splitting aces. Players may split any pair except a pair where both cards have the value 10 (two 10's, two jacks, two queens, or two kings). All free split wagers shall be made without making an additional wager.
- (g) "Hard total" shall mean the total point count of a hand which contains no aces or which contains one or more aces that are each counted as having one point in value.
- (h) "Push" or "tie" shall mean the player does not lose or win the hand played.
- (i) "Push 22 bonus wager" shall mean an optional wager that may be made by the player in an area designated for the push 22 bonus wager prior to the first card of the hand being removed from the shoe. The player must

- make an original blackjack wager in order to place the push 22 bonus wager.
- (j) "Shoe" or "dealing shoe" shall mean the receptacle into which cards are placed to be held for dealing to the players and dealer.
- (k) "Soft total" shall mean the total point count of a hand containing an ace when the ace is counted as having 11 points in value. (Authorized by K.S.A. 2014 Supp. 74-8710 and 74-8748; implementing K.S.A. 2014 Supp. 74-8710; effective, T-111-1-15-15, Dec. 10, 2014.)
- **111-401-198.** Object of game, method of play, and characteristics of game. (a) The object of the primary game for the "Free Bet Blackjack" game is to have the total point value of the player's hand exceed the total point value of the dealer's hand without going over a total point value of 21.
- (b) The game of "Free Bet Blackjack" also offers the following optional wagers: insurance; double down; free double down; split; free split; and push 22 bonus.
- (c) The game of "Free Bet Blackjack" is played with six (6) decks or eight (8) decks of standard playing cards and is dealt from a dealing shoe or shuffling device.
- (d) The game is played and wagers are placed on a table consisting of five to seven individual betting areas on a layout approved by the lottery.
- (e) Each deck of standard playing cards shall consist of 13 value cards (2, 3, 4, 5, 6, 7, 8, 9, 10, jack, queen, king, and ace) in each of four suits (hearts, spades, diamonds, and clubs). The point value of the cards contained in each deck shall be as follows:
  - (1) Any card from 2 to 10 shall have its face value;
- (2) Any jack, queen or king shall have a value of 10; and
- (3) An ace shall have a value of 11, unless that value would give a player or the dealer a score in excess of 21, in which case it shall have a value of one. (Authorized by K.S.A. 2014 Supp. 74-8710 and 74-8748; implementing K.S.A. 2014 Supp. 74-8710; effective, T-111-1-15-15, Dec. 10, 2014.)
- **111-401-199. Game operations.** The following game operations shall apply the game of "Free Bet Blackjack":
- (a) The following procedures for shuffling shall be implemented:
- (1) The cards will be shuffled at various times including, but not limited to, the following circumstances:
  - (A) New decks are put into play;
- (B) After the completion of the hand in which the cut card appeared;
- (C) The decks have been dropped or otherwise mishandled; and,
- (D) When instructed to do so by a table games supervisor or higher ranking casino official.
- (2) The cards may be shuffled manually or a shuffling machine may be used to shuffle the cards.
- (b) The following procedures for card cutting shall be implemented:
- (1) Upon completion of the shuffle, the dealer will offer the decks to a player to cut. In the event all players at the

table fail or refuse to perform the cut, the dealer or table games supervisor will cut the cards;

- (2) The cut will be performed by inserting the cut card the equivalent of approximately a minimum of one deck from either end of the stack of cards; and,
- (3) Once the deck has been cut, the dealer will insert the cut card approximately one and one-half decks from the back of the six-deck or eight-deck shoe unless otherwise instructed by the table games supervisor or higher ranking casino official.
- (c) The following procedures for dealing and taking cards shall be implemented:
- (1) All original wagers must be in place before the first card is dealt from the shoe;
- (2) Cards are distributed to the players, one at a time and face up, from left to right. The dealer distributes one card to the dealer face up before continuing. The dealer deals a second card to each player, one at a time face up, from left to right and deals a second card to the dealer face down and places it directly under the dealer's first card:
- (3) Beginning with the first player position to the left of the dealer, each player will indicate whether they wish to stand (receive no more cards for that hand) or hit (receive one or more additional cards for that hand, which shall be dealt face up). Cards will continue being distributed to each player, one a time face up, until the player indicates his or her desire to stand or the player's hand exceeds a total of 21 points ("busts"), whichever comes first:
- (4) After all of the players have stood or broken, the dealer's second card will be turned face up and the dealer will announce the total point value of the dealer's two cards. If any player's hand is still in action, the dealer will hit if the dealer holds cards with a total point value of 16 or less or a soft 17. The dealer will stand on a hard 17 or higher total point value. A "soft 17" hand contains an ace that is being counted as 11 points. A "hard 17" hand does not contain an ace that is being counted as 11 points; and,
- (5) If a player has a losing hand, the dealer will remove the player's chips and pick up the cards for placement into the discard rack.
- (d) The following procedures for burning cards shall be implemented:
- (1) A dealer will burn a card after completion of the shuffle; and,
- (2) A dealer will burn a card upon the dealer entering a game.
- (e) Collection and payment of bets shall be accomplished as follows:
- (1) Winning push 22 wagers will be paid and losing push 22 wagers will be collected after the completion of the game; and
- (2) All winning wagers will be paid and losing wagers will be collected beginning with the first player to the dealer's right and working toward the left. (Authorized by K.S.A. 2014 Supp. 74-8710 and 74-8748; implementing K.S.A. 2014 Supp. 74-8710; effective, T-111-1-15-15, Dec. 10, 2014.)
- **111-401-200.** Wagers and payout odds. (a) Minimum and maximum wagers will be posted on a sign at each table.

- (b) Maximum table payouts, if any, will be posted at each table and will not be less than the maximum wager times the maximum odds.
- (c) If a player has been permitted to wager less than the table minimum, the dealer will take or pay the amount actually wagered. If a player has been permitted to wager more than the table maximum, the excess will be returned to the player and the dealer will pay the correct odds on the posted maximum amount. The player will be informed of the table minimum or maximum for subsequent wagers.
- (d) A player may play two hands at double the table minimum per hand not to exceed the table maximum. A player may play three hands at five times the table minimum, per hand, not to exceed the table maximum. Exceptions to this rule are permitted if approved by the pit manager, casino shift manager, or higher ranking casino official.
- (e) The following describes a list of permissible wagers, payout odds, and what constitutes a win, loss, or tie:
  - (1) Original wagers:
- (A) An original wager must be made by the player prior to the first card of the hand being dealt;
- (B) An optional additional original wager may be made as a tip for the dealer;
- (C) An original wager will win if the total point value of the player's cards exceeds the total point value of the dealer's cards without exceeding a total point value of 21. In the event the player's first two cards have a total point value 21, the player will have a blackjack;
- (D) An original wager will lose if the total point value of the player's cards exceeds 21 or is lower than the total point value of the dealer's cards;
- (E) An original wager will tie ("push") if the point value of the dealer's hand totals 22 or if the total point value of the player's cards is equivalent to the total point value of the dealer's cards. A hand containing a blackjack beats a hand with a total point value of 21 that uses three or more cards; and,
- (F) When a player's hand consists of a blackjack, the winning hand will be paid out at a rate of 3 to 2. All winning original wagers, except hands consisting of a blackjack, will be paid out at the rate of 1 to 1.
  - (2) Insurance wager:
- (A) An insurance wager is an optional one-time wager in an amount up to one-half of the original wager that may be made by a player when the dealer has an ace for the dealer's up card (the first card dealt to the dealer, which card is dealt face up). An insurance wager must be made prior to the dealer looking at the hole card (the second card dealt to the dealer, which card is dealt face down);
- (B) An optional additional insurance wager may be made as a tip for the dealer;
- (C) An insurance wager will win at the rate of 2 to 1 if the dealer has a blackjack;
- (D) An insurance wager will lose if the dealer does not have a blackjack.
  - (3) Double Down wager:
- (A) A double down wager is an optional additional wager made by the player up to the amount of the

- player's original wager on the condition only one additional card will be dealt to the player. This wager can be made on any hand consisting of two cards including after splitting, except that the wager may not be made after splitting aces;
- (B) An optional additional double down wager may be made as a tip for the dealer only if the player has made an original wager for the dealer;
- (C) A double down wager will win if the total point value of the player's cards exceeds the total point value of the dealer's cards without exceeding a total point value of 21;
- (D) A double down wager will lose if the total point value of the player's cards exceeds 21 or is less than the total point value of the dealer's cards;
- (E) A double down wager will tie ("push") if the player's hand and the dealer's hand are of equal total point value or if the dealer's cards total 22; and,
- (F) A winning double down wager will be paid at the rate of 1 to 1.
  - (4) Free Double Down wager:
- (A) A free double down wager is an optional additional free wager made by the player up to the amount of the player's original wager on the condition only one additional card will be dealt to the player. This free wager can only be made on any hand consisting of two cards having a total point value of 9, 10, or 11 including after splitting, except that the wager may not be made after splitting aces;
- (B) An optional additional free double down wager may be made as a tip for the dealer only if the player has made an original wager for the dealer;
- (C) A free double down wager will win if the total point value of the player's cards exceeds the total point value of the dealer's cards without exceeding a total point value of 21;
- (D) A free double down wager will lose if the total point value of the player's cards exceeds 21 or is less than the total point value of the dealer's cards;
- (E) A free double down wager will tie ("push") if the player's hand and the dealer's hand are of equal total point value or if the dealer's cards total 22; and,
- (F) A winning free double down wager will be paid the same amount as the original blackjack wager.
  - (5) Split wager:
- (A) A split wager is an optional additional wager made when a player's initial two cards are of the same face value provided the player makes a wager equal to the original wager. A player may split up to three times for a total of four hands. A player may double down after splitting with the exception of after splitting aces. After splitting aces a player will only receive one additional card for each split hand;
- (B) A split wager will win if the total point value of the player's cards exceeds the total point value of the dealer's cards without exceeding a total point value of 21;
- (C) A split wager will lose if the total point value of the player's cards exceeds 21 or is less than the total point value of the dealer's cards;
- (D) A split wager will tie ("push") if the player's hand and the dealer's hand are of equal total point value or if the total point value of the dealer's cards is 22;

- (E) A winning split wager will be paid at the rate of 1 to 1; and,
- (F) An additional optional split wager may be made as a tip for the dealer only if the player has made an original optional wager for the dealer.
  - (6) Free Split wager:
- (A) A free split wager is an optional additional free wager made when a player's initial two cards are of the same face value. A player may split up to three times for a total of four hands. A player may double down after splitting with the exception of after splitting aces. A player will only receive one additional card after splitting aces. A player may split any pairs except pairs where the value of each card is ten (10) (10-10, jack-jack, queen-queen, and king-king);
- (B) A free split wager will win if the total point value of the player's cards exceeds the total point value of the dealer's cards without exceeding a total point value of 21;
- (C) A free split wager will lose if the total point value of the player's cards exceeds 21 or is less than the total point value of the dealer's cards;
- (D) A free split wager will tie ("push") if the player's hand and the dealer's hand are of equal total point value or if the dealers cards total 22;
- (E) A winning free split wager will be paid the same amount as the original blackjack wager; and,
- (F) An additional free split wager may be made as a tip for the dealer only if the player has made an original wager for the dealer.
  - (7) Push 22 Bonus Wager:
- (A) An optional push 22 bonus wager may be made by the player prior to the first card of the hand being removed from the shoe in an area designated for the push 22 bonus wager. The player must make an original blackjack wager in order to place the push 22 bonus wager;
- (B) A push 22 bonus wager will lose if the total point value of the dealer's cards is equal to or exceeds twenty-three (23) or is equal to or is lower than twenty-one (21);
- (C) A push 22 bonus wager will win if the total point value of the dealer's cards is twenty-two (22);
- (D) Winning push 22 bonus wagers will be paid out as follows:
- (i) When the dealer's cards are all the same suit, the push 22 bonus wager will be paid at a rate of 50:1.
- (ii) When the dealer's cards are all the same color but not the same suit, the push 22 bonus wager will be paid at a rate of 20:1.
- (iii) When all of the dealer's cards are not the same color or the same suit, the push 22 bonus wager will be paid at a rate of 7:1; and,

- (c) Failure to obtain prior authorization, if required, shall negate reimbursement for the service and any other service resulting from the unauthorized or noncertified treatment. The prior authorization shall affect reimbursement to all providers associated with the service.
- (d) The only exceptions to prior authorization shall be the following:
- (1) Emergencies. If certain surgeries and procedures that require prior authorization are performed in an emergency situation, the request for authorization shall be made within two working days after the service is provided.
- (2) Situations in which services requiring prior authorization are provided and retroactive eligibility is later established. When an emergency occurs or when retroactive eligibility is established, prior authorization for that service shall be waived, and if medical necessity is documented, payment shall be made.
- (e) Services requiring prior authorization shall be considered covered services within the scope of the program, unless the request for prior authorization is denied. ## Article 7.—FISH AND FROGS

- **115-7-2.** Fishing; general provisions. (a) Except as authorized in this regulation, any person may operate or set two fishing lines and, in addition, one trotline, eight floatlines, or eight setlines.
- (b) Each fishing line, trotline, and setline shall be checked at least once every 24 hours.
- (c) Each trotline, setline, tip-up, floatline, and unattended fishing line shall have a tag or label securely at-

tached, designating either the name and address of the operator or the operator's department-issued identification number. No trotline, floatline, or setline shall be set within 150 yards of any dam.

- (d) Sport fish shall be deemed legally taken by hook and fishing line only when hooked within the mouth, except paddlefish, which may be snagged as authorized by K.A.R. 115-7-1. Other sport fish hooked elsewhere shall be returned unrestrained to the water immediately.
- (e) Fish may be taken by legal methods through the ice, unless the area is closed to ice fishing by posted notice or otherwise prohibited by regulation. Ice holes used for ice fishing shall not exceed 12 inches in diameter or 144 square inches.
- (f) For ice fishing, a tip-up may be used on each of the allowed eight setlines, unless otherwise posted.
- (g) Bow and arrow fishing and crossbow and arrow fishing shall be permitted in all waters of the state except those waters posted as closed to such fishing and except all waters within 50 yards of an occupied boat dock or ramp, occupied swimming area, occupied picnic or camping area, or other occupied public use area.
- (h) Speargun fishing shall be permitted on waters open to skin and scuba diving, unless prohibited by posted notice or regulation. By posted notice, certain water areas may be opened by the department for the taking of one or more species of sport fish by spearguns during a specified time period.
- (i) Unless otherwise prohibited by regulation, in the flowing portions and backwaters of the Missouri river and in any oxbow lake through which the Kansas-Missouri boundary passes, any person may operate or set three fishing lines and, in addition, one trotline, eight floatlines, or eight setlines.
- (j) Unless otherwise prohibited by regulation, in the waters of the state other than those waters specified in subsection (i), any person in possession of a three-pole permit may operate or set three fishing lines and, in addition, one trotline, eight floatlines, or eight setlines. # Article 9.—LICENSES, PERMITS, STAMPS, AND OTHER DEPARTMENT ISSUES

**115-9-6. Vehicle permits; display.** Each person who purchases a vehicle permit for entry into a state park or other area requiring a vehicle permit shall affix the

permit to the lower corner of the windshield on the driver's side of the vehicle for which the vehicle permit was purchased. Annual vehicle permits shall be permanently affixed. #### Article 30.—BOATING

**115-30-1.** Display of identification number and decal. (a) All vessels required to be numbered pursuant to K.S.A. 32-1110 and amendments thereto, except sailboards and kiteboards, shall display the identification number stated on the certificate of number issued by the department to the vessel owner and the decals supplied by the department to the vessel owner as follows:

- (1) Each number consisting of a combination of capital letters and arabic numbers shall read from left to right and shall be painted or permanently attached on the top forward half of the vessel.
- (2) Each character of the number shall be in block form and easily read.
- (3) Each character of the number shall be of the same height and shall not be less than three inches in height.
- (4) The number shall be of a color that contrasts with the color of the vessel.
- (5) A hyphen or equivalent space that is equal to the width of a letter other than "I" or a number other than "1" shall separate arabic numbers from capital letters occurring in the number.
- (6) Department-issued validation decals shall be placed in line and within three inches of the registration number on both sides of the hull of the vessel.
- (b) Each sailboard and each kiteboard shall display only the decals supplied by the department with the certificate of number issued to the sailboard or kiteboard owner. The decals shall be attached to the front half of the top of the sailboard or kiteboard. However, any operator of a sailboard or kiteboard may carry proof of current registration, rather than attaching the decals as otherwise required by this subsection, if the decals supplied by the department do not adhere or cease to adhere to the sailboard or kiteboard.
