The Kansas Department of Health and Environment, Division of Health Care Finance (DHCF), is closing the Medicaid State Plan Health Home Program, as required by the Governor's budget. Effective July 1, 2016, all Medicaid eligible citizens will no longer be able to utilize Health Home services.

On that same date, Health Home services will be removed from the Kansas Alternative Benefit Plan titled *Work Opportunities Reward Kansans (WORK)*. WORK ser-

vices under the ABP will continue to comply with Section 440.345 (EPSDT) and provisions of section 5006(e) of the American Recovery and Reinvestment Act of 2009.

The Office of Attorney General Derek Schmidt will conduct a public hearing between 1 p.m. and 2 p.m. Friday, September 9, 2016, in the Memorial Hall auditorium, 120 S.W. Tenth Ave., Topeka, KS 66612, to consider the adoption of new regulations K.A.R. 16-14-10 and K.A.R. 16-14-11.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rules and regulations. All interested parties may submit written comments prior to the hearing to the office of the Attorney General Derek Schmidt, Scrap Metal Dealer Registration Unit, 120 S.W. Tenth Ave., 2nd Floor, Topeka, KS 66612, or by email to randy.slater@ag.ks.gov. All interested parties will be given a reasonable opportunity during the public hearing to present their views orally regarding the adoption of the proposed regulations. In order to provide all parties an opportunity to present their views, it may be necessary to require that each participant limit any oral presentation to an appropriate timeframe.

Any individual with a disability may request an accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statement in an accessible format. K.A.R. 16-14-10. This regulation outlines the requirements for scrap metal dealers to capture and enter data related to regulated scrap metal transactions into an on-line database.

K.A.R. 16-14-11. This regulation defines terms used in the Scrap Metal Theft Reduction Act, K.S.A. 2015 Supp. 50-6,109 *et seq.*, and in K.A.R. 16-14-10.

Economic Impact. It is anticipated that there will be no additional economic impact to the Office of Attorney General or to other governmental agencies. Scrap metal dealers may incur costs to enter required information into the online database, including costs to obtain internet access.

This 60-day notice of the public hearing constitutes a public comment period for purposes of receiving written public comments on the proposed regulations. All interested parties may submit written comments prior to the hearing to Max L. Foster, Jr., Executive Director, Behavioral Sciences Regulatory Board, 700 S.W. Harrison St., Suite 420, Topeka, KS 66603-3929. Email comments may be directed to max.foster@ks.gov. All interested parties will be given a reasonable opportunity to present their views orally at the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant to limit any oral presentation to five minutes.

K.A.R. 102-8-2 Implements the approved 2014 statutes (K.S.A. 65-7501 thru K.S.A. 65-7505) that identifies licensing fees for Behavioral Analysts and Assistant Behavioral Analysts.

K.A.R. 102-8-4 Implements the approved 2014 statutes (K.S.A. 65-7501 thru K.S.A. 65-7505) that identifies the application process associated with the licensure of Behavioral Analysts and Assistant behavioral Analysts.

K.A.R. 102-8-6 Implements the approved 2014 statutes (K.S.A. 65-7501 thru K.S.A. 65-7505) that affects the supervision requirements for the licensure of Assistant Behavioral Analysts.

K.A.R. 102-8-7 Implements the approved 2014 statutes (K.S.A. 65-7501 thru K.S.A. 65-7505) that clarifies the criteria for the expiration and the renewal of licenses of Behavioral Analysts and Assistant Behavioral Analysts.

K.A.R. 102-8-8 Implements the approved 2014 statutes (K.S.A. 65-7501 thru K.S.A. 65-7505) that identifies the terms and conditions for Continuing Education Unit audits associated with the licensure of Behavioral Analysts and Assistant Behavioral Analysts.

K.A.R. 102-8-9 Implements the approved 2014 statutes (K.S.A. 65-7501 thru K.S.A. 65-7505) that defines continuing education requirements associated with the licensure of Behavioral Analysts and Assistant Behavioral Analysts.

K.A.R. 102-8-10 Implements the approved 2014 statutes (K.S.A. 65-7501 thru K.S.A. 65-7505) that defines the criteria for the documentation of continuing education requirements associated with the licensure of Behavioral Analysts and Assistant Behavioral Analysts.

K.A.R. 102-8-11 Implements the approved 2014 statutes (K.S.A. 65-7501 thru K.S.A. 65-7505) that defines the acts that would be considered to be unprofessional conduct of a licensed Behavioral Analyst or Assistant Behavioral Analyst.

K.A.R. 102-8-12 Implements the approved 2014 statutes (K.S.A. 65-7501 thru K.S.A. 65-7505) that defines the recordkeeping requirements associated with the licensure of Behavioral Analysts and Assistant Behavioral Analysts.

Economic impact: There would be an economic impact to Behavioral Analysts and Assistant Behavioral Analysts as a result of the requirement for their licensure under these regulations. There would be no economic impact to other BSRB licensees, any other governmental agencies, or the public.

The bond will be payable solely from amounts received from the respective borrower, the obligation of which will be sufficient to pay the principal of, interest and redemption premium, if any, on the bond when it becomes due.
