Kansas Department of Health and Environment (KDHE), Division of Health Care Finance (DHCF) is issuing the following clarification to the notice published June 9, 2016.

In order to meet the Governor's SFY 2017 budget allotments, the KDHE DHCF will apply a Medicaid "Budget Shortfall" 4 percent payment reduction for services from July 1, 2016 forward. The net Medicaid payment will be reduced by 4 percent, and will be reflected in a notice to providers posted with the Medicaid rates. The payment reduction is applied to the net Medicaid paid amount after reductions for Medicare, other insurance, or any other third party liability payment.

The services exempt from the payment reduction are all Home and Community Based Services (HCBS). Limited Hospice services are also exempt from the reduction.

Provider types exempt from this payment reduction are Indian Health Services, Critical Access Hospital, Rural and Frontier Hospitals, WORK, FQHC and RHC.

A public hearing will be conducted on Thursday, September 8, 2016, at 10 a.m. in the 2nd Floor Auditorium of the Memorial Hall State Office Building, 120 S.W. Tenth Ave., Topeka, Kansas. The hearing is scheduled to last for 30 minutes. The hearing is to consider the adoption of proposed regulations by the Office of the Attorney General on a permanent basis.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments for the proposed regulations noted below. All interested parties may submit written comments prior to the hearing to the Bail Enforcement Agent Licensing Unit, 120 S.W. Tenth Ave., 2nd Floor, Topeka, KS 66612 or by email to general@ag.ks.gov. All interested parties will be given a reasonable opportunity to present their views orally regarding the adoption of the proposed regulations during the public hearing. In order to provide all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentation to an appropriate timeframe.

Any individual with a disability may request an accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statement in an accessible format. Requests

A summary of the proposed regulations and their Economic Impact follow.

K.A.R. 16-15-1: Definitions. This new regulation provides some definitions for terms that are used throughout 16-15-2, 16-15-3, and 16-15-4 pertaining to licensed bail enforcement agents.

K.A.R. 16-15-2: Application for licensure. This new regulation lays out the initial application process on what information is needed to be provided to the Attorney General in order for the person to be considered for licensure as a bail enforcement agent.

K.A.R. 16-15-3: Fees. Simply, this new regulation establishes what the rate of certain fees will be in order to become a licensed bail enforcement agent.

K.A.R. 16-15-4: License renewal. This new regulation lays out the process to renew a bail enforcement agent license.

Economic Impact. The Attorney General anticipates that there should be little, if any, economic impact to State and local governments due to these regulations.

Permanent Administrative Regulation

Article 102. – GAMING SUPPLIER AND NON-GAMING SUPPLIER CERTIFICATION

112-102-2. Gaming supplier and non-gaming supplier defined. (a) Each person that performs one or more of the following shall be considered a gaming supplier: (1) Manufactures, sells, leases, supplies, or distributes

devices, machines, equipment, accessories, or items that meet at least one of the following conditions:

(A) Are designed for use in a gaming facility;

(B) are needed to carry out a lottery facility game;

(C) have the capacity to affect the result of the play of a lottery facility game; or

(D) have the capacity to affect the calculation, storage, collection, or control of the revenues from a gaming facility;

(2) provides maintenance services or repairs gaming equipment, including slot machines;

(3) provides services directly related to the management or administration of a gaming facility;

(4) provides junket services; or

(5) provides items or services that the commission has determined are used in or are incidental to gaming or to an activity of a gaming facility.

(b)(1) Any person that is not a gaming supplier but otherwise meets one or more of the following may be considered a non-gaming supplier:

(A) Acts as a manager of an ancillary lottery gaming facility;

(B) is not a public utility and provides goods or services to a facility manager or ancillary lottery gaming facility in an amount of \$250,000 or more within a one-year period; or

(C) provides goods or services to a gaming facility and could present a security, integrity, or safety concern to the gaming operations as determined by the executive director.

(2) A person that is any of following shall not be considered a non-gaming supplier:

(A) Regulated insurance company providing insurance to a facility manager, an ancillary lottery gaming facility, or the employees of either;

(B) employee benefit or retirement plan provider, including the administrator;

(C) regulated bank or savings and loan association that provides financing to a facility manager or ancillary lottery gaming facility; or

(D) professional service provider, including an accountant, architect, attorney, and engineer. (Authorized by and implementing K.S.A. 2015 Supp. 74-8751 and 74-8772; effective Aug. 14, 2009; amended Dec. 9, 2011; amended July 15, 2016.)
