**K.A.R. 69-12-18** – **Access to Tanning Devices.** This is a new regulation and would carry out the provisions of 2016 HB 2456 (L. 2016, ch. 91, New Section 1) which requires tanning facility operators to prohibit minors' access to tanning devices.

**K.A.R. 69-11-1 – Fees.** Amendments to this regulation would increase the initial license application fee and the renewal fee for a cosmetologist, electrologist, manicurist (nail technologist) and esthetician. The amendment would also increase the salon initial application fee and the reciprocity application fee.

**Economic Impact.** The board anticipates that there should be little, if any, economic impact to state and local governments due to these regulations.

These regulations are proposed for permanent adoption. A summary of the proposed regulations and the estimated economic impact statement follows:

K.A.R. 61-1-24. Temporary permits issued; permits and licenses conspicuously displayed. This regulation is amended to clarify that temporary permits issued to

students upon graduation from a licensed barber school or college are only valid until the next examination.

K.A.R. 61-3-2. Minimum requirements for courses of instruction. This regulation is amended to require at least 1,200 hours and not more than 1,500 hours to enable a candidate to sit for the barber examination and it requires at least 500 hours for military certified or Kansas licensed cosmetologist related-industry professionals to enable a candidate to sit for the barber examination.

K.A.R. 61-3-3. Subjects required in courses of instruction. This regulation is amended to specify that licensed barber schools and colleges will meet the requirements in the board's documents "Kansas barber minimum curriculum (1,200 hours)" for the traditional barbering program and "Industry-related minimum additional curriculum (500 hours)" for the industry-related program.

**K.A.R. 61-3-5. Qualifications for supervisors of barber school or barber colleges.** This regulation is amended to specify that the individual supervising the barbering course shall be a licensed barber instructor.

**K.A.R. 61-3-20. Teaching staff.** This regulation is amended to specify there shall be one licensed instructor of every 10 or fewer students.

**K.A.R. 61-4-2. Issuance and renewal of licenses.** This regulation is amended to clarify annual licensing dates by the first letter of the last name of barbers, shop owners and instructors.

Economic Impact. The adoption of these regulations will have a minimal but positive impact on the growth in local, county and state taxes as a result of income and asset growth based on an increase in schools, colleges, instructors, students and new barbers. It is anticipated there will be an economic impact to the Board as it will need to increase the number of yearly barber license examinations conducted, resulting from an increase in barber school graduates as the number of licensed barber schools and colleges increase. The increase in expenditure to the board to cover costs of conducting these examinations will be covered by the examination and licensing fees charged by the Board. There is no environmental impact.

**Temporary Administrative Regulations** 

## Article 12.—CONDUCT AND PENALTIES

**44-12-301. Fighting.** (a) Fighting or any other activity that constitutes violence or is likely to lead to violence shall be prohibited.

(b) It shall be an affirmative defense, for which the offender shall bear the sole burden of proof, if the offender is engaged in self-defense.
