Executive Order 18-12 Criminal History and State Employment Practices

WHEREAS, thousands of Kansans who have served criminal penalties subsequently return to their homes and communities across Kansas seeking potential employment opportunities with state government; and

WHEREAS, individuals who have completed their sentences and have paid their debts to society are deserving of a second chance in life and a helping hand as they seek to reenter society; and

WHEREAS, individuals with criminal records often experience obstacles that increase the difficulties associated with successfully reentering society; and

WHEREAS, gainful employment is a significant factor for success in reducing recidivism rates and providing financial stability among former offenders; and

WHEREAS, the national "Ban the Box" initiative has brought renewed attention to the value of asking about an applicant's criminal history later in the hiring process and providing applicants with an opportunity to explain their unique facts and circumstances to potential employers; and

WHEREAS, numerous other states have adopted policies revising their state employment practices to lower the barriers to individuals with criminal histories seeking to enter the state workforce; and

WHEREAS, employment rates are at historic highs, there is a need for qualified job applicants, and other employers have taken this action in their hiring practices.

NOW THEREFORE, pursuant to the authority vested in me as Governor of the State of Kansas, I hereby order as follows:

- 1. Within ninety (90) days of the date of this order, all Executive Branch departments, agencies, boards, and commissions under the jurisdiction of the Office of the Governor shall take action to ensure that, during the initial stage of a state employment application, job applicants shall not be asked whether they have a criminal record, and a criminal record shall not automatically disqualify an applicant from receiving an interview.
- 2. This Order shall not apply when a criminal history would render an applicant ineligible for a position. In particular, if any law or regulation prohibits a person from holding a job due to prior criminal conduct, it is permissible to inquire about an applicant's criminal record during the initial stage of a state employment application and an applicant may be disqualified from further review for this reason.
- 3. Nothing in this Order shall prevent the conduct of a criminal background check as a condition of employment.
- 4. This Order is intended to supplement existing laws and regulations concerning State of Kansas employment practices, and shall not be interpreted to in any way diminish such laws and regulations. The Order is not intended to create any new right or benefit enforceable against the State of Kansas.

This document shall be filed with the Secretary of State as Executive Order No. 18-12 and shall become effective immediately.

The proposed regulation amendments are for adoption on a permanent basis. A summary of the proposed amendments to the regulation and the economic impact follows:

117-2-1. Licensed classification; education requirements. This regulation is being amended to remove the college level education from this classification.

There will be no economic impact to this agency, other governmental agencies or units, or existing appraisers. There could, however, be a substantial savings to applicants for this classification in the removal of the college level education.

117-2-2. Licensed classification; appraisal experience requirement. This regulation is being amended to modify both the hours of appraisal experience required for this classification, as well as the minimum time frame in which those hours may be accrued. We have also reduced the maximum number of alternate appraisal experience hours allowed. There is an update to the "experience hours table" adopted by reference in (d)(2).

There will be no economic impact to this agency, other governmental agencies or units, or existing appraisers. There could, however, be a substantial savings to applicants for this classification in shortening the number of experience hours required, as well as the minimum time in which they must work under the supervision of a certified appraiser.

117-3-2. General classification; appraisal experience requirement. This regulation is being amended to reduce the minimum time in which an applicant must accrue their experience hours.

There will be no economic impact to this agency, or other governmental agencies or units. There could, how-

ever, be a substantial savings to applicants or upgrades to this classification in shortening the minimum time in which they must work under the supervision of a certified appraiser.

117-4-1. Residential classification; education requirements. This regulation is being amended to provide applicants with options for meeting the college level education, as well as allowing an alternative to the college level education for state licensees to upgrade.

There will be no economic impact to this agency, or other governmental agencies or units. There could, however, be a substantial savings to state licensees to upgrade to this classification allowing their experience in lieu of the college level education and to applicants in the options for the college level education.

117-4-2. Residential classification; appraisal experience requirement. This regulation is being amended to reduce both the number of experience hours as well as the minimum time frame in which those hours must be accrued. There is also a reduction in the number of alternate experience hours which may be used.

There will be no economic impact to this agency, or other governmental agencies or units. There could, however, be a substantial savings to state licensees to upgrade to this classification, as well as new applicants in the reduction of the number of experience hours which must be met, and the minimum time frame in which those hours must be accrued.

117-5-1. Provisional classification; education requirements.

This regulation is being amended to reflect the changes to 117-2-1, 3-1, and 4-1 in the qualifying education and/or college level education that must be met.

There will be no economic impact to this agency, other governmental agencies or units, or appraisers. There could, however, be a substantial savings to new applicants in the changes to the college level education required in 117-2-1 and 3-1, as well as the reduction of experience hours in 117-2-2 and 3-2 and the reduction of the minimum time frame in which those hours must be accrued in 117-2-2, 3-2, and 4-2.

The purpose of this revocation is to eliminate confusion created by an unnecessary self-directing regulation. The revocation is not anticipated to have any economic impact.

Revocation of K.A.R. 21-45-1 through 21-45-18. This proposal revokes regulations that set the procedures to be followed in a post-probable cause public hearing. Since they were adopted, K.S.A. 44-1005 was amended to provide that such hearings are governed by the Kansas Administrative Procedures Act. The purpose of the revocation is to avoid confusion, as these regulations are no longer necessary. The revocation is not anticipated to have any economic impact.

Revocation of K.A.R. 21-45-21 through 21-45-25. This proposal revokes regulations that set the procedures to be followed in a post-probable cause public hearing. Since they were adopted, K.S.A. 44-1005 was amended to provide that such hearings are governed by the Kansas Administrative Procedures Act. The purpose of the revocation is to avoid confusion, as these regulations are no longer necessary. The revocation is not anticipated to have any economic impact.

Revocation of K.A.R. 21-46-2 and 21-46-3. This proposal revokes two regulations that the Kansas appellate courts have determined to be invalid. The purpose is to eliminate confusion by removing the text of these regulations from the published Kansas Administrative Regulations. The revocation is not anticipated to have any economic impact.

Article 401.—NORTHEAST GAMING ZONE

- 111-401-63. Wagers and payout odds. (a) Minimum and maximum wagers will be posted on a sign at each table.
- (b) Maximum table payouts, if any, will be posted at each table and will not be less than the maximum bet times the maximum odds.

- (c) If a player has been permitted to wager less than the table minimum, the dealer will take or pay the amount actually wagered. If a player has been permitted to wager more than the table maximum, the excess will be returned to the player and paid the correct odds on the correct wager. The player will be informed of the table minimum and maximum for subsequent wagers.
- (d) The following describes a list of the permissible wagers, payout odds, and what constitutes a win, loss, or tie:
 - (1) Ante:
- (A) An ante wager is placed by a player prior to receiving his or her initial two cards in area designated for the
 - (B) Winning ante wagers will be paid as follows:
 - (i) Royal flush, 500 to 1;
 - (ii) Straight flush, 100 to 1;
 - (iii) Four-of-a-kind, 40 to 1;
 - (iv) Full house, 10 to 1;
 - (v) Flush, 6 to 1;
 - (vi) Straight, 4 to 1;
 - (vii) Three-of-a-kind, 3 to 1;
 - (viii) Two pair, 2 to 1;
 - (ix) Pair of jacks or higher ranking hand, 1 to 1.
- (C) The ante wager will win if the player's five card hand contains a pair of jacks or higher ranking hand.
- (D) The ante wager will lose if the player forfeits or the player's five card hand contains a pair of 5s or lower ranking hand.
- (E) The ante wager will push (tie) if the player's five card hand contains a pair of 6s, 7s, 8s, 9s, or 10s.
- (F) An additional ante wager may be made as a tip for the dealer.
 - (2) Third street:
- (A) A third street wager is placed by a player after receiving his or her initial two cards in the area designated for the third street wager. The third street wager must be in an amount equal to one time, two times, or three times the ante wager.
 - (B) Winning third street wagers will be paid as follows:
 - (i) Royal flush, 500 to 1;
 - (ii) Straight flush, 100 to 1;
 - (iii) Four-of-a-kind, 40 to 1;
 - (iv) Full house, 10 to 1;
 - (v) Flush, 6 to 1;
 - (vi) Straight, 4 to 1;
 - (vii) Three-of-a-kind, 3 to 1;
 - (viii) Two pair, 2 to 1;
 - (ix) Pair of jacks or higher ranking hand, 1 to 1.
- (C) The third street wager will win if the player's five card hand contains a pair of jacks or higher ranking hand.
- (D) The third street wager will lose if the player forfeits, or the player's five card hand contains a pair of 5s or lower ranking hand.
- (E) The third street wager will push (tie) if the player's five card hand contains a pair of 6s, 7s, 8s, 9s, or 10s.
- (F) An additional third street wager may be made as a tip for the dealer if the dealer has an ante wager.
 - (3) Fourth street:
- (A) A fourth street wager is placed by a player after receiving his or her initial two cards and after the third street has been exposed in an area designated for the (continued)

fourth street wager. The fourth street wager must be in an amount equal to one time, two times, or three times the ante wager.

- (B) Winning fourth street wagers will be paid as follows:
 - (i) Royal flush, 500 to 1;
 - (ii) Straight flush, 100 to 1;
 - (iii) Four-of-a-kind, 40 to 1;
 - (iv) Full house, 10 to 1;
 - (v) Flush, 6 to 1;
 - (vi) Straight, 4 to 1;
 - (vii) Three-of-a-kind, 3 to 1;
 - (viii) Two pair, 2 to 1;
 - (ix) Pair of jacks or higher ranking hand, 1 to 1.
- (C) The fourth street wager will win if the player's five card hand contains a pair of jacks or higher ranking hand.
- (D) The fourth street wager will lose if the player forfeits, or the player's five card hand contains a pair of 5s or lower ranking hand.
- (E) The fourth street wager will push (tie) if the player's five card hand contains a pair of 6s, 7s, 8s, 9s, or 10s.
- (F) An additional fourth street wager may be made as a tip for the dealer if the dealer has an ante wager.
 - (4) Fifth street:
- (A) A fifth street wager is placed by a player after receiving his or her initial two cards and after the third and fourth street cards have been exposed in an area designated for the fifth street wager. The fifth street wager must be in an amount equal to one time, two times, or three times the ante wager.
 - (B) Winning fifth street wagers will be paid as follows:
 - (i) Royal flush, 500 to 1;
 - (ii) Straight flush, 100 to 1;
 - (iii) Four-of-a-kind, 40 to 1;
 - (iv) Full house, 10 to 1;
 - (v) Flush, 6 to 1;
 - (vi) Straight, 4 to 1;
 - (vii) Three-of-a-kind, 3 to 1;
 - (viii) Two pair, 2 to 1;
 - (ix) Pair of jacks or higher ranking hand, 1 to 1.
- (C) The fifth street wager will win if the player's five card hand contains a pair of jacks or higher ranking hand.
- (D) The fifth street wager will lose if the player forfeits, or the player's five card hand contains a pair of 5s or lower ranking hand.
- (E) The fifth street wager will push (tie) if the player's five card hand contains a pair of 6s, 7s, 8s, 9s or 10s.
- (F) An additional fifth street wager may be made as a tip for the dealer if the dealer has an ante wager.
 - (5) Progressive:
- (A) Players may participate in the optional progressive jackpot by placing a \$1 chip in the designated area. The player must have an ante wager to make a progressive bet.
- (B) The progressive jackpot will be comprised of a base amount of \$10,000.
- (C) The amount of the progressive jackpot will be displayed in a manner visible to patrons.
- (Ď) Winning progressive bets will be paid at the rate of:
- (i) If the player's hand consists of a three of a kind, 9 for 1.
 - (ii) If the players hand consists of a straight, 30 for 1.
 - (iii) If the player's hand consists of a flush, 40 for 1.

- (iv) If the player's hand consists of a full house, 50 for 1.
- (v) If the player's hand consists of four-of-a-kind, 300 for 1.
- (vi) If the player's hand consists of a straight flush, 10 percent of the progressive jackpot.
- (vii) If the player's hand consists of a royal flush, 100% of the progressive jackpot.
- (E) A progressive bet will win if the player's hand consists of a three-of-a-kind, straight, flush, full house, four-of-a-kind, straight flush, or a royal flush.
- (6) Winning progressive bets will be paid in the following manner:
- (A) If the winning hand consists of a three-of-a-kind, straight, flush, or a full house, or four-of-a-kind, the dealer will make the appropriate payout.
- (B) If the winning hand consists of straight flush, or a royal flush, the table games supervisor or higher ranking casino official will verify the winning hand and will verify the progressive bet was made. The table games supervisor or higher ranking casino official will notify the table games pit manager or higher ranking casino official. Surveillance will also be notified to verify the winning hand.
- (i) The dealer will verify the deck of cards by counting down and sorting the remaining cards by suit.
- (ii) Once the jackpot has been deducted from the progressive jackpot for the straight flush or royal flush, new cards will be placed on the table and play will resume.
- (iii) In the case of a royal flush, the meter will reset to an amount equal to the sum of \$10,000.
- (iv) In the event of multiple winning progressive hands consisting of Straight Flush or Royal Flush, the jackpot will be determined by whoever received their hand first according to the time on surveillance video at the lottery gaming facility.
- (C) A progressive bet will lose if the player's hand consists of any combination of cards other than a three-of-a-kind, straight, flush, full house, four-of-a-kind, straight flush, or a royal flush.
 - (7) Envy bonus:
- (A) Players who wager \$1 on the progressive bet qualify for the envy bonus.
- (i) Only the seated player for a position qualifies for the envy bonus.
- (ii) If two players have an envy bonus jackpot, the players are paid on both hands.
- (iii) The position which contains the qualifying envy bonus hand (royal flush or straight flush) cannot win the envy bonus.
 - (B) The envy bonus payouts are as follows:
 - (i) Royal flush, \$1,000;
 - (ii) Straight flush, \$300.
 - (8) Three card bonus side wager:
- (A) Players who have placed an ante wager may also participate in the optional three card bonus by placing a wager in the designated area. The three card bonus wager is a side wager based on the community cards. The three card bonus wager will remain an active wager and be resolved even if the player otherwise forfeits the hand.
- (B) The three card bonus wager will win if the community cards contain a pair or higher ranking hand and will lose if the community cards do not contain a pair or higher ranking hand.

- (C) Winning three card bonus wagers will be paid as follows:
- (i) Straight flush (three consecutively ranked cards of the same suit), 40 to 1;
 - (ii) Three of a kind, 30 to 1;
- (iii) Straight (three consecutively ranked cards of any suit), 6 to 1;
 - (iv) Flush (three cards of the same suit), 3 to 1; and,
 - (v) Pair, 1 to 1.
- (D) An additional three card bonus wager may be made as a tip for the dealer. (Authorized by K.S.A. 2017 Supp. 74-8710 and 74-8748; implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-2-9-12, Dec. 14, 2011; amended, T-111-5-31-13, May 15, 2013; amended, T-111-8-28-17, July 12, 2017; amended, T-111-4-18-18, Feb. 27, 2018.)

Article 601.—SOUTHEAST GAMING ZONE

111-601-36. Rules of the game and bet definitions.

- (a) The stickperson, boxperson, table games supervisor or a higher-ranking casino employee shall have the authority to invalidate a roll of the dice by calling "no roll" for any of the following reasons:
- (1) If the wrong player picks up the dice and throws or rolls them.
- (2) If the dice do not hit the end of the table opposite the shooter.
- (3) The dice do not leave the shooter's hand simultaneously.
- (4) Either or both of the dice come to rest on the chips constituting the craps bank (the chips in front of the boxperson).
- (5) Either or both of the dice come to rest in the dice bowl or on one of the rails surrounding the table.
 - (6) Either or both of the dice go off the table.
 - (7) Whenever one die comes to rest on top of the other.
- (8) The shooter does not have either a pass or don't pass bet.
- (9) Either or both of the dice do not move with forward motion.
- (10) If the player shooting the dice removes either one or both dice from the view of the boxperson or table games supervisor or higher-ranking casino official before he shoots them.
- (11) If the player attempts to deface the dice purposely or unintentionally before the player shoots the dice.
- (b) Whenever new dice are put into the game or existing dice are returned to the game, they shall be inspected by the boxperson before being put into the dice bowl.
 - (c) Permissible wagers shall be as follows:
- (1) "Pass bet" shall mean a wager placed on the pass line of the layout immediately prior to the come-out roll.
- (i) The "pass bet" shall win if, on the come-out roll a total of 7 or 11 is thrown, or a total of 4, 5, 6, 8, 9, or 10 is thrown and that total is again thrown before a total of 7 appears.
- (ii) The "pass bet" shall lose if, on the come-out roll a total of 2, 3 or 12 is thrown, or a total of 4, 5, 6, 8, 9, or 10 is thrown and a 7 subsequently appears before that total is thrown again.
- (2) "Don't pass bet" shall mean a wager placed on the don't pass line of the layout immediately prior to the come-out roll.

- (i) The "don't pass bet" shall win if, on the come-out roll a total of 2 or 3 is thrown, or a total of 4, 5, 6, 8, 9, or 10 is thrown and a 7 subsequently appears before that total is again thrown.
- (ii) The "don't pass bet" shall lose if, on the come-out roll a total of 7 or 11 is thrown, or a total of 4, 5, 6, 8, 9, or 10 is thrown and that total is again thrown before a 7 appears.
- (iii) The "don't pass bet" shall be a push if, on the comeout roll a total of 12 is thrown.
- (3) "Come bet" shall mean a wager placed on the come line of the layout at any time after the come-out roll.
- (i) The "come bet" shall win if, on the roll immediately following placement of such bet a total of 7 or 11 is thrown, or a total of 4, 5, 6, 8, 9, or 10 is thrown and that total is again thrown before a 7 appears.
- (ii) The "come bet" shall lose if, on the roll immediately following placement of such bet a total of 2, 3, or 12 is thrown, or a total of 4, 5, 6, 8, 9, or 10 is thrown and a 7 subsequently appears before that total is again thrown.
- (4) "Don't come bet" shall mean a wager placed on the "don't come" area of the layout at any time after the come-out roll.
- (i) The "don't come bet" shall win if, on the roll immediately following placement of such bet a total of 2 or 3 is thrown, or a total of 4, 5, 6, 8, 9, or 10 is thrown and a 7 subsequently appears before that total is again thrown.
- (ii) The "don't come bet" shall lose if, on the roll immediately following placement of such bet a total of 7 or 11 is thrown, or a total of 4, 5, 6, 8, 9, or 10 is thrown and that total is again thrown before a 7 appears.
- (5) The "don't come bet" shall be void if, on the roll following placement of such bet a total of 12 is thrown.
- (6) "Place bet" shall mean a wager that may be made at any time on any of the numbers 4, 5, 6, 8, 9, or 10 which shall win if the number on which wager was placed is thrown before a 7 and shall lose if a 7 is thrown before such number. All place bets shall be active on any roll, except the come-out roll, unless called "on" by the player and confirmed by the dealer through placement of an "on" button on top of such player's wager.
- (7) "Buy bets" shall mean a wager that may be made at any time, on the 4, 5, 6, 8, 9, and 10. All buy bets require an additional vigorish equal to five percent (5%) of the original wager. A buy bet shall win if the particular number is thrown before a 7 is thrown and shall lose if a 7 is thrown before that number is thrown.
- (8) "Lay bets" shall mean a wager that may be made at any time, against any of the numbers 4, 5, 6, 8, 9, and 10. A lay bet shall win if a 7 is thrown before the particular number against which the wager is placed and shall lose if a particular number against which the wager is placed is thrown before a 7 is thrown. A player placing a lay bet shall also be charged a vigorish not to exceed five percent (5%) on the amount the player may potentially win.
- (9) "Four the hardway" shall mean a wager, that may be made at any time, which shall win if a total of 4 is thrown the hardway (i.e., with 2 appearing on each die) before a 4 is thrown in any other way and before a 7 is thrown.
- (10) "Six the hardway" shall mean a wager, that may be made at any time, which shall win if a total of 6 is thrown (continued)

the hardway (i.e., with 3 appearing on each die) before 6 is thrown in any other way and before a 7 is thrown.

- (11) "Eight the hardway" shall mean a wager, that may be made at any time, which shall win if a total of 8 is thrown the hardway (i.e., with 4 appearing on each die) before 8 is thrown in any other way and before a 7 is thrown.
- (12) "Ten the hardway" shall mean a wager that may be made at any time, which shall win if a total of 10 is thrown the hardway (i.e., with 5 appearing on each die) before 10 is thrown in any other way and before a 7 is thrown.
- (13) "Field bet" shall mean a one-roll wager that may be made at any time which shall win if any of the totals of 2, 3, 4, 9, 10, 11, or 12 is thrown on the roll immediately following placement of such bet and shall lose if a total of 5, 6, 7, or 8 is thrown on such a roll.
- (14) "Any seven" or "big red" shall mean a one-roll wager that may be made at any time which shall win if a total of 7 is thrown on the roll immediately following placement of such a bet and shall lose if any other total is thrown.
- (15) "Any craps" shall mean a one roll wager that may be made at any time which shall win if a total of 2, 3, or 12 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown.
- (16) "Two Craps," "aces," or "low" shall mean a one-roll wager that may be made at any time which shall win if a total of 2 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown.
- (17) "Three Craps" or "ace-deuce" shall mean a one-roll wager that may be made at any time which shall win if a total of 3 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown.
- (18) "Twelve Craps," "high," or "boxcars" shall mean a one-roll wager that may be made at any time which shall win if a total of 12 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown.
- (19) "Eleven" or "yo" shall mean a one-roll wager that may be made at any time which shall win if a total of 11 is thrown on the next roll and shall lose if any other total is thrown.
- (20) "Horn bet" shall mean a one-roll wager that may be made at any time which shall win if a total of 2, 3, 11, or 12 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown.
- (21) "Horn high bet" shall mean a one-roll wager that may be made at any time, which shall win if any one of the totals 2, 3, 11, or 12 is thrown on the roll immediately following placement of such bet and shall lose, if any other total is thrown. A horn high bet will be placed in units of five, with four units wagered as a horn bet and an additional unit wagered on one of the totals 2, 3, 11, or 12. As used in this subsection, the term "unit" means chips or checks the value of which are equally divisible in whole dollars by five (5) such that the value of a single unit is not less than the minimum wager allowed or more than the maximum wager allowed.
- (22) "World bet" shall mean a one-roll wager that may be made at any time, which shall win if any one of the totals 2, 3, 7, 11, or 12 is thrown on the roll immediately following placement of such bet and shall lose if any

- other total is thrown. A world bet shall be placed on the lower line of the any seven wager area in units of five with one unit wagered on each of the totals 2, 3, 7, 11, or 12. As used in this subsection, the term "unit" means chips or checks the value of which are equally divisible in whole dollars by five (5) such that the value of a single unit is not less than the minimum wager allowed or more than the maximum wager allowed.
- (23) "3 way craps" shall mean a one-roll wager, that may be made at any time, which shall win, if any one of the totals 2, 3, or 12 is thrown on the roll immediately following the placement of such bet and shall lose if any other total is thrown. A "3 way craps" bet will be placed with one unit wagered on each of the totals 2, 3, or 12. The dealer shall place such a wager touching the "C" of the any craps wager area and the horn or horn high wagering area.
- (24) "Hop bet" means a one-roll wager that may be made at any time on a specific combination designated by the player which will win if the combination is thrown on a roll immediately following placement of such bet and will lose if any other combination is thrown.
- (25) "Big six" or "big 6" means a wager placed in the area of the layout marked "big six" or "big 6," which shall win if a total of 6 is thrown before a 7 and shall lose if a 7 is thrown before a 6.
- (26) "Big eight" or "big 8" means a wager placed on the area of the layout marked "big eight" or "big 8" and shall win if a total of eight is thrown before a 7, and shall lose if a 7 is thrown before an 8.
- (27) "Split bet" means a one-roll wager that is placed on the line or area between two proposition bets. One half of the split bet is being bet on each side. Both bets will be left up and a net payoff is made to the player.
- (28) "Craps-eleven" or "C and E" means a one-roll split bet on any craps and eleven.
- (29) "High-low" means a one-roll split bet aces (2) and twelve (12).
- (30) "Ace deuce—any craps split" means a one-roll split bet which is unique because if one die shows one spot up and the other die shows two spots up, both sides of the split bet win.
- (31) "Put bets" are bets that are made directly on any number at any time, including the point, after the comeout roll has already been made.
- (32) "Fire bets" are optional wagers that may be offered on selected craps tables that are placed before the first point is established by a new shooter. The wagers will win if three (3) or more of the six (6) individual points are made by the shooter before the shooter rolls a seven (7). The wagers will lose if two (2) or fewer of the six (6) individual points are made by the shooter before the shooter rolls a seven (7). "Individual points" in the game of craps are the following totals shown on the two dice: four (4), five (5), six (6), eight (8), nine (9), and ten (10). For purposes of fire bets, only the first of each individual point made before the shooter rolls a seven (7) counts toward the total number of individual points made and any duplicate individual point(s) made during that time are irrelevant. (Authorized by K.S.A. 2017 Supp. 74-8710 and 74-8748; implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-2-2-17, November 9, 2016; amended, T-111-4-18-18, Feb. 27, 2018.)

- **111-601-37. Making and removal of wagers.** (a) All wagers at craps shall be made by placing gaming chips on the appropriate areas of the craps layout.
 - (b) Wagers shall be made before the dice are thrown.
- (c) Wagers may be made by a player or may be made by verbal confirmation of a desired bet communicated to the dealer by the player with subsequent placement of said bet on the appropriate portion of the layout by the dealer.
- (d) A wager made on any bet may be removed or reduced at any time prior to a roll that decided the outcome of such wager except that a pass bet and a come bet shall not be removed or reduced after a come-out point or some point is established with respect to such bet. Pass line and come bets are always active and cannot be changed or withdrawn until the bet either wins or loses.
- (e) A don't come bet and a don't pass bet may be removed or reduced at any time but may not be replaced or increased after such removal or reduction until a new come-out roll.
- (f) All place bets, come bet odds and hardways shall be inactive on any come-out roll unless requested "on" by the player and confirmed by the dealer through placement of an "on" button on top of the wager. All other wagers shall be considered active unless a player requests to have his bets inactive. The dealer through placement of an "off" button must confirm this.
 - (g) Minimum and maximum table limits will be posted.
- (h) If a player wagers less than the table minimum bet and the dealer does not notice it, the dealer shall take or pay the amount actually bet and instruct the player of the minimum amount that must be wagered on subsequent bets.
- (i) If in error a player has been permitted to wager more than the table maximum, the dealer shall remove the excess and return it to the player, pay the bet at the correct odds for the maximum allowable wager, and inform the player of the permissible amount that can be wagered on subsequent bets.
- (j) In the event of a dealer placing a bet for a player, chips shall not be taken from the player's hands or from the rack in front of the player. All chips for the bet shall be set down on the layout by the player and the dealer shall clarify the purpose of the chips before picking them up.
 - (k) Wager and payout odds shall be as follows:

- (l) A horn bet shall be paid as if it were four separate wagers on 2, 3, 11, and 12.
- (m) All charges for vigorish that are less than one dollar amounts, will be rounded down to the nearest dollar figure.
- (n) A player may remove the player's lay bet at any time before the number or seven is rolled. If the player removes the lay bet, the amount of the vigorish will also be returned.
- (o) Players may take odds on their pass and come bets as follows:
- (1) On a pass line point/come bet of 4 and 10, odds can be taken up to 3 times the pass line bet.
- (2) On a pass line point/come bet of 5 and 9, odds can be taken up to 4 times the pass line bet.
- (3) On a pass line point/come bet of 6 and 8, odds can be taken up to 5 times the pass line bet.
- (p) Players may take odds on their put bets. Put bets are made the same way as pass line and come bets, except that put bets are placed directly on the number without going through the pass or come, as follows:
- (1) On a put bet of 4 and 10, odds can be taken up to three times the pass line bet.
- (2) On a put bet of 5 and 9, odds can be taken up to four times the pass line bet.
- (3) On a put bet of 6 and 8, odds can be taken up to five times the pass line bet.
- (q) Players may lay odds on their don't pass and don't come bets up to:
- (1) 4 and 10 can lay to win 3 times the don't pass/don't come bet.
- (2) 5 and 9 can lay to win 4 times the don't pass/don't come bet.
- (3) 6 and 8 can lay to win 5 times the don't pass/don't come bet.
- (r) Minimum and maximum odds will be posted at each table.
