The Kansas Department of Health and Environment (KDHE) is proposing to revise the State of Kansas Plan for Implementation, Maintenance, and Enforcement of the 2015 National Ambient Air Quality Standards (NAAQS) for Ozone (O₃). Any member of the public may request a public hearing or submit comments regarding this action. If requested, a public hearing for this action will be held at 2:30 p.m. Monday, September 24, 2018, in the Flint Hills Conference Room, third floor, Curtis State Office Building, 1000 SW Jackson, Topeka, Kansas. The State of Kansas Plan for Implementation, Maintenance, and Enforcement of the NAAQS for O₃ is proposed in accordance with the requirements of Section 110 of the Federal Clean Air Act Amendments (CAAA) of 1990. Section 110 of the CAAA requires that each state submit to the administrator of the U.S. Environmental Protection Agency a plan for the implementation, maintenance, and enforcement of the NAAQS. The proposed State Implementation Plan (SIP) revision demonstrates that Kansas has the programs and statutory authority necessary to implement, maintain, and enforce the O₃ NAAQS.
