Technical Proposals are due on or before 12:00 p.m. (CST) November 9, 2018 to be delivered via email to David.Nagy@ks.gov. Interested consulting firms must be pre-qualified by the Kansas Department of Transportation (KDOT) in category 322 and submit a Letter of Interest with the subject line reading "P&H and FC [Firm Name]."

Anticipated Schedule for Subsequent Events

Evaluation and ranking of technical proposals on or about November 30, 2018 after which time all firms that submitted will be notified of the ranking. Negotiations with the most highly ranked firm to commence on or about December 14, 2018. Agreement/work order in place and in effect January 1, 2019.

Request for Proposal (Technical)

Background and Purpose of Project

The Kansas Department of Transportation is seeking a consultant to provide statewide bridge inspection services consisting of requested Fracture Critical Member inspections and ultrasonic inspections of Pin and Hanger connections, all on the local system, starting with the inspections due in 2019. Due to the unique nature of these inspections, as well as the need at times to use specialized access equipment, these individual programs are offered to the local bridge owners as a method to economically share the costs of equipment and for the economics of bundling inspections. Inspections are to be performed in accordance with the latest published edition of the KDOT Bureau of Local Projects Local Bridge Inspection Manual, Local Fracture Critical Member Inspection Scope of Services, and the Local Pin and Hanger Inspection Scope of Services (available at http://kart.ksdot.org).

Scope of Services to be Performed

Consultant shall complete the following tasks and produce the deliverables described below:

- Provide an estimate of cost for work to be performed each year to be approved prior to commencing inspections.
- Inspect Pin and Hanger connections on local system bridges (currently 11 annually (2019/2020/2021/2022), 5 on a 24-month interval (2019/2021), and 20 bridges on a 48-month interval (2021)).
- Provide Fracture Critical Member inspections on bridges requested by individual owners to KDOT-Bureau of Local Projects (typically about 40-60 per year).
- Provide a final cost-per-bridge for each inspection performed at the end of each program year.
- Input inspection data into the KDOT-BLP Bridge Inspection Portal.
- Provide PDFs of the Draft Inspection Reports to the

KDOT Program Manager for review and approval.
Upload PDFs of the Final Inspection Reports into

the Bridge Inspection Portal and provide them to the KDOT Program Manager for distribution to the bridge owners.

Evaluation Factors

Technical proposals will be evaluated based on the factors listed below, evenly weighted, to rank the most qualified firm in order of preference as first, second, third, etc. Evaluation factors: 1) the quality and completeness of the response to this request; 2) qualifications and experience of consultant personnel/manager proposed for services; 3) proposed approach for inspection and ability to maintain separate costs for each bridge and program; and 4) past performance history for similar projects/ services for KDOT. The highest ranked firm will be asked to enter into negotiations with KDOT for an agreement. In the event KDOT cannot reach agreement with the ranked firm, it will terminate negotiations with such firm and commence negotiations with the next highest ranked firm, and so on, until either agreement is reached for a satisfactory scope of services for a fair and reasonable price, or KDOT decides to pursue other alternatives.

Contract Terms and Conditions

A four-year inspection contract will be implemented, with a CMS contract issued and closed annually. Special attachments for the Kansas "Tax Clearance Certificate," the "Certification of Final Indirect Costs," and the "Policy Regarding Sexual Harassment" will be among the standard special attachments with the contract.

Instructions for Technical Proposal

Note: No costs shall be contained in the technical proposal. Technical proposals will consist of the technical proposals and a completed and signed Special Attachment No. 7 ("Certificate of Final Indirect Costs"), a completed and signed Special Attachment No. 8 ("Tax Clearance Certificate"), and a completed and signed Special Attachment No. 10 ("Policy Regarding Sexual Harassment"). All these forms are attached to the original email announcement.

The main text of the consultant's technical proposal must not exceed four (4) pages (including cover sheets, indexes, etc.) to address the topics listed. Describe processes and procedures proposed by the consultant to complete the project requirements listed above. Describe processes and procedures, including best practices, that will be used to perform tasks and produce deliverables described above under "Scope of Services to be Performed." Include in the technical proposal items such as:

- Project manager/engineer in charge.
- Team leaders in charge of the inspections and their history of experience with Pin and Hanger and Fracture Critical Member inspections.
- Availability of staff to meet schedule.
- Proposed methods to separate costs for each bridge and each program.
- Cost-effective or cost-reduction practices, processes or procedures used by the consultant, if any.
- Any sub-consultant and their role, if any, that will be performing services on the project. All sub-

consultants must complete Special Attachment No. 7 ("Certificate of Final Indirect Costs"), the Special Attachment No. 8 ("Tax Clearance Certificate"), and a completed and signed Special Attachment No. 10 ("Policy Regarding Sexual Harassment").

Opinion No. 2018-05

Written October 24, 2018, to Mr. Jeffrey A. Chanay, Chief Deputy Attorney General, 120 SW 10th Ave., 2nd Floor, Topeka, KS 66612-1597.

Synopsis: Under the facts presented, a state employee's personal trip to Africa, and her acceptance of a gift or economic opportunity to defray the costs of the trip, are not in violation of the Kansas governmental ethics laws.

Cited herein: K.S.A. 46-217, 46-228, 46-2376, 46-237a, and. K.A.R. 19-40-3a(b).

Dear Mr. Chanay:

We understand that, in your capacity as chief deputy attorney general for the Kansas Office of the Attorney General (OAG), you request our opinion concerning application of the state governmental ethics law, K.S.A. 46-215 *et seq.* Our opinion in response to your request is limited to its applicability. This opinion does not address whether some other statutory system, common law theory, or agency rule or regulation applies to your inquiry.

Factual Statement

The following factual statement are provided in the request for opinion:

...one of our employees [may accept] a gift that offsets part of the cost of non-job-related travel. Because this travel is not related to the employee's job – and the travel is during the employee's vacation time – we are unable to find that the possible gift inures to the benefit of the State of Kansas and therefore falls within an exception under K.S.A. 46-237a.

The employee in question has worked in the Attorney General's office as director of human trafficking education and outreach since September 2013. She also serves as the office's public information officer. In March 2018, she accepted a volunteer position on the board of directors for Freedom Now USA, a new anti-trafficking non-profit organization affiliated with the Topeka Rescue Mission. She was later elected vice-chair of the board. ... The employee's position on this board is not ex officio, and her appointment is entirely independent of the Office of Attorney General. Her participation on the Freedom Now USA board is neither required nor compensated as work time by the OAG.

In June 2018, the employee decided to pursue a life-long dream of visiting Africa. She arranged to

take a religious pilgrimage to Rwanda led by a survivor of the 1994 genocide. The group will spend time in Kigali at the national genocide memorial and travel to rural Kibeho where she will attend Mass on a special Catholic feast day. There will also be stops at local schools to visit children in need. The trip is a personal one and our employee is taking vacation days to go. The employee's request for vacation leave has been approved. The total cost of the trip, including airfare, lodging and transportation in country is approximately \$5,000. This cost is the personal responsibility of the employee.

Recently, the executive director of Freedom Now USA made the employee aware of a donor to that organization who might be interested in donating funds toward the cost of the employee's personal trip to Rwanda. In return for the donation, the employee would represent Freedom Now as a board member while traveling in Rwanda by making contact with service and non-profit organizations within that country to inquire about current anti-trafficking efforts and to assess where gaps in service and interdiction efforts might exist. Thus, although the trip is a personal trip of the employee, some portion of her activities that would be paid for by the donor would include subject matter (anti-trafficking) that is common both to her volunteer service on the Freedom Now board and her work in the OAG. The employee will be the only person affiliated with Freedom Now on this trip.

On her own, the employee has set up a Go Fund Me account to receive free will donations from friends and family and also intends to sell original artwork to offset the cost of the trip.

Questions

"Is the OAG employee allowed to accept a gift from an individual with no connection to or business before the OAG that helps to defray the cost of the employee's personal mission trip when the only consideration for that gift is that the employee represent a non-profit board on which the employee sits in her private, personal capacity?"

Analysis and Opinion

Officers and employees of the executive branch of state government are subject to the provisions of K.S.A. 46-237a(b) which prohibit them from soliciting or accepting any *gift* or *economic opportunity* because of their official position. Pursuant to K.S.A. 46-237, they also are prevented from accepting the same from any person known to have a *special interest*, under circumstances where such person knows or should know that a major purpose of the donor is to influence them in the performance of their official duties or prospective official duties. Terms italicized are defined as:

- "'Gift' means the transfer of money or anything of value unless legal consideration of a reasonably equal or greater value is received in return." K.A.R. 19-40-3a(b)
- "Economic opportunity' means any purchase, sale, lease, contract, option, or other transaction or arrangement involving property or services wherein a state officer or employee or candidate for state of-

- fice may gain a personal economic benefit, but not including any gift." K.S.A. 46-217
- "'Special interest' means an interest of any person
 [...] in the action or non-action of any state agency or state officer or employee upon any matter affecting such person as distinct from affect upon the people of the state as a whole." K.S.A. 46-228

The facts make clear that the state employee's volunteerism and anticipated trip to Africa are not connected with her state employment—notwithstanding the anti-human trafficking nature of the employee's work for the state and her volunteering for Freedom Now USA. As such, the donor's offer to defray costs of the employee's personal Africa trip (whether defined as a gift or economic opportunity) is not because of her *official position* as a state employee in the OAG. Therefore, the K.S.A. 46-237a(b) prohibitions are inapplicable. Similarly, no suggestion of a special interest on behalf of the donor to the state employee or potential donors to the employee's "Go Fund Me" exist. Thus, prohibitions in K.S.A. 46-237(a) against receipt of any gift or economic opportunity are inapplicable.

Conclusion

Under the facts provided, the costs of the proposed Africa trip, whether personally funded or defrayed in part or in full, are not because of the OAG employee's official position. Hence, as proposed, the donor funding toward the trip costs do not violate the provisions of the Kansas governmental ethics laws, K.S.A. 46-215 *et seq*.

Opinion No. 2018-06

Synopsis: Under K.S.A. 46-295, a registered lobbyist must report receipt of public funds for lobbying services and services directly related to lobbying. Public funds received by registered lobbyists for other services not related to lobbying, even if received under the same contract, are not reportable.

Cited herein: K.S.A. 46-225, 46-295.

To All Interested Persons:

Pursuant to K.S.A. 46-254, the Kansas Governmental Ethics Commission issues this opinion regarding the receipt of public funds by registered lobbyists for lobbying services on behalf of a governmental entity or association of governmental entities.

Issue

When reporting receipt of public funds for services provided to governmental entities pursuant to K.S.A. 46-295, does a registered lobbyist report the total received for all services provided or only the portion received for lobbying?

Analysis And Opinion

Interpretation of this requirement depends upon whether a person, who meets the definition of a registered lobbyist, is contracted for multiple roles with a public entity. A lobbyist contracted solely for lobbying should report the entire amount of the contract, even if they do not expend that amount to lobby—the K.S.A. 46-295 reporting requirement is about the amount received by a lobbyist, not the amount expended. A lobbyist, contracted for lobbying as well as for other nonlobbying-related tasks, should report the approximate amount of the contract attributable to lobbying services. Further, if a lobbyist receives public funds from a public entity for a specific task, such as research, if the research was made preliminary to, or in support of, lobbying, then this amount would also need to be reported.

In closing, the Commission suggests that registered lobbyists may seek guidance from Commission staff regarding services that constitute lobbying, pursuant to K.S.A.46-225.
