#### Notice of Application to Expand an Industrial Landfill

The Kansas Department of Health and Environment (KDHE) has received an application to expand the Great Plains Development Authority (GPDA) industrial landfill, Permit 401, to include an adjacent historic industrial waste disposal area. Both disposal areas are closed, with cover soils applied and ongoing ground-water monitoring. The permit modification will expand the landfill area from 37.30 to 44.38 acres with 27.67 acres used for disposal. The proposed landfill expansion would be operated in conformance with state solid waste regulations and its post-closure care plan. The proposed expanded landfill is located East of Parsons, Kansas on Road 2 in the GPDA Industrial Park about ½ mile west of Scott Road, in the N½ of Section 34 and the S½ of Section 27, in Township 31 South, Range 20 East in Labette County.

KDHE has reviewed the application and found it to be in conformance with the state solid waste statutes and regulations.

KDHE is today providing public notice of the intent to approve the proposed landfill expansion. However, a final decision to approve the expansion has not been made, and KDHE will consider information gathered during the public comment period before making a final decision. Notice is hereby given that the Kansas Department of Health and Environment (KDHE) is soliciting comments regarding a proposed air quality construction permit for Exide Technologies (Exide), 413 E. Berg Rd., Salina, Kansas. Exide Technologies has applied for a permit modification pursuant to K.S.A. 65-3008 and K.A.R. 28-19-300 et seq. and as authorized by K.S.A. 65-3005. The U.S. Environmental Protection Agency (EPA) designated the area surrounding Exide Technologies' property in Saline County as nonattainment with the 2008 Lead National Ambient Air Quality Standards (NAAQS).

The purpose of this proposed permit is to modify existing federally enforceable limitations and conditions applicable to Exide as a result of the nonattainment designation. The proposed permit authorizes modifications to lead emissions limits that support attainment of the 2008 Lead NAAQS and include the following proposed modifications: Increase in the plant capability by 20 percent and addition of a new baghouse (BH6). Emissions of Volatile Organic Compounds (VOC), oxides of nitrogen (NO<sub>x</sub>), sulfur oxides (SO<sub>x</sub>), carbon monoxide (CO), particulate matter (PM), particulate matter less than 10 microns (PM<sub>10</sub>), and lead were evaluated during the permit review process.

A public comment period has been established to allow citizens the opportunity to express any concerns they may have about this proposed permitting action. The public comment period is to begin on Thursday, November 22, 2018 and will end on Wednesday, December 26, 2018, at 12:00 p.m. All comments should be submitted in writing to Susana Pjesky, Bureau of Air, 1000 SW Jackson, Suite 310, Topeka, KS 66612-1366, or by fax at 785-559-4256.

Any member of the public may request a public hearing to provide comments on the proposed issuance of the draft air quality construction permit. If a pertinent request is received, a public hearing is tentatively scheduled by KDHE for 6:00 p.m. Thursday, December 27, 2018 and continuing until audience members have an opportunity to submit comments. The tentatively scheduled hearing will be held at the Salina Public Library, Prescott Meeting Room, 301 W. Elm St., Salina, KS 67401. If no pertinent requests to hold the public hearing are received by 12:00 p.m. Wednesday, December 26, 2018, the public hearing will be cancelled and announced on the KDHE website at: http://www.kdheks.gov/bar/ publicnotice.html.

If a hearing is conducted, all interested parties will be given a reasonable opportunity to present their views orally or by submission of written materials during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to limit oral presentations to a specific time limit. Licensure by examination** The purpose of this revised regulation is to remove an unintentional barrier to licensure caused by: (1) language in the existing regulation requiring the licensure examination to specifically contain a separate and distinct biomedicine component of the national exam (biomedicine was not a separate component of the existing regulation prior to 2005); and (2) omission in the existing regulation of "substantial equivalent" language to allow the board flexibility in assessing examinations from other jurisdictions that have equal or higher standards than the national examination.

The revised regulation is more flexible and less restrictive. The revision is likely to enhance business activity because it allows for more flexibility in licensing decisions and makes the process for approving new licenses for practitioners more efficient.

Summaries of the proposed regulations follow. Most amendments are for clarity and to implement changes in state statute and federal legislation that are already in effect. There is no economic impact.

**K.A.R. 30-4-34 – Public assistance program.** This regulation updates the list of available assistance.

**K.A.R. 30-4-35 – Application process.** This regulation allows for the use of telephonic signature and clarifies current requirements for client interviews when requesting assistance. Application processing time is removed. This amendment implements current practice and has no economic impact.

**K.A.R. 30-4-36 – Redetermination of eligibility.** This regulation updates the frequency of redeterminations and clarifies requirements for client interviews. This amendment implements current practice and has no economic impact.

**K.A.R. 30-4-38 – Rights of applicants and recipients.** This regulation updates language, removes self-regulation language of the agency and adds the right to have a photograph of the recipient placed on the Kansas benefit card. This is no change in current law.

K.A.R. 30-4-40 – Department responsibility to applicants and recipients. This regulation removes references to general assistance and updates the department's reporting responsibilities to be consistent with federal law.

This amendment implements current practice and has no economic impact.

**K.A.R. 30-4-41 – Assistance planning for TANF.** This regulation removes references to general assistance and includes language of cohabiting boyfriend or girlfriend. This amendment implements current practice and has no economic impact.

**K.A.R. 30-4-50 – Assistance eligibility.** This regulation removes references to general assistance and updates the TANF time limits. TANF diversion is included. TANF suspicion-based drug testing language is added. This amendment implements current practice and has no economic impact.

**K.A.R. 30-4-51 – Eligibility process.** This regulation has been amended to improve clarity around the definition of a collateral contact. This amendment implements current practice and has no economic impact.

**K.A.R. 30-4-54 – Citizenship, alienage, and residence.** This regulation removes references to general assistance and updates with 1996 federal changes. This amendment implements current practice and has no economic impact.

**K.A.R. 30-4-55 – Cooperation.** This regulation has been amended to include the requirements that identity is to be verified for each adult in a public assistance case and social security numbers must be provided for all recipients of food assistance and TANF. Reporting of lottery prizes in excess of \$5,000 is included to reflect current law. Third party resource information for medical assistance is removed. It updates language regarding cooperation with child support. This amendment implements current practice and has no economic impact.

K.A.R. 30-4-64 –Work program requirements for TANF. This regulation is updated to reflect current state law. It removes requirements that are redundant with federal regulations. The additions and amendments implement current practice and there is no economic impact.

K.A.R. 30-4-70 – Eligibility factors specific to the TANF program. This regulation adds information regarding cohabiting partners and reflects current state law that requires school enrollment for children receiving TANF. The additions and amendments implement current practice and there is no economic impact.

K.A.R. 30-4-76 – The food assistance program; work and other eligibility requirements. This regulation adds language concerning state options for work requirements and categorical eligibility. This amendment implements current practice and has no economic impact.

K.A.R. 30-4-77 – The food assistance program; state option; education requirement. This regulation adds language concerning the state option and counting of noncitizen income for food assistance and includes school enrollment for children receiving TANF. This amendment implements current practice and has no economic impact.

K.A.R. 30-4-90 – Eligibility factors specific to the GA program. This regulation is being revoked and removes all references to general assistance. The program has not been funded for several years and there is no economic impact.

K.A.R. 30-4-92 – Low income energy assistance program. This regulation adds various requirements for participation in the energy assistance program. The additions implement current practice and there is no economic impact.

**K.A.R. 30-4-93 – Child care assistance program.** This regulation adds various requirements for participation in the child care assistance program including requirements in current state law. This amendment implements current practice and has no economic impact.

**K.A.R. 30-4-98 – Funeral assistance.** This regulation has been amended to improve clarity regarding the funeral assistance program. This amendment has no economic impact as the program is not funded.

K.A.R. 30-4-100 – Payment standards for the TANF and foster care programs. This regulation removes references to general assistance and provides more clarity of specific terms. There is no economic impact.

**K.A.R. 30-4-107 – Property exemption.** The resource value for assistance is updated to reflect changes in federal law. The amendment implements current practice and there is no economic impact.

**K.A.R. 30-4-109 – Personal property.** This regulation has been amended to improve clarity and updates language with resources exempted by federal regulations. This amendment implements current practice and has no economic impact.

**K.A.R. 30-4-111** – **Income.** This regulation has been amended to include language regarding the TANF work incentive payment, TANF diversion payment and income disregards. This amendment implements current practice and has no economic impact.

**K.A.R. 30-4-113 – Exempt income.** This regulation has been amended to include federal changes regarding veterans' administration payments and a child's student income. This amendment implements current practice and has no economic impact.

K.A.R. 30-4-120 – Special needs for applicants and recipients of TAF. This regulation is being revoked and removes references to special needs expenses for the previous TAF program. This revocation has no economic impact.

**K.A.R. 30-4-130 – Types of payments and payees.** This regulation removes references to general assistance and implements state law for situations requiring a payee for individuals. This amendment implements current practice and has no economic impact.

**K.A.R. 30-4-140 – Payments; penalties; enforcement.** This regulation has been amended to improve clarity and adds language concerning disqualification from TANF due to fraud based on state law. It removes language that is verbatim from state law. This amendment implements current practice and has no economic impact.

# Article 46.—CHILD ABUSE AND NEGLECT

**30-46-10.** Definitions. For the purpose of the child abuse and neglect central registry, the following definitions shall apply:

(a) "Abandon" and "abandonment" have the meaning specified in K.S.A. 38-2202, and amendments thereto.

(b) "Abuse" means "physical, mental or emotional abuse" or "sexual abuse," as these two terms are defined in K.S.A. 38-2202 and amendments thereto and as "sexual abuse" is further defined in this regulation, involving a child who resides in Kansas or is found in Kansas, regardless of where the act occurred. The term "abuse" shall include any act that occurred in Kansas, regardless of where the child is found or resides.

The term "abuse" may include the following:

(1) Terrorizing a child, by creating a climate of fear or engaging in violent or threatening behavior toward the child or toward others in the child's presence that demonstrates a flagrant disregard for the child;

(2) emotionally abandoning a child, by being psychologically unavailable to the child, demonstrating no attachment to the child, or failing to provide adequate nurturance of the child; and

(3) corrupting a child, by teaching or rewarding the child for unlawful, antisocial, or sexually mature behavior.

(c) "Affirmed perpetrator" means a person who has been determined by the secretary or the secretary's designee, by a preponderance of evidence, to have committed an act of abuse or neglect, regardless of where the person resides, but has not been substantiated so the affirmed perpetrator's name is not placed on the child abuse and neglect central registry.

(d) "Alleged perpetrator" means the person identified in the initial report or during the investigation as the person suspected of perpetrating an act of abuse or neglect.

(e) "Child" means anyone under the age of 18 or anyone under the age of 21 and in the custody of the secretary pursuant to K.S.A. 38-2255, and amendments thereto.

(f) "Child abuse and neglect central registry" means the list of names for individuals identified by the department as substantiated perpetrators.

(g) "Child care facility" has the meaning specified in K.S.A. 65-503, and amendments thereto.

(h) "Department" means Kansas department for children and families.

(i) "Investigation" means the gathering and assessing of information to determine if a child has been harmed, as defined in K.S.A. 38-2202 and amendments thereto, as the result of abuse or neglect, to identify the individual or individuals responsible, and to determine if the incident perpetrated by the individual or individuals should be affirmed or substantiated.

(j) "Neglect" has the meaning specified in K.S.A. 38-2202, and amendments thereto, involving a child who resides in Kansas or is found in Kansas, regardless of where the act or failure to act occurred.

The term "neglect" may include the following:

(1) The birth of an infant who is identified as being affected by or having withdrawal symptoms resulting from prenatal exposure to a legal or an illegal substance; and

(2) failure of the parent or caregiver to meet that individual's responsibilities to provide for the child's education as required by law.

(k) "Sexual abuse" has the meaning specified in K.S.A. 38-2202, and amendments thereto. With respect to the determination by the department for children and families of an affirmed or substantiated finding of sexual abuse, difference in age and maturity between the perpetrator and victim and issues of force or coercion may be considered.

(l) "Substantiated perpetrator" and "perpetrator" mean a person, regardless of where the person resides, who has been substantiated by the secretary or the secretary's designee, by a preponderance of evidence, to have either intentionally committed an act of abuse or neglect or failed or refused to protect a child when a reasonable person would have anticipated that the act of abuse or neglect would result in or create a likelihood of serious harm, injury, or deterioration to the child. The substantiated perpetrator's name is placed on the Kansas child abuse and neglect central registry, and the person is thereby prohibited from residing, working, or volunteering in a child care facility pursuant to K.S.A. 65-516, and amendments thereto.

(m) "Unsubstantiated alleged perpetrator" means a person who has been determined by the secretary or the secretary's designee, by a preponderance of evidence, to have not committed an alleged act of abuse or neglect. (Authorized by K.S.A. 2018 Supp. 38-2225 and 39-708c; implementing K.S.A. 2018 Supp. 38-2226 and 38-2230; effective Jan. 2, 1989; amended Jan. 2, 1990; amended Oct. 1, 1993; amended Jan. 1, 1997; amended Oct. 3, 1997; amended July 9, 2004; amended July 6, 2009; amended, T-30-61-12, June 1, 2012; amended Sept. 14, 2012; amended July 1, 2016; amended, T-30-11-15-18, Nov. 15, 2018.)

**30-46-13.** Right to interview. Each alleged perpetrator shall have an opportunity to be interviewed before a finding affirming or substantiating the perpetrator under K.A.R. 30-46-15 is issued. (Authorized by K.S.A. 2018 Supp. 39-708c; implementing K.S.A. 2018 Supp. 38-2226, K.S.A. 2018 Supp. 39-708c, and K.S.A. 65-516; effective Jan. 2, 1989; amended Oct. 28, 1991; amended July 1, 1997; amended July 9, 2004; amended, T-30-11-15-18, Nov. 15, 2018.)

**30-46-15.** Notice of decision. (a) Each affirmed perpetrator shall be notified in writing of the secretary's decision to affirm the perpetrator for an incident of child abuse or neglect. The notice shall specify the reasons for the finding and shall inform the affirmed perpetrator of the perpetrator's right to appeal the decision.

(b) Each substantiated perpetrator shall be notified in writing of the secretary's decision to substantiate the perpetrator for the purpose of placing the name of the perpetrator in the child abuse and neglect central registry. The notice shall specify the reasons for the finding and shall inform the substantiated perpetrator of the perpetrator's right to appeal the decision. (c) Each unsubstantiated alleged perpetrator shall be notified in writing of the secretary's decision that based on a preponderance of evidence, the alleged perpetrator has not committed an alleged act of abuse or neglect. (Authorized by K.S.A. 2018 Supp. 39-708c; implementing K.S.A. 2018 Supp. 38-2226, K.S.A. 2018 Supp. 39-708c, and K.S.A. 65-516; effective Jan. 2, 1989; amended Oct. 28, 1991; amended July 1, 1997; amended July 9, 2004; amended, T-30-11-15-18, Nov. 15, 2018.)

**30-46-17.** Expungement of record of perpetrator from child abuse and neglect central registry. (a) Application for expungement.

(1) Any perpetrator of abuse or neglect may apply in writing to the secretary to have the perpetrator's record expunged from the child abuse and neglect central registry when three years have passed since the perpetrator's name was entered on the child abuse and neglect central registry. Thereafter, if the expungement is denied, an application for expungement may be submitted by the perpetrator to the secretary no more than once every 12 months after the date of the most recent expungement review panel hearing.

(2) Each application for expungement shall be referred to the expungement review panel.

The panel shall consist of the director of prevention and protection services or the director's designee, the chief legal counsel of the department or the counsel's designee, and a representative of the public appointed by the secretary. The director of prevention and protection services or the director's designee shall chair the panel.

(b) Expungement review panel hearing.

(1) A review hearing shall be convened by the panel, at which time the applicant may present evidence supporting expungement of the applicant's name from the child abuse and neglect central registry. The applicant shall have the burden of providing the panel with the basis for granting the expungement. Evidence in support of or in opposition to the application and a recommendation may be presented by the regional office that conducted the original investigation.

(2) Recommendations of the review panel shall be determined by majority vote. The following factors shall be considered by the panel in making its recommendation:

(A) The nature and severity of the act of abuse or neglect;

(B) the number of findings of abuse or neglect involving the applicant;

(C) specification of whether the applicant was a child at the time of the finding of abuse or neglect for which expungement is requested and the age of the applicant at the time of the incident;

(D) circumstances that no longer exist that contributed to the finding of abuse or neglect by the applicant; and

(E) actions taken by the applicant since the incident to prevent the reoccurrence of abuse or neglect.

(3) The review hearing shall be set within 30 days from the date the application for expungement is received by the department. A written notice shall be sent to the applicant and the regional office that made the finding by the director of prevention and protection services or the director's designee at least 10 days before the hearing. The notice shall state the day, hour, and place of the hear ing. Continuances of the hearing may be granted by the secretary or the secretary's designee only for good cause.

(4) A written recommendation to the secretary shall be rendered by the panel within 45 days from the date of the hearing. The recommendation to the secretary shall be submitted in writing and shall specify the reasons for the recommendation.

(c) Expungement.

(1) Based upon the application for expungement, other records in the expungement file, and the findings and recommendations of the panel, a decision to grant or deny the requested expungement shall be made by the secretary and shall be the final agency order. The secretary's decision shall be made with 60 days of the expungement hearing.

(2) The applicant shall be informed in writing of the secretary's decision, the specific reasons for the decision, and the applicant's right to appeal that decision pursuant to the Kansas judicial review act.

(3) Any record may be expunded from the child abuse and neglect central registry by the secretary or the secretary's designee when 18 or more years have passed since the most recent finding of abuse or neglect.

(4) Each record of a perpetrator who was under 18 at the time of abuse or neglect and has not been substantiated for more than a single event or incident while a minor shall be expunged five years after the finding of abuse or neglect is entered in the child abuse and neglect central registry if the perpetrator has had none of the following after entry in the registry:

(A) A finding of abuse or neglect;

(B) juvenile offender adjudication for any act, other than the event or incident that resulted in the offender's name being placed on the child abuse and neglect central registry, that, if committed by an adult, would be a class A person misdemeanor or any person felony; or

(C) criminal conviction for a class A person misdemeanor or any person felony. All interested parties may submit written comments prior to the hearing to the Division of Workers Compensation, 401 SW Topeka Blvd., Suite 2, Topeka, KS 66603 or by email to Jose.Castillo@ks.gov. All interested parties will be given a reasonable opportunity to present their views orally regarding the adoption of the proposed regulations during the public hearing. In order to provide all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentation to five minutes.

An individual with a disability may request an accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Request for accommodation to participate in the hearing should be made at least five working days in advance of the hearing by contacting Jose Castillo at 785-296-4000, ext. 2159 (or TYY 1-800-766-3777). The northwest entrance to the Department of Labor Building is accessible. Handicapped parking is located at the northwest side of the Department of Labor Building.

Summaries of the proposed regulations and their economic impact follow (Note: Statements indicating that a regulation is "not anticipated to have any economic impact" are intended to indicate that no economic impact on the Department of Labor, other state agencies, state employees, or the general public has been identified.)

**K.A.R 51-9-17.** After November 29, 2018, this regulation will mandate reporting entities to report required data to the Division pursuant to the Kansas EDI Release 3.1 guide, which was revised on July 16, 2018. The purpose of the revision is to leverage the most recent standard to support the Online System for Claims Regulations/Research (OSCAR) data needs and functionality.

**Economic Impact**: Approximately 90% of reporting organizations utilize a reporting vendor and thus will not incur a cost in the move from Release 3.0 to Release 3.1. For those organizations that do not use a reporting vendor, those organization will incur a one-time cost to upgrade their system. That cost depends on various factors: 1) whether a contractor is hired or whether inhouse resources are used and 2) the complexity of their system and/or whether they seize on the opportunity to upgrade or add functionality which can create a range of cost from \$2,000 – \$7,000. For organizations that submit 100 claims or less a year, they have the option to use a free web-based application to submit their required data.

# **Temporary Administrative Regulation**

# Article 9.—MEDICAL AND HOSPITAL

**51-9-17.** Release 3.1 standards for trading partner profiles; submission of data; first reports of injury. (a) Each insurer, group-funded workers compensation pool, and self-insured employer shall participate in the electronic data interchange (EDI) program and shall submit to the director a completed EDI trading partner profile at least 30 days before submitting claim information pursuant to the international association of industrial accident boards and commissions' (IAIABC's) release 3.1 standards, as provided in K.S.A. 44-557a and amendments thereto. The EDI trading partner profile shall be completed according to the "Kansas EDI release 3.1 guide for reporting first (FROI) and subsequent (SROI) reports of injury" as revised on July 16, 2018 by the Kansas department of labor and hereby adopted by reference. This document shall be referred to as the "Kansas EDI release 3.1 guide" in this regulation.

(b) Each insurer, group-funded workers compensation pool, and self-insured employer shall report to the director within five days any changes to information submitted in the EDI trading partner profile.

(c) All claim information submitted pursuant to K.S.A. 44-557a, and amendments thereto, by electronic data interchange shall be submitted according to the Kansas EDI release 3.1 guide.

(d) All claim information submitted pursuant to K.S.A. 44-557a, and amendments thereto, and the Kansas EDI release 3.1 guide's first report of injury, commonly called "FROI 00," shall be considered the filing of an accident report pursuant to K.S.A. 44-557, and amendments thereto. This information shall not be open to public inspection, except as provided in K.S.A. 44-550b and amendments thereto.

(e) All claim information submitted pursuant to K.S.A. 44-557a, and amendments thereto, shall be considered a medical record to the extent that the information refers to an individual worker's identity. No references in the claim information to an individual worker's identity shall be open to public inspection, except as provided in K.S.A. 44-550b and amendments thereto. For purposes of this regulation, the claim number used by an insurance carrier, self-insured employer, or group-funded worker's compensation pool to identify an individual worker's identity.

(f) On or before the compliance date specified in subsection (g), each insurer shall file claim information for all "lost time/indemnity" and "denied" cases through EDI rather than by submitting paper forms. The insurer shall file the electronic form in accordance with the Kansas EDI release 3.1 guide.

(g) Each insurer shall comply on or before the implementation date of November 29, 2018 for reporting electronic FROI or SROI. Each claim administrator submitting claims

as EDI filings in production status using the IAIABC's release 3 national standard shall convert to release 3.1 and shall be in production status by the implementation date. #### Article 4.—MATERNAL AND CHILD HEALTH

**28-4-503.** Timing of specimen collections. (a) The initial specimen from each infant born in an institution shall be obtained as follows:

(1) (A) When the infant is at least 24 hours of age but less than 48 hours of age; or

(B) if the infant is discharged from the institution of birth before 24 hours of age, before the infant is discharged;

(2) before the infant is transferred from the institution of birth to another institution; and

(3) before the infant receives any blood transfusion.

(b) The initial specimen from each infant born outside of an institution shall be obtained as follows:

(1) When the infant is at least 24 hours of age but less than 48 hours of age; and

(2) before the infant receives any blood transfusion.

(c) A repeat specimen shall be obtained from each infant born in an institution or outside of an institution under any of the following conditions:

(1) The specimen is unsatisfactory as specified in K.A.R. 28-4-505.

(2) Follow-up recommendations have been issued by the department.

(3) The infant is less than 24 hours old when the initial specimen is taken. (Authorized by K.S.A. 65-101 and K.S.A. 65-180; implementing K.S.A. 65-180 and K.S.A. 65-181; effective, T-87-48, Dec. 19, 1986; effective May 1, 1987; amended April 14, 2000; amended Dec. 3, 2010; amended Dec. 7, 2018.)

Permanent Administrative Regulation

#### Article 70.—CANCER REGISTRY

**28-70-2.** Reporting requirements. (a)(1) Each administrator of a hospital, an ambulatory surgery center, a ra-

diology oncology center, or a pathology laboratory shall, within six months of the date of diagnosis, report to the registry each case of cancer diagnosed or treated, unless exempted under subsection (d).

(2) Each report shall provide all required information available in the medical or administrative records that are under the direct control of the reporting administrator. No administrator shall be required to contact the patient, the patient's family, or another health care provider to obtain additional information not contained in the medical or administrative records.

(b) Each person who is either licensed to practice medicine and surgery or licensed to practice dentistry and who practices in a clinic or physician's office and each administrator of a hospice or adult care home shall provide the following to the registry:

(1) If used to confirm each cancer diagnosis, a list of in-state and out-of-state pathologists, or pathology laboratories and dermatopathologists; and

(2) for each patient for whom a cancer diagnosis has been confirmed pathologically or clinically, a list that includes the name, social security number, date of birth, and cancer site. The social security number shall be used only for confirmation of patient identity.

(c) Upon receipt of any written request for information from the registry regarding a patient, each reporting party specified in subsection (a) or (b) shall provide the requested information that is contained in medical or administrative records under the direct control of the reporting party. The requested information may consist of either of the following:

(1) Any information specified in subsection (e), even if the patient's cancer has not been diagnosed or treated by the hospice or adult care home or by the health care provider or licensee specified in subsection (a) or (b); or

(2) annual follow-up information, including tumor recurrence and follow-up treatment.

(d) The reports specified in this regulation shall not be required for the following types of cancer:

(1) Squamous cell carcinoma of the skin, unless located on a lip of the face or in the genital area or unless spread beyond local tissues at the time of diagnosis;

(2) basal cell carcinoma of the skin, unless located on a lip of the face or in the genital areas or unless spread beyond local tissues at the time of diagnosis; and

(3) carcinoma in situ of the uterine cervix.

(e) Each report from any reporting party specified in subsection (a) or (b) shall include the following information, if available:

(1) Patient identifiers and demographics;

(2) cancer screening history;

(3) cancer diagnosis, including the cancer site and histology;

(4) personal and family history;

(5) vital status, including the date of death and cause of death, if applicable;

(6) cancer-related treatment information;

(7) follow-up information, including the date of last contact with the patient; and

(8) third-party payer information; and

(9) risk factors for cancer.

(f) Each report to the registry shall be submitted in one of the following formats:

(1) American standard code for information interchange (ASCII) file in the North American association of central cancer registries (NAACCR) format;

(2) electronic or paper forms provided by the registry;

(3) any other format equivalent to any format specified in this subsection that is acceptable to the cancer registry director.

(g) All data transferred to the registry shall be secure and confidential.
