### **Request for Proposals**

### **Background and Purpose of Project**

The Kansas Department of Transportation (KDOT) is seeking a consultant to provide construction inspection services for project 126-19 KA 3103-01. The project is located on K-126 in Crawford County, Bridge #039 (K-126 over the KCS Railway), located 0.47 miles east of the U.S. 69 Bus./K/126 junction in Pittsburg.

### Schedule/Deadlines

Request for Proposals (RFPs) are due on or before 12:00 p.m. (CST) February 7, 2020, to be delivered via email to kdot.designcontracts@ks.gov. Evaluation and ranking of submissions will occur on or about February 14, 2020, after which time all firms that submitted will be notified of the ranking. Negotiations with the most highly ranked firm to commence on or about February 19, 2020. An agreement should be in place on or about March 4, 2020. The contractor could start on the project as early as March 2020 or as late as April 2020.

### Scope of Services to be Performed

The project manager/inspectors must be capable inspecting the whole project, which includes concrete work, traffic control, PCC Paving, HMA Paving, grading, bridges, retaining wall, seeding, erosion control, SWPPP Inspections, CMS or AASHTOWare data entry, all project records, all project paperwork, and final paperwork, etc. Project records and paperwork including but not limited to: SWPPP Inspections, diary, pay quantities, certifications, sample identifications, change orders, pay estimates, monitoring subcontractor payments, and monitoring contractor's payrolls, etc. Records and paperwork must be submitted accurately and timely. Anticipated staffing needs: provide project management and all inspectors as needed to ensure inspection and material testing for this project are done correctly. The number of required inspectors will fluctuate throughout the project depending on the project needs. Submit the names

and information of the project manager, along with two more inspectors that will be supplemented as needed. Construction is anticipated to be completed within 250 working days, this is expected to span both the 2020 and 2021 construction season. Anticipate a reduction of inspection staff over the 2020-2021 winter. Provide all the equipment necessary to inspect and test materials.

### Instructions for Letter of Interest

No costs shall be contained in the RFP. The RFP must not exceed four (4) pages total (including any cover letter, index, etc.) and 2MB to address the pertinent topics. RFPs submitted will consist of the technical proposal and a completed and signed Special Attachment No. 7 ("Certificate of Final Indirect Costs"), a completed and signed Special Attachment No. 8 ("Tax Clearance Certificate"), and a signed Special Attachment No. 10 ("Policy Regarding Sexual Harassment"). Completed Special Attachments do not count against the four-page technical proposal submission. All these forms are attached to the original email announcement.

RFPs shall indicate the consultant's ability to meet the project inspection needs described above. RFPs shall describe any processes or procedures, including best practices, that will be used to perform tasks and to produce the desired results described above under "Scope of Services to be Performed." The RFP shall also include items such as:

- Project manager
- Supplemental project inspectors
- History of providing inspection services on similar projects
- Availability of staff
- Familiarity with KDOT standards and specifications
- Any subconsultant and their role in performing the services on the project
- Names, certifications, and experience of all inspectors that will be assigned to the project

### **Evaluation Factors**

RFPs will be evaluated based on the factors listed below, evenly weighted, to rank the most qualified firm in order of preference as first, second, third, etc. Evaluation factors include:

- 1. How the consultant plans to meet the fluctuating inspection needs of the project;
- 2. Employee names (project manager, two intermittent inspectors), certifications, and qualifications proposed for services;
- 3. Proximity of inspectors to project;
- 4. Past performance history on similar projects (list project numbers) for KDOT;
- 5. Types of direct expenses anticipated (lodging, mileage, etc.);
- 6. Anticipated time to close out project paperwork.

The highest ranked firm will be asked to enter into negotiations with KDOT for an agreement. In the event KDOT cannot reach agreement with the highest ranked firm, it will terminate negotiations with such firm and commence negotiations with the next highest ranked firm, and so on, until either agreement is reached for a (continued) satisfactory scope of services for a fair and reasonable price, or KDOT decides to pursue other alternatives.

The Secretary reserves the right to reject bids that do not comply with all requirements for preparing a bidding proposal as specified in the 2015 edition of the Kansas Department of Transportation Standard Specifications for State Road and Bridge Construction.

### **Opinion No. 2020-01**

Written January 22, 2020 to Ms. Katie Whisman, Executive Officer, Kansas Bureau of Investigation, 1620 SW Tyler, Topeka, KS 66612-1837.

**Synopsis:** Under the facts provided, KBI Executive Officer Whisman may accept immediate employment with one of a group of associated businesses, despite her substantial involvement in the making of contracts in her official position with the state that would prohibit her employment with another of the associated businesses for two years from the date her state employment ends.

Cited herein: K.S.A. 46-233.

### Dear Ms. Whisman:

We understand that, in your capacity as the executive officer for the Kansas Bureau of Investigation (KBI), you request our opinion concerning application of the state governmental ethics law, K.S.A. 46-215 *et seq*. Our opinion in response to your request is limited in its applicability. This opinion does not address whether some other statutory system, common law theory, or agency rule or regulation applies to your inquiry.

### **Factual Statement**

As indicated in your opinion request, since July 2018, as KBI executive officer you were substantially involved in the making of three separate contracts between the KBI and a group of associated businesses under common ownership

- In July 2018 the KBI released a Request for Proposal (RFP) for development of a webinar-based video training series for law enforcement. The RFP was let for competitive bid and notice was published in the Kansas Register. The procurement process was through the Kansas Department of Administration. After vetting the proposals received in response to the request, MotoVike Films was selected. The contract was executed between KBI and The Premier Advisory Group on August 23, 2018.
- In January 2019, after having received approval from the Department of Administration, the KBI entered into a sole-source contract with the Bajillion Agency, for development of a statewide public awareness campaign.
- In October 2019, the KBI entered into a sole-source contract with the Bajillion Agency for the purpose

of hosting a website that was developed in furtherance of the public awareness campaign.

MotoVike Films, a video and film production agency, and Bajillion Agency, a full-service marketing and advertising agency, are separate limited liability companies registered with the Kansas secretary of state. The Premier Advisory Group, a provider of marketing, business coaching and consulting, is a Colorado corporation registered as a foreign business with the Kansas secretary of state.

All three businesses have the same owner. Common fiscal accounting and payroll are a function of The Premier Advisory Group. All share office space in the same building but each businesses' employees are segregated in separate areas of the office. Their overhead sharing arrangement allows for cost savings. Aside from this, each business maintains a separate and distinct management. Each business has separate decision apparatuses, including: executive officers and employees that are not commingled among the businesses. Neither the owner nor The Premier Advisory Group are involved in active management of MotoVike Films and Bajillion Agency. In fiscal matters, the owner is involved to secure business loans. The owner, because of The Premier Group's common handling of fiscal accounts for all three businesses, the owner may be involved in major business decisions. For example, obtaining a business loan or the purchase of equipment, like a \$3,500 camera.

KBI Executive Officer Whisman (Whisman) has received a job offer with The Premier Advisory Group as a business development director. The position would involve identifying new business clients and their needs. Where the needs would require the types of services offered by MotoVike Films and Bajillion Agency, clients would then be referred to the appropriate business.

### Questions

Under the provided facts, may the offer of employment by The Premier Advisory Group be accepted without violating the K.S.A. 46-233 limitation on post-state employment with a person or business which contracted with the state within the preceding two years?

### Analysis and Opinion

The state ethics law which may limit a state employee's acceptance of employment after working for the state is K.S.A. 46-233. It provides in pertinent part:

(a) ... (2) Except as otherwise provided in this subsection, whenever any individual has participated as a state officer or employee in the making of any contract with any person or business, such individual shall not accept employment with such person or business as an employee, independent contractor or subcontractor until two years after performance of the contract is completed or until two years after the individual terminates employment as a state officer or employee, whichever is sooner. This prohibition on accepting employment shall not apply in any case where a state officer or employee who participated in making a contract while employed by the state of Kansas is laid off or scheduled to be laid off from any state position on or after July 1, 2002. As used in this subsection (a)

(2), "laid off" and "layoff" mean a state officer or employee in the classified service under the Kansas civil service act, being laid off under K.S.A. 75-2948, and amendments thereto.

(d) Subsections (a) and (b) shall not apply to the following:

(1) Contracts let after competitive bidding has been advertised for by published notice; and

(2) contracts for property or services for which the price or rate is fixed by law.

The July 2018 contract executed August 23, 2018, between the KBI and The Premier Group was let for competitive bids and the RFP was published in the Kansas Register. The exception in K.S.A. 46-233(d) therefore applies to the subparagraph (a)(2) waiting period and poststate employment with The Premier Group is not limited.

We are of the opinion that The Premier Advisory Group and Bajillion Agency, although associated for fiscal purposes, are not the same business. Each business entity is registered as a separate business, each have separate executive officers and employees that are not commingled. The proposed employment of Whisman by The Premier Advisory Group does not make Whisman an employee of Bajillion Agency. Thus, the January and October 2019 contracts between the KBI and Bajillion Agency do not bar or impede Whisman's post state employment with The Premier Advisory Group. We are further of the opinion that Ms. Whisman may not transfer employment to, or otherwise accept, employment with Bajillion Agency for two years from the date her state employment terminates.

### Conclusion

Under the facts provided, KBI Executive Officer Whisman may accept immediate employment with The Premier Advisory Group and not violate the provisions of the Kansas governmental ethics laws, K.S.A. 46-215 *et seq*.
