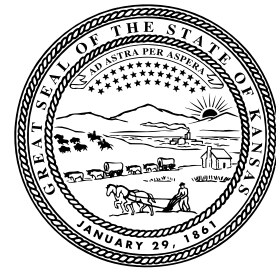

Extending Temporary Relief from Certain
Age Restrictions Concerning Online Driver's
License Renewal

WHEREAS, securing the health, safety, and economic well-being of residents of the State of Kansas is this Administration's top priority;

WHEREAS, Kansas is facing a crisis—the pandemic and public health emergency of COVID-19—with effects of illness, quarantines, school closures, and temporary closure of businesses resulting in lost wages and financial hardship to Kansas citizens;

WHEREAS, the United States Departments of Health and Human Services declared a public health emergency for COVID-19 beginning January 27, 2020, with more than 4,280,000 cases of the illness and more than 115,000 deaths as a result of the illness across the United States;

WHEREAS, the World Health Organization declared a pandemic on March 11, 2020;

WHEREAS, a State of Disaster Emergency was proclaimed for the State of Kansas on March 12, 2020;

WHEREAS, on March 13, 2020, the President of the United States declared the ongoing COVID-19 a pandemic of sufficient severity and magnitude to warrant an emergency declaration for all states, tribes, territories, and the District of Columbia pursuant to Section 501 (b) of the Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C. § 5121-5207 (the "Stafford Act");

WHEREAS, on March 13, 2020, the President of the United States pursuant to Sections 201 and 301 of the National Emergencies Act, 50 U.S.C. § 1601, et seq. and consistent with Section 1135 of the Social Security Act, as amended (42 U.S.C. § 1320b-5), declared a national emergency that the COVID-19 outbreak in the United States constitutes a national emergency beginning March 1, 2020;

WHEREAS, as of this date, there have been over 26,172 positive cases of COVID-19 in Kansas, spread among 103 counties and 335 deaths as a result of the illness;

WHEREAS, the COVID-19 pandemic threatens the stability of local, state, national, and global economies, with the potential to cause layoffs, furloughs, and significant decreases in pay;

WHEREAS, to protect Kansans, and especially those who may be members of a vulnerable population, it is necessary to allow certain drivers to renew their drivers licenses online;

WHEREAS, Executive Order 20-46 previously suspended the age limit for online driver's license renewals but that order is set to expire July 31, 2020; and

WHEREAS, this Administration will do whatever it can to assist Kansans in these challenging times, including providing temporary relief from certain age restrictions concerning online renewal of driver's licenses during the COVID-19 pandemic.

NOW, THEREFORE, pursuant to the authority vested in me as Governor of the State of Kansas, including the authority granted me by K.S.A. 48-924 and K.S.A. 48-925(b), (c)(1), and (c)(11), in order to address the effects of the spread of COVID-19, I hereby direct and order the following:

1. The provision in K.S.A. 8-240(j)(2)(B) prohibiting applicants 50 years of age or older from utilizing the electronic online driver's license renewal application is suspended for the limited purpose of allowing all drivers between the ages of 50 and 64, inclusive, to use the electronic online renewal system.
2. Other than as provided in paragraph 1, above, this order does not alter other laws, regulations, or rules relating to the requirements in K.S.A. 8-240 for an applicant to renew their driver's license.

This document shall be filed with the Secretary of State as Executive Order No. 20-60. It shall become effective immediately and remain in force until rescinded, until December 31, 2020, or until the statewide State of Disaster Emergency extended by House Bill 2016 enacted during the June 2020 special session relating to COVID-19 expires, whichever is earlier.

WHEREAS, the United States Departments of Health and Human Services declared a public health emergency for COVID-19 beginning January 27, 2020, with now more than 5,340,000 cases of the illness and more than 168,696 deaths as a result of the illness across the United States;

WHEREAS, the World Health Organization declared a pandemic on March 11, 2020;

WHEREAS, a State of Disaster Emergency was proclaimed for the State of Kansas on March 12, 2020;

WHEREAS, on March 13, 2020, the President of the United States declared the ongoing COVID-19 a pandemic of sufficient severity and magnitude to warrant an emergency declaration for all states, tribes, territories, and the District of Columbia pursuant to Section 501(b) of the Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C. § 5121-5207 (the "Stafford Act");

WHEREAS, on March 13, 2020, the President of the United States pursuant to Sections 201 and 301 of the National Emergencies Act, 50 U.S.C. § 1601, et seq. and consistent with Section 1135 of the Social Security Act, as amended (42 U.S.C. § 1320b-5), declared that the COVID-19 outbreak in the United States constitutes a national emergency beginning March 1, 2020;

WHEREAS, as of this date, there have been over 33,885 positive cases of COVID-19 in Kansas, spread among 103 counties and 402 deaths as a result of the illness;

WHEREAS, the COVID-19 pandemic threatens the stability of local, state, national, and global economies, and has caused layoffs, furloughs, and significant decreases in pay;

WHEREAS, Kansas law states that "[e]conomic insecurity, due to unemployment, is a serious menace to health, morals, and welfare of the people of this state";

WHEREAS, in March of 2020, the unemployment rate in Kansas was 2.8 percent, in April and May the unemployment rate skyrocketed to 11.9 and 10.0 percent, respectively, and during June 2020 the rate remained at a discouraging 7.5 percent;

WHEREAS, in light of the heightened unemployment rate and unprecedented public health challenges facing our state, on March 23, 2020, I issued Executive Order 20-10, prohibiting certain foreclosures and evictions;

WHEREAS, when the federal government responded to the economic crisis created by the COVID-19 pandemic by increasing financial support for those who lost jobs or wages as a result of the pandemic and implementing protections against foreclosures and evictions, and as Kansas was poised to follow the Ad Astra Plan for a phased re-opening of our economy, I allowed Executive Order 20-10 (as extended by Executive Order 20-28) to expire;

WHEREAS, on August 8, 2020, the President issued an "Executive Order on Fighting the Spread of COVID-19 by Providing Assistance to Renters and Homeowners," instituting some limited federal measures to discourage or prevent some evictions and foreclosures, but acknowledging that federal protections against evictions and foreclosures in the Coronavirus Aid, Relief, and Economic Security ("CARES") Act have expired;

WHEREAS, the President's executive order also acknowledges that "homelessness poses multiple challenges that can exacerbate and amplify the spread of COVID-19";

WHEREAS, during a pandemic emergency it becomes more important than ever for citizens to be safe and secure in their homes, and any interruption in housing threatens the public health and safety through increased burdens on social services, increased health risks, and increased spread of COVID-19;

WHEREAS, when the COVID-19 pandemic is stressing health care, local and state support systems, and our economy, any disruption in housing is likely to create additional and unnecessary burdens that will impede the response to the COVID-19 pandemic and potentially exacerbate it;

WHEREAS, in order to promote and secure the safety and

(continued)

protection of the civilian population in these unprecedented circumstances it is necessary to prevent housing disruption caused by the COVID-19 pandemic, and the provisions of Executive Order 20-10 are again necessary to secure the safety and protection of the civilian population; and

WHEREAS, this Administration will do whatever it can to assist Kansans in these challenging times, especially vulnerable Kansans in danger of losing their homes because of the COVID-19 pandemic.

NOW, THEREFORE, pursuant to the authority vested in me as Governor of the State of Kansas, including the authority granted me by K.S.A. 48-924 and K.S.A. 48-925(c)(11), in order to mitigate the spread and the effects of the spread of COVID-19 I hereby direct and order the following:

1. As used in this order, a “financial hardship resulting from the COVID-19 pandemic” occurs when (1) an individual or family suffers a significant loss of income, significant increase in necessary expenses, or inability to work as a direct or indirect result of the COVID-19 pandemic, and (2) the individual’s or family’s financial resources are depleted to the extent that making mortgage or rent payments would leave them unable to purchase food, medicine, or other goods, supplies, or services necessary to their health and safety.
2. This order does not prohibit the continuation of any judicial foreclosure or judicial eviction proceedings filed before the effective date of this order.
3. No bank or financial lending entity operating in Kansas shall foreclose on a residential property in Kansas when all defaults or violations of the mortgage are substantially caused by a financial hardship resulting from the COVID-19 pandemic.
 - a. The provisions of paragraph 3 and paragraph 5 do not apply to foreclosures on multi-family residential properties in which residential tenants rent from a landlord, as long as the foreclosure will not result in the eviction of any tenants.
4. No landlords—whether individuals, companies, banks, financial lending entities, nursing homes, long-term care facilities, or other entities—shall evict a residential tenant when all defaults or violations of the rental agreement are substantially caused by a financial hardship resulting from the COVID-19 pandemic.
5. Any bank, financial lending entity, or landlord initiating judicial foreclosure or judicial eviction proceedings after the effective date of this order shall have the burden of pleading and proving that the foreclosure or eviction proceeding is not being initiated solely because of defaults or violations of mortgages or rental agreements substantially caused by a financial hardship resulting from the COVID-19 pandemic.
6. This order does not relieve mortgage borrowers or tenants who have not suffered a financial hardship resulting from the COVID-19 pandemic from the obligation to comply with mortgage or rental agreements or to continue making required mortgage or rent payments.

7. This order does not prevent foreclosures or evictions for mortgage or rental agreement defaults or violations not due to a financial hardship resulting from the COVID-19 pandemic.
8. After the statewide State of Disaster Emergency proclaimed on March 12, 2020, relating to COVID-19 expires and financial hardships resulting from the COVID-19 pandemic abate, borrowers, lenders, renters, and landlords are encouraged to negotiate payment plans or other agreements to allow borrowers or renters to address any defaults, missed payments, or late fees substantially caused by a financial hardship resulting from the COVID-19 pandemic.
9. This order does not apply to foreclosures initiated by the United States government.
10. All other laws or regulations relating to foreclosures and landlord-tenant rights remain in effect.
11. This order supersedes any contrary order by any local health department regarding foreclosures or evictions and should be read in conjunction with previous executive orders responding to the COVID-19 pandemic. Any contrary provision in previous orders is superseded by this order.

This document shall be filed with the Secretary of State as Executive Order No. 20-61. It shall become effective immediately and remain in force until rescinded, until September 15, 2020, or until the statewide State of Disaster Emergency extended by House Bill 2016 enacted during the June 2020 special session relating to COVID-19 expires, whichever is earlier.

**Executive Order No. 20-62
Extending Conditional and Temporary Relief
from Certain Motor Carrier Rules and Regulations
During State of Disaster Emergency**

WHEREAS, securing the health, safety, and economic well-being of residents of the State of Kansas is this Administration’s top priority;

WHEREAS, Kansas is facing a crisis of economic insecurity resulting from a rapid increase in unemployment and lost wages;

WHEREAS, economic insecurity due to unemployment is a serious menace to the health, morals, and welfare of the people of Kansas, as expressed in K.S.A. 44-702 of the Kansas Employment Security Law;

WHEREAS, the economic recovery of Kansas is imperiled by the imminent threat of surges in COVID-19 infections in the State of Kansas as statewide restrictions on businesses and individual movement and gatherings are lifted—since May 15, 2020, fifteen counties in the State

have for the first time issued an emergency declaration resulting from the pandemic, indicating a further threat to the State's economic recovery.

WHEREAS, on July 14, 2020, I executed Executive Order 20-57 extending conditional and temporary relief from certain motor carrier rules and regulations in response to the COVID-19 Pandemic, and the justifications for that Order are fully set forth therein and incorporated herein by reference;

WHEREAS, on August 11, 2020, the Federal Motor Carrier Safety Administration extended and modified its emergency declaration (No. 2020-002) regarding motor carrier regulations, leaving the declaration in effect until 11:59 p.m. (ET) on August 14, 2020;

WHEREAS, the operative provisions of Executive Order 20-57 were not only necessary to deal with the public health crisis caused by COVID-19 but are now also necessary to deal with the imminent threat of additional outbreaks of COVID-19 and the economic emergency resulting from COVID-19 in that the operative provisions provide relief for certain motor carriers and persons operating commercial vehicles from strict compliance with operating, licensing, certification, and permitting rules and regulations that might otherwise prevent these certain motor carriers and persons operating commercial vehicles from continuing operation in furtherance of commerce-related activities;

WHEREAS, continuing the operative provisions of Executive Order 20-57 minimizes the economic loss to commerce-related activities that would result if strict compliance with certain operating, licensing, certification, and permitting rules and regulations prevented motor carriers and persons operating commercial vehicles from continuing operation in furtherance of commerce-related activities; and

WHEREAS, this Administration will do whatever it can to assist Kansans in these challenging times, including ensuring that essential goods and supplies can be delivered as efficiently as possible while still maintaining adequate safety standards.

NOW, THEREFORE, pursuant to the authority vested in me as Governor of the State of Kansas, including but not limited to the authority granted me by K.S.A. 48-924 and K.S.A. 48-925(b), (c)(1), and (c)(11), in order to respond to the effects of the spread of COVID-19, cope with the effects of the pandemic both in Kansas and elsewhere, and to promote and secure the safety and protection of the civilian population, I hereby acknowledge a state of emergency exists in the United States and direct and order the following:

1. In accordance with the FMCSA's declaration under Title 49 C.F.R. § 390.23(a)(1)(i), Title 49 C.F.R. §§ 390-399 are hereby suspended for motor carriers and persons operating commercial vehicles actively participating in COVID-19 relief or restoration efforts, except that 49 C.F.R. §§ 392.2, 392.3, 392.80, and 392.82 remain in effect.
2. Motor carriers and persons operating commercial vehicles actively participating in COVID-19 relief and restoration efforts may haul up to 10% more than their licensed weight on Kansas highways, not to exceed 90,000 pounds.
3. All other applicable state and federal regulations shall continue to apply, including but not limited to: Title 49 C.F.R. Part 382, Controlled Substances and Alcohol Use and Testing; the Kansas Motor Vehicle Driver's License Act, K.S.A. 8-234 *et. seq.*, and Title 49 C.F.R. Part 383 Commercial Driver's License Standards as adopted by the Kansas Uniform Commercial Drivers' License Act, K.S.A. 8-2,125 *et. seq.*, the federal Minimum Levels of Financial Responsibility (insurance requirements) Title 49 C.F.R. Part 387 as adopted by K.A.R. 82-4-3n and state insurance requirements as provided in K.A.R. 82-4-23; and, adherence to the regulations governing the Transportation of Hazardous Materials as provided Title 49 C.F.R. 397 and adopted by K.A.R. 82-4-3k and Parts: 107, 171-173, 177, 178 and 180 as adopted by K.A.R.82-4-20.
4. The licensing, certification, and permitting rules and regulations as required by the Kansas Corporation Commission are temporarily suspended for motor carriers and persons operating commercial vehicles actively participating in COVID-19 relief or restoration efforts.
5. The registration and fuel tax permits as enforced by the Kansas Department of Revenue are temporarily suspended for motor carriers and persons operating commercial vehicles actively participating in COVID-19 relief or restoration efforts.
6. Motor carriers and persons operating commercial vehicles actively participating in COVID-19 relief or restoration efforts must still obtain the requisite over-dimension/overweight permits as required by the Kansas Department of Transportation prior to operating; however, the fees associated with these permits are temporarily waived.
7. Except as specifically stated in this order, all other state motor carrier laws or regulations remain in full force and effect.
8. This order supersedes any contrary order by any local health department regarding motor carriers and should be read in conjunction with previous executive orders responding to the COVID-19 pandemic. Any contrary provision in previous executive orders is superseded by this order.

This document shall be filed with the Secretary of State as Executive Order No. 20-62. It shall become effective immediately and remain in force until rescinded, until 11:59 p.m. on September 14, 2020, or until the statewide State of Disaster Emergency extended by House Bill 2016 enacted during the June 2020 special session relating to COVID-19 expires, whichever is earlier.

The Kansas Department of Health and Environment (KDHE), Division of Environment, Bureau of Air, will conduct a public hearing at 10:00 a.m. Wednesday, November 4, 2020, to consider the adoption of proposed amended air quality regulation K.A.R. 28-19-720, and revocation of K.A.R. 28-19-719. KDHE will submit the final revocation of K.A.R. 28-19-719 to the U.S. Environmental Protection Agency (USEPA) for approval into the State Implementation Plan (SIP).

Due to recent concerns regarding COVID-19, only remote public participation is available. To participate in the hearing, call 866-620-7326 and enter conference code 3147467296#. During the hearing, all interested individuals will be given a reasonable opportunity to present their views orally on the proposed regulations. If an individual wishes to give oral comment during the remote hearing, email or mail a written copy of the comment to the email or postal mailing address provided in this notice. In order to give each individual an opportunity to present their views, it may be necessary for the hearing officer to request that each presenter limit an oral presentation to an appropriate time frame.

The time period between the publication of this notice and the scheduled hearing constitutes a 60-day public comment period for the purpose of receiving written public comments on the proposed regulations. A summary of the proposed regulations and the estimated economic impact follows:

Summary of Regulations:

K.A.R. 28-19-720. KDHE proposes to amend K.A.R. 28-19-720 to maintain agreement with the USEPA allowing Kansas to be the delegated authority to enforce New Source Performance Standards (NSPS) requirements in the State of Kansas. Adopting these amendments allows KDHE to gain primary enforcement authority over NSPS amendments adopted through June 2017. Without adopting these amendments, KDHE loses primary enforcement capability for these amendments, which will result in a split authority between KDHE and the USEPA for Kansas sources regarding NSPS requirements.

K.A.R. 28-19-719. KDHE proposes to revoke K.A.R. 28-19-719, the Kansas City summertime Reid Vapor Pressure (RVP) regulation. The Kansas City area is attaining the 2015 ozone standard based on 2015-2017, 2016-2018, and 2017-2019 monitoring data, and modeling shows that ozone forming compounds from transportation sources will continue to decrease even without the RVP regulation. The Bureau of Air concludes that a regulation

change from summertime 7.0 psi RVP to summertime 9.0 psi RVP gasoline will not interfere with continued attainment of the 2015 ozone standard. The regulation is no longer necessary and is proposed for revocation.

Economic Impact:

The proposed regulations impose no additional costs to the implementing agency, other governmental agencies, units, or the general public.

Permanent Administrative Regulations

Article 24.—KANSAS SCRAP
METAL DATA REPOSITORY

10-24-1. Definitions. As used in this article of the KBI's regulations, each of the following terms shall have the meaning specified in this regulation:

(a) "KBI" means Kansas bureau of investigation.
(b) "Repository" means the Kansas scrap metal data repository.

(c) "Seller" means an individual selling regulated scrap metal to a scrap metal dealer.

(d) "Transaction" means the purchase or receipt of any junk vehicle or regulated scrap metal by a scrap metal dealer that requires information to be recorded pursuant to K.S.A. 2019 Supp. 50-6,110, as amended by L. 2019, ch. 66, sec. 6, and amendments thereto. (Authorized by and implementing K.S.A. 2019 Supp. 50-6,110, as amended by L. 2019, ch. 66, sec. 6; effective, T-10-5-4-20, July 1, 2020; effective Sept. 11, 2020.)

10-24-2. Information to be submitted. For each transaction, each scrap metal dealer shall submit to the

KBI the following information for entry into the repository:

- (a) The date and place of the transaction;
- (b) the seller's name, address, date of birth, and sex;
- (c)(1) The identifying number from the seller's driver's license, military identification card, passport, or personal identification license; or
- (2) the identifying number from the seller's official governmental document for a country other than the United States;
- (d) the license number, make, and model of the vehicle in which the junk vehicle or other regulated scrap metal is delivered in the transaction, if applicable;
- (e) a general description, made in accordance with the custom of the trade, of the predominant type of junk vehicle or other regulated scrap metal property purchased in the transaction;
- (f) the weight or quantity, made in accordance with the custom of the trade, of the regulated scrap metal property purchased;
- (g) if a junk vehicle or vehicle part, a description of the junk vehicle or vehicle part, including the make, the model, and either the vehicle identification number or the serial number; and
- (h) the name of the individual acting on behalf of the scrap metal dealer in making the purchase. (Authorized by and implementing K.S.A. 2019 Supp. 50-6,110, as amended by L. 2019, ch. 66, sec. 6; effective, T-10-5-4-20, July 1, 2020; effective Sept. 11, 2020.)

10-24-3. Manner of submission. Each scrap metal dealer shall submit the information specified in K.A.R. 10-24-2 to the repository either by using the KBI's electronic form online or by using a standard software interface to electronically transfer the information from the scrap metal dealer's transaction storage system to the repository. (Authorized by and implementing K.S.A. 2019 Supp. 50-6,110, as amended by L. 2019, ch. 66, sec. 6; effective, T-10-5-4-20, July 1, 2020; effective Sept. 11, 2020.)

Article 20.—KANSAS OPEN MEETINGS ACT

16-20-1. Compliance with the Kansas open meetings act during an emergency declaration. (a) This regulation shall be in effect only as follows:

- (1) During a state of disaster emergency lawfully declared by the governor pursuant to K.S.A. 48-924(a) through (c), and amendments thereto, or other emergency declaration lawfully declared pursuant to applicable emergency-powers provisions of local, state, or federal law;
- (2) in the territory affected by any such declaration; and
- (3) to the extent that emergency responses required pursuant to any such declaration prevent or impede the ability of any of the following:

(A) Members of a public body or agency subject to the Kansas open meetings act, K.S.A. 75-4317 et seq. and amendments thereto, to conduct meetings by physically gathering in person;

(B) members of the public to attend or observe public meetings by physically attending the meetings; or

(C) a combination of both paragraph (a)(3)(A) and paragraph (a)(3)(B).

(b) All requirements of the Kansas open meetings act, K.S.A. 75-4317 et seq. and amendments thereto, shall remain in force and effect during any emergency declared as described in paragraph (a)(1) unless expressly suspended by order of the governor pursuant to K.S.A. 48-925(c)(1), and amendments thereto, or other applicable provision of K.S.A. 48-925, and amendments thereto. No order of the governor shall be construed to suspend any requirement of the Kansas open meetings act, unless the order meets the following conditions:

(1) Expressly cites and invokes K.S.A. 48-925(c)(1), and amendments thereto, and any other specific provision of K.S.A. 48-925, and amendments thereto, from which the order draws authority;

(2) expressly references the Kansas open meetings act and the specific provisions thereof that the governor intends to suspend during the state of disaster emergency; and

(3) makes plain and unequivocal the intent of the governor to suspend any such requirement.

(c) Any public body or agency may comply with the requirement of K.S.A. 75-4318(a), and amendments thereto, that a meeting be "open to the public" through the use of a telephone or other medium for interactive communication if the requirements of subsection (e) are met.

(d) As used in this regulation, "medium for interactive communication" shall include teleconference, video-conference, internet conference, television broadcast, or any other method that permits the public to listen to the meeting and also to observe the meeting if the method allows for visual observation.

(e) Each public body or agency conducting an open meeting utilizing solely a telephone or another medium for interactive communication rather than by members of the body or agency gathering in person at a physical location shall meet the following requirements:

(1) Use a medium for interactive communication that, at a minimum, allows members of the public, without cost, to listen to the meeting and, if available, also allows video observation of the meeting;

(2) comply with all requirements of the Kansas open meetings act, except any temporarily suspended by the governor as provided by subsection (b), including requirements for notice;

(3) if the medium for interactive communication allows, provide an alternative means to access the meeting for members of the public who do not have internet access that also complies with the requirements issued pursuant to any emergency declaration;

(4) provide directions describing how members of the public will be able to electronically access, listen to, or observe the open meeting;

(5) if the medium for interactive communication does

(continued)

not permit easy identification of the individual speaker, require each member of the public body or agency, staff, or presenter to state the individual’s name and title, if any, each time the individual begins speaking or voting so that the individual can be readily identified by remote listeners or observers;

(6) require all participants to ensure that microphones, phones, or other electronic devices are muted when the participants are not speaking so that the ability of remote listeners or observers to hear the proceedings is not unnecessarily impeded;

(7) describe at the beginning of the meeting whether public comment will be allowed and what process will be used to identify any individual who wishes to comment, if permitted;

(8) describe at the beginning of the meeting the process that will be used for a closed or executive meeting pursuant to K.S.A. 75-4319, and amendments thereto;

(9) before any meeting, provide electronic or paper copies of an agenda, if any, to any individual requesting the agenda;

(10) clearly state each motion before the public body votes and announce the results of the final vote; and

(11) when not otherwise established by the agency or by ordinance or resolution of the public body, pass a motion that clearly identifies and authorizes by delegation each member of the public body or staff who will be permitted to sign any binding document for the public body or agency.

(f) To the extent that emergency responses required pursuant to the emergency declaration prevent or impede the ability of the public to physically attend a public meeting, any public body or agency may comply with the requirement of K.S.A. 75-4318(a), and amendments thereto, by meeting in person but limiting physical access of the public to the place where the meeting occurs if the public body or agency meets the following requirements:

(1) Complies with all requirements of the Kansas open meetings act, except any requirements suspended by the governor as provided by subsection (b), including requirements for notice;

(2)(A)(i) Broadcasts the meeting live on television or the internet; and

(ii) provides members of the public with the ability to access the meeting by telephone without cost; or

(B) uses any other method other than the methods specified in paragraphs (f)(2)(A)(i) and (ii) that permits the public to listen to or observe the meeting without cost;

(3) provides directions describing how members of the public will be able to electronically access, listen to, or observe the open meeting;

(4) if the medium for interactive communication does not permit easy identification of the individual speaker, requires each member of the public body or agency, staff, or presenter to state the individual’s name and title, if any, each time the individual begins speaking or voting so that the individual can be readily identified by remote listeners or observers;

(5) describes at the beginning of the meeting whether public comment will be allowed and what process will be used to identify any individual who wishes to comment, if permitted;

(6) describes at the beginning of the meeting the process that will be used for a closed or executive meeting pursuant to K.S.A. 75-4319, and amendments thereto;

(7) before any meeting, provides electronic or paper copies of an agenda, if any, to any individual requesting the agenda;

(8) states each motion before the public body votes and announces the results of the final vote; and

(9) when not otherwise established by the agency or by ordinance or resolution of the public body, passes a motion that clearly identifies and authorizes by delegation each member of the public body or staff who will be permitted to sign any binding document for any public body or agency.

(g) Nothing in this regulation shall require any public body or agency to provide members of the public with the opportunity for public comment.

(h) Nothing in this regulation shall require any public body or agency to take action to prevent any member of the public from physically attending any public meeting. Article 15.—RAFFLE GAMES

111-15-1. Name of the game; rules and regulations.

The Kansas lottery may conduct a lotto game entitled “Holiday Millionaire Raffle” beginning at 4:00 a.m. September 1, 2020, for a drawing to be conducted on January 5, 2021.

The rules and regulations for the “Holiday Millionaire Raffle” game are contained in K.A.R. 111-15-1 through 111-15-11 and K.A.R. 111-15-21, and applicable generic rules are contained in K.A.R. 111-6-1 *et seq.* (Authorized by and implementing K.S.A. 74-8710; effective, T-111-10-8-09, Sept. 9, 2009; amended, T-111-12-7-10, Sept. 8, 2010; amended, T-111-10-12-11, Sept. 14, 2011; amended, T-111-10-18-12, Sept. 12, 2012; amended, T-111-11-6-13, Sept. 11, 2013; amended, T-111-9-4-14, Aug. 13, 2014; amended, T-111-9-14-15, Aug. 12, 2015; amended, T-111-9-9-16, Aug. 10, 2016; amended, T-111-8-28-17, July 12, 2017; amended, T-111-11-16-18, Aug. 8, 2018; amended, T-111-6-19-19, May 22, 2019; amended, T-111-8-6-20, June 3, 2020.)

111-15-3. Game description; retail sale of tickets.

(a) “Holiday Millionaire Raffle” is a raffle drawing which offers a total of 150,000 online tickets available for sale. Each ticket shall bear a ticket number on the face of the ticket. The Kansas lottery will conduct three “Holiday Millionaire Raffle Early Bird Drawings” according to the following schedule, unless otherwise determined by the executive director:

Early Bird 2	Sunday, November 8, 2020	Sunday, November 8, 2020

For each Early Bird drawing, one ticket number will be drawn to determine the winner of an Early Bird drawing prize. A ticket must be purchased by 6:59 p.m. the day of the Early Bird drawing to be eligible for that drawing. In the event a ticket wins a prize in an Early Bird drawing, the ticket will remain eligible for any remaining drawings, including the final drawing held on January 5, 2021. For the final drawing an electronic drawing machine shall randomly select a total of 5,645 winning numbers. A player wins by exactly matching his or her ticket number to a winning number that was selected in

the drawing. The first winning number selected during the drawing process shall be the grand prize winner. The second winning number selected during the drawing process shall be the second prize winner. The third winning number selected during the drawing process shall be the third prize winner. The next two winning numbers selected during the drawing process, which shall be drawn in the order of the fourth winning number and fifth winning number, shall be the fourth prize winners. The next 10 winning numbers selected during the drawing process, which shall be drawn in the order of the sixth winning number through the 15th winning number, shall be the fifth prize winners, and the next 30 winning numbers selected during the drawing process, which shall be drawn in the order of the 16th winning number, through the 45th winning number, shall be the sixth prize winners. The next 800 winning numbers selected during the drawing process, which shall be drawn in the order of 46th winning number through the 845th winning number shall be the seventh prize winners. The next 4,800 winning numbers selected during the drawing process, which shall be drawn in the order of 846th winning number through the 5,645th winning number shall be the eighth prize winners. To play the “Holiday Millionaire Raffle,” a player shall purchase a “Holiday Millionaire Raffle” ticket which bears a ticket number on the face of the ticket.

(b) A “Holiday Millionaire Raffle” ticket shall sell for \$20.

(c) Tickets shall not be sold to any person under the age of 18 years. Each retailer may require a person purchasing tickets to produce proof of age.

(d) Each ticket shall be purchased from a terminal operated by a retailer.

(e) All tickets sold by a retailer shall be a “computer pick” or “quick pick” ticket.

(f) A validated ticket shall be the only proof of a game play. The only method of claiming a prize or prizes shall be the submission of the original winning ticket to and receipt of said ticket by the lottery or its authorized agent.

(g) The only guaranteed methods of win checking a ticket to determine whether the ticket bears a winning number shall be through the Kansas lottery ticket checker machines, or submission of a ticket to the Kansas lottery or an authorized retail agent.

(h) A ticket shall not be voided or cancelled by returning the ticket to the selling retailer, including tickets that are printed in error. Exchange tickets may be printed by the lottery for Early Bird drawing winners at the discretion of the executive director.

(i) Ticket sales will begin at 4:00 a.m. central time on September 1, 2020.

(j) Ticket sales will end at 2:59 a.m. central time on January 5, 2021, or whenever all tickets that are available for sale are sold, whichever comes first.

(k) The game will officially close at 2:59 a.m. on January 5, 2021, or whenever the 150,000th ticket is sold, whichever occurs first.

(l) After the drawing official has verified the game is closed, the final drawing shall be conducted at a secure location under conditions and procedures promulgated by the executive director of the lottery.

(m) Each player shall have the sole responsibility for verifying the accuracy and condition of the data printed on the ticket. The purchase of a ticket is done at the player's own risk through the online retailer who is deemed to be acting on behalf of the player in entering the play or plays.

(n) For any reason or under any circumstance, the liability of the Kansas lottery or its agents shall be strictly limited to a refund of the amount of the ticket purchase price.

(o) Winning ticket numbers shall be made available to the public on or about noon, January 5, 2021. 111-15-10. Ticket responsibility. (a) Until such time as a signature, mark or name is placed on the back of a ticket in the area designated for a signature, mark or name, a ticket shall be owned by the holder of the ticket. When a signature, mark or name is placed on a ticket in the place designated, the person whose signature, mark or name appears in that area shall be the owner of the ticket and shall be entitled to any prize attributable thereto.

(b) If the signature, mark or name of more than one person appears on the back of the ticket in the designated place, the lottery shall make payment to the person presenting the ticket whose signature, mark or name appears on both the ticket and the winner claim form, and after execution of a notarized affidavit. 111-19-89. PlayOn to the Big Game. (a) The Kansas lottery may conduct a drawing entitled "PlayOn to the Big Game" awarding a trip prize package to the player selected as the winner. The Kansas lottery will accept entries into the drawing beginning at 12:01 a.m. on September 1, 2020. Entry deadline into the drawing is 11:59 p.m. on December 13, 2020. The drawing will be conducted sometime after entry into the drawing has closed but before noon on December 18, 2020, at which time the winner will be announced.

(b) Only registered Kansas Lottery PlayOn members may enter the drawing. PlayOn members must enter themselves into the drawing according to the terms and conditions of PlayOn. Entries shall not be accepted that are submitted by any method other than through PlayOn.

(c) A total of 4,567 player loyalty club points are required for a PlayOn member to enter once in the drawing. A player may enter the drawing as many times as his or her points allow.

(d) The procedures set forth in K.A.R. 111-18-5 for selecting the winner and alternate winners shall be followed.

(e) One drawing will be conducted to select a winner of a trip prize package to Tampa, Florida for the February 2021 National Football League Super Bowl game. The trip prize package shall include:

(1) Round trip coach airfare for two persons on an airline approved by the Kansas lottery to and from Tampa International Airport and any of the following cities: Wichita, Kansas; Manhattan, Kansas; Kansas City, Missouri; or Denver, Colorado;

(2) Roundtrip ground transportation for two persons to and from the airport and hotel;

(3) Three nights' deluxe hotel accommodations (double occupancy, room and tax only);

(4) Breakfast daily for three mornings;

(5) Attendance at an NFL experience event with roundtrip ground transportation to and from the hotel;

(6) Two lower level end zone tickets to the Super Bowl game with hospitality and ground transportation to and from the hotel;

(7) Access to the pre-game party;

(8) \$1,000 cash; and

(9) State and federal mandatory income withholding taxes paid by the Kansas lottery.

(f) The prize package is valued at approximately \$44,665.49.

(g) The procedures set forth in K.A.R. 111-18-5 for contacting the winner and the claiming of the prize shall be followed, except that in this promotion the 10-day deadline for the winner to return their claim forms shall be business days and commence with the date of the announcement of the winners.

(h) The winner must book travel within 15 business days after being notified by the Kansas lottery that he or she has won a prize. Travel must be completed by the winner at the time of the February 2021 Super Bowl game.

(i) By accepting any portion of the prize for which a ticket, voucher, certificate or pre-paid gift card is provided, winner must abide by any terms, conditions, and restrictions provided thereon. Article 302.—SPECIFIC LOTTERY FACILITY GAMES AT LOTTERY GAMING FACILITIES; CRAPS

111-302-5. Wagers. (a) The following shall constitute the permissible wagers at the games of craps:

(1) A "pass bet" is a wager placed on the pass line of the layout immediately prior to the come out roll. A pass bet shall win if, on the come out roll:

- (A) A total of 7 or 11 is thrown; or
(B) A total of 4, 5, 6, 8, 9, or 10 is thrown and that total is again thrown before a 7 total appears.
A pass bet shall lose if, on the come out roll:
(C) A total of 2, 3, or 12 is thrown; or
(D) A total of 4, 5, 6, 8, 9, or 10 is thrown and a total of 7 subsequently appears before that total is again thrown.
- (2) A "don't pass bet" is a wager placed on the don't pass line of the layout immediately prior to the come out roll. A don't pass bet shall win if, on the come out roll:
(A) A total of 2 or 3 is thrown; or
(B) A total of 4, 5, 6, 8, 9, or 10 is thrown and a total of 7 subsequently appears before that total is again thrown.
A don't pass bet shall lose if, on the come out roll:
(C) A total of 7 or 11 is thrown; or
(D) A total of 4, 5, 6, 8, 9, or 10 is thrown and that total is again thrown before a total of 7 appears.
A don't pass bet shall be void if, on the come out roll, a total of 12 is thrown.
- (3) A "come bet" is a wager placed on the come line of the layout at any time after the come out roll. A come bet shall win if, on the roll immediately following placement of such bet:
(A) A total of 7 or 11 is thrown; or
(B) A total of 4, 5, 6, 8, 9, or 10 is thrown and that total is again thrown before a total of 7 appears.
A come bet shall lose if, on the roll immediately following placement of such bet:
(C) A total of 2, 3, or 12 is thrown; or
(D) A total of 4, 5, 6, 8, 9, or 10 is thrown and a total of 7 subsequently appears before that total is again thrown.
- (4) A "don't come bet" is a wager placed on the don't come area of the layout at any time after the come out roll. A don't come bet shall win if, on the roll immediately following placement of such bet:
(A) A total of 2 or 3 is thrown; or
(B) A total of 4, 5, 6, 8, 9, or 10 is thrown and a total of 7 subsequently appears before that total is again thrown.
A don't come bet shall lose if, on the roll immediately following placement of such bet:
(C) A total of 7 or 11 is thrown; or
(D) A total of 4, 5, 6, 8, 9, or 10 is thrown and that total is again thrown before a total of 7 appears.
A don't come bet shall be void if, on the roll immediately following placement of such bet, a total of 12 is thrown.
- (5) "Place bet to win" is a wager that may be made at any time on any of the numbers 4, 5, 6, 8, 9, or 10, which shall win if the number on which the wager was placed is thrown before a total of 7 and shall lose if a total of 7 is thrown before such number. All place to win bets, hardway bets and come odds bets shall be inactive on any come out roll unless called "on" by the player and confirmed by the dealer through placement of an "on" marker button on top of such player's wager.
- (6) "Four the hardway" is a wager that may be made at any time, which shall win if a total of 4 is thrown with 2 spots appearing on each die before a total of 4 is thrown in any other way and before a total of 7 is thrown.
- (7) "Six the hardway" is a wager that may be made at any time, which shall win if a total of 6 is thrown with 3 spots appearing on each die before a total of 6 is thrown in any other way and before a total of 7 is thrown.

(8) "Eight the hardway" is a wager that may be made at any time, which shall win if a total of 8 is thrown with 4 spots appearing on each die before a total of 8 is thrown in any other way and before a total of 7 is thrown.

(9) "Ten the hardway" is a wager that may be made at any time, which shall win if a total of 10 is thrown with 5 spots appearing on each die before a total of 10 is thrown in any other way and before a total of 7 is thrown.

(10) "Field bet" is a one roll wager that may be made at any time, which shall win if any one of the totals 2, 3, 4, 9, 10, 11, or 12 is thrown on the roll immediately following placement of such bet and shall lose if a total of 5, 6, 7, or 8 is thrown on such roll.

(11) "Any seven" is a one roll wager that may be made at any time, which shall win if a total of 7 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown.

(12) "Any craps" is a one roll wager that may be made at any time, which shall win if a total of 2, 3 or 12 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown.

(13) "Craps two" is a one roll wager that may be made at any time, which shall win if a total of 2 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown.

(14) "Craps three" is a one roll wager that may be made at any time, which shall win if a total of 3 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown.

(15) "Craps twelve" is a one roll wager that may be made at any time, which shall win if a total of 12 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown.

(16) "11 in one roll" is a one roll wager that may be made at any time, which shall win if a total of 11 is thrown on the next roll and shall lose if any other total is thrown.

(17) "Craps-eleven" or "C and E" is a one roll wager that may be made at any time, which shall win if either a craps (a total of 2, 3 or 12) is rolled or a total of 11 is rolled immediately following placement of such bet and shall lose if any other total is thrown.

(18) "Horn bet" is a one roll wager that may be made at any time, which shall win if any one of the totals 2, 3, 11 or 12 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown.

(19) "Horn high bet" is a wager that may be made at any time, which shall win if any one of the totals 2, 3, 11, or 12 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown. A horn high bet shall be placed in wager units of five with four units wagered as a horn bet and an additional unit wagered on one of the totals 2, 3, 11, or 12. If the craps table layout does not have a designated area for the acceptance of a horn high bet, a dealer shall break down the bet into two separate wagers on the horn and one of the totals 2, 3, 11, or 12.

(20) "Whirl bet" or "world bet" is a one roll wager that may be made at any time, which bet shall consist of a horn bet and an any seven wager. A whirl bet shall be placed in units of five, with four units wagered on 2, 3, 11

and 12 and the fifth unit wagered as an any seven wager. A dealer may break down a whirl bet into two separate wagers on the horn bet and the any seven wager.

(21) "Four the hardway on the hop" is a one roll wager that may be made at any time, which shall win if a total of 4 is thrown with 2 spots appearing on each die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(22) "Six the hardway on the hop" is a one roll wager that may be made at any time, which shall win if a total of 6 is thrown with 3 spots appearing on each die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(23) "Eight the hardway on the hop" is a one roll wager that may be made at any time, which shall win if a total of 8 is thrown with 4 spots appearing on each die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(24) "Ten the hardway on the hop" is a one roll wager that may be made at any time, which shall win if a total of 10 is thrown with 5 spots appearing on each die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(25) "One-three (ace-trey) on the hop" is a one roll wager that may be made at any time, which shall win if a total of 4 is thrown with a 1 spot appearing on one die and a 3 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(26) "One-four (ace-four) on the hop" is a one roll wager that may be made at any time, which shall win if a total of 5 is thrown with a 1 spot appearing on one die and a 4 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(27) "Two-three (deuce-trey) on the hop" is a one roll wager that may be made at any time, which shall win if a total of 5 is thrown with a 2 spot appearing on one die and a 3 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(28) "One-five (ace-five) on the hop" is a one roll wager that may be made at any time, which shall win if a total of 6 is thrown with a 1 spot appearing on one die and a 5 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(29) "Two-four (deuce-four) on the hop" is a one roll wager that may be made at any time, which shall win if a total of 6 is thrown with a 2 spot appearing on one die and a 4 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(30) "One-six (ace-six) on the hop" is a one roll wager that may be made at any time, which shall win if a total of 7 is thrown with a 1 spot appearing on one die and a 6 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(31) "Two-five (deuce-five) on the hop" is a one roll wager that may be made at any time, which shall win if a total of 7 is thrown with a 2 spot appearing on one die

and a 5 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(32) "Three-four (trex-four) on the hop" is a one roll wager that may be made at any time, which shall win if a total of 7 is thrown with a 3 spot appearing on one die and a 4 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(33) "Two-six (deuce-six) on the hop" is a one roll wager that may be made at any time, which shall win if a total of 8 is thrown with a 2 spot appearing on one die and a 6 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(34) "Three-five (trex-five) on the hop" is a one roll wager that may be made at any time, which shall win if a total of 8 is thrown with a 3 spot appearing on one die and a 5 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(35) "Three-six (trex-six) on the hop" is a one roll wager that may be made at any time, which shall win if a total of 9 is thrown with a 3 spot appearing on one die and a 6 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(36) "Four-five on the hop" is a one roll wager that may be made at any time, which shall win if a total of 9 is thrown with a 4 spot appearing on one die and a 5 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(37) "Four-six on the hop" is a one roll wager that may be made at any time, which shall win if a total of 10 is thrown with a 4 spot appearing on one die and a 6 spot appearing on the other die on the roll immediately following placement of such bet and shall lose if any other combination is thrown.

(38) "Big 6," if offered, is a wager that may be made at any time on the big number 6 on the table layout, which shall win if a total of 6 is rolled before a total of 7 is rolled and shall lose if a total of 7 is thrown before a total of 6.

(39) "Big 8," if offered, is a wager that may be made at any time on the big number 8 on the table layout, which shall win if a total of 8 is rolled before a total of 7 is rolled and shall lose if a total of 7 is thrown before a total of 8.

(40) A "put bet" is a wager that may be made at any time on any of the numbers 4, 5, 6, 8, 9, and 10 which wins if the number on which the wager was placed is thrown before a 7 appears and loses if a 7 is thrown before such number.

(41) A "high low" bet is a one roll wager that wins if either a high (12) or low (2) is rolled and loses if any other total is thrown.

(42) "Three way craps" is a one roll wager that wins if either an ace deuce (3) or any craps (2, 3 or 12) is rolled and loses if any other total is thrown. This bet is broken down into separate wagers and placed on the appropriate areas of the "ace-deuce", "2", and "12" on the table layout.

(43) "Sharp shooter" is a wager made on the initial come out roll that wins if the shooter makes three or

more come out points before rolling a losing pass line 7 and loses if the shooter makes fewer than three points before rolling a losing pass line 7. Wagers are only paid based upon the highest number of come out points made before a losing pass line 7 is rolled.

(b) Wagers are made before the dice are thrown but they may also be made between the time the dice leave the shooter's hand and the time the dice come to rest, provided that the wager is confirmed orally by the dealer and a supervisor.

(c) All wagers at craps are made by placing gaming chips on the appropriate area of the table layout.

(d) A wager made on any bet may be removed or reduced at any time prior to a roll that decides the outcome of such wager except that a pass line bet and a come bet may not be removed or reduced after a come out point or come point is established with respect to such bet.

(e) A don't come bet and a don't pass bet may be removed or reduced at any time but may not be replaced or increased after such removal or reduction until a new come out roll.

(f) All place to win bets, hardway bets and come odds bets are inactive on any come out roll unless called "on" by the player and confirmed by the dealer through placement of an "on" marker button on the top of each player's wager. All other wagers are considered "on."

(g) The minimum and maximum wagers allowed at a table shall be posted at the table.

(h) No call bets are allowed. A "call bet" is a bet made verbally without actually placing gaming chips on the table layout.

(j) A horn bet and horn high bet shall be paid as if they were four separate wagers on 2, 3, 11, and 12.

(k) A craps-eleven or C and E bet shall be paid as if one half of the wagered amount had been placed on "any craps" and one half on "eleven," and shall be paid as if two separate wagers were made for the one roll.

(l) A lottery gaming facility manager may offer true odds on place bets under the following circumstances:

(1) In addition to the payout odds set forth in above for place bets to win on 4, 5, 6, 8, 9, and 10, a manager may offer a player the option of receiving true odds on these bets in return for the player paying to manager, at the time of making the bet, a percentage of the amount which in no event shall exceed five percent of such wager;

(2) If a true odds place bet to win is made by a player, winning wagers shall be paid as follows:

Buy Bet made	True odds paid
4 to Win	2 to 1
5 to Win	3 to 2
6 to Win	6 to 5
8 to Win	6 to 5

(continued)

9 to Win	3 to 2
10 to Win	2 to 1

(3) In addition to the payout odds set forth above, for lay bets on 4, 5, 6, 8, 9, and 10, a manager may offer a player the option of receiving true odds on these bets in return for the player paying to manager, at the time of making the bet, a percentage of the amount to be won which in no event shall exceed five percent of such wager;

(4) Lay bets: If a true odds place bet to lose is made by a player, winning wagers shall be paid as follows:

Lay bet made	True odds paid
4 to Lose	1 to 2
5 to Lose	2 to 3
6 to Lose	5 to 6
8 to Lose	5 to 6
9 to Lose	2 to 3
10 to Lose	1 to 2

(m) Supplemental wagers shall also be allowed as follows:

(1) Whenever a player makes a pass bet and a total of 4, 5, 6, 8, 9, or 10 is thrown on the come out roll, the player shall have the right to make a supplemental wager in support of the pass bet which may be limited to an amount that is equal to the amount of the original pass bet. If, in such circumstances, the pass bet wins, the original pass bet shall be paid at odds of 1 to 1 and the supplemental wager shall be paid at odds of 2 to 1 if the come out point was 4 or 10, at odds of 3 to 2 if the come out point was 5 or 9, and at odds of 6 to 5 if the come out point was 6 or 8. A player loses this supplemental wager if the pass bet loses.

(2) Whenever a player makes a don't pass bet and a total of 4, 5, 6, 8, 9, or 10 is thrown on the come out roll, the player shall have the right to make a supplemental wager in support of the don't pass bet which may be limited to an amount so calculated as to provide winnings not in excess of the amount originally wagered on the don't pass bet. If, in such circumstances, the don't pass bet wins, the original don't pass bet shall be paid at odds of 1 to 1 and the supplemental wager shall be paid at odds of 1 to 2 if the come out point was 4 or 10, at odds of 2 to 3 if the come out point was 5 or 9, and at odds of 5 to 6 if the come out point was 6 or 8. A player loses this supplemental wager if the don't pass bet loses.

(3) Whenever a player makes a come bet and a total of 4, 5, 6, 8, 9, or 10 is thrown on the roll immediately following placement of such bet, the player shall have the right to make a supplemental wager in support of the come bet which may be limited to an amount that is equal to the amount of the original come bet. If, in such circumstances, the come bet wins, the original come bet

shall be paid at odds of 1 to 1 and the supplemental wager shall be paid at odds of 2 to 1 if the come point was 4 or 10, at odds of 3 to 2 if the come point was 5 or 9, and at odds of 6 to 5 if the come point was 6 or 8. A player loses this supplemental wager if the come bet loses.

(4) Whenever a player makes a don't come bet and a total of 4, 5, 6, 8, 9, or 10 is thrown on the roll immediately following placement of such bet, the player shall have the right to make a supplemental wager in support of the don't come bet which may be limited to an amount so calculated as to provide winnings not in excess of the amount originally wagered on the don't come bet. If, in such circumstances, the don't come bet wins, the original don't come bet shall be paid at odds of 1 to 1 and the supplemental wager shall be paid at odds of 1 to 2 if the come point was a 4 or 10, at odds of 2 to 3 if the come point was 5 or 9, and at odds of 5 to 6 if the come point was 6 or 8. A player loses this supplemental wager if the don't come bet loses.

(5) The casino may allow a supplemental wager in support of a pass or come bet in an amount up to 10 times the amount of the original pass or come bet. Manager may allow a supplemental wager in support of a don't pass or don't come bet in an amount so calculated as to provide a winning player with winnings not in excess of up to 10 times the amount originally wagered on the don't pass or don't come bet. The original pass, don't pass, come or don't come bet and any supplemental wager allowed pursuant to this subsection shall be paid at the same odds as the original and supplemental wagers are paid under (1) through (4) above.

(6) Whenever a player makes a put bet, the player has the right to make an additional wager in support of the bet which may be limited to an amount equal to the table minimum or maximum odds. If, in such circumstances, the bet wins, the original amount of the bet is paid at odds of 1 to 1 and the supplemental amount is paid in multiples of 2 to 1 if the come point was 4 or 10, 3 to 2 if the come point was 5 or 9, and 6 to 5 if the come point was 6 or 8. A player loses this supplemental bet if the put bet loses.

(7) The casino may accept a supplemental wager that exceeds an amount that is otherwise authorized by this section or posted as the maximum wager permitted at the table, provided that the excess amount of the supplemental wager is necessary to facilitate the payouts permitted by this section.
