A summary of the proposed regulation and its economic impact are as follows: (Note: Statements indicating that a regulation is "not anticipated to have any economic impact" are intended to indicate that no economic impact on the State Corporation Commission, other state agencies, state employees, or the general public has been identified.)

K.A.R. 82-4-30a. Applications for interstate registration.

This existing regulation adopts relevant portions of the Federal Motor Carrier Safety Administration ("FMCSA") regulations (49 C.F.R. Part 367) and Unified Carrier Registration (UCR) Act (49 U.S.C. 14504a) which together establish the rules and registration fees owed by carriers based in Kansas that operate interstate. The proposed changes to this regulation include the following:

 Adoption of 2021 UCR fees – The UCR fees owed by interstate carriers based in Kansas have declined each year from 2017 through 2020. In 2021 the fees

- will remain the same as 2020. Adoption of the proposed changes allows the Kansas Corporation Commission and Kansas Highway Patrol to continue to enforce the existing fee schedule into 2021.
- Relevant Portions of the UCR Act The proposed changes adopt additional portions of the federal statute authorizing the Unified Carrier Registration Act to be enforced by states. The portions include definitions unique to the UCR Act and certain enforcement procedures that were not previously adopted.
- National Registration System—The proposed update directs carriers to pay their UCR fees through the National Registration System which utilizes the UCR website to pay their UCR fees.

K.A.R. 82-4-30a: Economic Impact Summary

The Transportation Division of the Commission anticipates the proposed changes would not have any change in economic impact on Kansas based motor carriers operating interstate. This is because the 2021 UCR fee schedule does not change from 2020, but instead allows the same fee schedule to apply to future years. Government agencies and the general public should see no economic impact from the changes in this regulation.

Permanent Administrative Regulations

Article 2.—BOVINE BRUCELLOSIS

- **9-2-35.** Movement of sexually intact cattle and bison from designated surveillance areas. (a) Each of the following terms, as used in this regulation, shall have the meaning specified in this subsection:
- (1) "Designated surveillance area" and "DSA" mean any area identified by the USDA with an elevated risk for brucellosis infection due to serological evidence of brucella exposure in wild elk sampled in that area.
- (2) "Official identification" means a unique and permanent form of individual animal identification approved by the USDA's animal and plant health inspection service or the animal health commissioner. This term shall not include breed registration tattoos, brands, or any registered brand even if the registered brand is accompanied by a brand inspection certificate.
- (3) "Official test" means a USDA-approved test for brucellosis conducted at a USDA-approved lab pursuant to "brucellosis eradication: uniform methods and rules," which is adopted by reference in K.A.R. 9-2-32.
- (4) "USDA" means United States department of agriculture.
- (b) All sexually intact cattle or bison, regardless of age and sex, moving from a DSA into Kansas shall have official identification for each animal, shall obtain a movement permit number from the Kansas animal health

commissioner, and shall be accompanied by a certificate of veterinary inspection issued by a state-licensed and federally accredited veterinarian in the state of origin. The certificate of veterinary inspection shall include the movement permit number and a statement verifying that each animal has official identification.

- (c) In addition to the requirements of subsection (b), the certificate of veterinary inspection for all sexually intact cattle and bison aged 12 months or older moving from a DSA into Kansas and all sexually intact cattle and bison moving from a DSA into Kansas for breeding or exhibition purposes, regardless of age, shall also include official identification for each animal and a statement that each animal being moved meets one of the following requirements:
- (1) Originates and moves directly from a USDA-certified brucellosis-free herd in the state of origin;
- (2) originates and moves directly from a herd that has had a negative whole-herd test for brucellosis conducted within the previous 12 months, including the date of the last qualifying whole-herd test; or
- (3) has tested negative in response to an official test for brucellosis within the 30 days before movement to Kansas, including the date of the last qualifying test for the animal.
- (d) One copy of the certificate of veterinary inspection shall accompany the cattle or bison shipment, one copy shall be retained by the official state agency in the state of origin, and one copy shall be sent by the inspecting veterinarian in the state of origin to the office of the Kansas animal health commissioner. Article 3.—SWINE BRUCELLOSIS AND CERVIDS

9-3-9. Certificate of veterinary inspection; importation and intrastate movement requirements and permits. (a) Each cervid imported into Kansas shall be identified with official identification and shall be accompanied by a certificate of veterinary inspection.

(b) Each individual importing a cervid into Kansas shall obtain an import permit from the Kansas department of agriculture, division of animal health before the cervid enters Kansas. The cervid shall not be allowed entry into Kansas without this permit.

(c) Each animal of the genera Odocoileus, Cervus, and Alces, including whitetail deer, mule deer, black-tailed deer and associated subspecies, North American elk (wapiti), red deer, sika deer, moose, and any hybrids of these species, and the genera Rangifer, including reindeer and caribou, regardless of age, not moving directly to a licensed slaughter establishment within Kansas shall originate and move directly from a herd with at least five years of herd status in the APHIS herd certification program or an equivalent program administered by the office of the state veterinarian in the state of origin.

Muntjacs, Père David's deer, fallow deer, and axis deer shall be exempt from the monitoring requirements for CWD in K.A.R. 9-3-15 and 9-3-16. Other cervid species

may be exempted by the commissioner if the species are determined by APHIS to be nonsusceptible to CWD.

- (d) All cervids originating from an area identified by APHIS as a designated surveillance area shall be prohibited entry into Kansas.
- (e) Each domesticated cervid, except nursing young under four months of age and accompanied by their dam, that is entering Kansas, is not from a herd accredited by APHIS to be TB-free, and is not moving directly to a licensed slaughter establishment in Kansas shall be required to test negative for TB, using an approved test administered twice at least 90 days apart. The first test shall be administered no more than 180 days before entry into Kansas, and the second test shall be administered no more than 90 days before entry.
- (f) Any imported cervid may be quarantined for a retest for TB by order of the commissioner.
- (g) Each domesticated cervid, alive or dead, transported within the state of Kansas shall be accompanied by a completed transportation notice signed by the shipper on a form provided by the Kansas department of agriculture, division of animal health. One copy of the notice shall be mailed to the commissioner, one copy shall accompany the shipment, and one copy shall be retained by the shipper. The shipper shall possess a current domesticated cervid permit. Article 7.—EXAMINATIONS

100-7-1. Designated examinations for medicine and surgery and osteopathic medicine and surgery; limitation on attempts. (a)(1) Each applicant for licensure by examination in medicine and surgery shall be required to successfully complete either of the following:

(A) Step 1, step 2, and step 3 of the United States medical licensing examination (USMLE); or

(B) the substantial equivalent of the examination specified in paragraph (a)(1)(A) in the year the examination was completed, as determined by the board.

(2) Each applicant who does not complete all steps of the USMLE within seven total attempts shall be deemed ineligible for licensure by examination until the applicant has submitted evidence acceptable to the board of further professional study of the subject matter tested in each USMLE step not completed by the applicant and the board determines that the further professional study is sufficient to substantially improve the applicant's likelihood of completing each USMLE step not completed by the applicant.

(continued)

- (b)(1) Each applicant for licensure by examination in osteopathic medicine and surgery shall be required to successfully complete either of the following:
 - (A)(i) Step 1, step 2, and step 3 of the USMLE; or
- (ii) level 1, level 2, and level 3 of the comprehensive osteopathic medical licensing examination (COMLEX-USA); or
- (B) the substantial equivalent of either examination specified in paragraphs (b)(1)(A)(i) and (ii) in the year the examination was completed, as determined by the board.
- (2) Each applicant who does not complete all steps of the USMLE or all levels of the COMLEX-USA within seven total attempts shall be deemed ineligible for licensure by examination until the applicant has submitted evidence acceptable to the board of further professional study of the subject matter tested in each USMLE step or COMLEX-USA level not completed by the applicant and the board determines that the further professional study is sufficient to substantially improve the applicant's likelihood of completing each USMLE step or COMLEX-USA level not completed by the applicant. (Authorized by K.S.A. 65-2828 and K.S.A. 65-2865; implementing K.S.A. 65-2828, K.S.A. 65-2833, and K.S.A. 65-2873; effective Jan. 1, 1966; amended Feb. 15, 1977; amended July 7, 2000; amended Nov. 13, 2020.)

Article 76. – ACUPUNCTURISTS

- **100-76-6.** Continuing education. (a) Each licensee shall complete at least 30 contact hours of approved continuing education within the 24 months preceding each renewal date in an even-numbered year, except as specified in subsection (b).
- (b) A licensee initially licensed less than 12 months before a renewal date when continuing education is required shall not be required to submit evidence of completion of the continuing education required by subsection (a) for the first renewal period. Each licensee initially licensed more than one year but less than two years before a renewal date when continuing education is required shall complete at least 15 contact hours of approved continuing education within the licensure period.
- (c) Each licensee shall maintain evidence of successful completion of all continuing education activities for five years from the date of completion of the activity. Evidence of successful completion of the continuing education activities required by subsections (a) and (b) may be requested by the board.
- (d) Upon request by a licensee, an extension of up to six months may be granted by the board if the licensee cannot meet the requirements of subsection (a) or (b) due to a substantiated medical condition, natural disaster, death of a spouse or an immediate family member, or any other similar circumstance that renders the licensee incapable of meeting the requirements of subsection (a) or (b). Each request shall include a plan for completing the required continuing education activities.
- (e) A contact hour shall consist of 50 minutes of approved continuing education activities. Meals and breaks shall not be included in the calculation of contact hours.

- (f) All continuing education activities shall be related to the practice of acupuncture and shall pertain to any of the following:
 - (1) Clinical skills;
 - (2) clinical techniques;
- (3) educational principles when providing service to patients, families, health professionals, health professional students, or the community;
 - (4) health care and the health care delivery system;
- (5) problem solving, critical thinking, medical record-keeping, and ethics;
 - (6) policy;
 - (7) biomedical science; or
 - (8) research.
- (g) Continuing education activities shall consist of the following:
- (1) Offerings. "Offerings" shall mean any offerings approved by the NCCAOM, by NCCAOM state affiliates, or by an entity with standards substantially equivalent to the standards of the NCCAOM as determined by the board or any other offerings approved by the board, subject to the limitation specified in paragraph (g)(9)(A).
- (2) Lecture. "Lecture" shall mean a live discourse for the purpose of instruction given before an audience.
- (3) Panel. "Panel" shall mean the presentation of multiple views by several professional individuals on a given subject, with none of the views considered a final solution.
- (4) Workshop. "Workshop" shall mean a series of meetings designed for intensive study, work, or discussion in a specific field of interest.
- (5) Seminar. "Seminar" shall mean directed advanced study or discussion in a specific field of interest.
- (6) Symposium. "Symposium" shall mean a conference of more than a single session organized for the purpose of discussing a specific subject from various viewpoints and by various speakers.
- (7) İn-service training. "In-service training" shall mean an educational presentation given to employees during the course of employment that pertains solely to the enhancement of acupuncture skills in the evaluation, assessment, or treatment of patients.
- (8) Administrative training. "Administrative training" shall mean a presentation that enhances the knowledge of an acupuncturist on the topic of quality assurance, risk management, reimbursement, statutory requirements, or claim procedures.
- (9) Self-instruction. "Self-instruction" shall mean either of the following:
- (A) Reading professional literature. A maximum of four contact hours for each continuing education cycle shall be awarded. Each licensee shall maintain a log of all professional literature read as a continuing education activity; or
- (B) completion of a correspondence, audio, video, or internet course approved by the NCCAOM, by NCCAOM state affiliates, or by an entity with standards substantially equivalent to the standards of the NCCAOM as determined by the board or any other continuing education offerings approved by the board, for which a printed verification of successful completion is provided by the person or organization offering the course.

(10) Continuing education activity presentation. "Continuing education activity presentation" shall mean the preparation and presentation of a continuing education activity that meets the requirements of this subsection. Three contact hours shall be awarded for each hour spent presenting.

(h) No contact hours shall be awarded for any continu-

ing education activity that is repeated within a 48-month period. (Authorized by K.S.A. 65-7615; implementing K.S.A. 65-7609; effective, T-100-9-21-17, Sept. 21, 2017; effective Jan. 12, 2018; amended Nov. 13, 2020.)
